- 2 CHAIRMAN SCOTT: Pursuant to the provisions of
- 3 the Illinois Open Meetings Act, I now convene a
- 4 regularly scheduled Bench Session of the Illinois
- 5 Commerce Commission. With me in Chicago are
- 6 Commissioners Ford and O'Connell-Diaz, and with us in
- 7 Springfield are Commissioner Elliott and Acting
- 8 Commissioner Colgan. I'm Chairman Scott. We have a
- 9 quorum.
- 10 Before moving into the Agenda,
- 11 according to Section 1700.10 of Title II of the
- 12 Administrative Code, this is the time we allow
- 13 members of the public to address the Commission.
- 14 Members of the public wishing to address the
- 15 Commission must notify the Chief Clerk's Office at
- 16 least 24 hours prior to the Bench Session. According
- 17 to the Chief Clerk's Office, we have no requests to
- 18 speak at today's session.
- 19 Under the Transportation Agenda, we'll
- 20 begin today with approval of minutes from prior
- 21 Commission meetings. Up first are minutes from our
- 22 November 2nd Bench Session. I understand amendments

- 1 have been forwarded.
- 2 Is there a motion to amend the
- 3 minutes?
- 4 COMMISSIONER FORD: So moved.
- 5 CHAIRMAN SCOTT: Is there a second?
- 6 COMMISSIONER O'CONNELL-DIAZ: Second.
- 7 CHAIRMAN SCOTT: It's been moved and seconded.
- 8 All in favor say, Aye.
- 9 (Chorus of ayes.)
- 10 CHAIRMAN SCOTT: Any opposed?
- 11 (No response.)
- 12 CHAIRMAN SCOTT: The vote is 5 to nothing and
- 13 amendments to the November 2nd minutes are adopted.
- 14 Is there a motion to approve the
- 15 minutes as amended?
- 16 COMMISSIONER FORD: So moved.
- 17 ACTING COMMISSIONER COLGAN: So moved.
- 18 CHAIRMAN SCOTT: Is there a second?
- 19 COMMISSIONER ELLIOTT: Second.
- 20 COMMISSIONER FORD: Second.
- 21 CHAIRMAN SCOTT: It's been moved and seconded.
- 22 All in favor say, Aye.

- 1 (Chorus of ayes.)
- 2 CHAIRMAN SCOTT: Any opposed?
- 3 (No response.)
- 4 CHAIRMAN SCOTT: The vote is 5 to nothing and
- 5 the November 2nd Bench Session minutes as amended are
- 6 approved.
- 7 Moving on to the Railroad Section,
- 8 Items RR-1 through RR-8 will be taken together.
- 9 These items are stipulated agreements regarding
- 10 public safety improvements at highway-rail grade
- 11 crossings across Illinois. In each case Staff
- 12 recommends entry of an Order approving the stipulated
- 13 agreement.
- 14 Is there any discussion?
- 15 (No response.)
- 16 CHAIRMAN SCOTT: Is there a motion to enter the
- 17 Orders?
- 18 COMMISSIONER O'CONNELL-DIAZ: So moved.
- 19 CHAIRMAN SCOTT: Is there a second?
- 20 COMMISSIONER FORD: Second.
- 21 CHAIRMAN SCOTT: It's been moved and seconded.
- 22 All in favor say, Aye.

- 1 (Chorus of ayes.)
- 2 CHAIRMAN SCOTT: Any opposed?
- 3 (No response.)
- 4 CHAIRMAN SCOTT: The vote is 5 to nothing and
- 5 the Orders are entered.
- 6 We will use this 5 to nothing vote for
- 7 the remainder of the Transportation Agenda unless
- 8 otherwise noted.
- 9 Items RR-9 through RR-11 can be taken
- 10 together. These items are Petitions for
- 11 Authorization of construction projects of crossings
- 12 across Illinois. In each case the ALJ recommends
- 13 entry of an Order authorizing the project.
- 14 Is there any discussion?
- 15 (No response.)
- 16 CHAIRMAN SCOTT: Any objections?
- 17 (No response.)
- 18 CHAIRMAN SCOTT: Hearing none, the Orders are
- 19 entered.
- 20 Items RR-12 through RR-17 can be taken
- 21 together. These items are stipulated agreements
- 22 regarding public safety improvements at highway-rail

- 1 grade crossings across Illinois. In each case Staff
- 2 recommends entry of a Supplemental Order allowing
- 3 additional time and/or funding for the project's
- 4 completion.
- 5 Is there any discussion?
- 6 (No response.)
- 7 CHAIRMAN SCOTT: Any objections?
- 8 (No response.)
- 9 CHAIRMAN SCOTT: Hearing none, the Supplemental
- 10 Orders are entered.
- 11 On to Motor Carriers. Items MC-1 is
- 12 Bloomington Relocation Systems' Application for a new
- 13 Household Goods Property Motor Carrier Authority.
- 14 ALJ Duggan recommends entry of an Order granting the
- 15 Application.
- Is there any discussion?
- 17 (No response.)
- 18 CHAIRMAN SCOTT: Any objections?
- 19 (No response.)
- 20 CHAIRMAN SCOTT: Hearing none, the Order is
- 21 entered and the Application is granted.
- 22 Item MC-2 through MC-4 can be taken

- 1 together. These are Applications for the renewal of
- 2 the Applicants' Commercial Relocation Towing
- 3 Licenses. In each case Staff recommends entry of an
- 4 Order granting the license renewal.
- 5 Is there any discussion?
- 6 (No response.)
- 7 CHAIRMAN SCOTT: Any objections?
- 8 (No response.)
- 9 CHAIRMAN SCOTT: Hearing none, the Orders are
- 10 entered and the renewals are granted.
- 11 Item MC-5 concerns Rapid Recovery's
- 12 Application for a Commercial Relocator's License.
- 13 Before us today is a Motion for Rehearing brought by
- 14 Intervenors in this matter and ALJ Kirkland-Montague
- 15 recommends that the Motion for Rehearing be denied.
- Is there any discussion?
- 17 (No response.)
- 18 CHAIRMAN SCOTT: Are there any objections to
- 19 denying the motion?
- 20 (No response.)
- 21 CHAIRMAN SCOTT: Hearing none, the Intervenor's
- 22 Petition for Rehearing is denied.

- 1 We have one administrative item for
- 2 consideration today. Item AM-1 concerns proposed
- 3 rules for implementing Public Act 97-0576 concerning
- 4 the recovery of collateral. Transportation Bureau
- 5 Chief Matrisch recommends adoption of a Resolution
- 6 authorizing submission of a notice of proposed rule
- 7 to the Illinois Secretary of State to initiate a
- 8 rulemaking.
- 9 Is there any discussion?
- I had a couple questions for you,
- 11 Mr. Matrisch, if you could.
- MR. MATRISCH: Sure.
- 13 CHAIRMAN SCOTT: I'm understanding that there
- 14 were a couple of workshops that were held in advance
- of these rules being promulgated.
- 16 MR. MATRISCH: That's correct, Chairman. There
- 17 was a workshop held on October 17th in Springfield
- and one October 26th in Chicago where we met with
- 19 representatives from the industry and worked out some
- 20 issues with the rules. And the rules that are before
- 21 the Commission today are post-workshop rules where we
- 22 have incorporated some of the suggested changes by

- 1 the industry.
- 2 CHAIRMAN SCOTT: Okay. Thank you. And my
- 3 understanding, this is the first time that this
- 4 particular piece of this industry has been regulated?
- 5 MR. MATRISCH: That's correct, in Illinois. I
- 6 believe Chicago regulates repossession -- the
- 7 repossession industry in the Chicago area. But in
- 8 Illinois, this is state-wide regulation. This is the
- 9 first time that this industry has been regulated in
- 10 Illinois.
- 11 CHAIRMAN SCOTT: Thank you very much. I
- 12 appreciate it.
- 13 Any further questions? Any other
- 14 discussion?
- 15 (No response.)
- 16 COMMISSIONER O'CONNELL-DIAZ: My only comment
- 17 is I hope I don't see this on a reality show. I
- 18 think there's been about four repoman shows out
- 19 there.
- 20 CHAIRMAN SCOTT: That's right.
- MR. MATRISCH: So do I, Commissioners.
- 22 CHAIRMAN SCOTT: Especially the rules. How bad

- 1 would it be if the rules ended up on a reality show?
- 2 COMMISSIONER O'CONNELL-DIAZ: Oh, I tell you.
- 3 Yeah, right.
- 4 CHAIRMAN SCOTT: That would really be bad.
- 5 Any further discussion?
- 6 (No response.)
- 7 CHAIRMAN SCOTT: Are there any objections to
- 8 the Resolution?
- 9 (No response.)
- 10 CHAIRMAN SCOTT: Hearing none, the Resolution
- 11 is adopted.
- Mr. Matrisch, is there any further
- business to come before the Commission today?
- 14 MR. MATRISCH: Nothing further, Chairman.
- 15 Thank you.
