1 PROCEEDINGS

- 2 CHAIRMAN SCOTT: Pursuant to the provisions of
- 3 the Illinois Open Meetings Act, I now convene a
- 4 Regular Open Meeting of the Illinois Commerce
- 5 Commission. With me in Springfield is Commissioner
- 6 Colgan and with us in Chicago are Commissioners Ford
- 7 and O'Connell-Diaz and Acting Commissioner McCabe. I
- 8 am Chairman Scott. We have a quorum.
- 9 Before moving into the agenda,
- 10 according to Section 1700.10 of Title II of the
- 11 Administrative Code, this is the time we allow
- 12 members of the public to address the Commission.
- 13 Members of the public wishing to address the
- 14 Commission must notify the Chief Clerk's Office at
- 15 least 24 hours prior to our Commission meeting.
- 16 According to the Chief Clerk's Office,
- 17 we have no requests to speak at today's Regular Open
- 18 Meeting.
- Moving on to our agenda for today,
- 20 Item 1 is Docket Number 11-0689. This item concerns
- 21 evaluation of our state's On-Bill Financing Programs.
- 22 Before us today is a motion by Staff regarding

- 1 start-up dates related to an Evaluation Report due to
- 2 the General Assembly. ALJ Haynes recommends adoption
- 3 of Staff's Option 1 resulting in a single Evaluation
- 4 Report being submitted to the General Assembly.
- 5 Is there any discussion?
- 6 (No response.)
- 7 Is there a motion to confirm adoption
- 8 of Staff's Option 1?
- 9 COMMISSIONER COLGAN: So moved.
- 10 CHAIRMAN SCOTT: Is there a second?
- 11 COMMISSIONER O'CONNELL-DIAZ: Second.
- 12 CHAIRMAN SCOTT: It's been moved and seconded.
- 13 All in favor say aye.
- 14 COMMISSIONERS: Aye.
- 15 CHAIRMAN SCOTT: Any opposed?
- 16 (No response.)
- The vote is five to nothing, and
- 18 Staff's Option 1 regarding the start-up dates for the
- 19 Evaluation is adopted.
- 20 We will use this five to nothing vote
- 21 for the remainder of today's agenda, unless otherwise
- 22 noted.

- 1 Item 2 is Docket Number 11-0661. This
- 2 is American Transmission Company's petition for a
- 3 certificate to construct, operate and maintain a new
- 4 transmission line in Lake County. ALJ Teaque
- 5 recommends entry of an Order granting the requested
- 6 certificate authorizing the project.
- 7 Is there any discussion?
- 8 (No response.)
- 9 Any objections?
- 10 (No response.)
- Hearing none, the Order is entered.
- 12 Item 3 is Docket Number 12-0180. This
- is HIKO Energy's application for a Certificate of
- 14 Service Authority to operate as an alternative retail
- 15 electric supplier. ALJ Albers recommends entry of an
- 16 Order granting the requested certificate.
- 17 Is there any discussion?
- 18 (No response.)
- 19 Any objections?
- 20 (No response.)
- 21 Hearing none, the Order is entered.
- 22 Item 4 was Docket Number 12-0203.

- 1 This item has since been withdrawn.
- 2 Item 5 is Docket Number 12-0205. This
- 3 is IDT Energy's application for a Certificate of
- 4 Service Authority to operate as an alternative retail
- 5 electric supplier. The applicant now seeks to
- 6 withdraw its application, and ALJ Albers recommends
- 7 dismissing this matter without prejudice.
- 8 Is there any discussion?
- 9 (No response.)
- 10 Any objections?
- 11 (No response.)
- 12 Hearing none, this matter is dismissed
- 13 without prejudice.
- 14 Item 6 is Docket Number 10-0690. This
- is Mt. Carmel's reconciliation case concerning
- 16 revenues collected under gas adjustment charges. ALJ
- 17 Jones recommends entry of an Order approving the
- 18 reconciliation, subject to adjustments proposed by
- 19 Staff.
- Is there any discussion?
- 21 (No response.)
- 22 Any objections?

- 1 (No response.)
- 2 Hearing none, the Order is entered.
- 3 Item 7 is Docket Number 11-0710. This
- 4 is Chicago Clean Energy's sourcing agreement matter
- 5 on rehearing. Before us today is a Petition for
- 6 Interlocutory Review filed by CCE and EDI regarding
- 7 denial of their Motion in Limine.
- 8 Is there any discussion?
- 9 COMMISSIONER O'CONNELL-DIAZ: Mr. Chairman?
- 10 CHAIRMAN SCOTT: Yes, Commissioner
- 11 O'Connell-Diaz?
- 12 COMMISSIONER O'CONNELL-DIAZ: I would just note
- 13 that I think the Commission was very clear in
- 14 suggesting that we needed to have a full record.
- 15 Commissioner Colgan was very erudite with regard to
- 16 that. And due to the compressed schedule that we
- 17 were presented with, we didn't have that. And so the
- 18 petition was granted and now it appears that the
- 19 party in this case is suggesting that there should be
- 20 some other expedited treatment that in fact would
- 21 deny due process to everyone that is not in agreement
- 22 with their position.

- 1 As we stated, or I stated, I would be
- 2 watching the procedural aspects of this case, and it
- 3 is clear from the Commission's statement from the
- 4 bench that we want a clear and complete record with
- 5 regard to these important issues. And so I was quite
- 6 surprised as I read through the petitions that were
- 7 filed in this matter, and I would just suggest that
- 8 counsel should think about things before they file
- 9 them as being according to our rules, and I find that
- 10 there is nothing in this Petition for Rehearing that
- 11 would support where they would like the Commission to
- 12 go.
- We want to have a full record. We
- 14 want to have that before us, and Judge Wallace has
- 15 created a schedule pursuant to our expressed intent,
- 16 and I think that's where the Commission wants to go.
- So, you know, again I will be watching
- 18 the procedural aspects of this case and all the
- 19 filings of the lawyers, as I am sure all of the other
- 20 Commissioners will be doing. But I would suggest
- 21 that some of the language and styling of certain
- 22 arguments were specious at best.

- 1 So I just wanted to say that for the
- 2 record.
- 3 CHAIRMAN SCOTT: Commissioner Colgan?
- 4 COMMISSIONER COLGAN: Yeah. I voted no on the
- 5 Commission's final sourcing agreement and I
- 6 encouraged the parties to seek rehearing on this
- 7 case.
- 8 I had concerns that the Commission may
- 9 be over-reaching its statutory authority and the
- 10 legislative intent of the General Assembly, and I had
- 11 these concerns because the statute to me, despite
- 12 strong opinions to the contrary, is not clear in
- 13 several ways. And a couple of respected legislators
- 14 were raising concerns, and the General Assembly, as
- 15 we all know, has passed resolutions on this case,
- 16 which seemed to me to be a unique situation, so.
- 17 I also expressed that I had an
- 18 interest in this case because I am interested in
- 19 commercial-scale CO2 capture and sequestration, and
- 20 that's part of this project. But there were other
- 21 comments, and I think I made comments about this,
- 22 too, that this is really novel territory for us. And

- we really -- the constraint in timelines that we had
- 2 to operate within had to put a lot of pressure on
- 3 everybody involved.
- 4 So I actually agree with Commissioner
- 5 O'Connell-Diaz that I asked for a rehearing because I
- 6 wanted to hear the arguments on this case.
- 7 I also think it is important to point
- 8 out that the schedule that the parties have agreed to
- 9 in this case has cut the time frame from 150 days to
- 10 basically in half. So in that regard I think to try
- 11 to give everybody a little bit of time to think
- 12 through and respond and then respond to other
- 13 people's comments, I think that that's -- you know,
- 14 we are trying to expedite this.
- And, finally, I just wanted to say
- 16 that I think we are trying to do our best here with
- 17 this issue, and I believe that Chief ALJ Wallace is
- doing his very best, as he always does, to be fair
- 19 and transparent and impartial. But, you know,
- 20 regardless of what the Chief ALJ recommends, the
- 21 Commission has the final say in this case and, you
- 22 know, I think we have it cued up and it is moving

- 1 through and, you know, where it all comes out, we
- 2 still have to see all the discussion. So, you know,
- 3 I actually don't --
- 4 COMMISSIONER FORD: I certainly concur with
- 5 you. I also voted no with you, Commissioner Colgan,
- 6 and for those same reasons, that I wanted it to be
- 7 fair, impartial and certainly transparent.
- 8 I would hope that with this new
- 9 hearing that we are going to have -- and this time
- 10 certainly has been expedited from 150 days or
- 11 whatever, to half the time. So I am looking forward
- 12 to hearing all the evidence that's going to be
- 13 presented in this case so that we can make a
- 14 decision. Even though we are creatures of the
- 15 legislature and we do listen to -- we have to go by
- 16 law, but they certainly have sent resolutions over
- 17 here to influence us. But I am glad that we are
- 18 still an independent agency.
- 19 CHAIRMAN SCOTT: Commissioner McCabe?
- 20 COMMISSIONER McCABE: I am going to abstain as
- 21 this is still early in my tenure here.
- 22 CHAIRMAN SCOTT: Very good. All right. I just

- 1 want to add, I agree with the comments that have been
- 2 said so I won't reiterate them. Although I do want
- 3 to say that I think Judge Wallace has gone to great
- 4 lengths and steps to get the information out that we
- 5 said we wanted through the rehearing and to do that
- 6 in a timely fashion and to do it in a way that is
- 7 fair to all of the parties, and I think that this
- 8 motion circumvents that.
- 9 In the year I have been here, to me
- 10 this is the most disappointing motion that I have
- 11 seen because what it does is, it is not an academic
- 12 exercise. It might be interesting to talk about if
- 13 we were just talking about these things
- 14 theoretically. These are real motions that require a
- 15 lot of parties to use resources to talk about them,
- 16 as well as Staff time and Commission time. It just
- 17 goes against what, as the other Commissioners
- 18 eloquently stated, we were looking for when we did
- 19 the rehearing in the first place.
- 20 So I agree with the comments that have
- 21 been stated, and we will obviously not be supporting
- 22 the motion.

- 1 Are there any objections to denying
- 2 the Petition for Interlocutory Review?
- 3 (No response.)
- 4 Hearing none, the petition is denied
- 5 by a four to nothing vote.
- 6 Item 8 is Docket Number 12-0082. This
- 7 is Direct Energy Service's petition seeking
- 8 confidential and/or proprietary treatment of its
- 9 compliance report. ALJ Von Qualen recommends entry
- 10 of an Order granting the requested protective
- 11 treatment.
- 12 Is there any discussion?
- 13 (No response.)
- 14 Any objections?
- 15 (No response.)
- 16 Hearing none, the Order is entered.
- 17 Item 9 was Docket Number 12-0145.
- 18 This item has been withdrawn.
- 19 Item 10 is Docket Number 12-0224.
- 20 This is YMax Communications' petition seeking
- 21 confidential and/or proprietary treatment of its
- 22 Annual Report. ALJ Von Qualen recommends entry of an

- 1 Order granting the requested protective treatment.
- 2 Is there any discussion?
- 3
 (No response.)
- 4 Any objections?
- 5 (No response.)
- 6 Hearing none, the Order is entered.
- 7 Item 11 is Docket Number 07-0566.
- 8 This is ComEd's 2007 rate case on remand from the
- 9 Appellate Court, and before us today is a rehearing
- 10 request filed by CUB and the AG. ALJ Haynes
- 11 recommends denying the rehearing request.
- 12 Is there any discussion?
- 13 COMMISSIONER McCABE: Mr. Chairman, I am going
- 14 to abstain on this one, also.
- 15 CHAIRMAN SCOTT: Thank you, Commissioner
- 16 McCabe.
- 17 Are there any objections to denying
- 18 the rehearing application?
- 19 (No response.)
- Hearing none, the rehearing is denied
- 21 by a four to nothing vote.
- Judge Wallace, are there any other

1	matters to come before the Commission today as far as
2	this agenda?
3	JUDGE WALLACE: No, Mr. Chairman.
4	CHAIRMAN SCOTT: Thank you. Hearing none, this
5	meeting stands adjourned. We will commence our
6	Emergency Special Open Meeting to address a
7	procurement issue shortly.
