5	Commission. With me in Springfield are Commissioners
6	Colgan and McCabe and with us in Chicago are
7	Commissioners Ford and O'Connell-Diaz. I am Chairman
8	Scott. We have a quorum.
9	Before moving into the agenda,
10	according to Section 1700.10 of Title II of the
11	Administrative Code, this is the time we allow
12	members of the public to address the Commission.
13	Members of the public wishing to address the
14	Commission must notify the Chief Clerk's Office at
15	least 24 hours prior to the Commission meeting.
16	According to the Chief Clerk's Office, we have no
17	requests to speak at today's Bench Session.
18	(The Transportation
19	portion of the proceedings
20	was held at this time and
21	is contained in a separate
22	transcript.)

                    I know Bill Marr is here to answer any

     questions for us today as well, should we have them.

- 1 I would start the discussion off here, as Bill is
- 2 making his way to the table.
- While I believe everyone's best
- 4 interests are served by not suspending the filing,
- 5 there was some disconcerting things revealed during
- 6 the process associated with the filing, particularly
- 7 in the report we see from our Customer Services
- 8 Department which noted 39 comments on the case over
- 9 about a two-months period in 2011, with all 39
- 10 opposing the increase. According to the CSD, quote,
- in 29 of those cases customers also expressed
- 12 dissatisfaction with the quality of service,
- including poor water quality, need to purchase
- 14 drinking water, no or low pressure, service
- 15 interruptions, frequent boil orders, lack of meter
- 16 reading, billing inaccuracy and poor customer
- 17 service, including can't reach the company by phone.
- 18 In one case the customer included a picture of a
- 19 bathtub being filled with orange water. In three
- 20 cases billing was cited as an issue as well, unquote.
- 21 I believe these concerns need to be
- 22 addressed, and with that in mind I would like to

- 1 request that Staff develop an Initiating Order for an
- 2 investigation under Section 8-102 of the Public
- 3 Utilities Act so that we can start looking at some of
- 4 these very serious service issues. We would then
- 5 vote on the Initiating Order at a future Commission
- 6 meeting, so this approach doesn't require a vote
- 7 today. But I thought it was necessary to bring these
- 8 issues to light and that we absolutely need to
- 9 investigate the significant service issues raised in
- 10 this matter.
- 11 Further discussion?
- 12 COMMISSIONER O'CONNELL-DIAZ: Mr. Chairman, I
- 13 too noted the memo that was attached to this, and it
- 14 raised a level of concern, and I do note that the
- 15 date on it is 2011 and this is the first I have seen
- 16 this and I am sure all the other Commissioners have
- 17 seen this report of issues that customers in this
- 18 company have.
- 19 So I guess I would look to someone
- 20 from Staff to give us an explanation as to, you know,
- 21 what's been going on since this was brought to their
- 22 attention. I would imagine that would be in a report

- 1 that would be submitted to us. That also struck me,
- 2 so I concur in your evaluation.
- 3 CHAIRMAN SCOTT: Commissioners, further
- 4 discussion? Commissioner Colgan?
- 5 COMMISSIONER COLGAN: I don't really have
- 6 anything to offer, anything further to offer, but I
- 7 agree that I would like to see the initiation of some
- 8 investigation into this issue and deal with it at a
- 9 later date. I agree with that.
- 10 CHAIRMAN SCOTT: Further discussion?
- 11 (No response.)
- 12 Okay, thank you. In terms of what we
- 13 have to address today, are there any objections to
- 14 not suspending the filing?
- 15 (No response.)
- With that, the filing will not be
- 17 suspended. Thank you, Bill.
- 18 Item W-2 is Docket Number 09-0151.
- 19 This item will be held for disposition at a future
- 20 Commission meeting.
- 21 We have one item of Other Business to
- 22 take up today. This concerns our Annual Report on

- 1 Cable and Video Service Deployment and voting to have
- 2 this report sent over to the General Assembly. Do we
- 3 have somebody from Staff who is available to brief us
- 4 on the report?
- Jim Zolnierek? Step right up. Go
- 6 ahead.
- 7 MR. ZOLNIEREK: The Cable and Video Services
- 8 Competition Law of 2007 permits cable or video
- 9 service providers to obtain from this Commission
- 10 state-issued authorization to offer to provide
- 11 cable/video service. Every year those with the
- 12 state-issued authorization are required by April 1 to
- 13 report to us certain statistics on their deployment,
- 14 number of houses passed in the area, number of low
- income houses passed, and then we are required to
- 16 turn that around to the General Assembly by July 1 of
- 17 each year, and that's what we did with this report.
- 18 At the end of year-end 2011 there were
- 19 three providers with Commission authorization:
- 20 Illinois Bell Telephone Company that received
- 21 authorization in 2007; Wide Open West or WOW who
- 22 received authorization in 2010; and Highland

- 1 Communication Services who received authorization in
- 2 2011. All three provided us reports, and the reports
- 3 are pretty standard. There is not too much of
- 4 terrible excitement in the reports, other than just
- 5 sort of reporting the numbers.
- The one key hurdle, I think, in the
- 7 report is that by October 23 of 2012 AT&T is required
- 8 to deploy 50 percent of the households in the
- 9 telecommunications service area. At year-end 2011
- 10 they were at 48 percent, so it looks like they are on
- 11 track to meet that hurdle.
- 12 And just as an FYI, the Cable and
- 13 Video Services Deployment Act expires October of
- 14 2013. So we may see some rewrite action on that as
- 15 far as that.
- I am here to take questions if you
- 17 have any questions regarding the report.
- 18 CHAIRMAN SCOTT: Discussion on the report?
- 19 (No response.)
- 20 Are there any objections to approving
- 21 the report and having it sent to the General
- 22 Assembly?

2	Hearing none, the report is approved,
3	and it will be sent along to the General Assembly.
4	Thanks, Jim.
5	MR. ZOLNIEREK: Thank you.
6	CHAIRMAN SCOTT: Judge Wallace, are there any

10	this meeting stands adjourned.
