- 18 Assistant Director to the Telecommunications Division
- 19 before going on to DCEO.
- 20 So, Jonathan, we are very excited to
- 21 have you here. It is a very interesting and exciting
- 22 time for the Commission, and we very much look

- 1 forward to working with you and we know you are going
- 2 to do a tremendous job. So welcome to the
- 3 Commission.
- 4 MR. FEIPEL: Thank you.
- 5 CHAIRMAN SCOTT: And while we are welcoming
- 6 Jonathan, we also want to thank Randy Nehrt who
- 7 served as the Interim Executive Director for six
- 8 months, a very difficult job to do at a very
- 9 difficult and busy time for the Commission.

- 11 want to thank Randy for his outstanding service both
- 12 before that time and during that time and look
- 13 forward to continuing to work with Randy in the
- 14 future as well. Thanks.

- 18 Jonathan and look forward to working with you for the
- 19 next several months.
