The Financial Analysis Division of the Illinois Commerce Commission is seeking **2 candidates** to work in its **Accounting** Department as an **Economic Analyst III**. This position will be located in Sangamon County at 527 East Capitol Avenue, Springfield, Illinois 62701.

BRIEF DESCRIPTION OF DUTIES:

The Economic Analyst III reviews and evaluates information provided by the company, performs reviews of the utilities' books and records in accordance with standard guidelines, develops data requests, identifies issues that need further review and develops adjustments as appropriate; develops cross-examination questions for staff counsel to ask company and intervenor witnesses; prepares written testimony that set forth opinions and positions on pertinent accounting issues and presents proposed adjustments; presents expert witness testimony in Commission hearings and assists in the preparation of legal briefs; performs research of accounting issues and other related matters that affect public utilities; performs other duties, research, and special projects, as required or assigned, which are reasonably within the scope of duties enumerated above.

EDUCATION, TRAINING AND EXPERIENCE REQUIRED:

The **Economic Analyst III – Accounting** requires a bachelor's degree in accounting and a Certified Public Accountant certificate. A bachelor's degree in another field and a minimum of one year of regulatory, public accounting, or auditing experience may substitute for the degree requirement. Additionally, requires minimum of two years of regulatory, public accounting, or auditing experience, superior oral and written English communication skills, and extensive knowledge of the personal computer and its related software programs and applications.

The **Economic Analyst III - Accounting position** is represented by AFSCME and is an RC 63, grade 21 position with an expected monthly salary range of \$6,688 to \$9,745 monthly. Work hours are anticipated to be 8:30 a.m. to 5:00 p.m., Monday through Friday.
