RE: *REVISED SCHEDULE* FOR LONG-TERM RENEWABLE RESOURCES PROCUREMENT

PLAN COMMENT, FILING, & APPROVAL

DATE: September 3, 2019

In its Cover Letter dated August 15, 2019, the Illinois Power Agency ("IPA") established a due date of September 16, 2019 (30 days after posting) for the receipt of written public comments on its Revised Long-Term Renewable Resources Procurement Plan ("Revised Plan"). This deadline would allow the Agency to conduct its public comment process "in conjunction with" the plan development and public comment process applicable to its annual electricity procurement plan.¹

After discussions with the Staff of the Illinois Commerce Commission, the IPA believes there is, at minimum, a colorable argument that the 45-day public comment applicable to the publishing of the Agency's Initial Long-Term Renewable Resources Procurement Plan should also apply to the development of its Revised Long-Term Renewable Resources Procurement Plan.² This reading of Section 16-111.5(b)(5)(ii) of the Public Utilities Act also extends to allowing the Agency 21 days to revise its Plan, allowing parties 14 days for Objections, and allowing the Commission 120 days for its review and approval.

The IPA strongly values the public comment process and wishes to ensure that no party receives any less opportunity to offer public comment than what that party could arguably be entitled to under Illinois law. Additionally, given the multitude of issues addressed in its Long-Term Renewable Resources Procurement Plan and the complexity of many of those issues, it understands that interested parties may benefit from additional time to prepare and submit written public comments.

Consistent with these principles, the Agency will now be utilizing the following schedule for receiving written public comment on, revising, and filing its Revised Long-Term Renewable Resources Procurement Plan.

REVISED SCHEDULE

Monday, September 30, 2019: New deadline for affected utilities and other interested parties to provide comments to the IPA on the draft Revised Plan.

Comments are required to be "specific, supported by data or other detailed analyses, and, if objecting to all or a portion of the procurement plan, accompanied by specific alternative wording or proposals." (See 220 ILCS 5/16-111.5(b)(5)(ii)(B) [emphasis added])

Monday, October 21, 2019: The IPA plans to revise the draft Revised Plan, as necessary, based on the comments received, and intends to file the Revised Plan with the Illinois Commerce Commission ("Commission") for review and approval by this date. (See 220 ILCS 5/16-111.5(b)(5)(ii)(B))

Monday, November 4, 2019: Within fourteen days, any person objecting to the Revised Plan may file an objection with the Commission, consistent with the timeline applicable to the Initial Plan. (See 220 ILCS 5/16-111.5(b)(5)(ii)(C))

Tuesday, November 12, 2019: The Commission, within twenty-one days of the filing of the Revised Plan,³ will determine whether a hearing is necessary. (See 220 ILCS 5/16-111.5(b)(5)(ii)(C))

Tuesday, February 18, 2020: The IPA assumes a 120-day deadline for the Commission to enter its order confirming or modifying the Revised Plan, consistent with the time allowed for the approval of the Initial Plan. (See 220 ILCS 5/16-111.5(b)(5)(ii)(C))

The schedule for public hearings remains unchanged:

Wednesday, September 4, 2019, 2:30 pm - 4:30 pm: Illinois Commerce Commission Springfield Office, 527 East Capital Ave, Springfield, Illinois. Hearing Room C.

These hearings will continue to be conducted jointly with hearings on the Agency's 2020 Electricity Procurement Plan, although comments on the 2020 Electricity Procurement Plan remain due by September 16th, and the previously announced schedule⁴ for Commission review and approval of the 2020 Electricity Procurement Plan remains unchanged.
