#### PART FIRST.

AUSTIN:

G. TRACY, STATE PRINTER, 1871. Mr. Plumley offered the following resolution :

Resolved, That we do now proceed to organize the House by the election of a Speaker, a Sergeant-at-Arms, a Chief Clerk and a Doorkeeper.

Resolution read first and second times, and on motion of Mr. Morrison, it was adopted.

[Mr. Tegener in the chair.]

Nominations for Speaker:

Mr. Zoeller nominated Hon. Ira H. Evans.

Mr. Lane nominated Hon. W. P. McLean.

On motion of Mr. Plumley the nominations were closed.

Mr. McLean declined the nomination.

On motion of Mr. Camp Hon. Ira H. Evans was unanimously declared elected Speaker of the House of Representatives of the Twelfth Legislature, by acclamation.

Messrs. Zoeller, McLean and Butler were appointed a committee to conduct the Speaker elect to the chair.

O Upon taking the chair the Speaker said :

GENTLEMEN: I return you my sincere thanks for the high honor you have conferred upon me in reelecting me your presiding officer. As a mark of your confidence in me, if I may so interpret it, it is more esteemed by me than in any other way. It shall be my constant endeavor to prove worthy of your confidence by discharging the duties of Speaker in a fair and impartial manner.

I have to ask that you extend to me the assistance and support so cheerfully accorded by you in the past, and which I shall need again to enable me to enforce the rules of the House for the preservation of order, and the proper dispatch of business.

We have re-convened in a period of great and general prosperity to our State. We may add to this prosperity by the enactment of wise and just measures, and thus win not only the approval of our own consciences, but the plaudits of the million of people whom we represent.

The ceaseless tide of immigration which is pouring into our State with constantly increasing volume, shows us that we are legislating not for the present alone, but that our actions must effect, for good or evil, the many thousands who will yet seek homes, happiness, prosperity, and the benefits of a good government within this, the greatest and fairest State in the Union, and the one nature has endowed with the greatest and most varied resources.

Let us hope that increased charity among those who differ in opinion, and an earnest desire to promote the public welfare, may mark our present session, and produce the happy results which cannot fail to flow from such a course."
