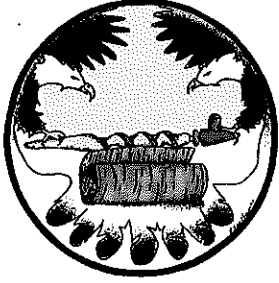
Foreign Judgment process: Person (s) requesting Foreign Judgment filing.

- 1) Notice of Registration form
 - a) Fill in Petitioner/Respondent information
 - b) Fill in To: with Respondent's name and address
 - c) Fill in numbers 2 and 3 only

The rest of the form is for Tribal Court use only.
- 2) Affidavit of Petitioner form
 - a) Fill in Petitioner/Respondent information
 - b) Fill in your name (*Petitioner*)
 - c) Fill in number 2 with Respondent's name and address
 - d) Fill in number 6
 - e) Fill in number 7 date and sign and have notarized.
- 3) Certification of Records of Foreign Court form
 - a) Fill in Petitioner/Respondent information
 - b) The Foreign Court fills rest of the form out and seals with foreign court seal

Note: Petitioner, provide the Tribal Court with a copy of the Foreign Judgment Order /Writ for Garnishment Order for the Tribal Court file. The filing fee for this process is \$25.00.

1. Notice is hereby provided to you that a judgment against you has been filed with the Tribal Court on _____. A copy of the judgment is attached to this *Notice* along with the *Certification of Records* and the *Affidavit of Petitioner*.

3. The name and address of the attorney representing the Petitioner, if any, is: _____

4. An *Order Granting the Recognition and Entitlement to Enforcement of the Foreign Court Judgment* shall be entered by this Court within twenty-one (21) days of the date of the *Certificate of Mailing*. The entry of an *Order Granting the Recognition and Entitlement to Enforcement of the Foreign Court Judgment* by this Court shall entitle the Petitioner to enforce its judgment against you in any manner currently available for judgment holders/creditors.

5. You have the right to file (a) written objection(s) to the entry of the order granting recognition with the Court within the twenty-one (21) day period. Objections filed with the Court must demonstrate that:

a. The foreign court lacked personal or subject matter jurisdiction, or

b. The judgment:

1. was obtained by fraud, duress or coercion;
2. was obtained without fair notice or a fair hearing;
3. is repugnant to the public policy of the Band; or
4. is not final under the laws and procedures of the foreign court.

6. If you file a written objection based on the above list of grounds, a hearing will be scheduled. At the hearing, you will be required to prove the grounds why the judgment should not be recognized by this Court because judgments are presumed to be valid unless shown otherwise.

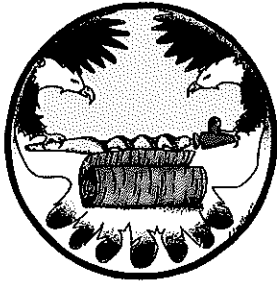

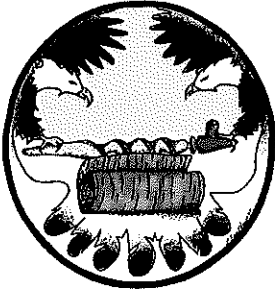
