

# AFRICA

#### Burundi: SG reports on the situation in Burundi

Resolution 2303 (2016) of 29 July 2016

Para.19: Requests the Secretary-General to report to the Security Council on the situation in Burundi <u>every three months</u> after the adoption of this resolution, including on any public incidents of incitements to hatred and violence, as well as on steps to ensure the deployment of the United Nations police component and on possible adaptations of the United Nations police component as referred to in paragraphs 13 and 14 of this resolution, and further requests the Secretary-General to provide written reports immediately to the Security Council, as necessary, on grave security incidents, violations of international humanitarian law and violations or abuses of human rights, as applicable, of which the United Nations police component in Burundi, together with OHCHR, has knowledge, whoever perpetrates them;

The report of the Secretary-General is expected to be issued in January 2017.

#### CAR: Sanctions: Arms embargo, travel ban and assets freeze

#### Resolution 2262 (2016) of 27 January 2016

Para. 1: Decides that, until <u>31 January 2017</u>, all Member States shall continue to take the necessary measures to prevent the direct or indirect supply, sale or transfer to the CAR, from or through their territories or by their nationals, or using their flag vessels or aircraft, of arms and related materiel of all types, including weapons and ammunition, military vehicles and equipment, paramilitary equipment, and spare parts for the aforementioned, and technical assistance, training, financial or other assistance, related to military activities or the provision, maintenance or use of any arms and related materiel, including the provision of armed mercenary personnel whether or not originating in their territories, and decides further that this measure shall not apply to:

Para.5: Decides that, until <u>31 January 2017</u>, all Member States shall continue to take the necessary measures to prevent the entry into or transit through their territories of individuals designated by the Committee, provided that nothing in this paragraph shall oblige a State to refuse its own nationals entry into its territory;

Para.8: Decides that all Member States shall, until <u>31 January 2017</u>, continue to freeze without delay all funds, other financial assets and economic resources which are on their territories, which are owned or controlled, directly or indirectly, by the individuals or entities designated by the Committee, or by individuals or entities acting on their behalf or at their direction, or by entities owned or controlled by them, and decides further that all Member States shall continue to ensure that any funds, financial assets or economic resources are prevented from being made available by their nationals or by any individuals or entities within their territories, to or for the benefit of the individuals or entities designated by the Committee;

The measures on arms embargo, travel ban and assets freeze will expire on 31 January 2017.

# CAR: Sanctions: SC review of Panel of Experts mandate

Resolution 2262 (2016) of 27 January 2016

Para.22: Decides to extend the mandate of the Panel of Experts until 28 February 2017 and, expresses its intent to review the mandate and take appropriate action regarding further extension no later than <u>31 January 2017</u> and requests the Secretary-General to take the necessary administrative measures as expeditiously as possible to support its action;

The PoE mandate is expected to be reviewed no later than <u>31 January 2017</u>.

# CAR: Sanctions: Panel of Experts final report

Resolution 2262 (2016) of 27 January 2016

Para.23 (c): Provide to the Committee a midterm report no later than 30 July 2016 and a final report to the Security Council, after discussion with the Committee, by <u>31 December 2016</u> on the implementation of the measures imposed by paragraphs 54 and 55 of resolution 2127 (2013) and paragraphs 30 and 32 of resolution 2134 (2014) renewed by paragraphs 1, 2, 5 and 8 of this resolution

The letter from the PoE dated 5 December (S/2016/1032) is before the Security Council.

# Côte d'Ivoire: SG report on the implementation of the mandate of UNOCI and its phased drawdown

# Resolution 2284 (2016) of 28 April 2016

Para.36: Requests the Secretary-General to keep the Council regularly informed of the situation in Côte d'Ivoire, and to provide to it a report by <u>31 January 2017</u> on the implementation of the mandate of UNOCI and its phased drawdown, including an update on the continued transition of the security responsibilities to the Government of Côte d'Ivoire, and an oral briefing by 30 June 2017 on the completion of UNOCI's mandate and its closure;

The report of the Secretary-General is expected to be issued by <u>31 January 2017</u>.

# DRC: SG reports on MONUSCO

# Resolution 2277 (2016) of 30 March 2016

Para.50: Requests the Secretary-General to report to the Council <u>every three months</u> on the implementation of MONUSCO's mandate, including its Intervention Brigade, as set out in this resolution, including on:

(i) the situation on the ground, including updates on operations to neutralize armed groups and any instances where the Mission's protection of civilians obligations are not fully met, as well as sexual violence and the impact of conflict on women and children;

(ii) progress made by the DRC on protecting human rights, on the electoral process, including on the provisions of paragraphs 7, 8 and 9 above, and in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national SSR

roadmap, its provincial stabilisation plan supported by the ISSSS and on the implementation of the DDR and DDRRR plans;

(iii) progress in the implementation of the recommendations of the strategic review, notably the measures taken to transform MONUSCO's Force, including the deployment of rapidly deployable battalions, to become more efficient and effective in implementing its mandate;

Para.48: Reiterates the need for a clear exit strategy of the Intervention Brigade, including through sustainable progress in ending the threat of armed groups and the implementation of sustainable SSR which may include the development of a Congolese rapid reaction force, requests the Secretary-General to report <u>by December 2016</u> on the implementation of the tasks of the Intervention Brigade on the basis of the evolution of the situation on the ground, its integration within MONUSCO and its effectiveness, as well as on the progress of the transformation of the Force;

The report of the Secretary-General is expected to be issued in January 2017.

# DRC: Sanctions: Group of Experts midterm report

Resolution 2293 (2016) of 23 June 2016

Para.9: Requests the Group of Experts to fulfil its mandate as consolidated below, and to provide to the Council, after discussion with the Committee, a mid-term report no later than <u>30 December</u> <u>2016</u>, and a final report no later than 15 June 2017, as well as submit monthly updates to the Committee, except in the months where the mid-term and final reports are due:

The PoE midterm report dated 28 December (S/2016/1102) is before the Security Council.

# Mali: SG reports on MINUSMA, focusing on progress in the implementation of the Agreement on Peace and Reconciliation and MINUSMA's efforts to support it

Resolution 2295 (2016) of 29 June 2016

Para.46: Requests the Secretary-General to report to the Security Council <u>every three months</u> after the adoption of this resolution on the implementation of this resolution, focusing on the progress in the implementation of the Agreement on Peace and Reconciliation in Mali and on MINUSMA's efforts to support it, and, in this regard, requests the Secretary-General to include in his December report benchmarks and timelines as referred to in paragraph 12, and, then, to report on these benchmarks in his regular reports;

The report of the Secretary-General is expected to be issued in January 2017.

# South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions

# Resolution 2304 (2016) of 12 August 2016

Para.16: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the Transitional Government of National Unity has maintained its consent in principle to deployment of the Regional Protection Force and not imposed any political or operational impediments to operationalizing the Regional Protection Force or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the Regional Protection Force's operations,

deployment, and future requirements, as well as any political or operational impediments to operationalizing the Regional Protection Force and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and <u>every 30 days</u> thereafter;

The report of the Secretary-General is expected to be issued in January 2017.

# South Sudan: Sanctions: Panel of Experts updates

Resolution 2290 (2016) of 31 May 2016

Para.12: (d) Provide to the Council, after discussion with the Committee, an interim report by 1 December 2016, a final report by 1 May 2017, and except in the months when these reports are due, updates each month;

The update from the PoE is expected in January 2017.

# Somalia: SG to review UN presence and present options and recommendations to SC Resolution 2275 (2016) of 24 March 2016

Para. 6: Requests the Secretary-General to conduct a review of the United Nations presence in Somalia after the 2016 electoral process, to ensure that the United Nations is properly configured to support the next phase of state-building in Somalia, and to present options and recommendations to the Security Council by <u>30 January 2017</u>;

The Secretary-General is expected to present options and recommendations by 30 January 2017.

# Somalia: UNSOM: SG reports on the implementation of resolution 2275 (2016)

Resolution 2275 (2016) of 24 March 2016

Para. 22: Requests the Secretary-General to keep the Security Council regularly informed on the implementation of this resolution, including through oral updates and no fewer than three written reports, with the first written report by 12 May 2016 and <u>every 120 days</u> thereafter;

# Somalia: AMISOM: SG reports on the implementation of resolution 2297 (2016)

Resolution 2297 (2016) of 7 July 2016

Para.18: Requests the AU to keep the Security Council regularly informed, through the Secretary-General, on the implementation of AMISOM's mandate, and report to the Council, through the provision of oral updates and no fewer than three written reports, <u>every 120 days</u> with the first written report no later than 12 September 2016;

The report of the Secretary-General is expected to be issued in January 2017.

#### **Somalia: AU oral updates and written reports on implementation of AMISOM mandate** Resolution 2297 (2016) of 7 July 2016

Para.18: Requests the AU to keep the Security Council regularly informed, through the Secretary-General, on the implementation of AMISOM's mandate, and report to the Council, through the provision of oral updates and no fewer than three written reports, every 120 days with the first written report no later than 12 September 2016;

# South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions

# Resolution 2327 (2016) of 16 December 2016

Para.31: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the TGNU has maintained its consent in principle to deployment of the RPF and not imposed any political or operational impediments to operationalizing the RPF or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the RPF's operations, deployment, and future requirements, as well as any political or operational impediments to operationalizing the RPF and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and every 30 days thereafter;

The Secretary-General is expected to provide an assessment in January 2017.

# Sudan: SG recommendations on what practical steps need to be taken by Sudanese parties with support of UNAMID to make tangible progress towards achieving benchmarks <u>Resolution 2296 (2016) of 29 June 2016</u>

Para.33: Takes note of ongoing consultations between the United Nations, the African Union and the Government of Sudan, notably in the frameworks of the Tripartite mechanism and the Joint Working Group, including discussion of operational and logistical issues pertaining to the mission's operation as well as the development of an exit strategy in accordance with the mission's benchmarks; requests the Secretary-General to make recommendations, within 120 days of the adoption of this resolution, including by building on any agreed recommendations of the Joint Working Group and undertakes to consider the Secretary-General's recommendations in due course, on what practical steps need to be taken by all Sudanese parties with the support of UNAMID in order to make tangible progress towards achieving the benchmarks;

# Sudan: SG reports on UNAMID

#### Resolution 2296 (2016) of 29 June 2016

Para.34: Requests the Secretary-General to report to the Council <u>every 90 days</u> following adoption of this resolution on UNAMID, including:

(i) information on the political, humanitarian and security situation in Darfur, including detailed reporting on incidents of violence and attacks against civilians, by whomsoever perpetrated;
(ii) information on violations of the Status of Forces Agreement, including those involving attacks or threats of attack on UNAMID, violations of international humanitarian law perpetrated by any party to the conflict, as well as access restrictions and significant operational obstacles such as those related to customs clearances and visas;

(iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks, including progress in response to the Secretary General's recommendations on practical steps requested in paragraph 33 of this resolution;

(iv) developments and progress in addressing the challenges facing UNAMID as identified in the review of UNAMID; and

(v) on the implementation of this resolution;

The report of the Secretary-General dated 23 December (S/2016/1109) is before the Security Council.

# Sudan: Sanctions: Panel of Experts final report

Resolution 2265 (2016) of 10 February 2016

Para.2: Requests the Panel of Experts to provide no later than 12 August 2016, a midterm update on its work to the Committee established pursuant to paragraph 3 (a) of resolution 1591 (2005) (hereinafter "the Committee") and a final report no later than <u>13 January 2017</u> to the Council with its findings and recommendations;

The PoE final report is expected to be provided no later than <u>13 January 2017</u>.

# AMERICAS

#### Colombia: SG report on implementation of the Mission's mandate

Resolution 2261 (2016) of 25 January 2016

Para.5: Further requests the Secretary-General, based on the reporting of the special representative to the Secretary-General, to report to the Security Council on the implementation of the Mission's mandate every 90 days after the start of its monitoring and verification activities and on completion of the Mission;

# <u>SG letter of 26 October 2016 (S/2016/902)</u>

First para.: The present letter describes the events surrounding the plebiscite of 2 October 2016 in Colombia, the decisions taken since by the Government of Colombia and the Revolutionary Armed Forces of Colombia - People's Army (FARC-EP) and my recommendations with regard to the United Nations Mission in Colombia, consistent with resolution 2261 (2016) and resolution 2307 (2016). I plan to present my first progress report on the activities of the Mission <u>by 26 December 2016</u>, at the conclusion of the initial 90 days of its twelve-month mandate.

Para. 4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities...;

The report of the Secretary-General is expected to be issued in January 2017.

#### Iraq: SG reports on UN compensation fund

Resolution 1956 (2010) of 15 December 2010

Para.6: Requests the Secretary-General to provide written reports on an ongoing basis to the council <u>every six months</u>, with the first report due no later than 1 January 2012, about the United Nations compensation fund, evaluating the continued compliance with the provisions of paragraph 21 of resolution 1483 (2003).

The report of the Secretary-General dated 28 December (S/2016/1120) is before the Security Council.

# Middle East (Syria): SG report on the implementation of resolution 2268 (2016)

Resolution 2268 (2016) of 26 February 2016

Para.10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution 2254 (2015), within 15 days of the adoption of this resolution and <u>every 30 days thereafter;</u>

The Secretary-General is expected to report in January 2017.

#### Middle East (Syria): SG (in coordination with OPCW DG) to present progress report Resolution 2319 (2016) of 17 November 2016

Para.8: Requests the United Nations Secretary-General, in coordination with the OPCW Director-General, present a report to the United Nations Security Council and inform the OPCW Executive Council every 60 days on the progress made;

The report is expected to be presented in January 2017.

# Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014) and 2258 (2015)

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and <u>every 30 days</u> thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2191 (2014) of 17 December 2014

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all parties to the Syrian domestic conflict, within the framework of its reporting on resolutions 2139 (2014) and 2165 (2014);

#### Resolution 2258 (2015) of 22 December 2015

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014) and 2191 (2014), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

# Middle East (Syria): SG to report on the implementation of resolution 2332 (2016) and overall trends in humanitarian access

<u>Resolution 2332 (2016) of 21 December 2016</u>Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014), 2191 (2014) and 2258 (2015), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

The report of the Secretary-General is expected to be issued in January 2017.

The Secretary-General is expected to report in January 2017.

Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

#### Middle East (Yemen): Sanctions: Panel of Experts final report

Resolution 2266 (2016) of 24 February 2016

Para.6: Requests the Panel of Experts to provide a midterm update to the Committee no later than 27 July 2016, and a final report no later than <u>27 January 2017</u> to the Security Council, after discussion with the Committee;

The PoE final report is expected to be provided no later than <u>27 January 2017</u>.

# EUROPE

Cyprus: briefing on good offices S/PRST/2008/34 of 4 September 2008 Last para.: The Security Council welcomes the appointment of Alexander Downer as the Secretary General's Special Advisor and looks forward to being briefed on the progress of the Good Offices process.

The Secretary-General is expected to report in January 2017.

# Cyprus: SG report on implementation of resolution 2300 (2016), including on transition planning in relation to the settlement

Resolution 2300 (2016) of 26 July 2016

Para.12: Requests the Secretary-General to submit a report on implementation of this resolution, including on transition planning in relation to the settlement, by <u>8 January 2017</u> and to keep the Security Council updated on events as necessary;

The report of the Secretary-General is expected to be submitted by <u>8 January 2017</u>.

#### Cyprus: UNFICYP mandate

<u>Resolution 2300 (2016) of 26 July 2016</u> Para.8: Expresses its full support for UNFICYP and decides to extend its mandate for a further period ending <u>31 January 2017</u>;

The mandate will expire on <u>31 January 2017</u>.

#### UNMIK: SG report

Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at <u>regular intervals</u> on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution;

The report of the Secretary-General is expected to be issued in January 2017.

# OTHER

Cooperation between UN and regional/subregional organizations: SG to include in regular reporting assessments of progress on the cooperation between the UN and relevant regional organizations

Resolution 1809 (2008) of 16 April 2008

Para.17: Requests the Secretary-General to include in his regular reporting to the Security Council, assessments of progress on the cooperation between the United Nations and relevant regional organizations;

The report of the Secretary–General dated 15 July 2016 (S/2016/621) is before the Security Council.

# ISIL (Da'esh) and Al-Qaeda: SG strategic-level reports

Resolution 2253 (2015) of 17 December 2015

Para.97: Recalling the threat posed to international peace and security by ISIL and associated individuals, groups, undertakings, and entities, requests the Secretary-General to provide an initial strategic-level report that demonstrates and reflects the gravity of the aforementioned threat, including foreign terrorist fighters joining ISIL and associated groups and entities, and the sources of financing of these groups including through illicit trade in oil, antiquities, and other natural resources, as well as their planning and facilitation of attacks, and reflects the range of United Nations efforts in support of Member States in countering this threat, in 45 days and provide updates every four months thereafter, with the input of CTED, in close collaboration with the Monitoring Team, as well as other relevant United Nations actors;

The report of the Secretary-General is expected to be issued in January 2017.

#### ISIL (Da'esh) and Al-Qaeda Sanctions: Office of Ombudsperson reports

<u>Resolution 2253 (2015) of 17 December 2015</u> Annex II, para.20: (c) Submit <u>biannual reports</u> summarizing the activities of the Ombudsperson to the Security Council.

The report of the Ombudsperson is expected to be issued in January 2017.

#### Non-proliferation (Iran): Joint Commission reports

Resolution 2231 (2015) of 20 July 2015

JCPOA Annex IV – Joint Commission para. 6.10.: The Joint Commission will report to the United Nations Security Council at least every 6 months on the status of the Procurement Working Group's decisions and on any implementation issues.

#### Non-proliferation (Iran): Facilitator to brief the other members of the SC

Note by PSC of 16 January 2016

Para.3: To facilitate its work under resolution 2231 (2015), the Security Council shall select on an annual basis one member to serve as its facilitator for the functions specified in the present note. The facilitator shall brief the other members of the Council on its work and the implementation of the resolution every six months, in parallel with the report submitted by the Secretary-General in accordance with paragraph 7 below.

The facilitator is expected to brief the Security Council in January 2017.

# Non-proliferation (Iran): SG reports on the implementation of resolution 2231 (2015)

Note by PSC of 16 January 2016

Para.7: The Security Council requests that the Secretary-General report to the Security Council every six months on the implementation of resolution 2231 (2015). Prior to the public release of that report, the Security Council shall meet informally, normally at the expert level, to review the findings and recommendations contained in the report.

The report of the Secretary-General is expected to be issued in January 2017.

# Maintenance of international peace & security: Migrant smuggling: States to inform SC on progress of actions undertaken

Resolution 2312 (2016) of 6 October 2016

Para. 14: Requests States utilizing the authority of this resolution to inform the Security Council within three months of the date of adoption of this resolution and every three months thereafter on the progress of actions undertaken in exercise of the authority provided in paragraph 7 above;

#### Peacekeeping operations: SG report on the role of policing

Resolution 2185 (2014) of 20 November 2014

Para.33: Requests the Secretary-General to submit a report by the end of 2016 on the role of policing as an integral part of peacekeeping and post-conflict peacebuilding, with particular focus on the challenges faced by Police Components of United Nations peacekeeping operations and special political missions, and making recommendations on how best to strengthen their contribution to the achievement of mission mandates.

# Peacekeeping operations: Report and recommendations on the progress of partnerships between the UN and relevant regional organizations in peacekeeping operations Resolution 2167 (2014) of 28 July 2014

Para.28: Requests the Secretary-General, in close consultation with the AU Commission and EU to produce, not later than <u>31 March 2015</u>, an assessment report and recommendations on the progress of the partnerships between the UN and relevant regional organizations in peacekeeping operations;

# PBC Organizational Committee: election of two E-10 members

#### Resolution 1645 (2005) of 20 December 2005

Para.6: Decides that members of the Organizational Committee shall serve for renewable terms of two years, as applicable.

#### Resolution 1646 (2005) of 20 December 2005

Para.1: Decides pursuant to paragraph 4 (a) of resolution 1645 (2005) that the permanent members listed in article 23 (1) of the Charter shall be members of the Organizational Committee of the Peacebuilding Commission and that, in addition, the Council shall select annually two of its elected members to participate in the Organizational Committee.

The Security Council is expected to announce by January 2017 the two members elected to serve on the PBC Organizational Committee.

# Security Council annual report: SC to complete introduction

Note by PSC of 10 December 2015 (S/2015/944)

Fourth para.: The report shall consist of an introduction, containing an agreed concise summary prepared on behalf of the Council under the coordination of the President of the Council for the month of July. In the case of the presidency for the month of July ending its tenure on the Council that year, the task of coordinating the introduction of the report shall then devolve on the member of the Council

next in English alphabetical order and who will not be leaving the Security Council that calendar year. The introduction to the report should continue to be approved by all members of the Council who served on the Council during the reporting period. The introduction, which should not exceed 10,000 words, may contain, inter alia, a brief description of the key activities and trends, and the nature of decisions taken by the Security Council during the period covered by the report. The introduction shall be completed <u>no later than 31 January</u> so as to allow the Secretariat enough time for translation.

The introduction to the annual report is expected to be completed no later than 31 January 2017.

# Terrorism/Cross-border crime: SG report on UN efforts to address the threat of terrorists benefitting from transnational organized crime in affected regions

# Resolution 2195 (2014) of 19 December 2014

Para.20: Requests the Secretary-General to submit to the Council a report on the efforts of the United Nations entities to address the threat of terrorists benefiting from transnational organized crime in affected regions, including Africa, with respect to matters with which the Council is seized, with input from the relevant entities of the United Nations system including the UNODC, CTED, the Analytical Support and Sanctions Monitoring Team, and other relevant CTITF entities;

Para.21: Further requests that the report include recommendations of concrete options for strengthening Member States' capabilities, including financing such proposed UN projects and activities to build capacity with existing resources and contributions in the UN system, as well as UN activities to reduce the negative impacts of terrorists benefiting from transnational organized crime including those relevant to its conflict resolution efforts with a focus on border security, counter-terrorist financing, and anti-money-laundering, and that the report be submitted to the Council no later than <u>six months</u> from the adoption of this resolution;

The report of the Secretary-General dated 21 May 2015 (S/2015/366) is before the Security Council.

# WMD: 1540 Committee report: review implementation

#### Resolution 1977 (2011) of 20 April 2011

Para.3: Decides that the 1540 Committee will conduct a comprehensive review on the status of implementation of resolution 1540 (2004), both after five years and prior to the renewal of its mandate, including, if necessary, recommendations on adjustments to the mandate, and will submit to the Security Council a report on the conclusions of those reviews, and decides that, accordingly, the first review should be held before December 2016;

#### Resolution 2325 (2016) of 15 December 2016
