**AFRICA**

**CAR: Sanctions: Secretariat to provide options for elaboration of benchmarks to assess arms embargo and information on recommended working group**

Resolution 2339 (2017) of 27 January 2017

Para. 29: Requests the Secretariat to provide to the Security Council, by 30 May 2017, options for the elaboration of benchmarks, in coordination with EUTM and other active partners in the field of SSR and in consultation with the CAR Authorities, to assess the arms embargo measures according to the progress of the SSR, including FACA and Internal Security Forces and their needs, as well as additional information on the Panel of Experts' recommended arms embargo working group to be potentially established within MINUSCA by the Security Council, including on the composition, tasks, functioning, resource requirements and implication with regards the implementation of MINUSCA's mandate, of such a working group, with reference to previous similar experiences in other UN Peacekeeping Missions;

The report of the Secretary-General dated 10 July ([S/2017/597](#)) is before the Security Council.

**CAR: Sanctions: Panel of experts midterm report**

Resolution 2339 (2017) of 27 January 2017

Para. 27: (c) Provide to the Security Council, after discussion with the Committee, a midterm report no later than 30 July 2017, and a final report by 31 December 2017, on the implementation of the measures imposed by paragraphs 54 and 55 of resolution [2127 \(2013\)](#) and paragraphs 30 and 32 of resolution [2134 \(2014\)](#) renewed by paragraphs 1, 2, 5 and 12 of this resolution;

The PoE midterm report dated 26 July ([S/2017/639](#)) is before the Security Council.

**DRC: SG to conduct strategic review of MONUSCO and provide the SC with options, provide advice on exit strategy**

Resolution 2348 (2017) of 31 March 2017

Para. 51: Requests the Secretary-General, in accordance with best practices, to conduct a strategic review of MONUSCO, examining the continued relevance of all mandated tasks, priorities and related resources, as well as necessity to adapt the Mission's mandate to the specific needs of the post-elections phase, with a view to:

Para. 51: (a) Providing the Security Council with options, no later than 30 September 2017, for a reduction of MONUSCO's Force and civilian components in order to maximize the efficient use of the Mission's resources, to be delivered after the successful implementation of the 31 December 2016 agreement, and sustainable progress in reducing the threat of armed groups, taking account of the Mission and the UNCT's comparative advantages, capacities and other relevant factors, with a view to transferring relevant activities to the UNCT and other relevant partners, as appropriate; and

Para. 51: (b) In light of the Security Council's reaction to these options and following successful implementation of the 31 December 2016 agreement, providing advice to the Security Council on an exit strategy, in line with paragraph 50 above and in advance of the next mandate renewal;

The report of the Secretary-General is expected to be issued no later than 30 September 2017.

**DRC: SG reports on MONUSCO**

Resolution 2348 (2017) of 31 March 2017

Para. 52: Requests the Secretary-General to report to the Council every three months on the implementation of MONUSCO's mandate, including its Intervention Brigade, as set out in this resolution, including on:

- (i) progress made by the DRC on the implementation of the 31 December 2016 agreement and the electoral process, including on the provisions of paragraphs 1 to 6 above, as well as on the ways in which MONUSCO will be best prepared to address security risks and to monitor and report on human rights violations and abuses in the context of the elections, including in terms of deployment of the Force in areas identified as potential zones of instability and configuration of civilian and police component of MONUSCO, sexual violence and the impact of conflict on women and children, and any gender considerations made;
- (ii) the situation on the ground, including updates on operations to neutralize armed groups, in accordance with paragraph 34.i.d, and any instances where the Mission is not effectively fulfilling its protection of civilians mandate, and the circumstances surrounding these instances;
- (iii) progress made by the DRC on protecting human rights and in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national SSR roadmap, its provincial stabilisation plan supported by the ISSSS and on the implementation of the DDR and DDRRR plans;
- (iv) progress in the implementation of the measures taken to transform MONUSCO's Force and improve its performance, including measures to ensure Force effectiveness as outlined in paragraphs 44 to 47, the deployment of rapidly deployable battalions and employment of the Intervention Brigade's capabilities, to become more mobile, efficient and effective in implementing its mandate, and on the definition of an exit strategy for MONUSCO, including the Intervention Brigade;
- (v) the risks and their implications for the safety and the security for the United Nations personnel and facilities as a result of the possible military operations as well as measures taken to strengthen their security and mitigate risks;

The report of the Secretary-General is expected to be issued in September 2017.

**DRC: SG reports on implementation of the commitments under the PSC Framework**

Resolution 2348 (2017) of 31 March 2017

Para. 54: Requests the Secretary-General to report to the Security Council every six months, in coordination with the Secretary-General's Special Envoy for the Great Lakes Region and the SRSG for the DRC on the implementation of the commitments under the PSC Framework and its linkages with the broader security situation in the Great Lakes Region;

The report of the Secretary-General is expected to be issued in September 2017.

**DRC: SG to update SC in writing on implementation of the 31 December 2016 agreement**  
**Resolution [2348 \(2017\)](#) of 31 March 2017**

Para. 53: Requests the Secretary-General to update the Security Council in writing every 45 days on political and technical progress and obstacles to the implementation of the 31 December 2016 agreement, when no regular reports are due;

The report of the Secretary-General dated 15 August 2017 ([S/2017/712](#)) is before the Security Council.

**Libya: UNSMIL mandate**

**Resolution [2323 \(2016\)](#) of 13 December 2016**

Para.1: Decides to extend until 15 September 2017 the mandate of UNSMIL, under the leadership of the Special Representative of the Secretary-General, as an integrated special political mission, in full accordance with the principles of national ownership to exercise mediation and good offices to support:

- (i) implementation of the Libyan Political Agreement;
- (ii) consolidation of the governance, security and economic arrangements of the Government of National Accord; and
- (iii) subsequent phases of the Libyan transition process;

The mandate expires on 15 September 2017.

**Mali: SG reports on MINUSMA on the implementation of resolution [2364 \(2017\)](#)**

**Resolution [2364 \(2017\)](#) of 29 June 2017**

Para.47: Requests the Secretary-General to report to the Security Council every three months after the adoption of this resolution on the implementation of this resolution, focusing:

- (i) on the progress in the implementation of the Agreement on Peace and Reconciliation in Mali and on MINUSMA's efforts to support it, including through the benchmarks and timelines agreed between the Government of Mali and MINUSMA in December 2016, pursuant to resolution [2295 \(2016\)](#);
- (ii) on progress in the implementation of the measures taken to improve MINUSMA's effectiveness to implement its mandate, as outlined in paragraphs 31 to 36 above, including measures to enhance the safety and security of MINUSMA's personnel;
- (iii) on coordination and exchange of information between MINUSMA, French forces and the FC-G5S as outlined in paragraph 42 above;

The report of the Secretary-General is expected to be issued in September 2017.

**Mali: Report by France on implementation of mandate to support MINUSMA**

**Resolution [2364 \(2017\)](#) of 29 June 2017**

Para.37: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate in Mali and to coordinate its reporting with the reporting by the Secretary-General referred to in paragraph 47 below;

**Peace & Security in Africa: SG report on the situation in the Lake Chad Basin Region**  
**Resolution [2349 \(2017\)](#) of 31 March 2017**

Para.34: Requests the Secretary-General to produce a written report within five months on the United Nations' assessment of the situation in the Lake Chad Basin Region as it relates to elements of this resolution, particularly regarding the progress made and remaining challenges, and possible measures for consideration, including with respect to achieving greater coherence of efforts in the context of overlapping regional strategies, and thereafter to include these elements in regular reporting by UNOCA and UNOWAS.

The report of the Secretary-General is expected to be issued in September 2017.

**Somalia: UNSOM: SG reports on the implementation of resolution [2358 \(2017\)](#)**  
**Resolution [2358 \(2017\)](#) of 14 June 2017**

Para.25: Requests the Secretary-General to keep the Security Council regularly informed on the implementation of this resolution, including through oral updates and no fewer than three written reports, with the first written report by 1 September 2017 and every 120 days thereafter;

The report of the Secretary-General is expected to be issued by 1 September 2017.

**Somalia: Sanctions: Federal Government of Somalia reports to SC**  
**Resolution [2317 \(2016\)](#) of 10 November 2016**

Para.7: Welcomes the improvement in FGS reporting to the Security Council pursuant to paragraph 9 of resolution [2182 \(2014\)](#) and as requested in paragraph 7 of resolution [2244 \(2015\)](#), calls on the FGS and regional administrations to prioritize a sustainable and comprehensive agreement on the composition of the Somali Security Forces based on the National Security Policy and requests the FGS to report to the Security Council in accordance with paragraph 9 of resolution [2182 \(2014\)](#) and as requested in paragraph 7 of resolution [2244 \(2015\)](#) on the structure, composition, strength and disposition of its Security Forces, including the status of regional and militia forces by 30 March 2017 and then by 30 September 2017;

**South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions**

**Resolution [2327 \(2016\)](#) of 16 December 2016**

Para.31: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the TGNU has maintained its consent in principle to deployment of the RPF and not imposed any political or operational impediments to operationalizing the RPF or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the RPF's operations, deployment, and future requirements, as well as any political or operational impediments to operationalizing the RPF and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and every 30 days thereafter;

The report of the Secretary-General is expected in September 2017.

### **South Sudan: SG report on implementation of the UNMISS mandate**

Resolution 2327 (2016) of 16 December 2016

Para. 32: Requests the Secretary-General to report to the Council on implementation of the UNMISS mandate including UNMISS' RPF as well as to report on progress in implementing the HRDDP per paragraph 17 above, an update on how UNMISS is working toward fulfilling its protection of civilian duties, including but not limited to new patrol areas and proactive deployment per paragraph 15 above, and the consideration of gender as cross cutting through the mandate per paragraph 14 above, and to present the recommendations on the steps to adapt UNMISS to the situation on the ground and to increase efficiency of the implementation of its mandate in a same comprehensive written report to be submitted within 90 days of the date of adoption of this resolution, and every 90 days thereafter;

The report of the Secretary-General is expected to be issued in September 2017.

### **South Sudan: Sanctions: Panel of Experts updates**

Resolution 2353 (2017) of 24 May 2017

Para.2: Decides to extend until 30 June 2018 the mandate of the Panel of Experts as set out in subparagraphs (a), (b), (c), (e) and (f) of paragraph 12 of resolution 2290 (2016), and decides that the Panel of Experts should provide to the Council, after discussion with the Committee, an interim report by 1 December 2017, a final report by 1 May 2018, and, except in the months when these reports are due, updates each month, and expresses its intention to review the mandate and take appropriate action regarding the further extension of the mandate no later than 31 May 2018;

The update from the PoE is expected to be provided in September 2017.

### **Sudan: SG reports on UNAMID**

Resolution 2363 (2017) of 29 June 2017

Para.41: Requests the Secretary-General to report to the Council every 60 days following adoption of this resolution on UNAMID, including:

- (i) information on the political, humanitarian and security situation in Darfur, including detailed reporting on incidents of violence and attacks against civilians, including sexual and gender-based violence, by whomsoever perpetrated;
- (ii) information on violations of the Status of Forces Agreement, including those involving attacks or threats of attack on UNAMID, violations of international humanitarian law perpetrated by any party to the conflict, as well as access restrictions and significant operational obstacles such as those related to customs clearances and visas;
- (iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks;
- (iv) progress in the implementation of the recommendations made in the Special Report, including the progress of reductions to UNAMID's military and police component and its impact, including on protection needs and violations and abuses of human rights;
- (v) developments and progress on strategically addressing the underlying drivers of inter-communal conflict and the action plan on the prevention and resolution of inter-communal conflict;
- (vi) developments and progress in addressing the challenges facing UNAMID;
- (vii) enhanced, detailed and full information on abuses and violations of human rights, including those committed against women and children and violations of international humanitarian law;
- (viii) developments regarding UNAMID's support for local conflict resolution mechanisms, including progress regarding the full and effective participation of women; and
- (ix) on the implementation of this resolution;

The report of the Secretary-General is expected to be issued in September 2017.

## AMERICAS

### **Colombia: Mission**

Resolution [2261 \(2016\)](#) of 25 January 2016

Para.1: Decides to establish a political mission to participate for a period of 12 months, as the international component and coordinator of the above-mentioned tripartite mechanism (the Mission), headed by a special representative of the Secretary-General of the United Nations;

Para.2: Decides further that the Mission will be a political mission of unarmed international observers, responsible for the monitoring and verification of the laying down of arms, and a part of the tripartite mechanism that will monitor and verify the definitive bilateral ceasefire and cessation of hostilities, consistent with the Joint Communiqué, beginning all monitoring and verification activities, which will commence the 12 month period, following the signing of the Final Peace Agreement between the Government of Colombia and the FARC-EP;

SG letter of 26 October 2016 ([S/2016/902](#))

First para: The present letter describes the events surrounding the plebiscite of 2 October 2016 in Colombia, the decisions taken since by the Government of Colombia and the Revolutionary Armed Forces of Colombia — People's Army (FARC-EP) and my recommendations with regard to the United Nations Mission in Colombia, consistent with resolutions [2261 \(2016\)](#) and [2307 \(2016\)](#). I plan to present my first progress report on the activities of the Mission by 26 December 2016, at the conclusion of the initial 90 days of its 12-month mandate.

PSC letter of 1 November 2016 ([S/2016/923](#))

Last para: After due consideration, the Security Council takes note of your recommendation in the above-mentioned letter. The Council notes that the United Nations Mission in Colombia is authorized, pursuant to Council resolutions [2261 \(2016\)](#) and [2307 \(2016\)](#), to verify implementation of the ceasefire protocol signed on 13 October 2016.

The mandate will expire in September 2017.

### **Colombia: SG present recommendations on size, operational aspects and mandate of Verification Mission**

Resolution [2366 \(2017\)](#) of 10 July 2017

Para.6: Further requests the Secretary-General to initiate preparations now, including on the ground, and to present detailed recommendations to the Security Council for its consideration and approval regarding the size and operational aspects and mandate of the Verification Mission, consistent with the Final Agreement, within 45 days of the adoption of this resolution;

The recommendations of the Secretary-General are expected to be issued in September 2017.

### **Colombia: SG report on implementation of the Mission's mandate**

Resolution [2261 \(2016\)](#) of 25 January 2016

Para.5: Further requests the Secretary-General, based on the reporting of the special representative to the Secretary-General, to report to the Security Council on the implementation of the Mission's mandate every 90 days after the start of its monitoring and verification activities and on completion of the Mission;

SG letter of 26 October 2016 ([S/2016/902](#))

First para.: (...) I plan to present my first progress report on the activities of the Mission by 26 December 2016, at the conclusion of the initial 90 days of its 12-month mandate.

The report of the Secretary-General is expected in September 2017.

## ASIA/MIDDLE EAST

### **Afghanistan: SG reports on UNAMA**

Resolution 2344 (2017) of 17 March 2017

Para. 37: Requests that the Secretary-General reports to the Council every three months on developments in Afghanistan, and to include in his reports an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of UNAMA's mandate, including at the subnational level, and priorities as set out in this resolution;

The report of the Secretary-General is expected to be issued in September 2017.

### **Afghanistan: SG conduct a strategic review of UNAMA and report to the SC**

Resolution 2344 (2017) of 17 March 2017

Para. 7: Affirms its continuing commitment to UNAMA, and to ensure that the Mission is able to effectively support Afghanistan, requests the Secretary-General, in accordance with best practices, to conduct a strategic review of UNAMA, examining mandated tasks, priorities, and related resources, assessing the mission's efficiency and effectiveness, in order to optimize the division of labour and configuration to ensure better cooperation and minimize duplication with other UN related organizations, and further requests the Secretary-General to report to the Security Council on the results of this review by July 2017;

The report of the Secretary-General dated 10 August 2017 ([S/2017/696](#)) is before the Security Council.

### **Iraq: SG reports on escrow account (oil for food termination)**

Resolution 2335 (2016) of 30 December 2016

Para. 4: Requests the Secretary-General to report on implementation of this resolution no later than 30 March 2017 and with a final report three months after the transfer of any remaining funds pursuant to paragraph 2 to the Government of Iraq, unless otherwise authorized by the Security Council;

The report of the Secretary-General is expected to be issued in September 2017.

### **Middle East (Syria): OPCW DG to report to SC (through SG) on impl. of resolution 2118 (2013)**

Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a



coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report is expected to be presented in September 2017.

**Middle East (Syria): JIM: SG (in coordination with OPCW DG) to present progress report**  
**Resolution 2319 (2016) of 17 November 2016**

Para.8: Requests the United Nations Secretary-General, in coordination with the OPCW Director-General, present a report to the United Nations Security Council and inform the OPCW Executive Council every 60 days on the progress made;

The report of the Secretary-General is expected to be issued in September 2017.

**Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015) and 2332 (2016)**

**Resolution 2139 (2014) of 22 February 2014**

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;  
**Resolution 2191 (2014) of 17 December 2014**

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all parties to the Syrian domestic conflict, within the framework of its reporting on resolutions 2139 (2014) and 2165 (2014);

Para.4: Decides to adjust the measures imposed by paragraph 8 of resolution [1718 \(2006\)](#) and this resolution through the designation of additional goods, directs the Committee to undertake its tasks to this effect and to report to the Security Council within fifteen days of adoption of this resolution, and further decides that, if the Committee has not acted, then the Security Council will complete action to adjust the measures within seven days of receiving that report;

Resolution [2371 \(2017\)](#) of 5 August 2017
