4 FOR the purpose of ~~repealing a certain provision of law requiring a custodian to deny~~  
5 ~~inspection of certain surveillance images of illegal dumping in Baltimore City except~~  
6 ~~under certain circumstances~~; altering a requirement that a custodian deny  
7 inspection of certain surveillance images of illegal dumping in Baltimore City to  
8 allow inspection by certain employees or agents of Baltimore City; authorizing the  
9 Baltimore City Department of Housing and Community Development to publicly  
10 disseminate a surveillance image under certain circumstances; and generally  
11 relating to ~~the inspection of~~ surveillance images of illegal dumping in Baltimore City.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

1 (a) In this section, “surveillance image” has the meaning stated in § 10–112 of the  
2 Criminal Law Article.

3 (b) Except as provided in subsection (c) of this section, a custodian of a  
4 surveillance image shall deny inspection of the surveillance image.

5 (c) A custodian shall allow inspection of a surveillance image:

6 ~~(1) as required in § 10–112 of the Criminal Law Article;~~

7 ~~(2)~~ **(1)** by any person issued a citation under § 10–112 of the Criminal Law  
8 Article, or by an attorney of record for the person; or

9 ~~(3)~~ **(2)** by an employee or agent of the Baltimore City Department of ~~Public~~  
10 ~~Works~~ **HOUSING AND COMMUNITY DEVELOPMENT** in an investigation or a proceeding  
11 relating to the imposition of or indemnification from civil liability under § 10–112 of the  
12 Criminal Law Article.†

13 **(D) NOTWITHSTANDING SUBSECTION (B) OF THIS SECTION, THE**  
14 **BALTIMORE CITY DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT**  
15 **MAY PUBLICLY DISSEMINATE A SURVEILLANCE IMAGE AS PART OF AN**  
16 **INVESTIGATION.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 October 1, 2024.
