3 FOR the purpose of altering the membership of the State Board of Cosmetologists; and

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Business Occupations and Professions**

18 5–201.

19 There is a State Board of Cosmetologists in the Department.

2 (a) (1) The Board consists of seven members.

3 (2) Of the seven members of the Board:

4 (i) four shall be licensed cosmetologists;

5 (ii) **ONE SHALL BE A LICENSED ESTHETICIAN;**

6 **(III)** one shall be affiliated with a private cosmetology school as an
7 educator or owner; and

8 ~~[(iii)]~~ **(IV)** ~~[two]~~ **ONE** shall be A consumer ~~[members]~~ **MEMBER.**

9 (3) The Governor shall appoint the members with the advice of the
10 Secretary.

11 (c) ~~[Each]~~ **THE** consumer member of the Board:

12 (1) shall be a member of the general public;

13 (2) may not be a licensee or otherwise be subject to regulation by the Board;

14 (3) may not be required to meet the qualifications for the professional
15 members of the Board; and

16 (4) may not, within 1 year before appointment, have had a financial
17 interest in or have received compensation from a person regulated by the Board.

18 (d) While a member of the Board, **[a]** **THE** consumer member may not:

19 (1) have a financial interest in or receive compensation from a person
20 regulated by the Board; or

21 (2) grade any examination given by or for the Board.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2024.
