1 AN ACT concerning

2 **General Provisions – State Flag – Casket of an Eligible Decedent**

3 FOR the purpose of requiring the Secretary of State to furnish a State flag to drape the
4 casket of an eligible decedent; establishing the process for a State flag to be claimed
5 after burial; prohibiting the Secretary of State from procuring a certain flag; and
6 generally relating to the burial of an eligible decedent.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – General Provisions**

15 **7–207.**

16 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
17 **INDICATED.**

18 **(2) “ELIGIBLE DECEDENT” MEANS:**

1 (I) AN EMPLOYEE OF THE STATE OR ANY POLITICAL
2 SUBDIVISION WHO DIED AS A RESULT OF:

3 1. AN ACCIDENTAL INJURY THAT AROSE OUT OF AND IN
4 THE COURSE OF EMPLOYMENT WITH THE STATE OR POLITICAL SUBDIVISION; OR

5 2. AN INJURY CAUSED BY A WILLFUL OR NEGLIGENT ACT
6 OF A THIRD PERSON, DIRECTED AGAINST THE EMPLOYEE IN THE COURSE OF
7 EMPLOYMENT WITH THE STATE OR POLITICAL SUBDIVISION;

8 (II) A CURRENT OR FORMER CONSTITUTIONAL OFFICER, AS
9 DEFINED IN § 29-305 OF THE STATE PERSONNEL AND PENSIONS ARTICLE;

10 (III) A CURRENT OR FORMER MEMBER OF THE GENERAL
11 ASSEMBLY;

12 (IV) A CURRENT OR FORMER GOVERNOR OF THE STATE;

13 ~~(IV)~~ (V) A JUDGE, AS DEFINED IN § 1-101 OF THE COURTS
14 ARTICLE;

15 ~~(V)~~ (VI) AN INDIVIDUAL WHO CURRENTLY HOLDS OR
16 FORMERLY HELD ANY OF THE POSITIONS IDENTIFIED IN § 29-304 OF THE STATE
17 PERSONNEL AND PENSIONS ARTICLE; OR

18 ~~(VI)~~ (VII) ANY OTHER INDIVIDUAL WHOM THE GOVERNOR
19 DESIGNATES THROUGH AN EXECUTIVE ORDER.

20 (3) "POLITICAL SUBDIVISION" HAS THE MEANING STATED IN § 4-101
21 OF THIS ARTICLE.

22 (4) "WHOLLY PRODUCED IN THE UNITED STATES" MEANS A FLAG
23 THAT CONTAINS ONLY:

24 (I) MATERIALS AND COMPONENTS THAT ARE GROWN,
25 MANUFACTURED, OR CREATED ENTIRELY IN THE UNITED STATES;

26 (II) PROCESSING COMPONENTS, INCLUDING SPINNING,
27 WEAVING, DYEING, AND FINISHING, THAT ARE PERFORMED ENTIRELY IN THE
28 UNITED STATES; AND

29 (III) MATERIALS THAT HAVE BEEN MANUFACTURED AND
30 ASSEMBLED ENTIRELY IN THE UNITED STATES.

1 **(B) (1) ~~THE~~ ON REQUEST, THE SECRETARY OF STATE SHALL FURNISH A**
2 **STATE FLAG TO DRAPE THE CASKET OF AN ELIGIBLE DECEDENT.**

3 **(2) THE SECRETARY OF STATE SHALL ADOPT REGULATIONS**
4 **ESTABLISHING A PROCESS TO:**

5 **(I) SUBMIT A REQUEST UNDER PARAGRAPH (1) OF THIS**
6 **SUBSECTION; AND**

7 **(II) VERIFY THAT A REQUEST UNDER PARAGRAPH (1) OF THIS**
8 **SUBSECTION IS BEING MADE ON BEHALF OF AN ELIGIBLE DECEDENT.**

9 **(C) (1) AFTER THE BURIAL OF AN ELIGIBLE DECEDENT, THE FLAG SHALL**
10 **BE:**

11 **(I) CLAIMED BY AND PROVIDED TO THE ELIGIBLE DECEDENT'S**
12 **NEXT OF KIN; OR**

13 **(II) PROVIDED TO A CLOSE FRIEND OR AN ASSOCIATE, IF IT IS**
14 **NOT CLAIMED BY THE ELIGIBLE DECEDENT'S NEXT OF KIN.**

15 **(2) ONLY ONE FLAG MAY BE PROVIDED FOR THE DEATH OF AN**
16 **ELIGIBLE DECEDENT UNDER THIS SECTION.**

17 **(D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,**
18 **THE SECRETARY OF STATE MAY NOT PROCURE ANY FLAG UNDER THIS SECTION**
19 **UNLESS IT IS WHOLLY PRODUCED IN THE UNITED STATES.**

20 **(2) THE SECRETARY OF STATE MAY WAIVE THE REQUIREMENT**
21 **UNDER PARAGRAPH (1) OF THIS SUBSECTION IF IT CANNOT BE MET REASONABLY.**

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2024.
