- (1) Pursuant to Laws of 1991, Chapter 332, Section 29, the sum of \$10,000,000 is reserved for the Minnesota Rural Finance Authority, of which \$3,910,140 has been allocated through May 26, 1992.
- (2) This total includes \$50,188,000 for the Minnesota Housing Finance Authority, \$20,187,000 for the City of Minneapolis, \$15,141,000 for the City of Saint Paul, and \$10,000,000 for the County of Dakota pursuant to Minnesota Statute 474A.
- (3) Special 1992 allocation for student loans as provided in Laws of 1992, Chapter 545, Article I, Section 10.
- (4) In accordance with Laws of 1992, Chapter 545, Article I, Section 11, a "Common Pool was formed on June 1, 1992 from the balances of the Small Issue, Housing, and Public Facilities pools. Upon formation of the common pool, \$30,000,000 was set aside until July 1, 1992. From June 1, 1992 through November 30, 1992, any available balance may be allocated for any purpose authorized under federal tax law.
- (5) The City of Minneapolis, City of Saint Paul, and the County of Dakota have indicated their intent to carry forward their entitlements and issue after December 31, 1992.
