

RESOLUTION R-5334

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KIRKLAND SUPPORTING INITIATIVE MEASURE NO. 1639, CONCERNING FIREARMS.

1 WHEREAS, on January 3, 2017, the Mayor, with the
2 support of the City Council, reiterated the values of the City of
3 Kirkland ("City") by proclaiming Kirkland as a safe, inclusive and
4 welcoming city for all people, and requested that City staff assist
5 the City Council in developing and implementing a program to
6 communicate the City's values; and
7

8 WHEREAS, on February 21, 2017, the City Council passed
9 Resolution R-5240 formalizing the themes in the proclamation and
10 directing the City Manager to identify, through community
11 discussions, additional actions that can be taken by the City and
12 the community to help keep Kirkland a safe, welcoming and
13 inclusive city for all people; and
14

15 WHEREAS, on February 21, 2017, the City Council also
16 enacted Ordinance O-4558 adding a new Chapter 3.18 to the
17 Kirkland Municipal Code entitled "Sustaining a Safe, Inclusive and
18 Welcoming City"; and
19

20 WHEREAS, the tragic killing of 17 people at Marjory
21 Stoneman Douglas High School in Parkland, Florida, on February
22 14, 2018, reignited the debate in communities around the nation
23 regarding gun safety and community safety, including in Kirkland;
24 and

26 WHEREAS, the federal and state constitutions guarantee
27 the right to keep and bear arms, and many Kirkland residents
28 legally own firearms for reasons such as hunting, recreation and
29 personal protection; and
30

31 WHEREAS, input from all community members, including
32 gun owners, is necessary to promote safe and responsible gun
33 ownership in order to reduce mass shootings, homicides, suicides
34 and accidental shootings; and
35

36 WHEREAS, on March 14, 2018, the City Council welcomed
37 over 70 parents from various Kirkland schools to City Hall to hear

38 community concerns and discuss potential actions that could be
39 taken to help keep students safe from gun violence; and

40
41 WHEREAS, on March 21, 2018, the City and the Lake
42 Washington School District ("School District") co-hosted a
43 community discussion about school safety and community safety
44 at which members of the public requested further action by the
45 City and School District on the topics of gun safety and community
46 safety; and

47
48 WHEREAS, on May 1, 2018, in response to a request from
49 Kirkland residents, the City Council adopted Resolution R-5312
50 setting forth the need for community dialogue and action on the
51 topic of gun safety and community safety; and

52
53 WHEREAS, on June 20, 2018, the City Council hosted a
54 Town Hall on gun safety and community safety in order to receive
55 input from the community on actions the City might undertake to
56 reduce gun violence; and

57
58 WHEREAS, some concerned Kirkland residents have urged
59 the City Council to officially support statewide ballot measures that
60 promote gun and community safety; and

61
62 WHEREAS, Initiative Measure 1639 ("I-1639"), concerning
63 firearms, will be on the general election ballot, November 6, 2018;
64 and

65
66 WHEREAS, I-1639 seeks to make changes to the Chapter
67 9.41 RCW, Firearms and Dangerous Weapons; and

68
69 WHEREAS, I-1639 would create an enhanced background
70 check system and require firearm safety training and waiting
71 periods before semiautomatic assault rifles may be purchased or
72 delivered; and

73
74 WHEREAS, I-1639 would impose age limitations on who
75 may purchase or possess certain firearms, including prohibiting
76 purchases by persons under age 21; and

77
78 WHEREAS, I-1639 would require certain secured firearm
79 storage or trigger locks, and criminalize noncompliant firearm
80 storage if it results in unauthorized use; and

81 WHEREAS, I-1639 would enact other firearm-related
82 requirements, including certain warnings, recordkeeping and fees;
83 and

85 WHEREAS, as provided for by RCW 42.17A.555, the City
86 Council provided public notice of its intent to consider taking
87 action at its September 18, 2018 regular meeting to support or
88 opposed I-1639, at which time members of the public were given
89 an opportunity to express their views in connection with I-1639;
90 and

92 WHEREAS, the City Council now desires to show its support
93 to I-1639.
94

95 NOW, THEREFORE, be it resolved by the City Council of the
96 City of Kirkland as follows:
97

98 Section 1. The City Council supports Initiative 1639,
99 concerning firearms.

101 Section 2. The City Council urges Kirkland voters to vote
102 yes on Initiative 1639 and enact the measure into law.
