

RESOLUTION NO. 2017-28

A RESOLUTION OF THE OKANOGAN COUNTY TRANSIT AUTHORITY DECLARING CERTAIN PROPERTY SURPLUS AND DIRECTING THE GENERAL MANAGER TO DISPOSE OF SUCH SURPLUS PROPERTY IN A COMMERCIALY REASONABLE MANNER.

WHEREAS, the Okanogan County Transit Authority ("OCTA") Board of Directors ("Board") has determined that certain personal property or equipment belonging to OCTA is damaged, inoperable, outdated or unnecessary for the needs of OCTA; and

WHEREAS, the Board is desirous of declaring such personal property and equipment to be surplus and to be disposed of in a commercially reasonable manner.

NOW, THEREFORE, BE IT RESOLVED by the Board of OCTA as follows:

Section 1. Surplus Declaration. The Board does hereby declare that the personal property and equipment listed on Exhibit A attached hereto, and incorporated herein as though fully set forth, are either damaged, inoperable, outdated or unnecessary for the needs of OCTA and are, therefore, declared to be surplus.

Section 2. Disposition of Surplus Property. The Board does hereby direct the General Manager of OCTA to dispose of such surplus property designated on Exhibit A in a commercially reasonable manner, and any proceeds derived in disposing of such surplus property shall be deposited into such fund or funds of OCTA as the General Manager shall deem appropriate.
