

ORDINANCE NO. 3073

AN ORDINANCE REPEALING ORDINANCE NO. 2973 ADOPTING A BIENNIAL BUDGET PROCESS, AUTHORIZING REVERSION TO THE PROVISIONS OF AN ANNUAL BUDGET CONSISTENT WITH RCW CHAPTER 35A.33 WITH RESPECT TO THE PREPARATION OF A BUDGET FOR FISCAL YEAR 2021, AND FIXING A TIME WHEN THE SAME SHALL BECOME EFFECTIVE

WHEREAS, RCW Chapter 35A.34 authorizes adoption of a biennial budget, and

WHEREAS, Council adopted Ordinance 2973 establishing a biennial budget process, and

WHEREAS, RCW 35A.34.040 permits the repeal of a biennial budget process, as long as the repeal occurs concurrently with the expiration of the biennial budget period, which in this case is December 31, 2020, and

WHEREAS, given the unprecedented financial uncertainty facing the City, and the need to closely monitor and respond, the City Council determines it to be in the public interest to revert to an annual budgeting process as authorized in RCW Chapter 35A.33.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Anacortes, Washington, as follows:

Section 1. Ordinance 2973 and the biennial budget process adopted pursuant thereto is hereby repealed, effective December 31, 2020, provided, however, that the adoption of a budget for fiscal year 2021 shall proceed during the course of the latter half of 2020 in accordance with the requirements of RCW chapter 35A.33.

Section 2. Effective date. This Ordinance shall take effect five (5) days after its passage and publication, as required by law, provided, however, that this effective date shall be interpreted in accordance with the provisions of Section 1 in that the currently adopted biennial budget shall continue in full force and effect until December 31, 2020 in accordance with the provisions of RCW 35A.34.040, and the budget process for fiscal year 2021 shall proceed during the latter part of 2020 in accordance with the provisions of Chapter 35A.33.
