

ORDINANCE 22-07

AN ORDINANCE REPLACING “APPENDIX S” OF CHAPTER 12.08 OF THE ROYAL CITY MUNICIPAL CODE ENTITLED “SEWER SERVICE SYSTEM” RELATING TO SEWER RATES

THE CITY COUNCIL OF THE CITY OF ROYAL CITY WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Existing Appendix S of Chapter 12.08 “Sewer Service System” is replaced with the attached Appendix S which shall become the sewer rates charged and collected within the city effective with the January 2023 billings.

Section 2. This ordinance shall be in full force and effect five days after its passage and publication of its summary as provided by law.
