PETITION

TO: The Honorable King County Council, State of Washington Boundary Review Board for King County, and the King County Auditor/Recorder and Director of Records and Elections, State of Washington.

We, the undersigned citizens of King County, Washington and legal voters residing within the boundary of the area described herein, respectfully request that this petition be acted upon in the manner provided for by law:

- I. That the territory hereby requested to be incorporated is described on the reverse side, page 2, of this petition, and is contained entirely within King County, Washington.
- II. That the territory be incorporated as a noncharter code City pursuant to RCW Title 35A, under the council-manager form of government, and is hereby named Sammamish, WA.
- III. That said territory is not incorporated as a municipal corporation and no part of said territory is within the corporate limits of an existing city or town.
- IV. That the number of inhabitants, as nearly as may be determined, residing within the boundaries of said territory proposed is approximately 28,000.
- V. That each of the undersigned is a qualified (registered) voter of the County of King, Washington, and is a resident of the said territory and that the total of all petitions is ten percent or more of the votes cast in the proposed area in the last state general election.
- VI. That this petition is one of many petitions herewith presented for the incorporation of said city. That all said petitions are to be considered as one petition for the formation of said city. That petitioners have not signed any one of the other petitions for the incorporation of said city.

WHEREFORE, Petitioners pray that proceedings be had hereon in the manner prescribed by RCW Title 35.02 and that said described territory be incorporated as a noncharter code city under the provisions of RCW Title 35A.

Beginning at the intersection of the North margin of Southeast Duthie Hill Road(SE 28th Street) with the East line of the Northeast quarter of Section 12, Township 24 North, Range 6 East, W.M. King County, Washington;

Thence North along said line of said section 12 and the East line of Sections 1, Township 24 North, Range 6 East, W.M. to corner of said Section 1;

Thence North along East line of section 36, Township 25 North, Range 6 East, W.M., to the Northeast corner of said Section;

Thence Westerly along the North line of said Section 36 to the Northwest corner thereof;

Thence South along the West line of said Section 36 to South margin of Northeast 8th Street;

Thence Westerly along said South margin of Northeast 8th Street to the West Margin of 244th Avenue Northeast;

Thence generally Northerly along said West margin of 244th Ave Northeast to its intersection with the East line of Section 22, Township 25 North, Range 6 East, W.M.;

Thence North along said East line to the Northeast corner of the Southeast Quarter of said Section 22;

Thence West along the East/West centerlines of Sections 22 and 21 to its intersection with the West margin of Sahalee Way;

Thence generally Northwest along said West margin of Sahalee Way to its intersection with the North boundary line (Extended) of Timberline Plat number 2;

Thence Westerly along said North boundary of said Timberline Plat number 2 to its intersection with the extension of the most Westerly margin of 205th Place Northeast(being an easement 50.00 feet wide);

Thence Southerly along said West margin of said easement and the West margin of the right-of-way of 205th Place Northeast to the NorthWest margin of 204th Ave. Northeast;

Thence generally Southerly along said Northwest margin of said 204th Ave Northeast to the South line of Section 17, Township 25 North, Range 6 East, W.M.;

Thence Westerly along said South line of said Section 17 to its intersection with the East margin of northeast 39th street, said road being the northerly end of a Cul de Sac;

Thence Northerly, Easterly, Northerly, Westerly, and Southerly along the margins of 39th street to its intersection with the aforementioned South line of said section 17;
