INTRODUCTION

Your continued use of this site after such modifications will constitute acknowledgment and agreement of the modified terms and conditions.

By using the wireless network you agree to defend, indemnify, and hold harmless GGU for any losses or damages that may result from your use of the wireless network.

GGU takes no responsibility and assumes no liability for any content uploaded, shared, transmitted, or downloaded by you or any third party, or for anything you may encounter or any data that may be lost or compromised while connected to the Wireless Network.

RESPONSIBLE USE AND CONDUCT
