## Background

The word “sex” is universally recognized. It is also one of the leading key word searches online, with approximately 37.5 million Google searches per month. As the operator of .XXX, ICM Registry, LLC saw an opportunity with the New Generic Top-Level Domain (gTLD) Program to expand its product line. The company applied for .SEX with the intention of creating an environment that supports responsible business practices, while broadening the appeal beyond the adult entertainment industry.

Registrants of .SEX domain names must meet key best practice standards that ICM Registry pioneered with .XXX. These best practices help facilitate parental control regarding access to online adult entertainment, combat child abuse imagery and protect consumer rights. To honor its .XXX community, ICM created a way for .XXX stakeholders to have priority on securing matching .SEX domain names. ICM Registry opened registration to .SEX for its .XXX stakeholders before it made .SEX names available to the general public; this allowed .XXX stakeholders to consistently brand their online properties.


## Objectives


With .SEX, ICM Registry seeks to provide an online space that appeals to members of the adult entertainment community as well as entities outside of the adult industry whose work relates to sex, sexuality and health-related issues. Examples of these types of entities include pharmaceutical companies and organizations that provide sexuality education or fertility-related products and services. In addition, domain portfolio investors find the .SEX domain extension valuable.

“Sex” is a word that is known by many people around the world, even to those who may not be fluent in English. This makes .SEX an appropriate online destination for a global range of products, services and resources.

Given the nature of the word itself, .SEX generates a fair amount of media attention. In addition, ICM Registry participates in global trade shows through sponsorships and panel presentations, and engages in advertising campaigns with target industry media outlets.

# New gTLD Fast Facts

The Internet Corporation for Assigned Names and Numbers' (ICANN) New gTLD Program is responsible for introducing new generic top-level domains (gTLDs) into the Internet, which will result in the largest-ever expansion of the domain name system. The goal of this expansion is to enhance competition, innovation and consumer choice. Top-level domains are the letters immediately following the final dot in an Internet address. Through the program, the domain name system is expanding from 22 gTLDs to hundreds.

The New gTLD Program, led by ICANN's Global Domains Division makes it possible for communities, governments, businesses and brands to apply to operate a top-level domain registry. Operating a registry is a responsibility that requires a major commitment. In essence, the registry operator becomes the custodian of a piece of the Internet's core infrastructure. For this reason, ICANN established a rigorous process for those who applied for a new gTLD. The application process is a cornerstone of the New gTLD Program.
