TO: ALL CALIFORNIA LAW ENFORCEMENT TELECOMMUNICATIONS (CLETS) USERS

The purpose of this information bulletin is to inform all criminal justice agencies that effective **January 1, 2022**, the California Department of Justice will be updating the California Restraining and Protective Order System (CARPOS).

Pursuant to SB 1141, the Judicial Council of California (JCC) updated the “Personal Conduct Order” section of the Temporary Restraining Order (CLETS—TRO) form DV-110 and Restraining Order After Hearing (CLETS—OAH) (Order of Protection) form DV-130. These changes include adding the “Cannot Look for Protected People”, “Order to Not Abuse”, and “No-Contact Order” sections. These updates are only applicable to the TRO and OAH order types.

Cannot Look for Protected People

The Cannot Look for Protected Person(s) (CLP) field is an optional field. By default, the record will display the verbiage below.

- THE RESTRAINED PERSON MUST NOT TAKE ANY ACTION TO LOOK FOR THE PROTECTED PERSON(S), INCLUDING ADDRESSES OR LOCATIONS

If the TRO or OAH form indicates that the court has found good cause not to make this order, then “Y” should be entered in the CLP field and the CLP will **not** display.

Entry Format:

Modify Format:

Modify Format to Clear CLP:

UB MRO.fcn.rsp.CLP/

Clearing the CLP field will change the value between “Y” and Null.

Order to Not Abuse

The Order for No Abuse (ONA) field is an optional field. When “Y” is entered in the ONA field, the record will display the following verbiage.

- **Y – YES - THE RESTRAINED PERSON MUST NOT HARASS, ATTACK, STRIKE, THREATEN, ASSAULT, HIT, FOLLOW, STALK, MOLEST, DESTROY PERSONAL PROPERTY, KEEP UNDER SURVEILLANCE, IMPERSONATE, BLOCK MOVEMENTS, ANNOY BY PHONE OR OTHER ELECTRONIC MEANS, OR DISTURB THE PEACE (INCLUDING COERCIVE CONTROL) OF THE PROTECTED PERSON(S)**

Entry Format:

Modify Format to Add ONA:

UB MRO.fcn.rsp.ONA/Y

Modify Format to Clear ONA:

UB MRO.fcn.rsp.ONA/

No-Contact Order

Below is the updated verbiage for the No Contact Order (CON) field when the order type is TRO or OAH and “N” is entered in the CON field.

- **N – NO - THE RESTRAINED PERSON MUST NOT CONTACT THE PROTECTED PERSON(S) DIRECTLY OR INDIRECTLY, BY ANY MEANS INCLUDING TELEPHONE, MAIL, EMAIL, OR OTHER ELECTRONIC MEANS - PEACEFUL WRITTEN CONTACT THROUGH 3RD PARTY FOR SERVICE OF LEGAL PAPERS ALLOWED**

Programming changes will be required for agencies utilizing local systems for data entry in order to accommodate the updates; however, the string format may be used as an alternative. For agencies utilizing LEAWEb, no programming changes will be necessary.
