

# OKLAHOMA COVID-19 WEEKLY REPORT

Weekly Epidemiology and Surveillance Report  
January 22 - 28, 2021



**PURPOSE** To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

- **3,139,837** specimens have been tested in total
- **373,279** vaccine doses have been administered in total

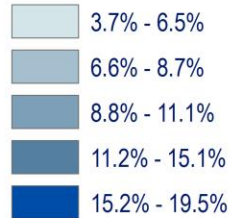

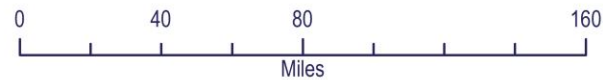

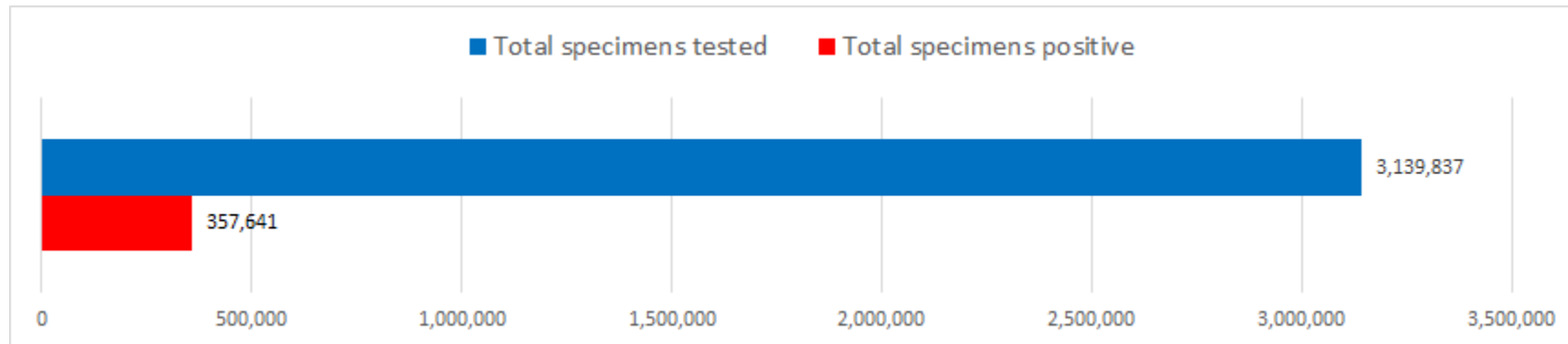

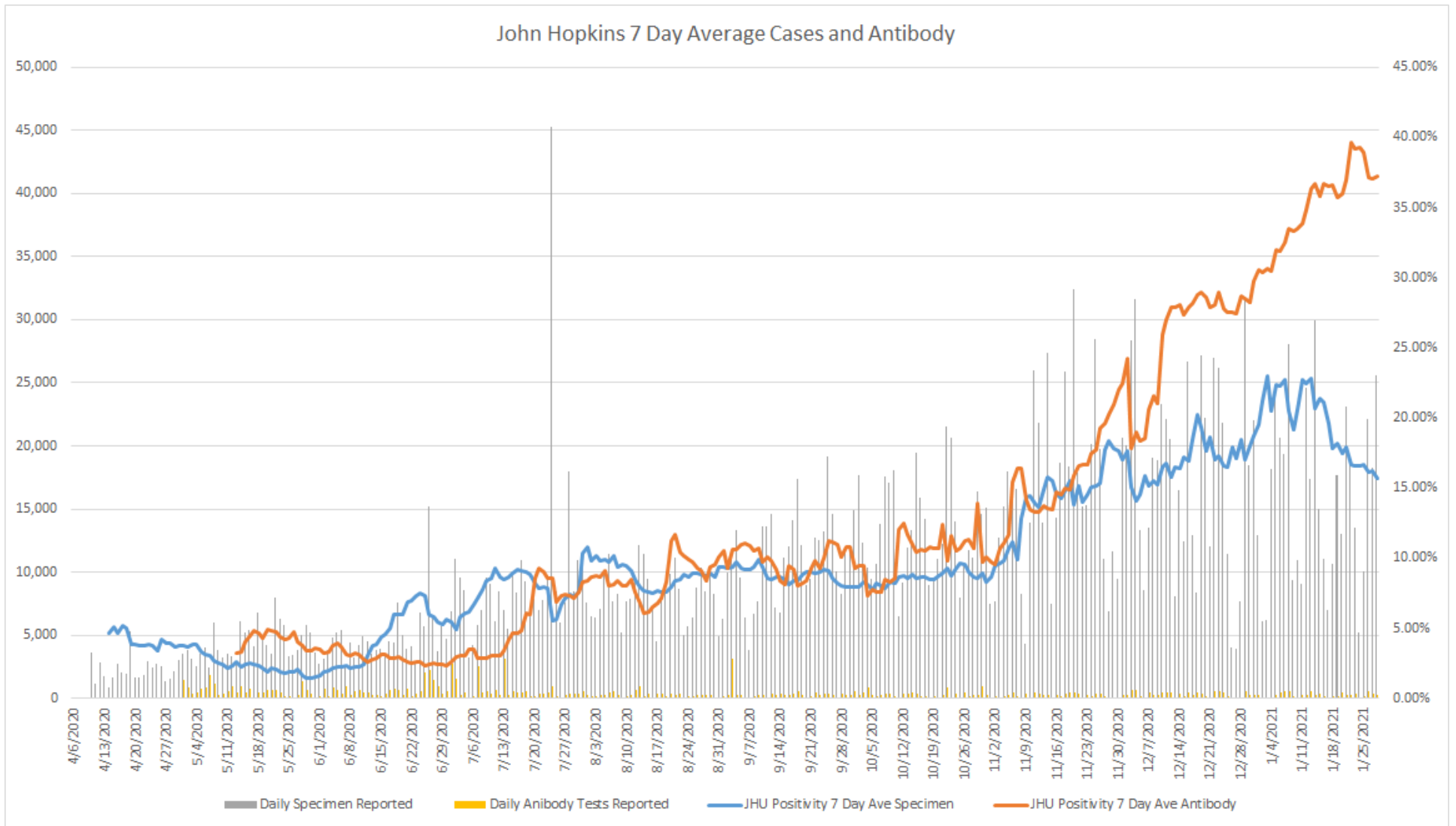

# JOHNS HOPKINS 7 DAY AVERAGE POSITIVITY RATE FOR SPECIMEN AND ANTIBODY CASES

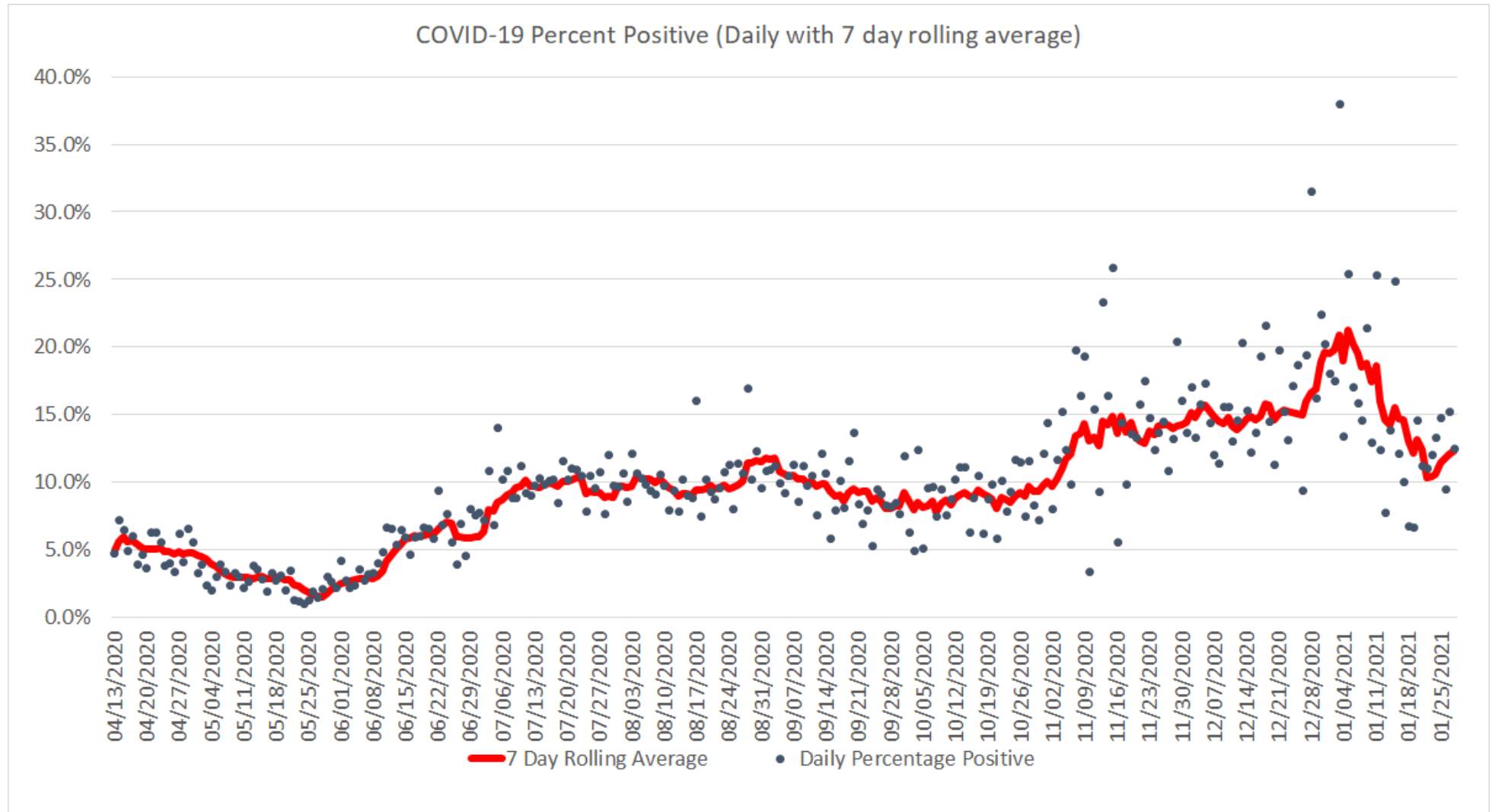

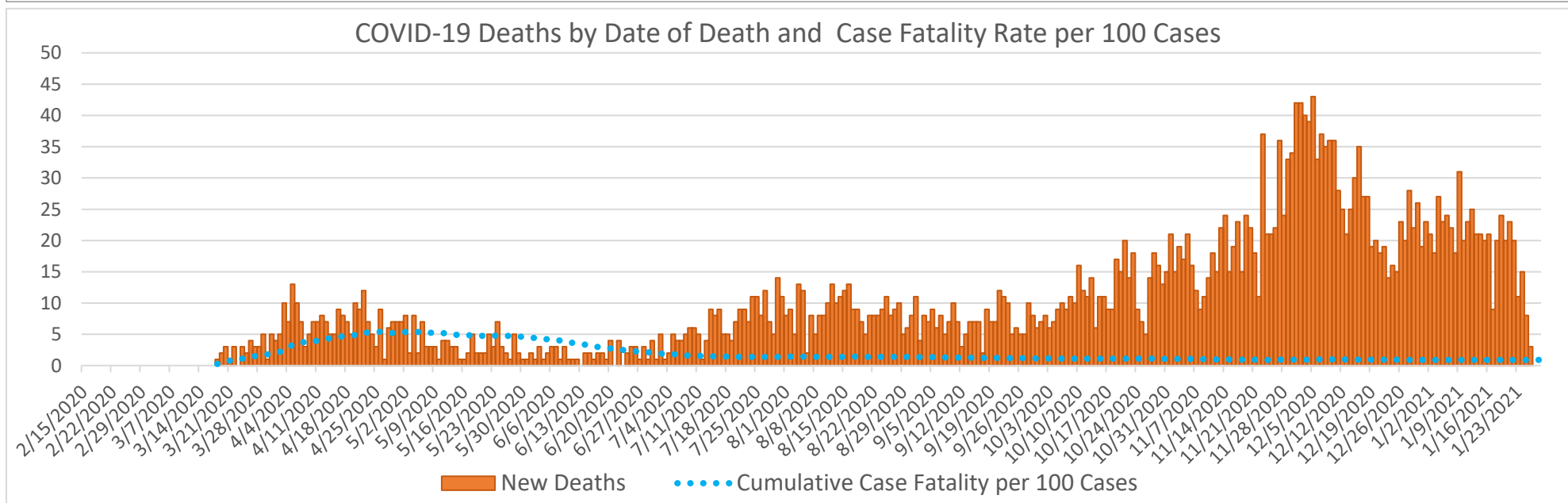
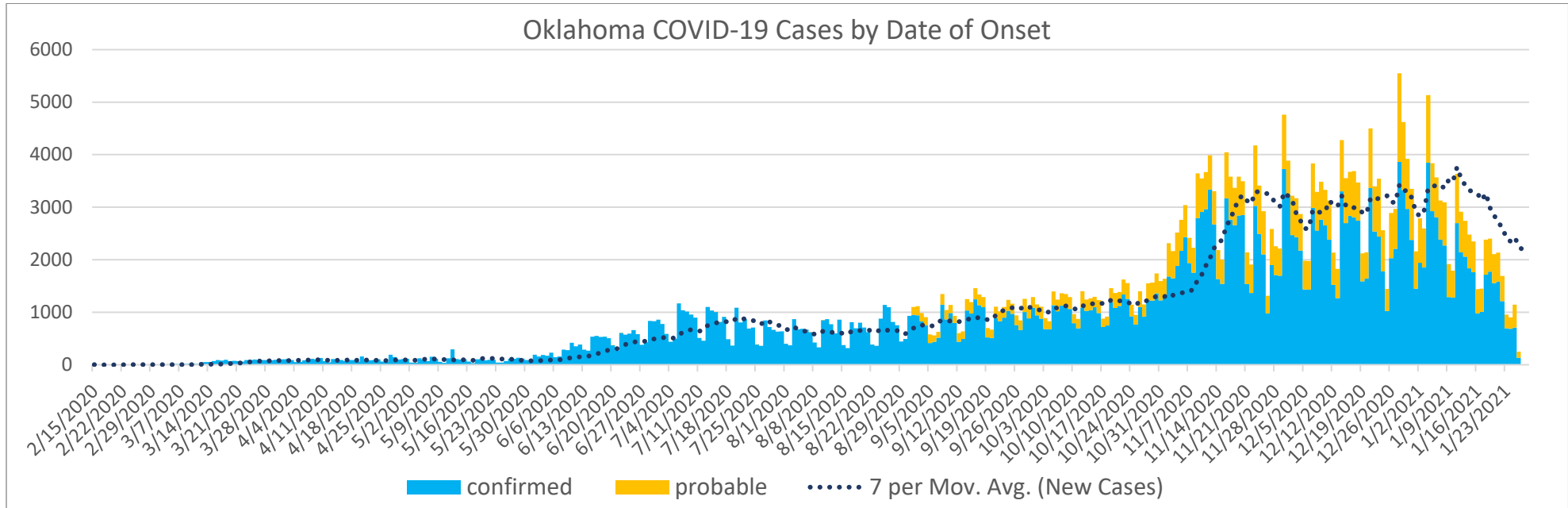

Additionally, a 7-day lag has been applied to the trend line based on information collected to-date for 7/19 and 7/25 where within 7 days of onset date approximately 80% of the cases had been reported.

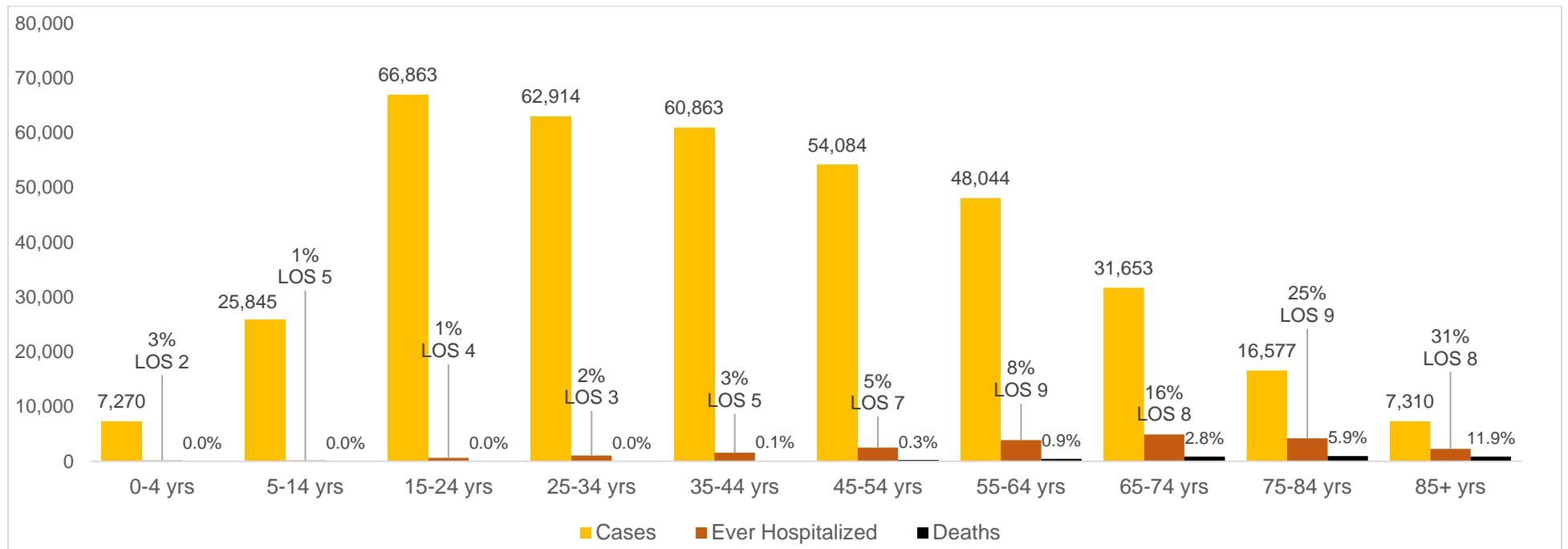

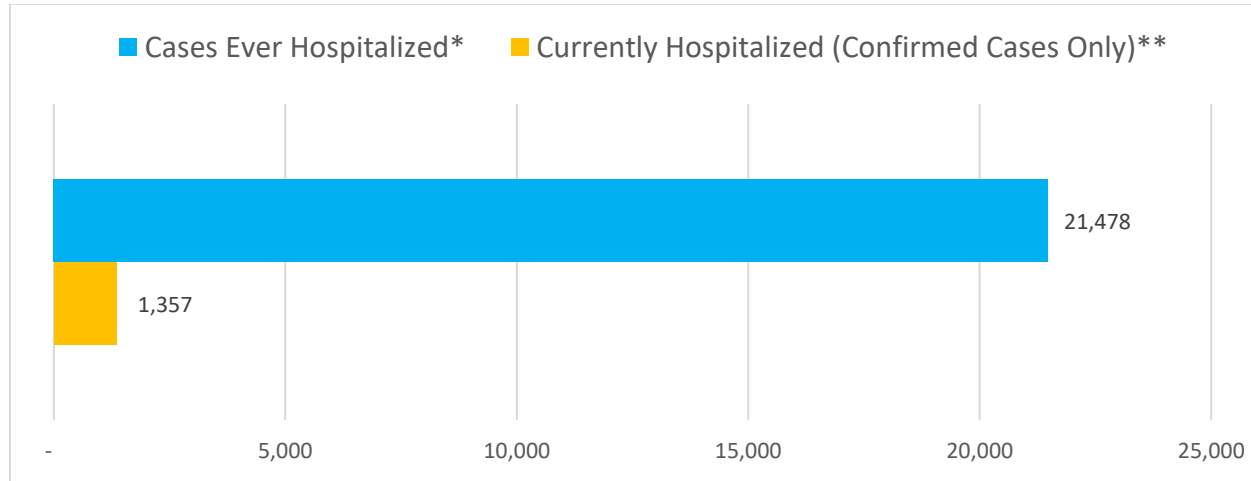

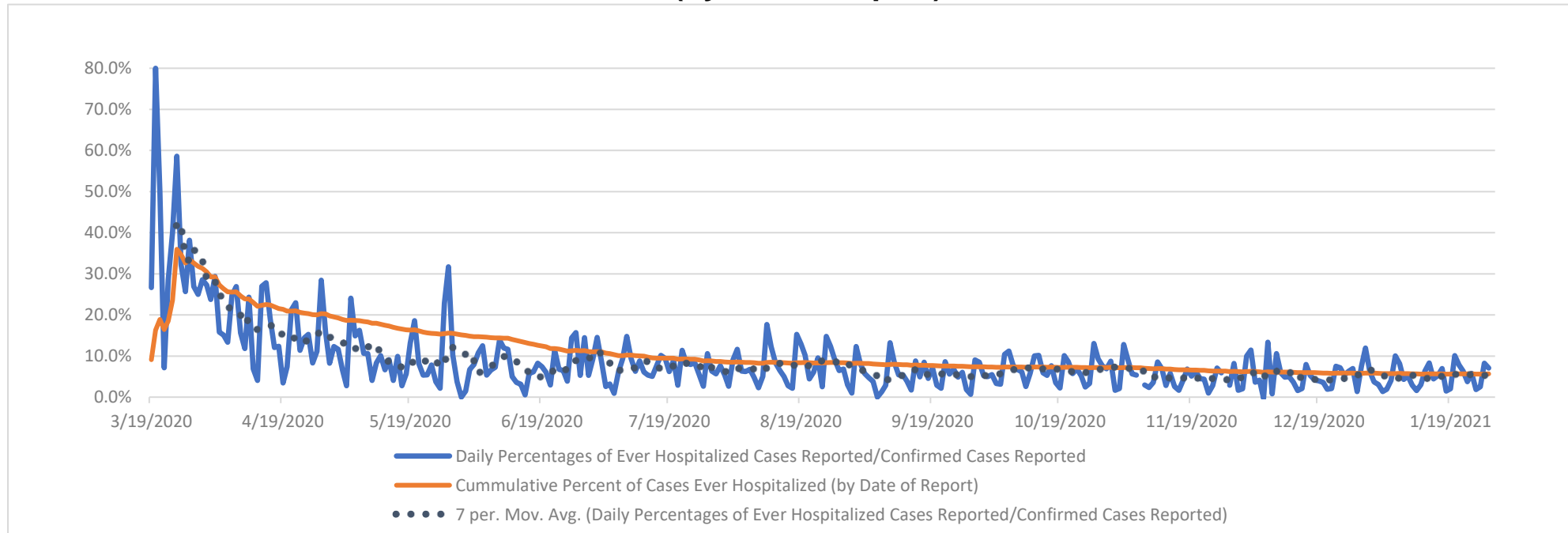

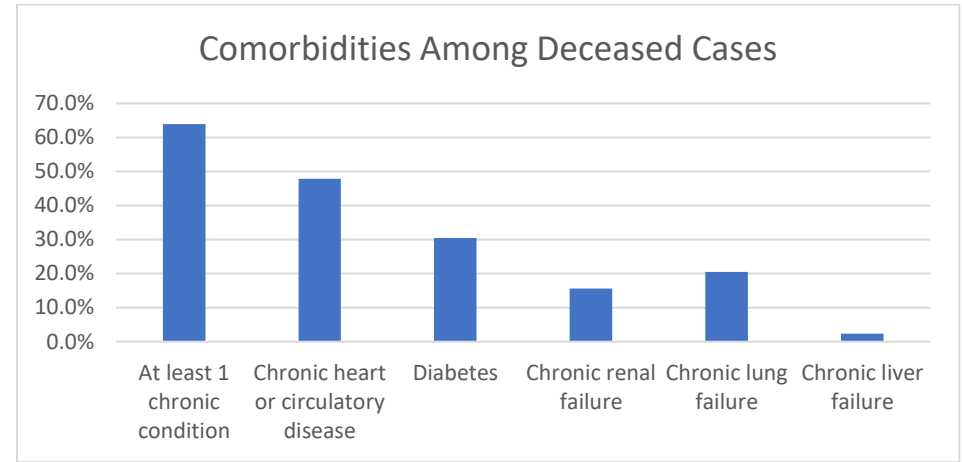

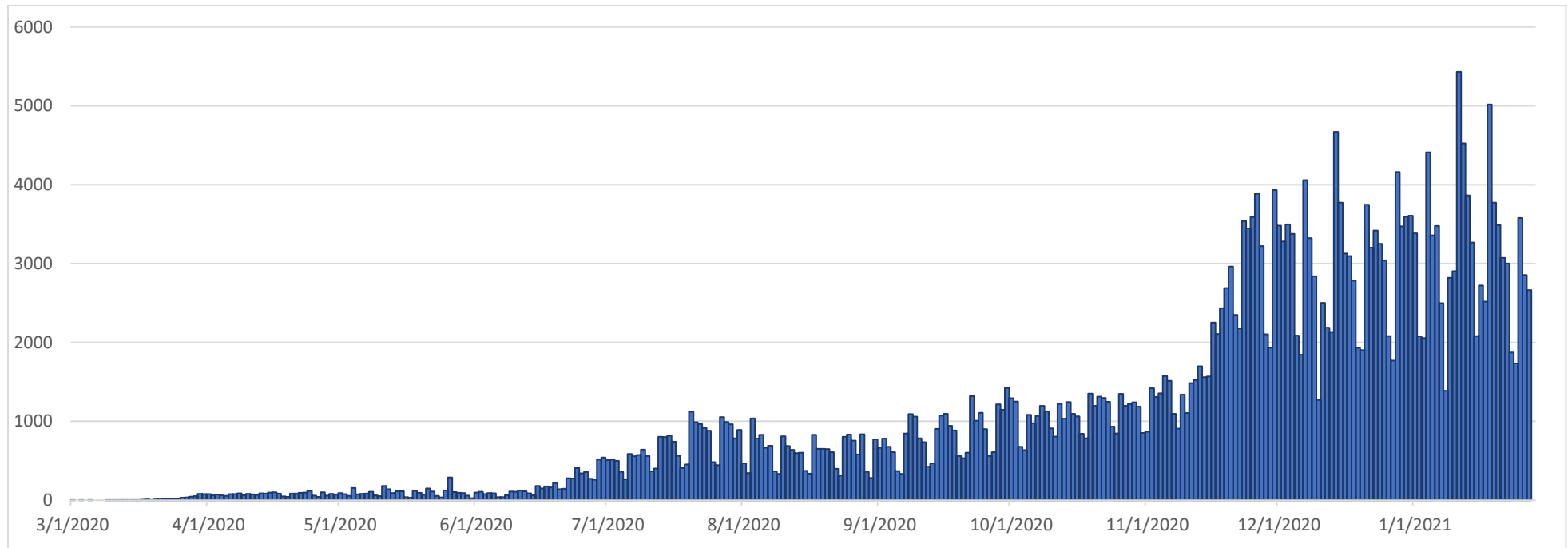

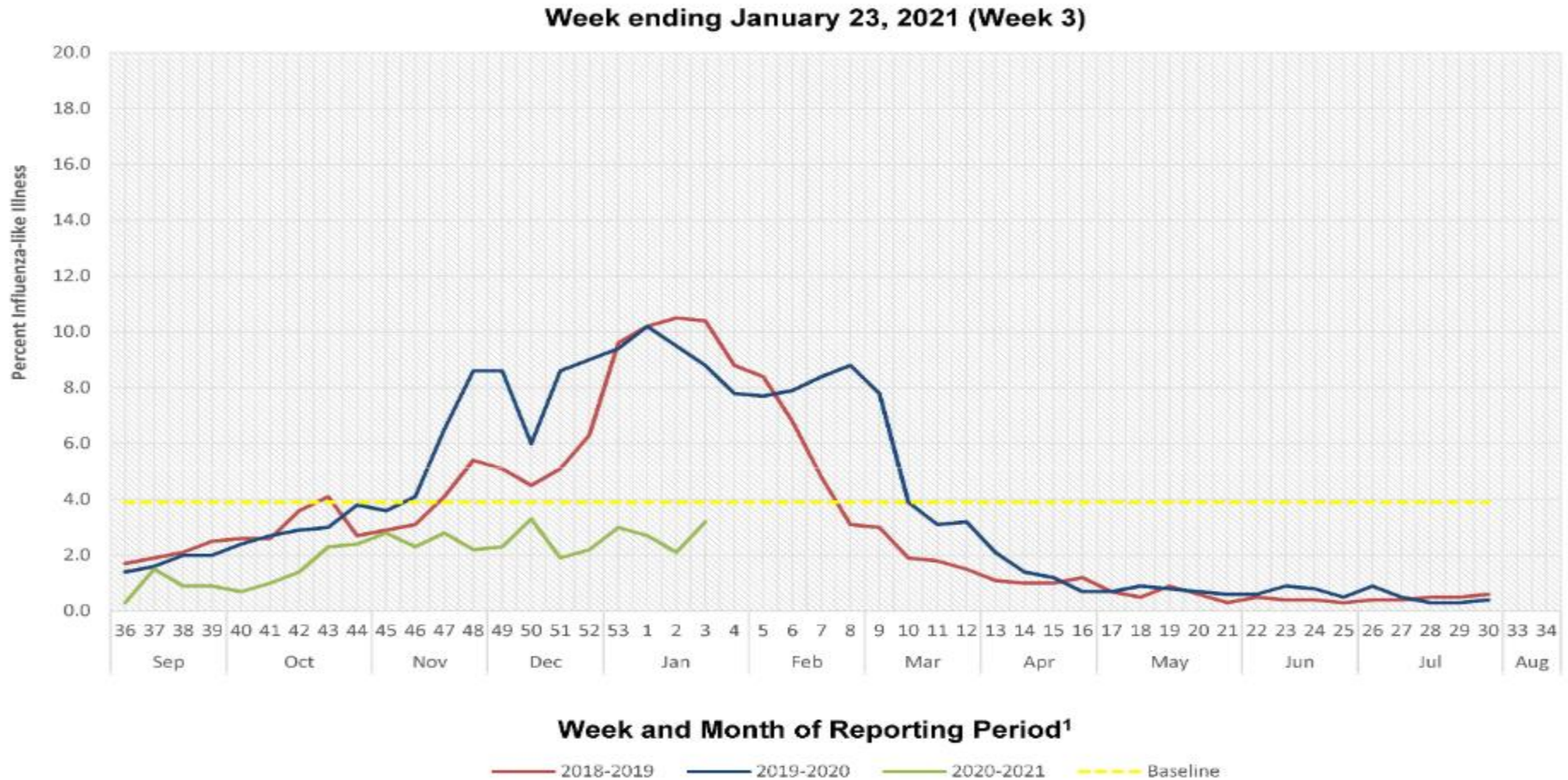
Distribution of recovered cases of COVID-19, March 2020 – January 2021, Oklahoma

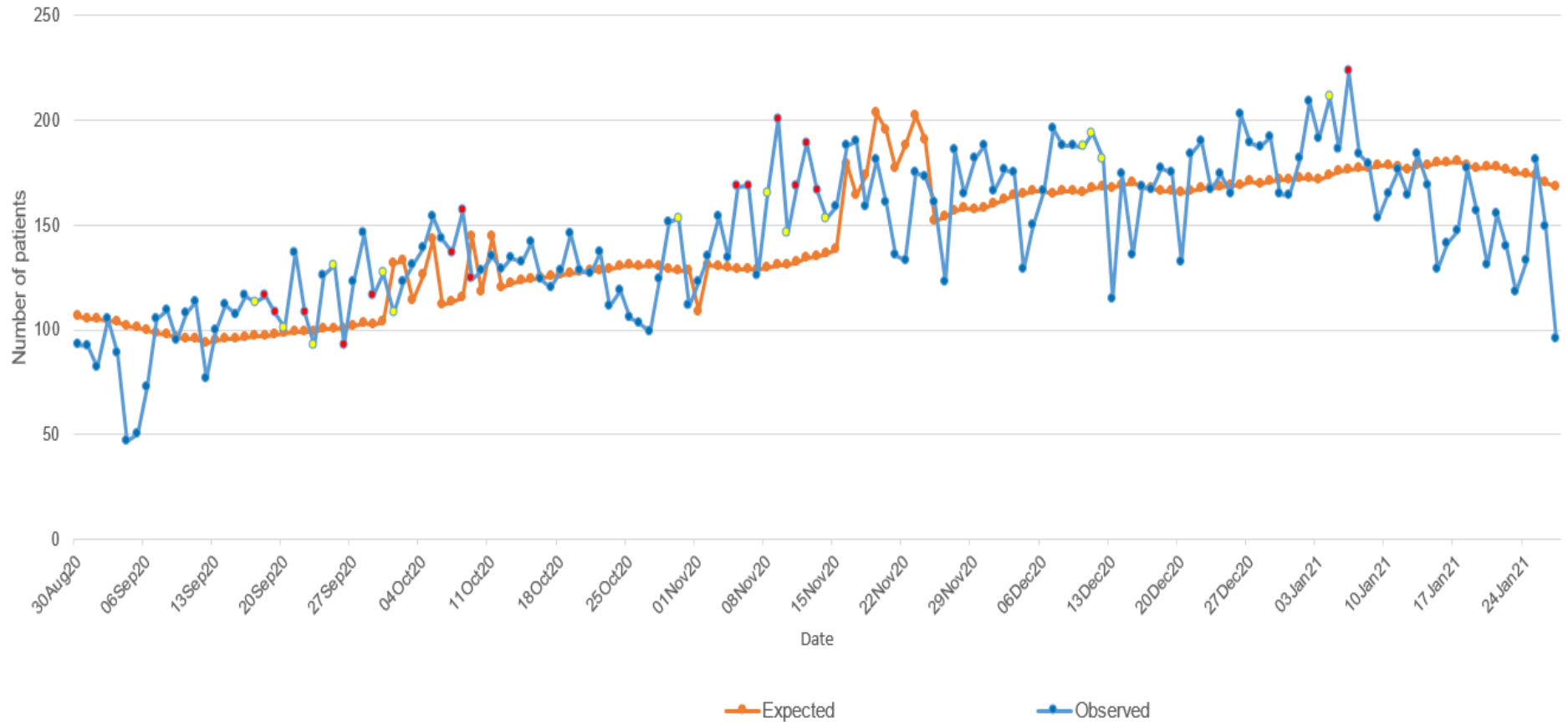

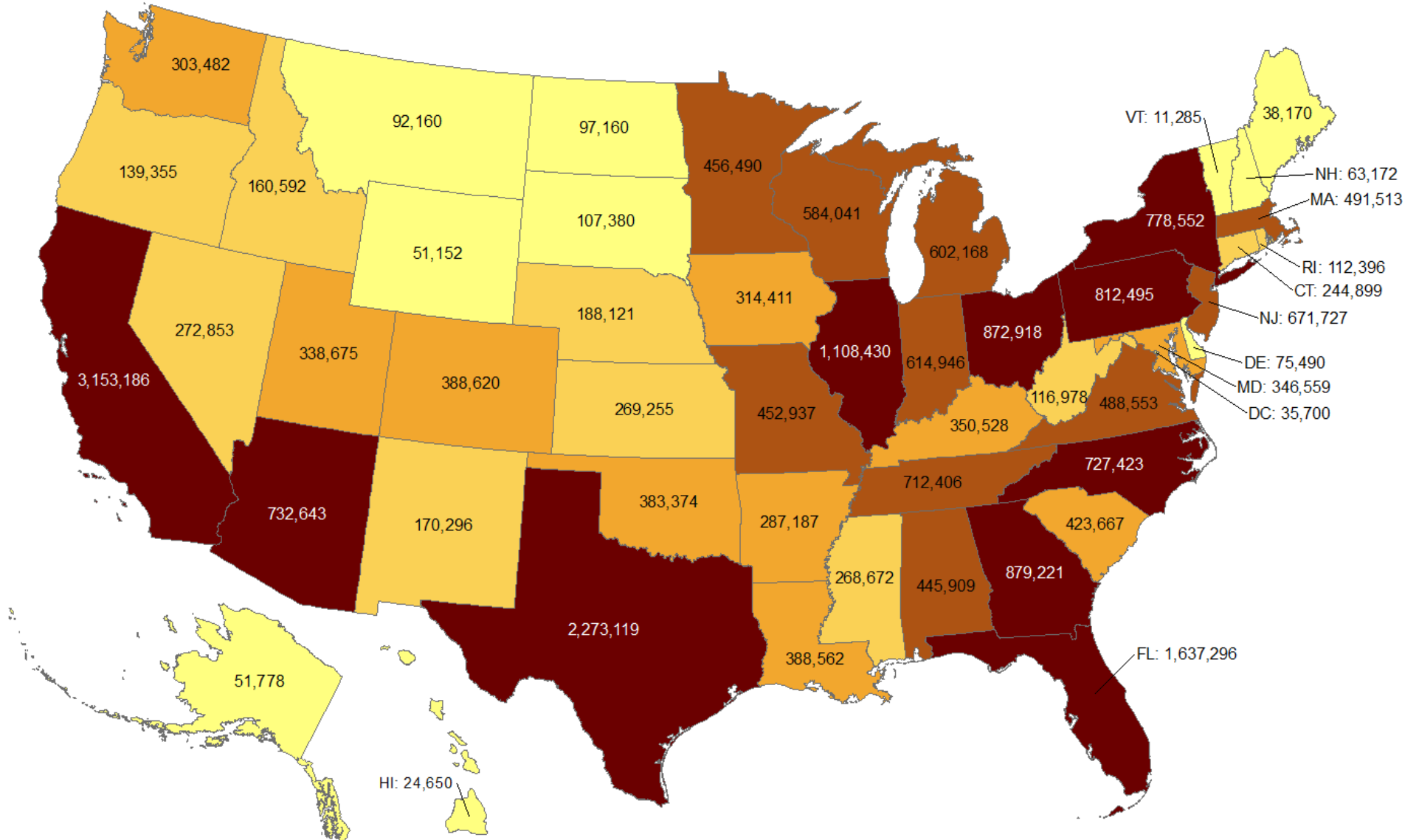

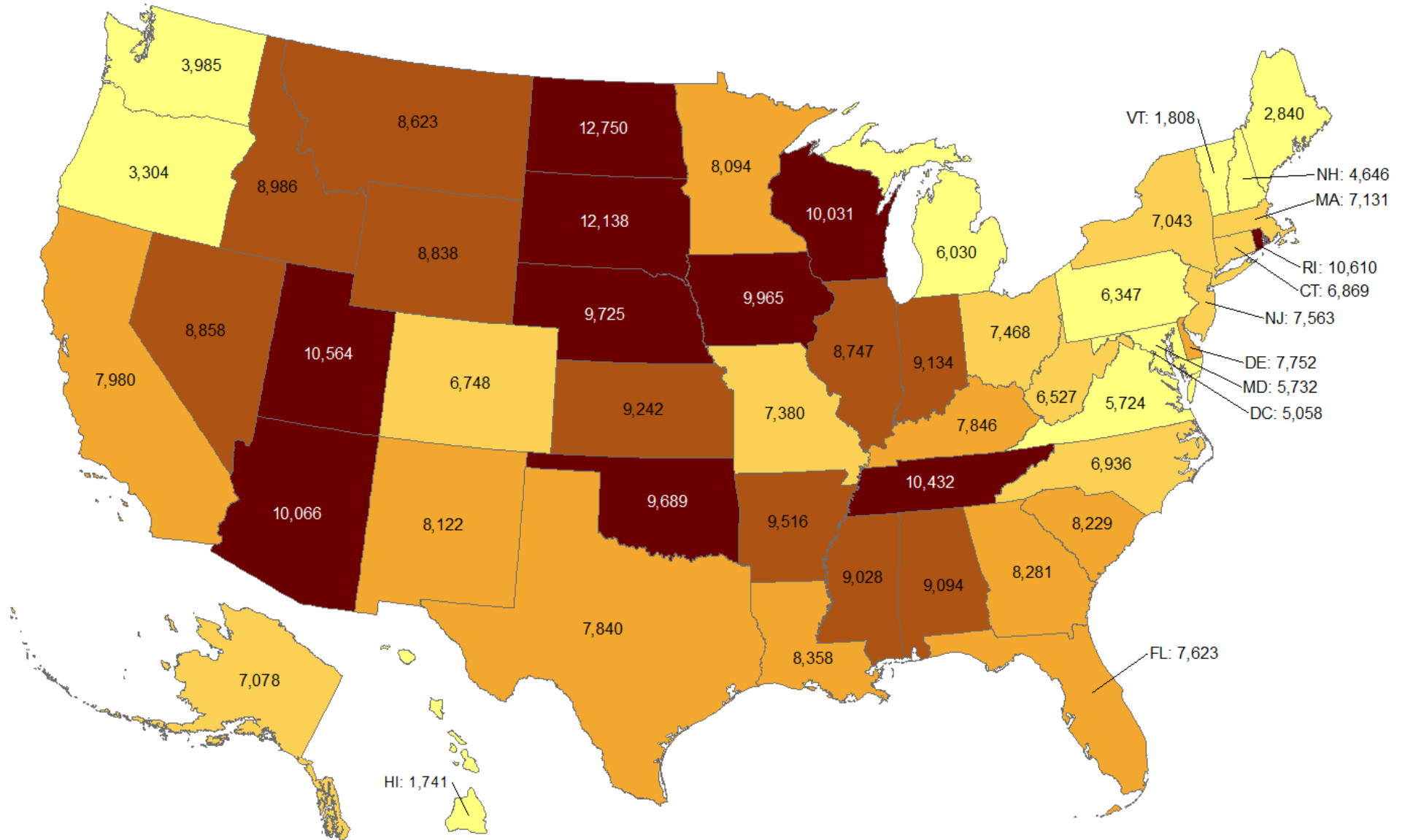

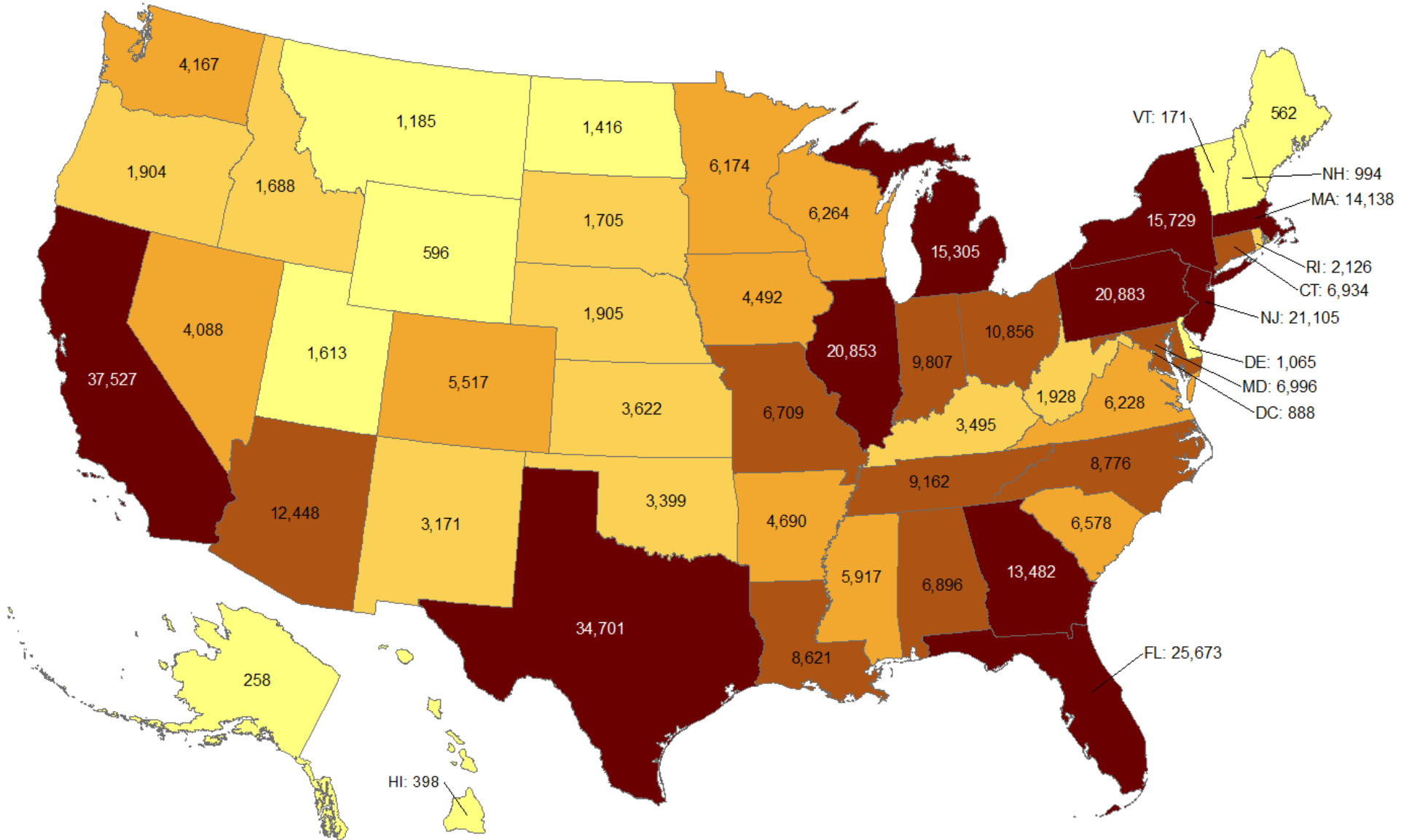

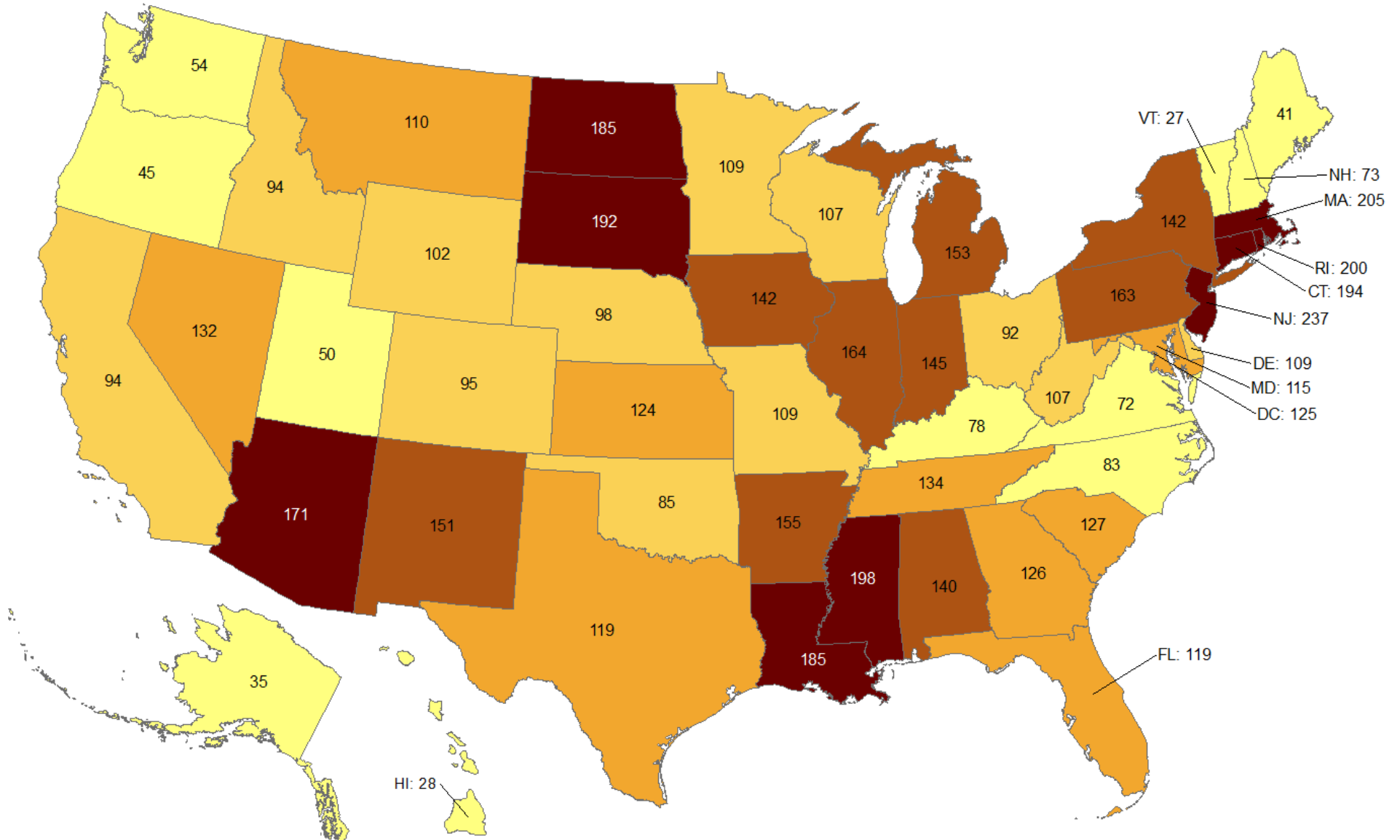

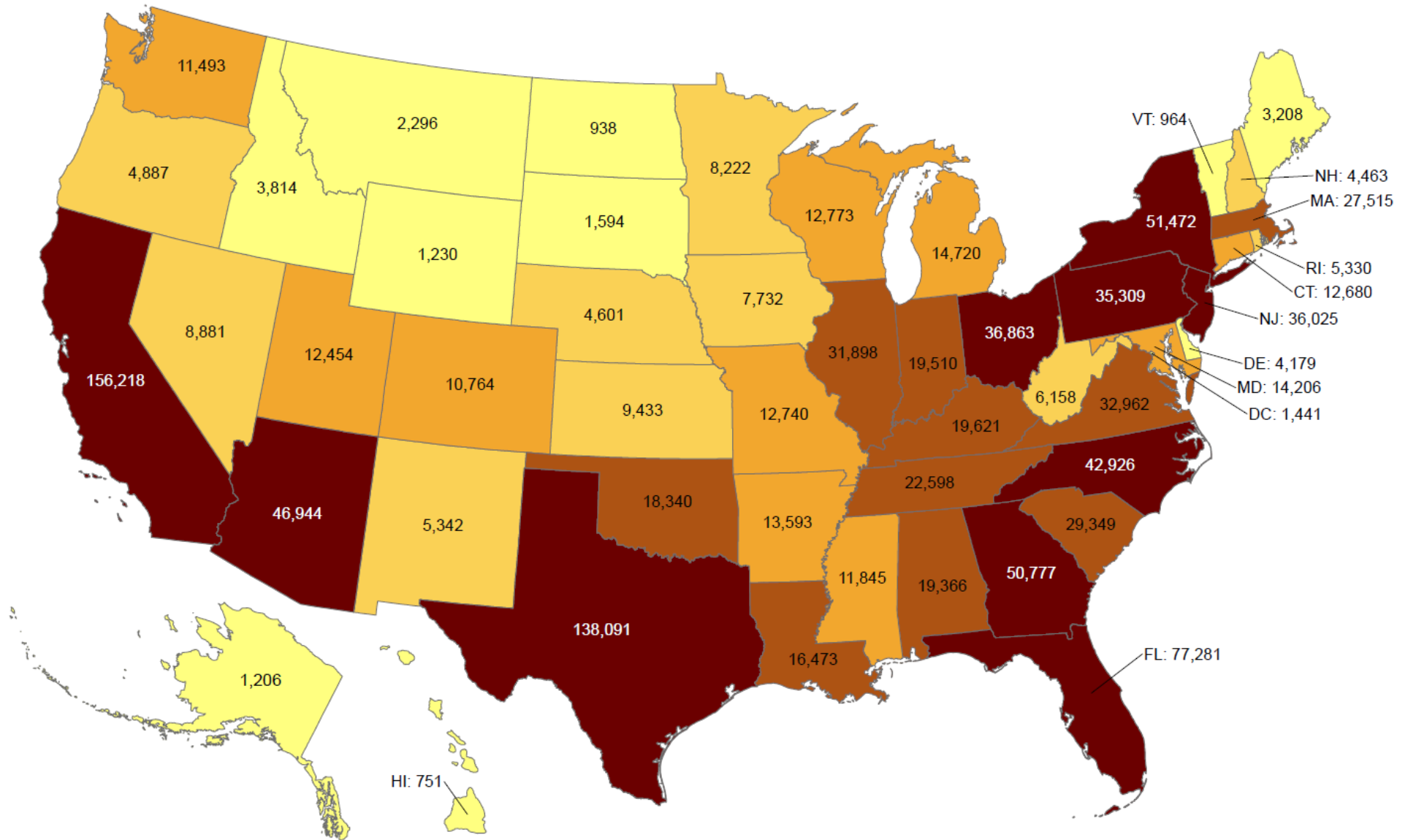

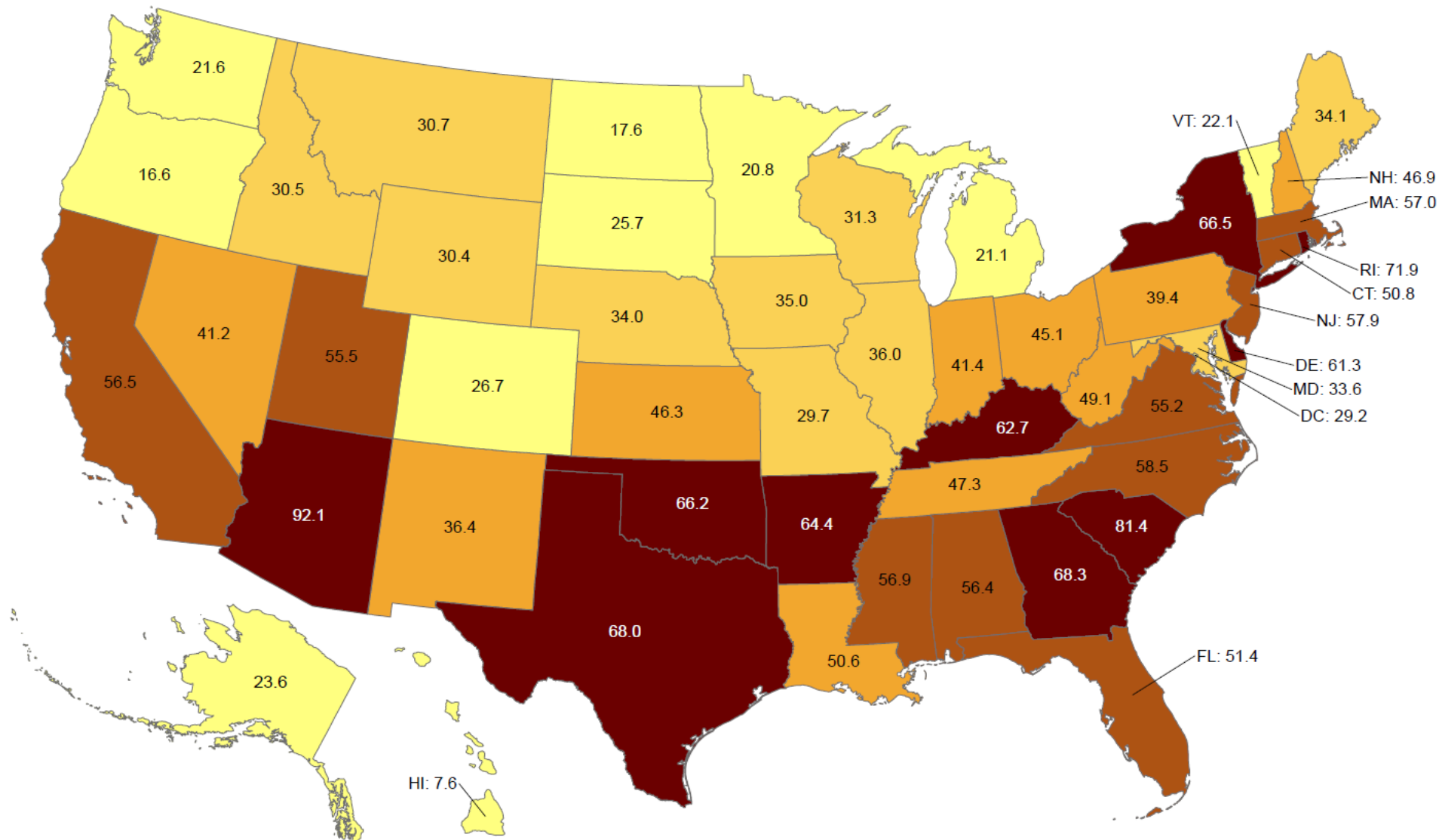

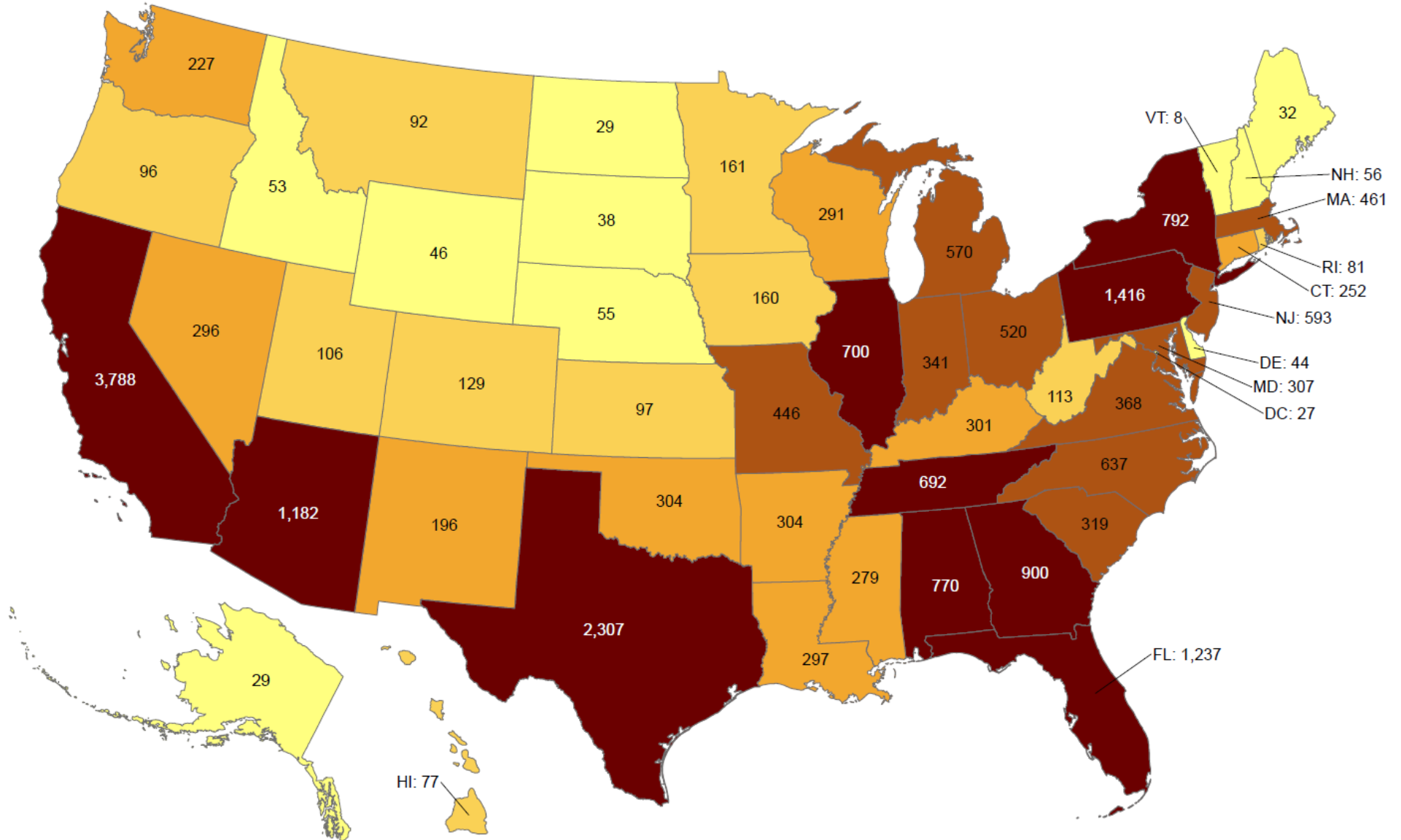

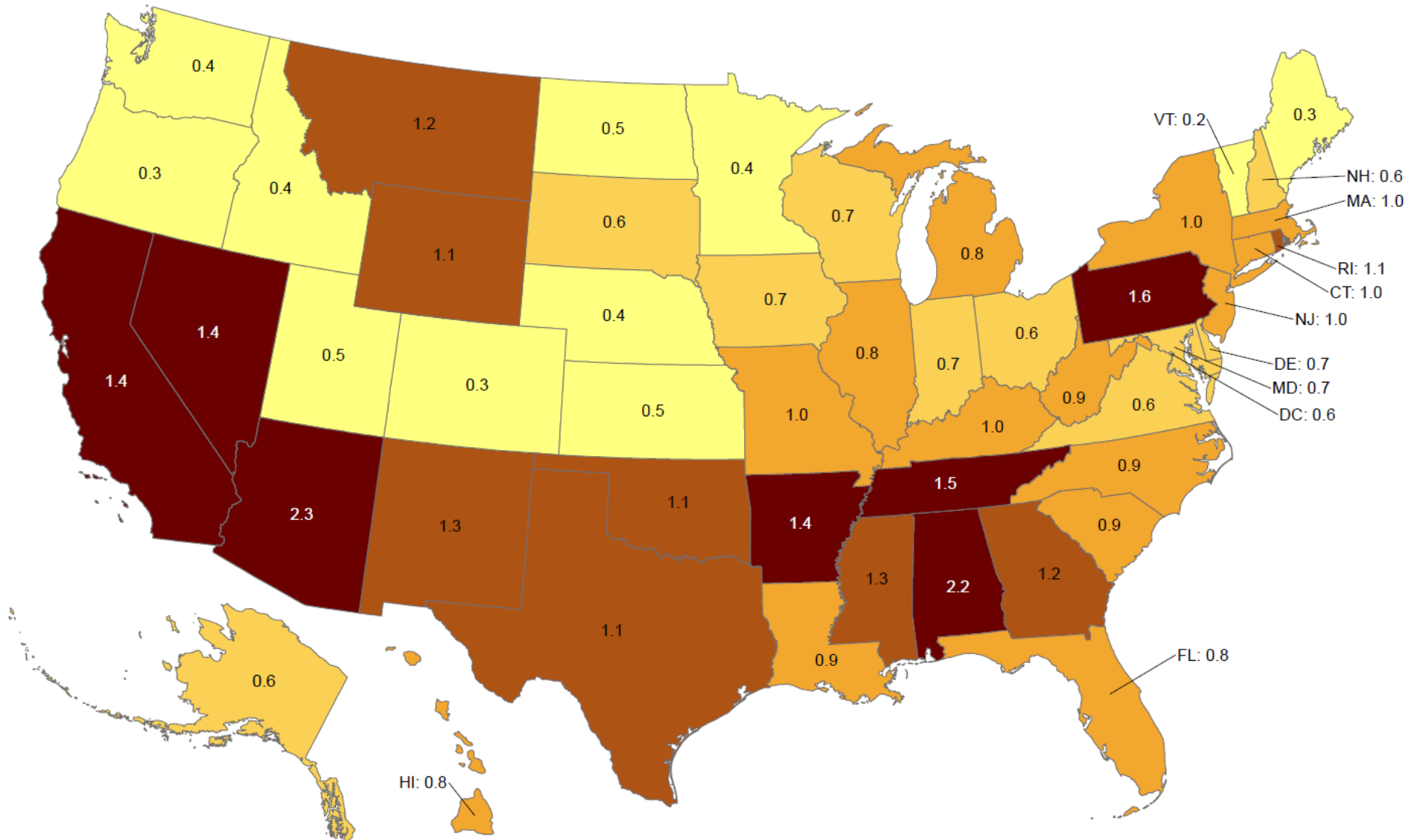

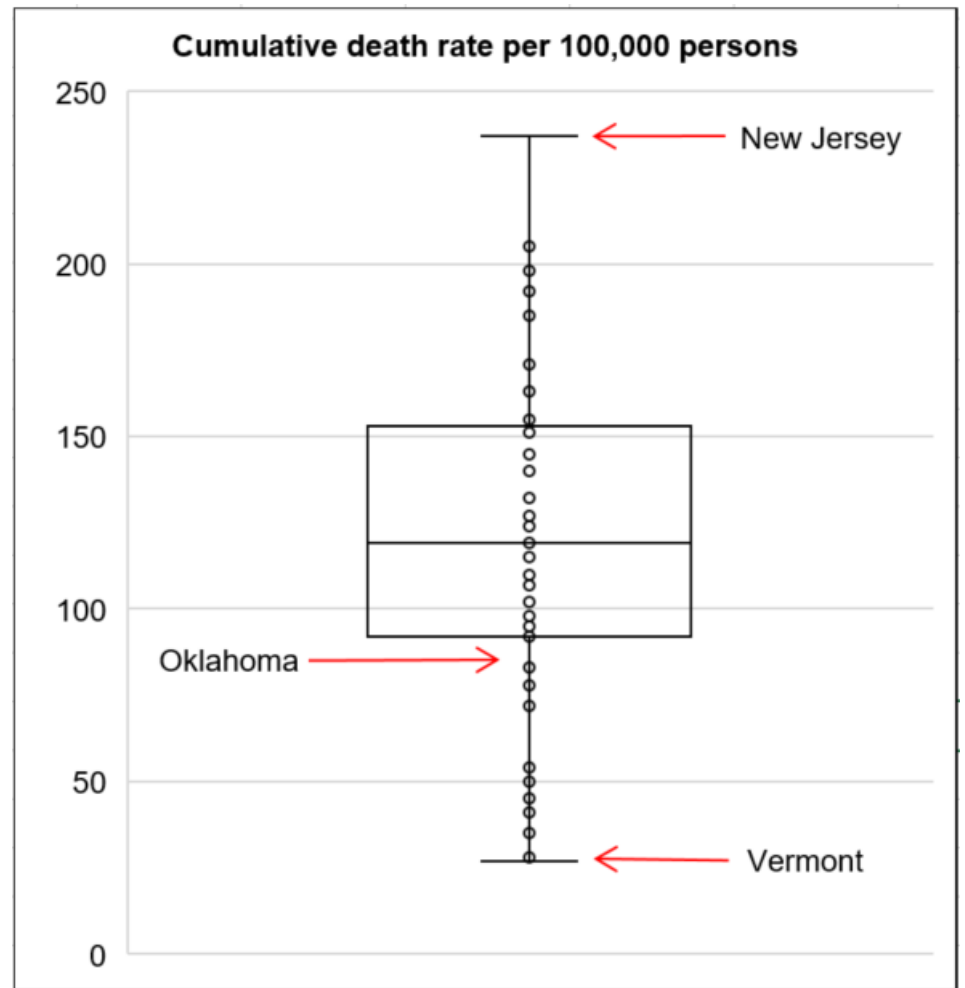

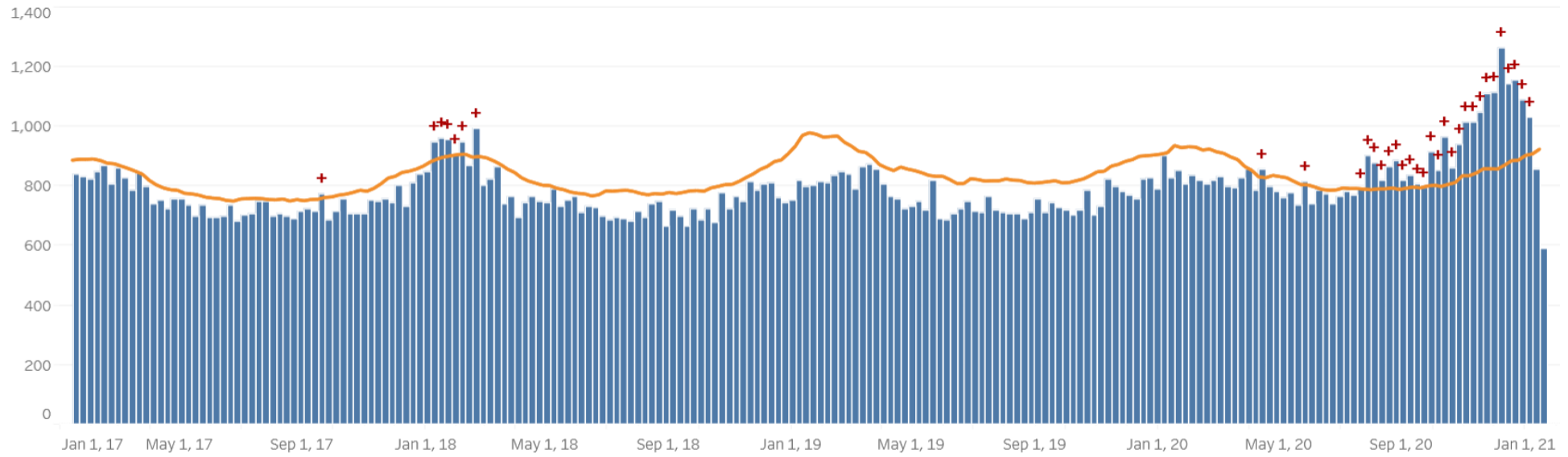
