PURPOSE To provide up-to-date weekly epidemiological data on COVID-19 in Oklahoma.

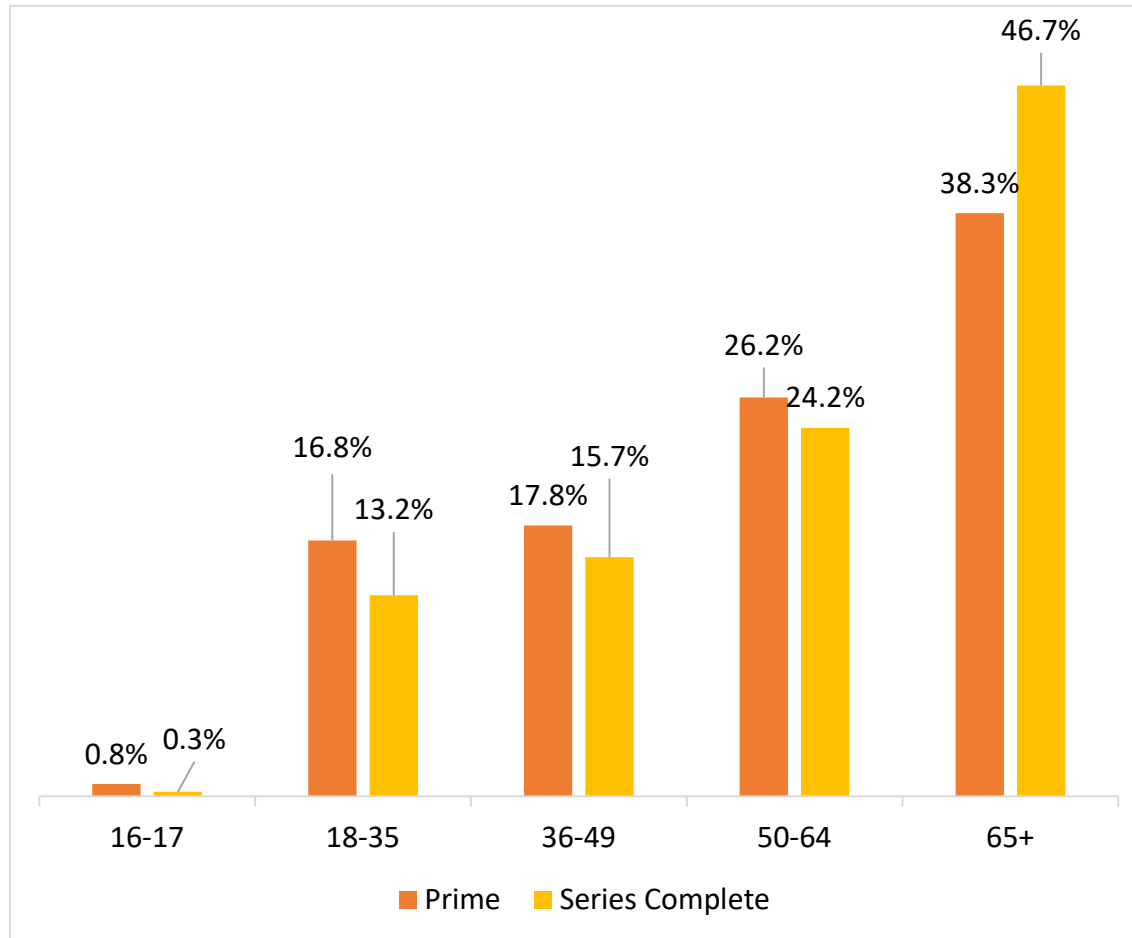
KEY POINTS

- **2,170** cases were reported in the past week
9.7% decrease from the week before (Mar 21– Mar 27)
- **1,716** deaths were reported, *this total includes deaths that occurred as far back as April of 2020.*
- **25,320 (5.8%)** cases have been hospitalized
- **3,806,432** specimens have been tested in total (as of April 3)
- **1,791,071** vaccine doses have been administered in total
- The average age of cases was **41** years and average age of individuals who died was **75** years
- The youngest case was **less than a year old** and the oldest case was **100+ years**
- The youngest individual to die from COVID-19 was **less than 15 years** and the oldest was **100+ years**

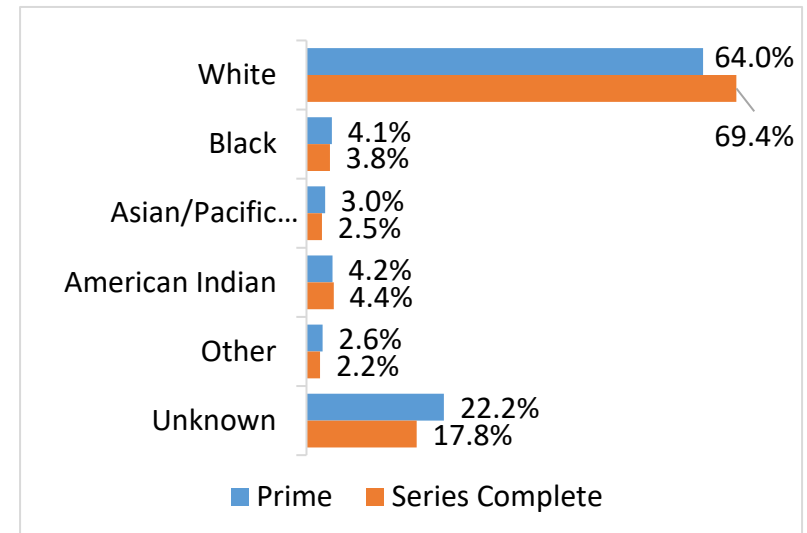
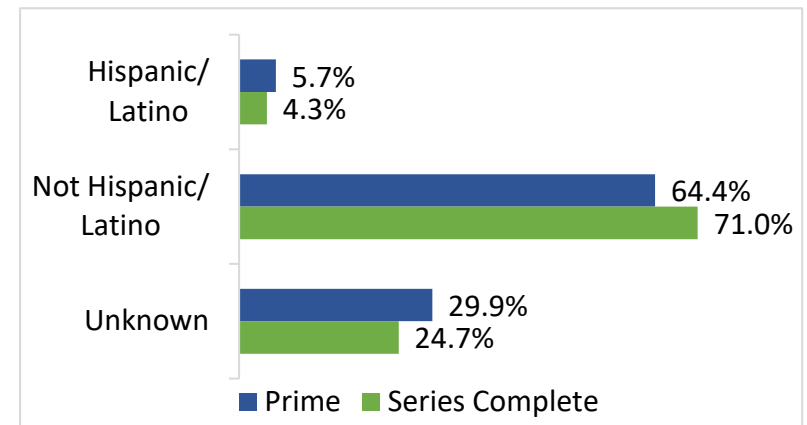
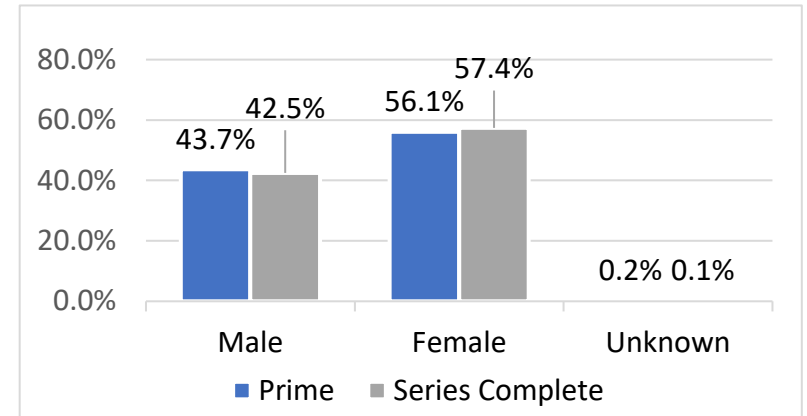

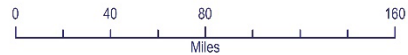

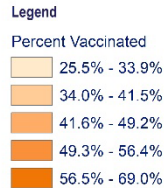

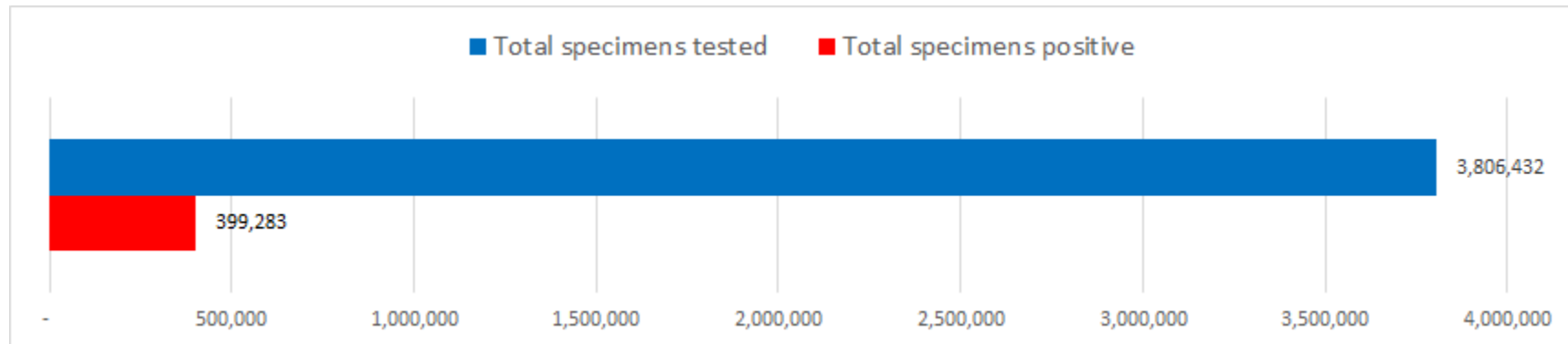

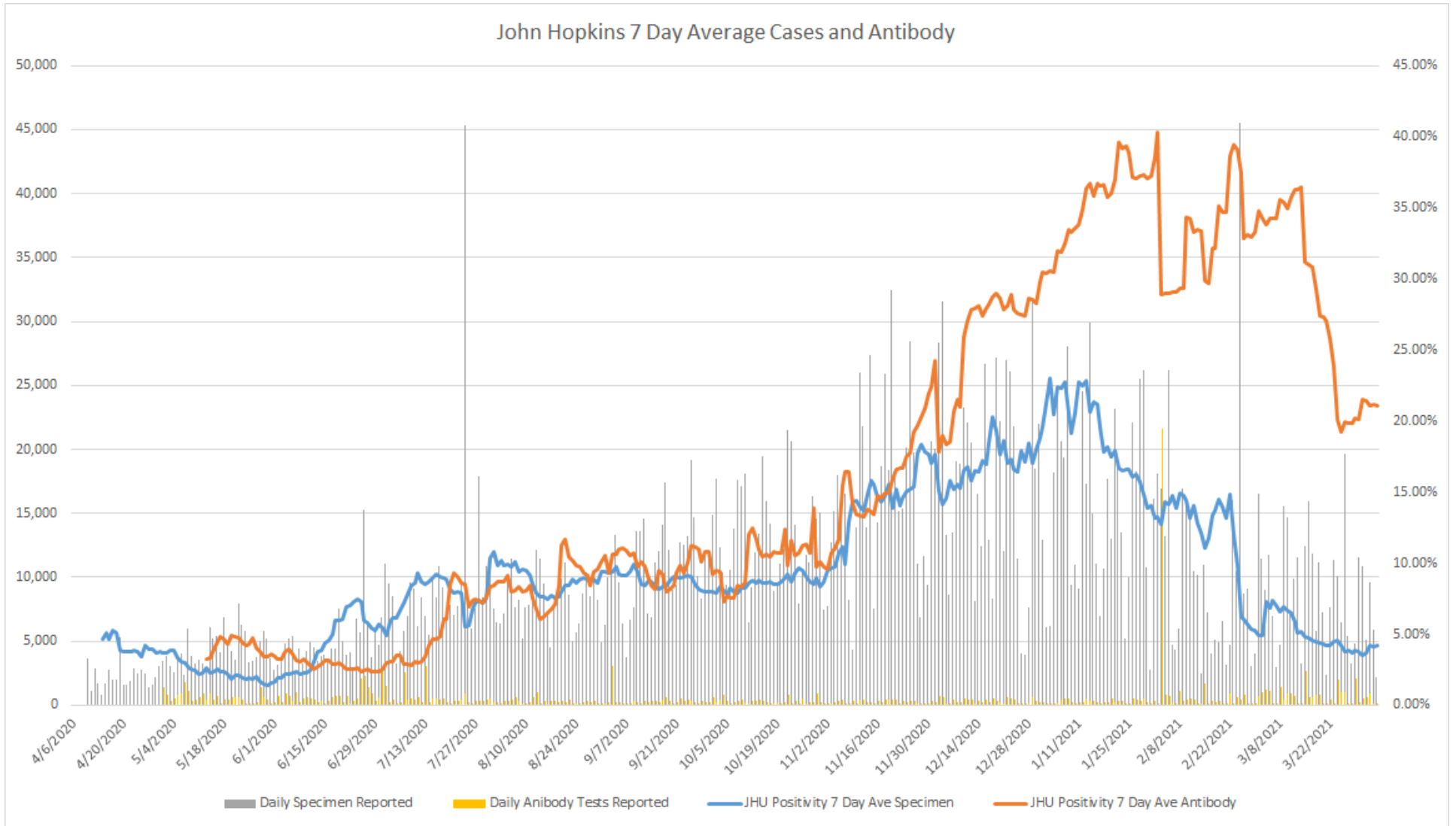

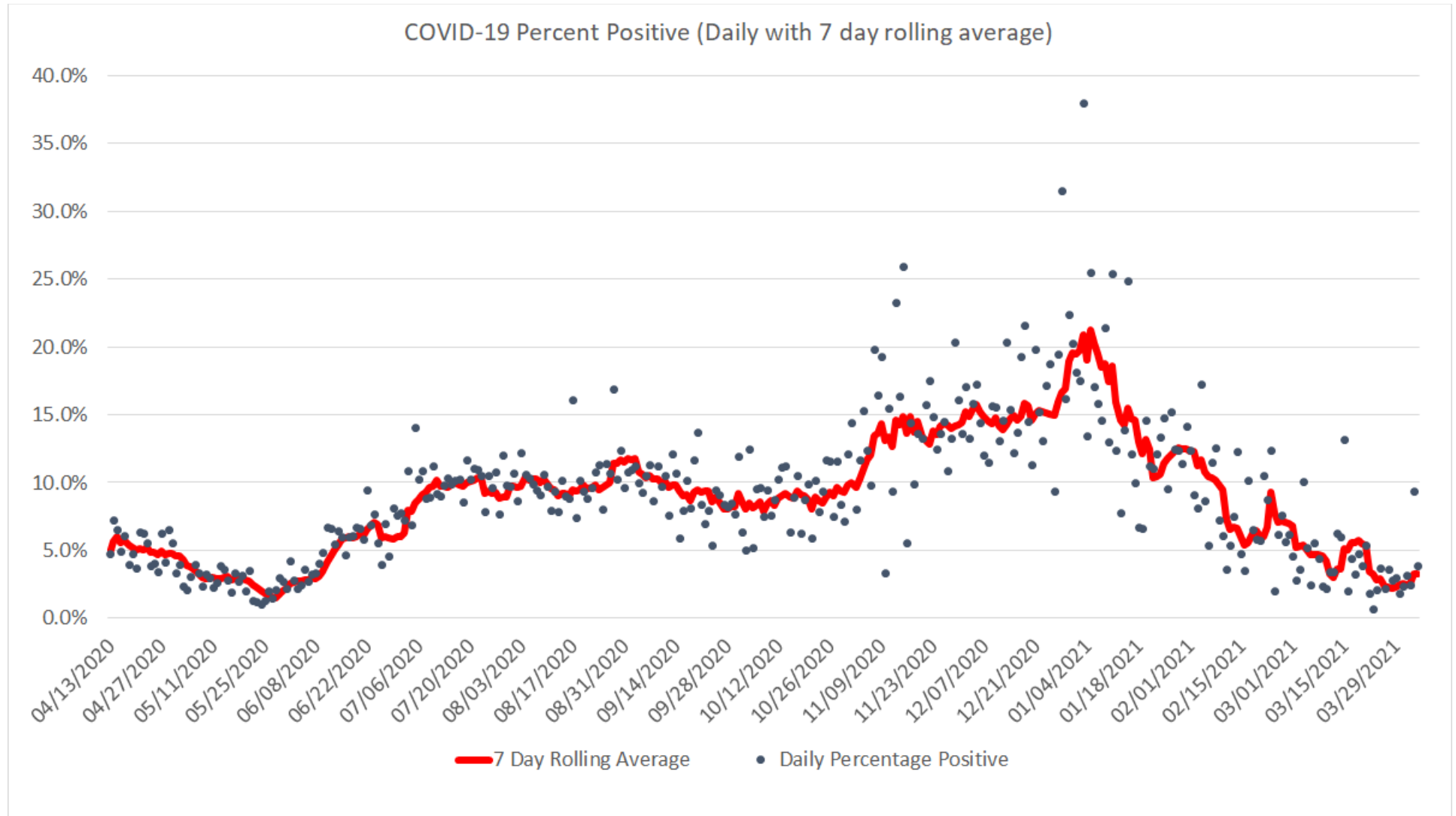

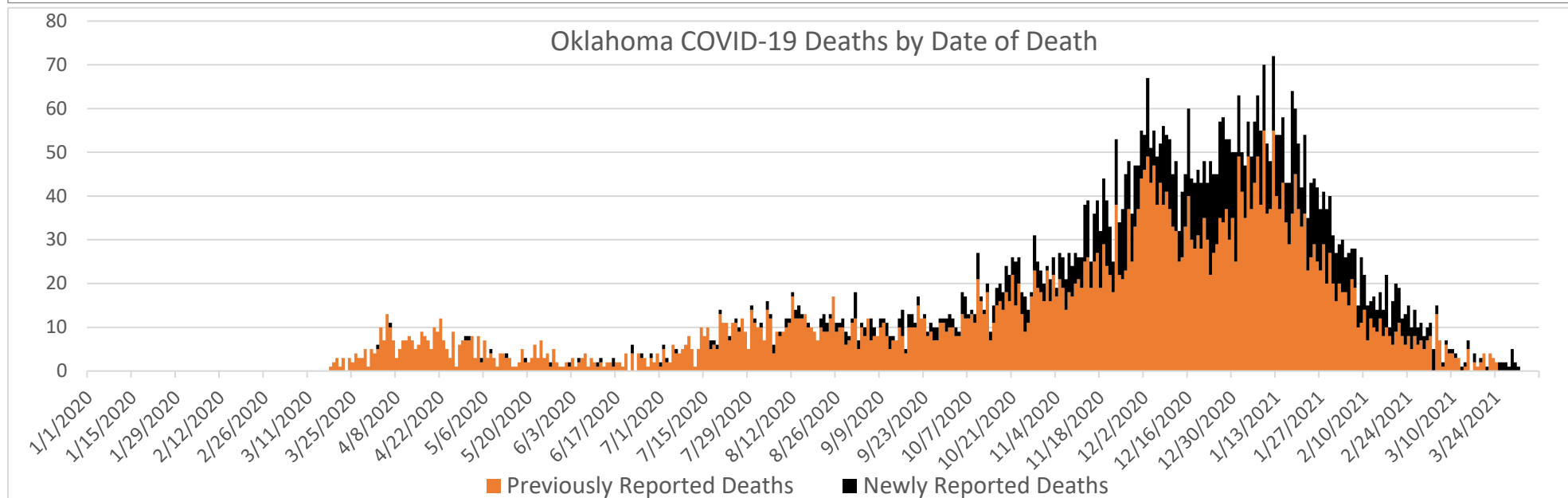

Case-fatality risk (crude)	1.5%	The estimate is not adjusted for the lag time from reporting to death (i.e., delay between the time someone dies and the time their death is reported). The fatality estimate could be lower due to cases that were undiagnosed or had milder symptoms.
Cumulative Hospitalization rate (overall)	642.1 (per 100,000 persons)	About 642 people per 100,000 have ever been hospitalized for COVID-19 during this outbreak.

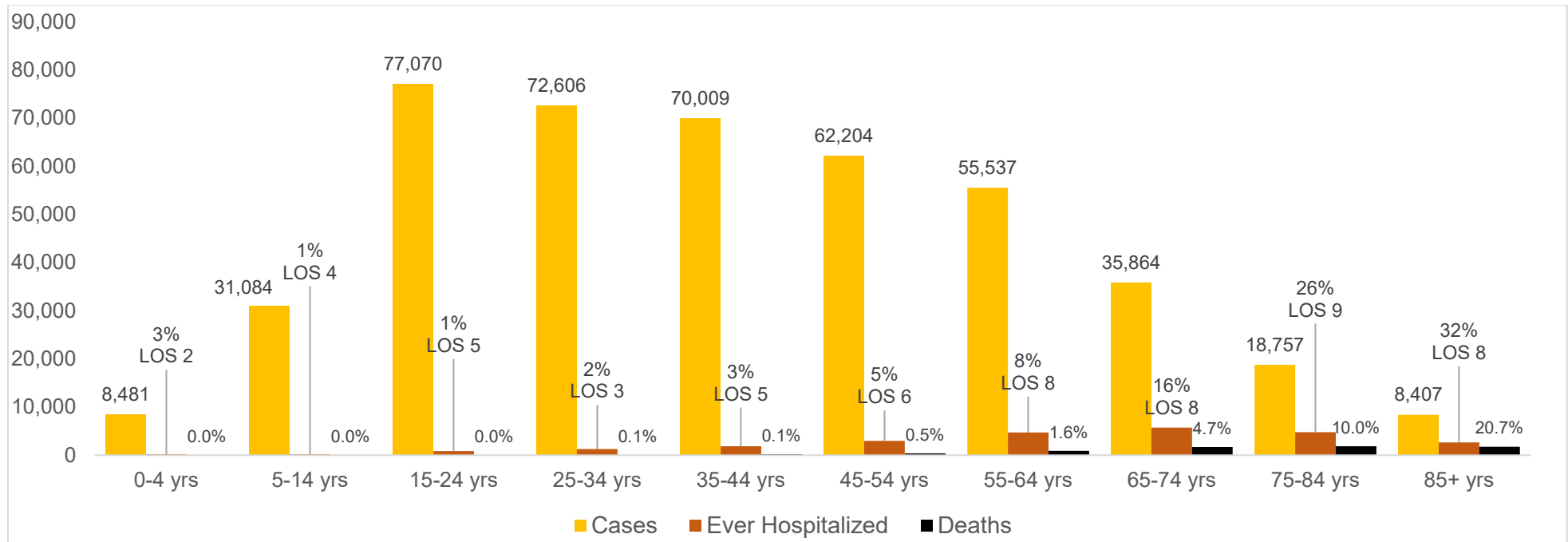

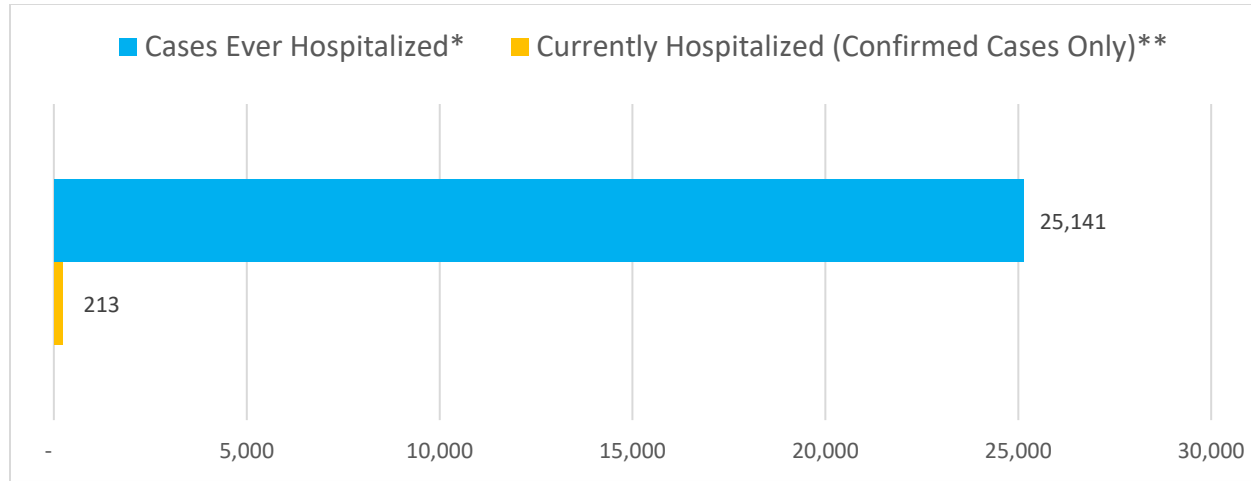

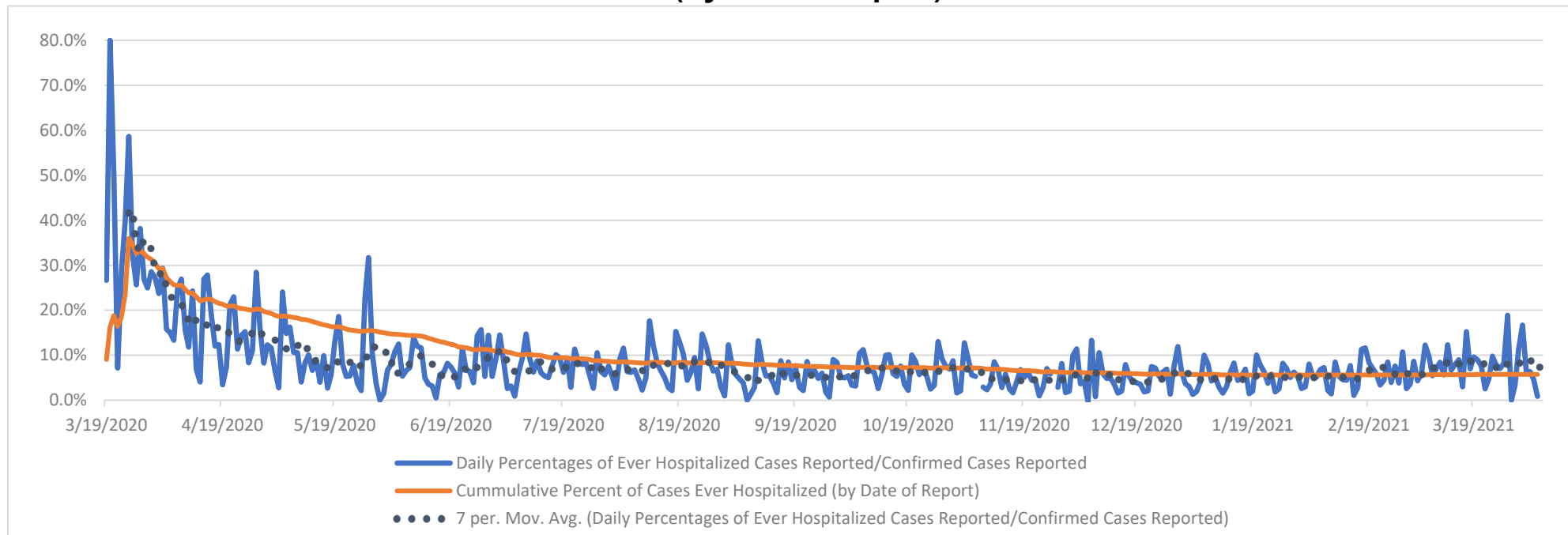

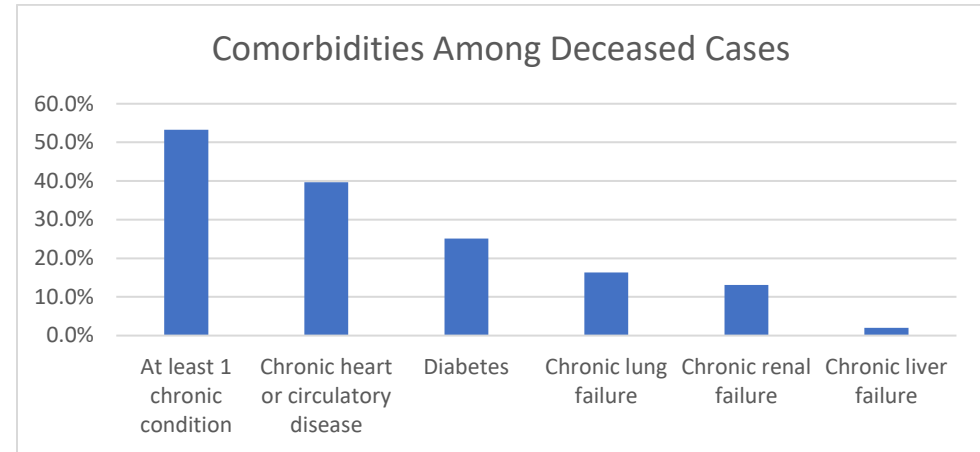

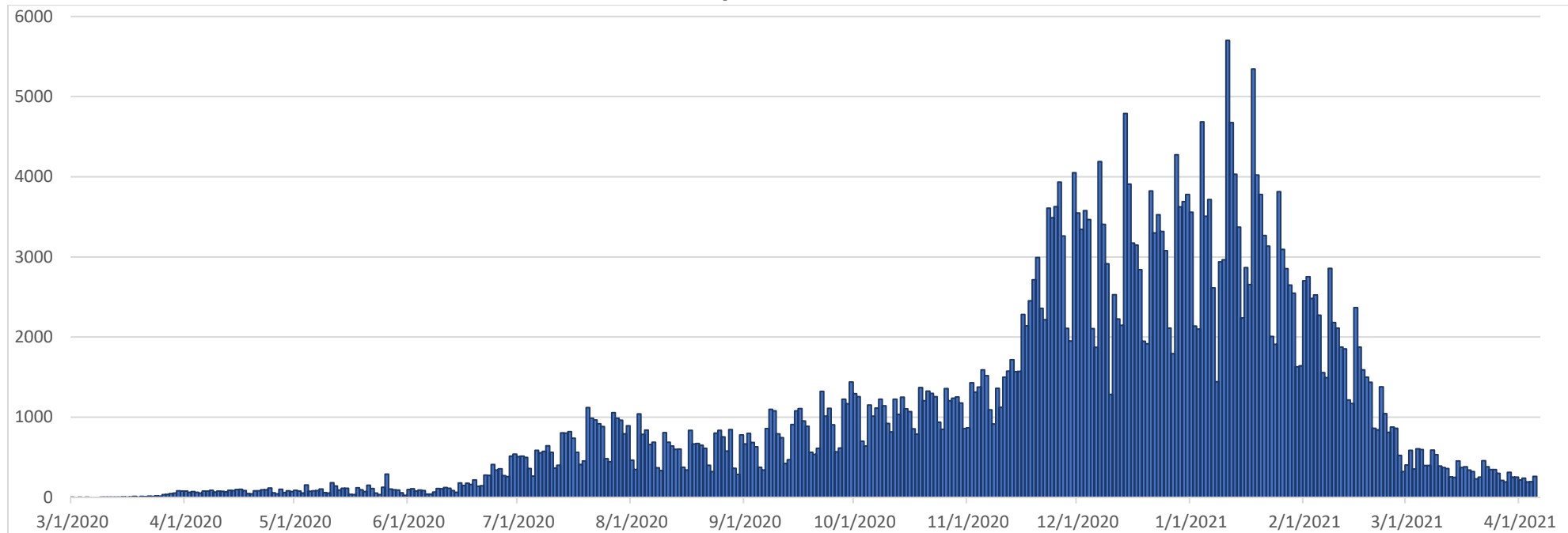

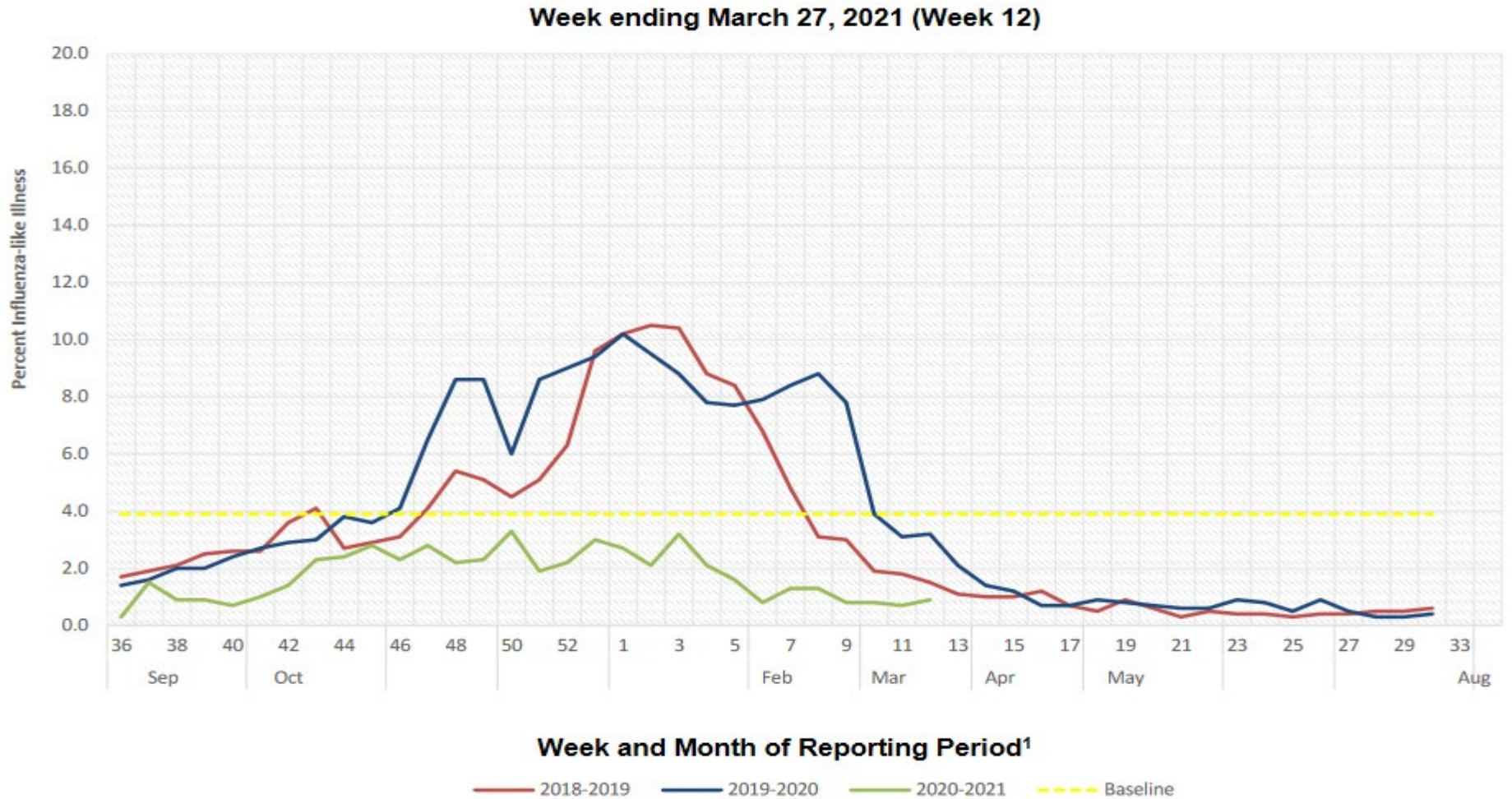
Distribution of recovered cases of COVID-19, March 2020 – April 2021, Oklahoma

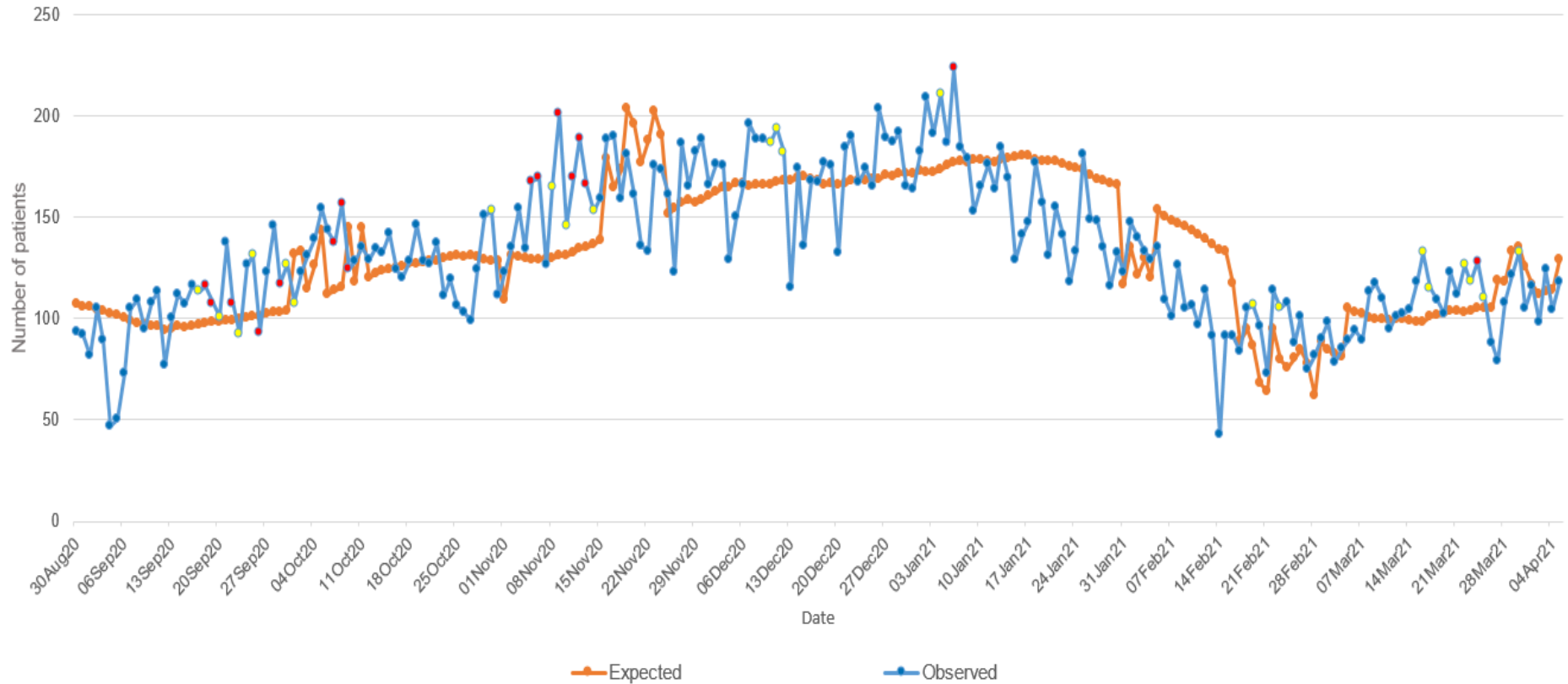

August 30, 2020 – April 05, 2021

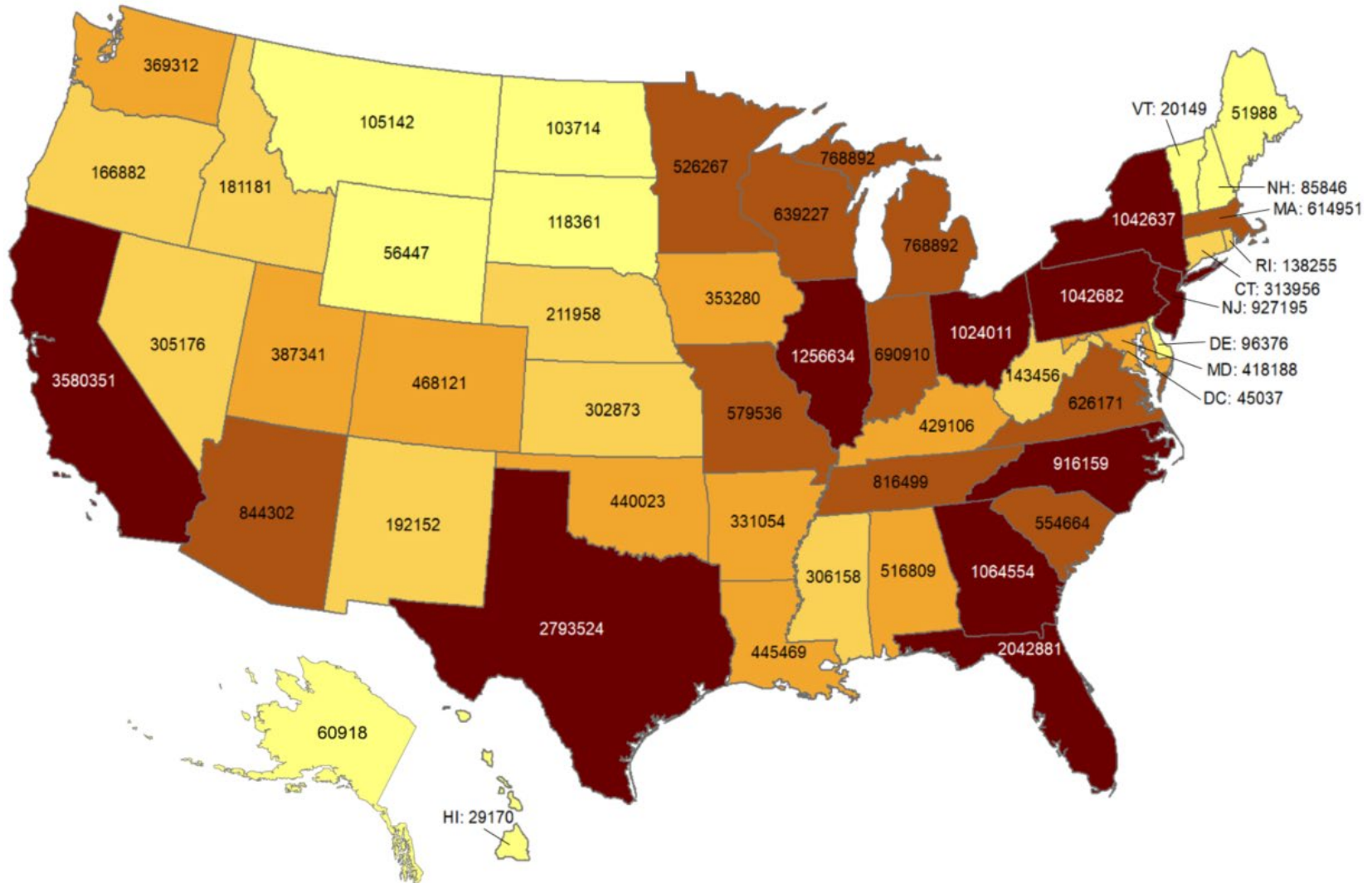

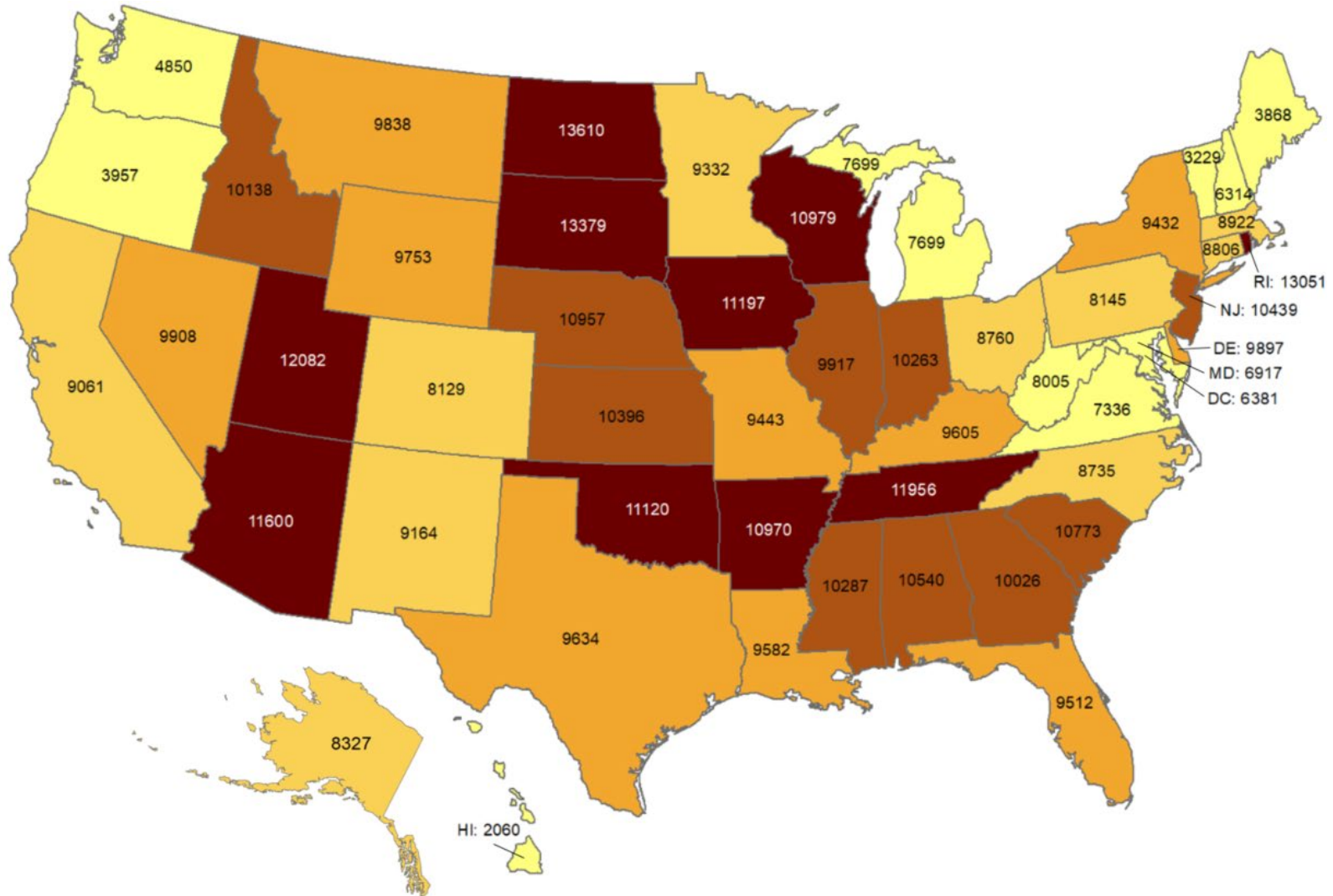

Cumulative incidence of reported COVID-19 cases

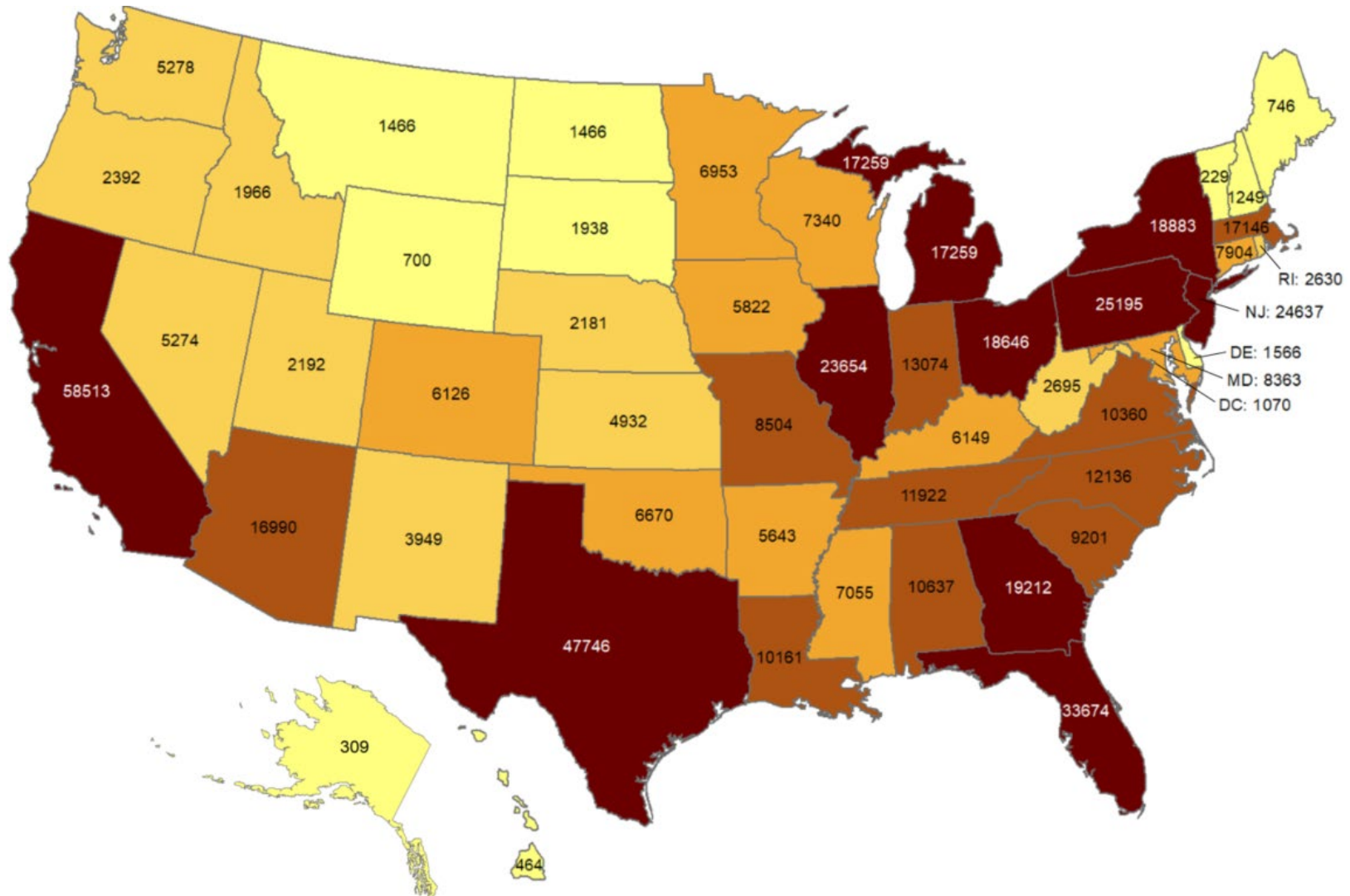

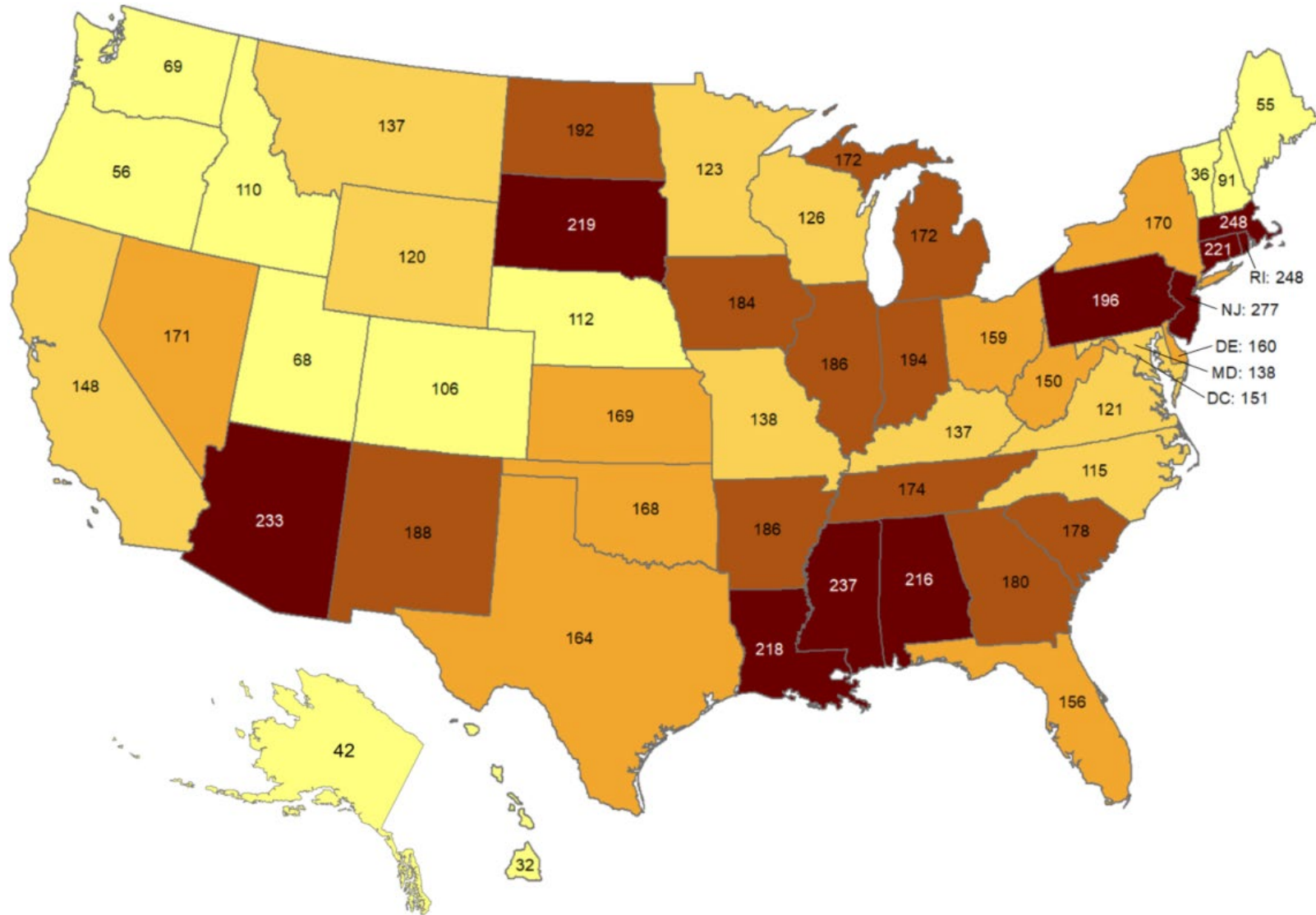

Cumulative death rate of reported COVID-19 cases

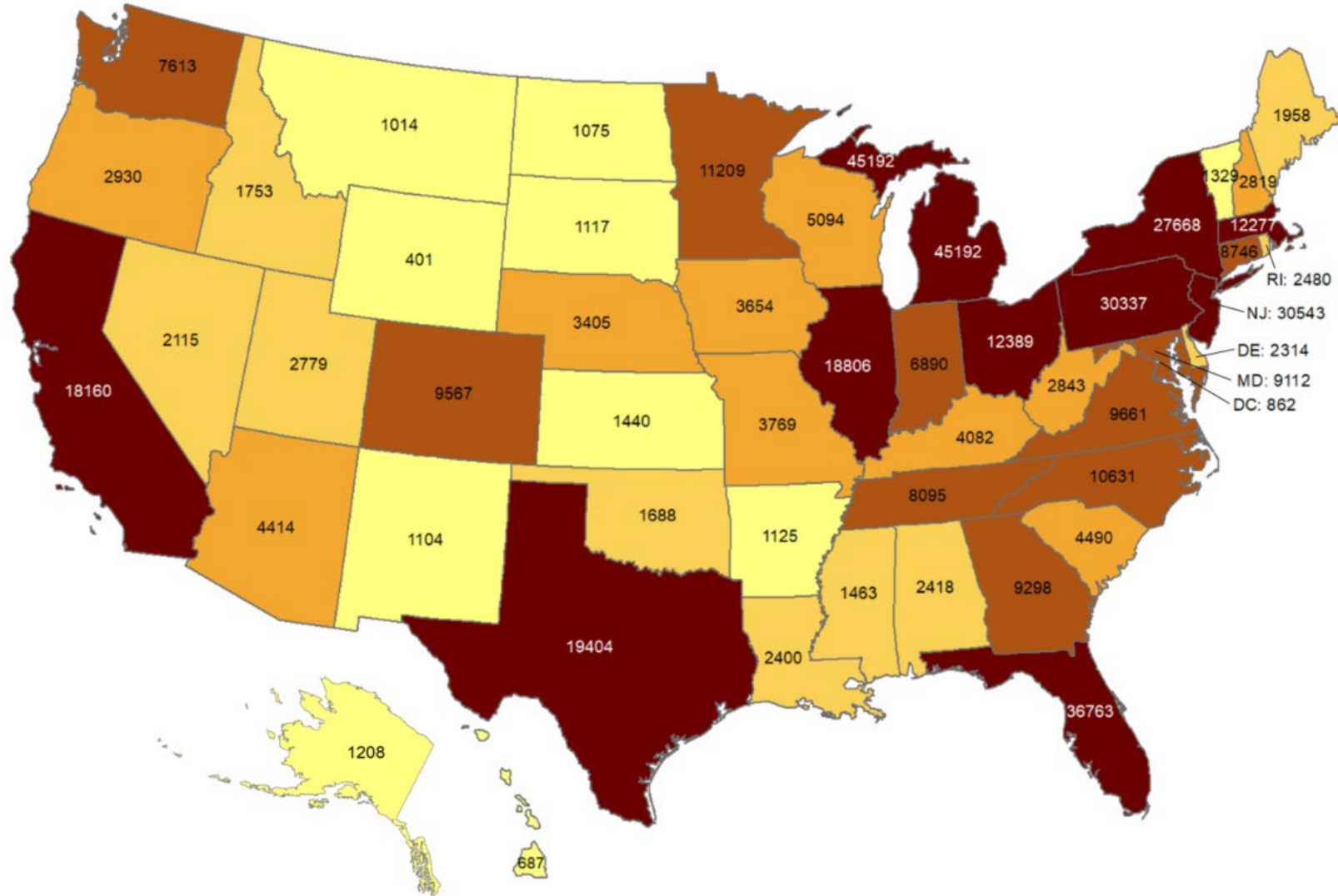

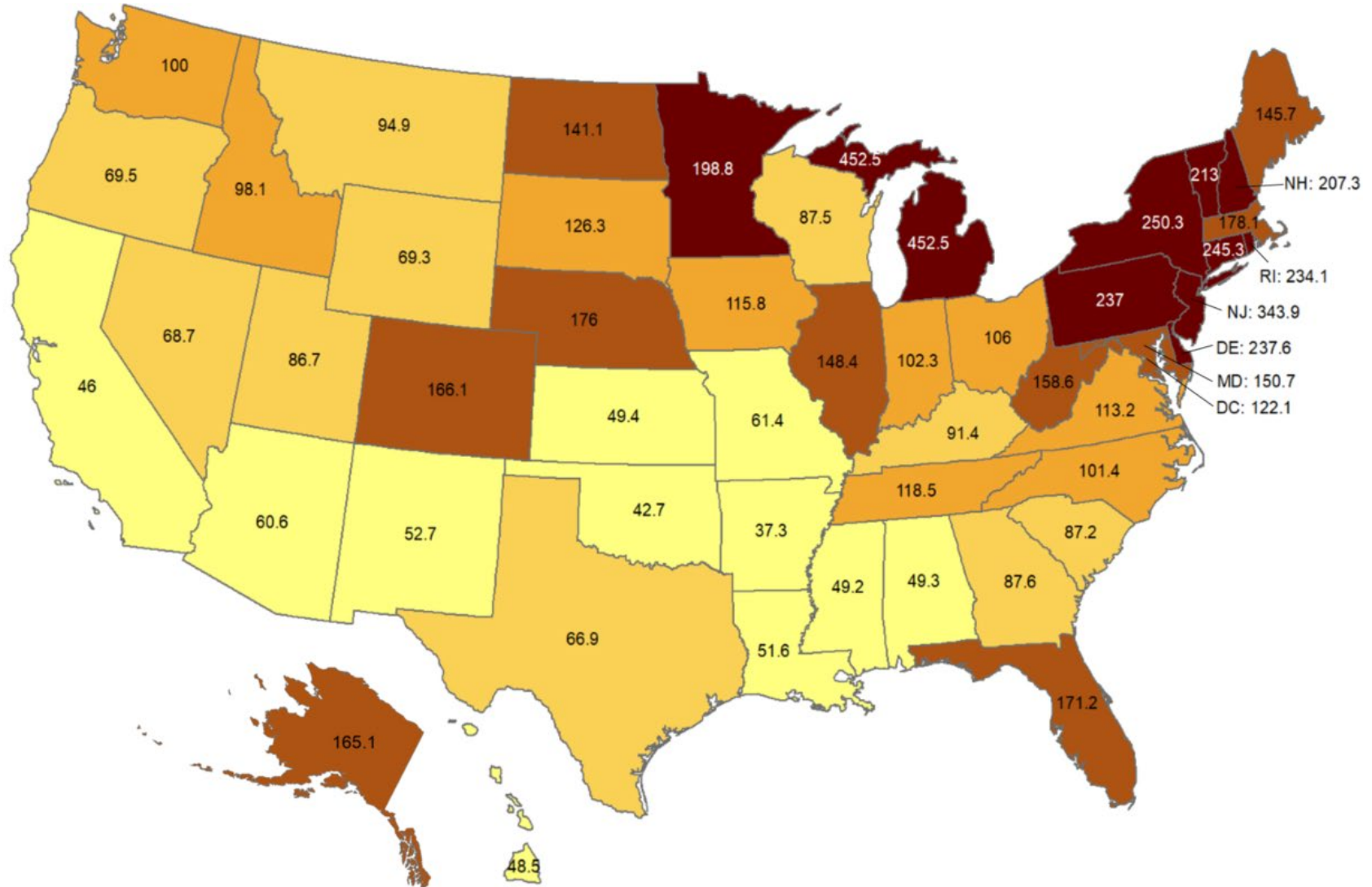

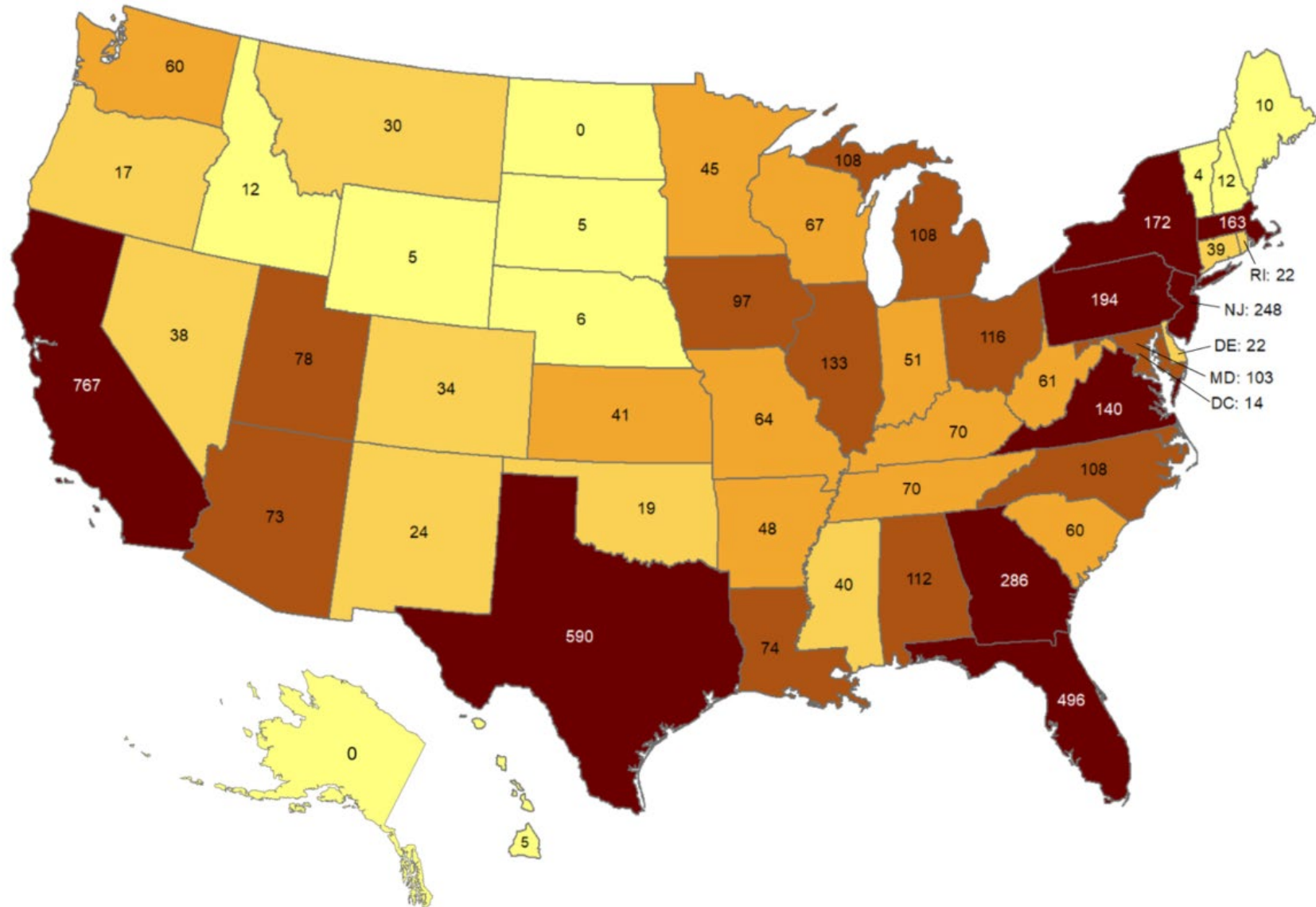

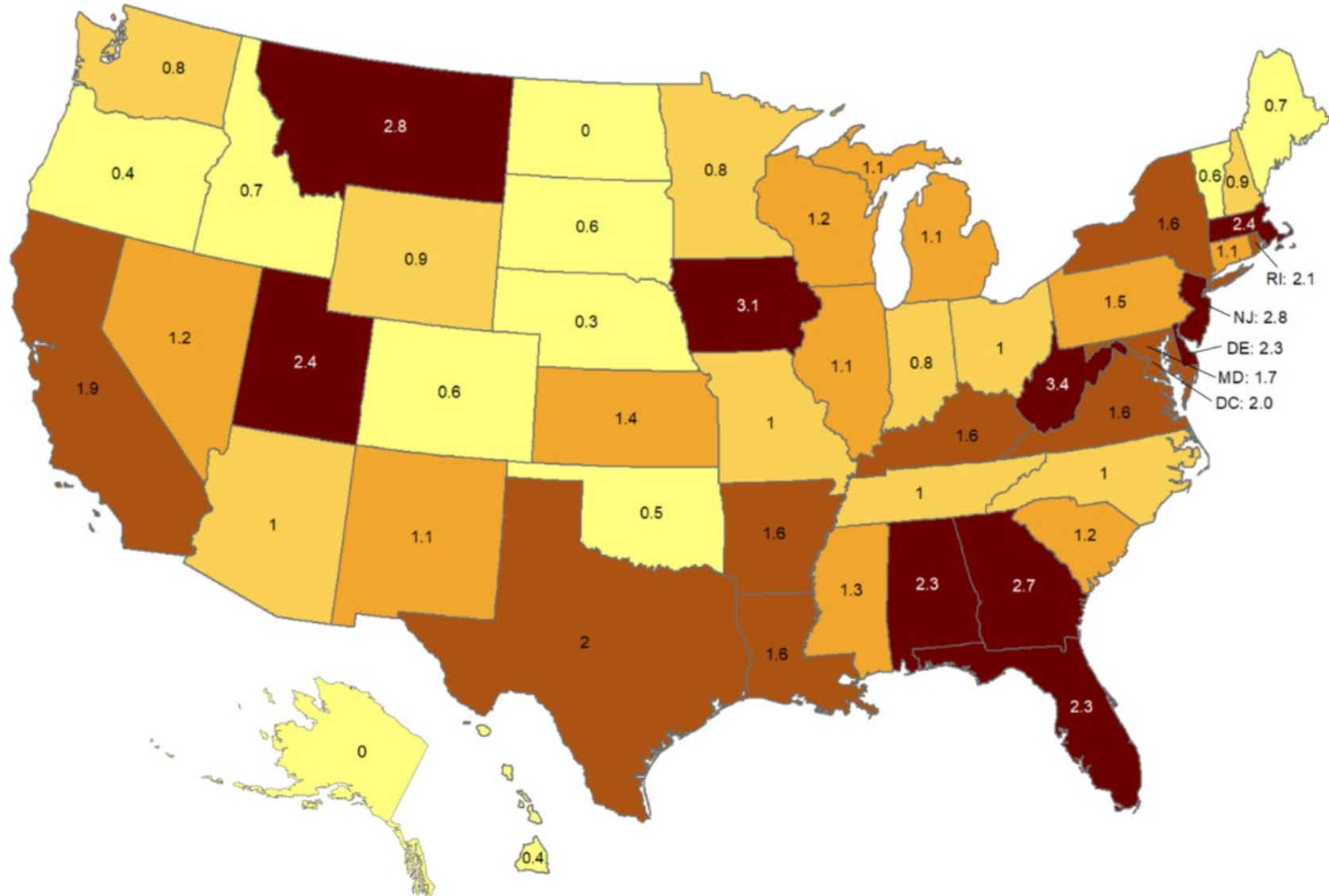

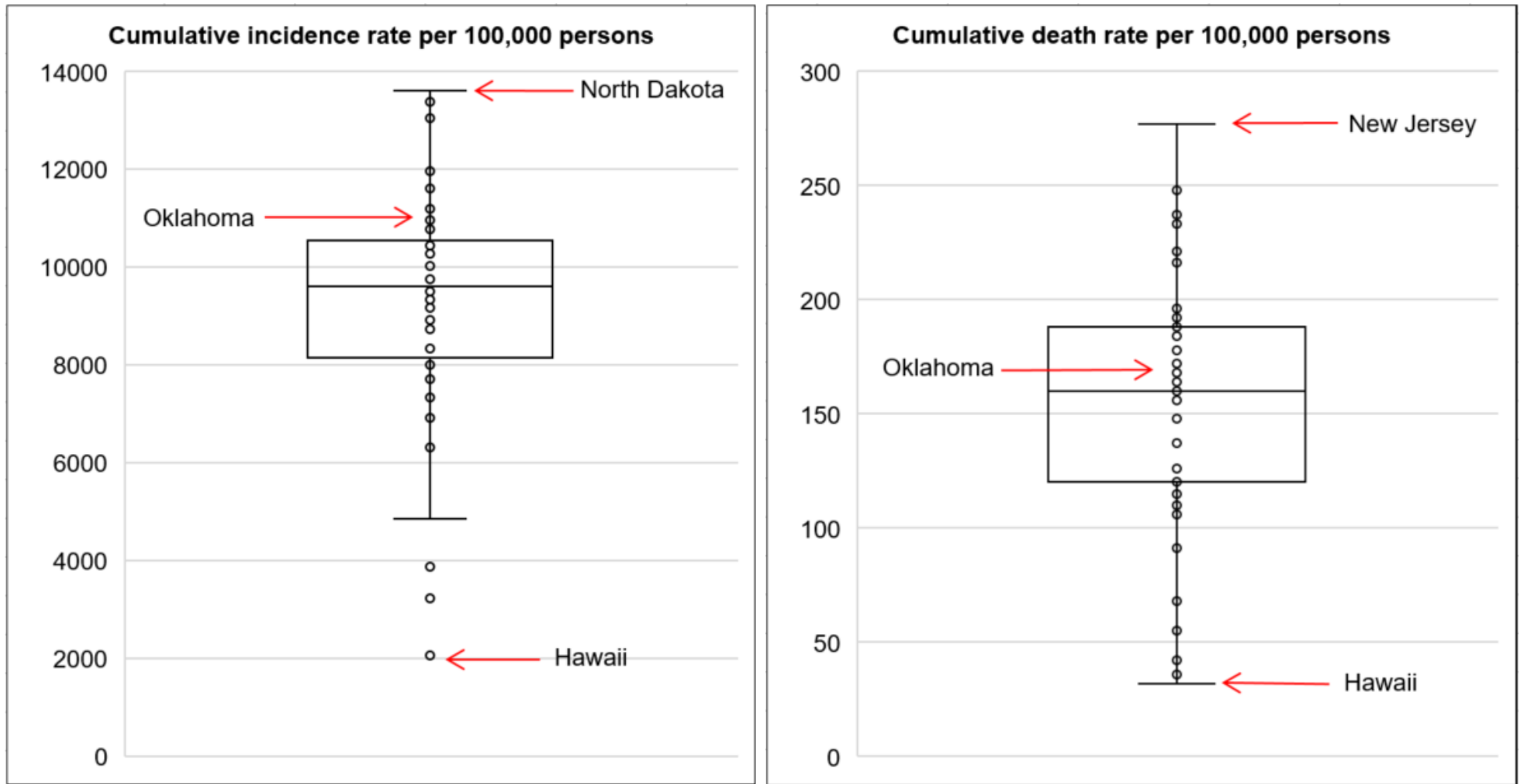

Weekly number of deaths (from all causes)

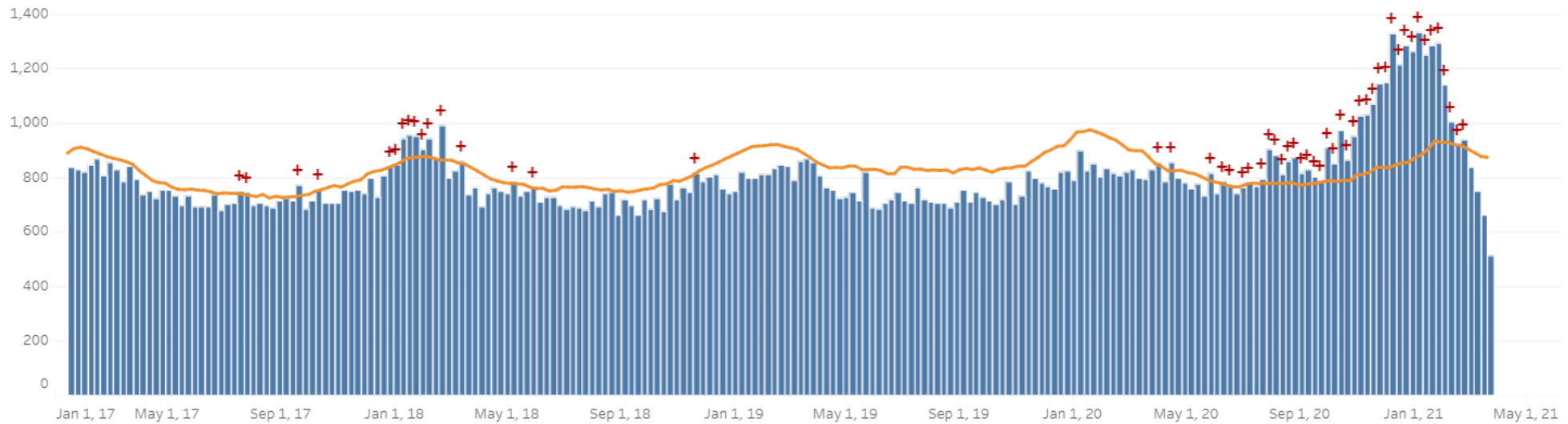
