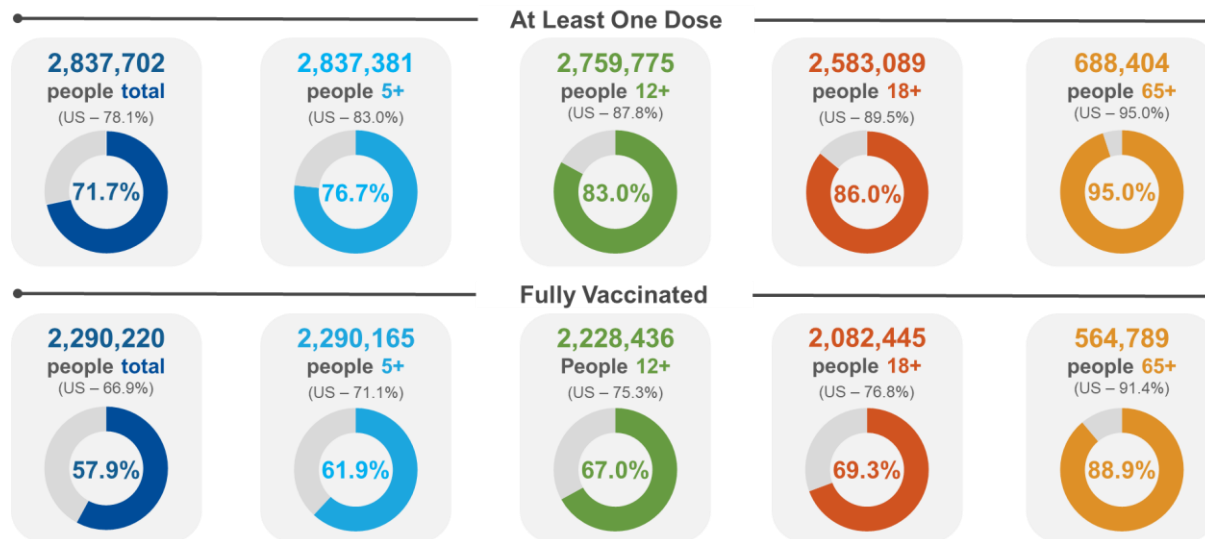

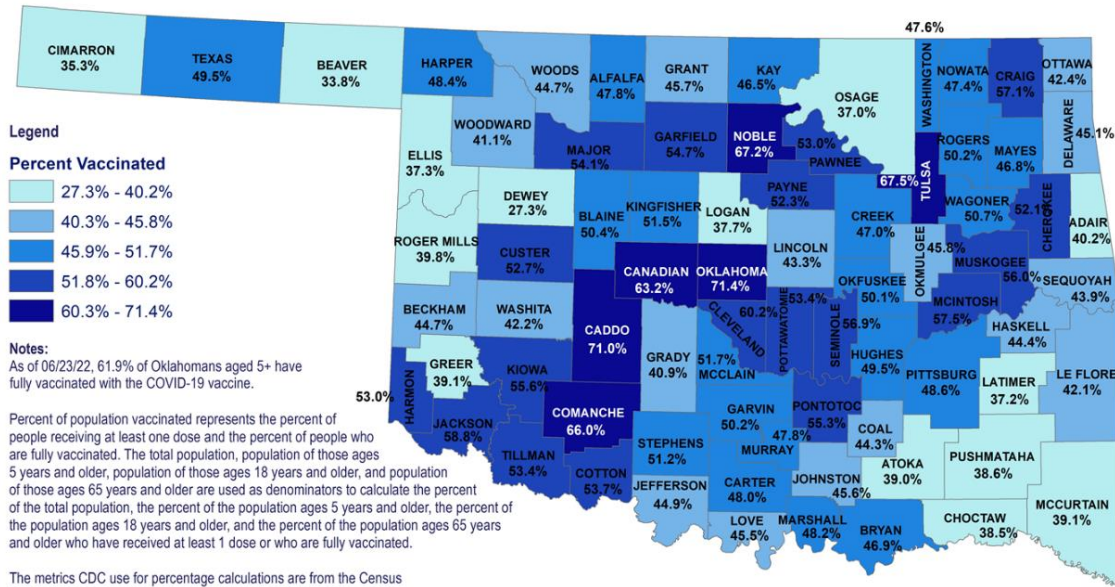

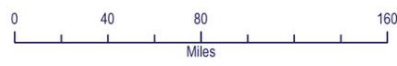

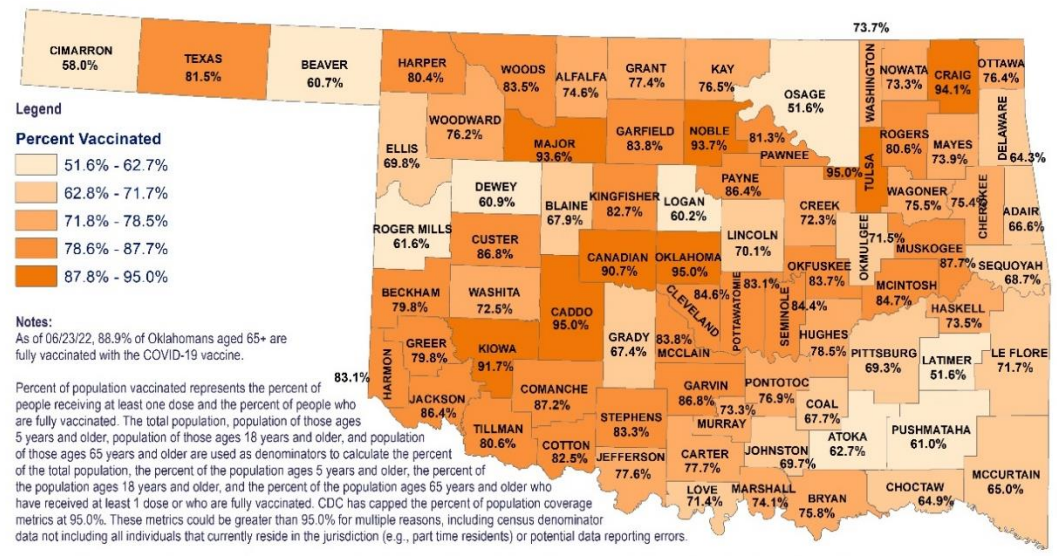

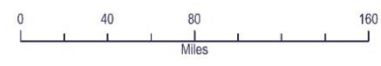

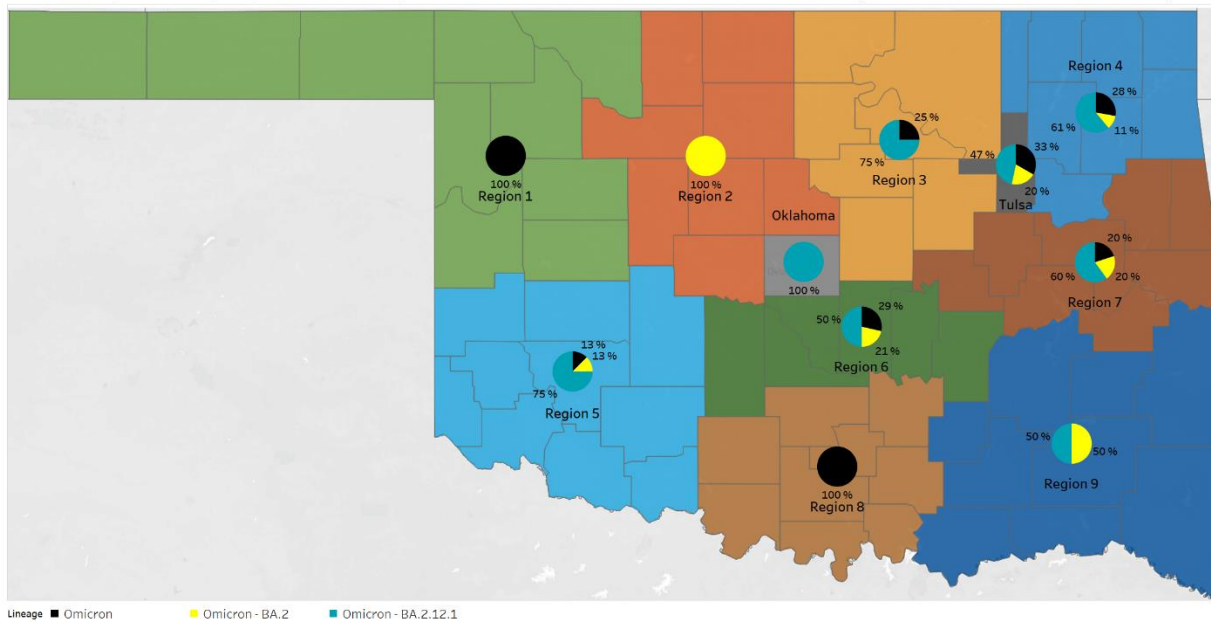

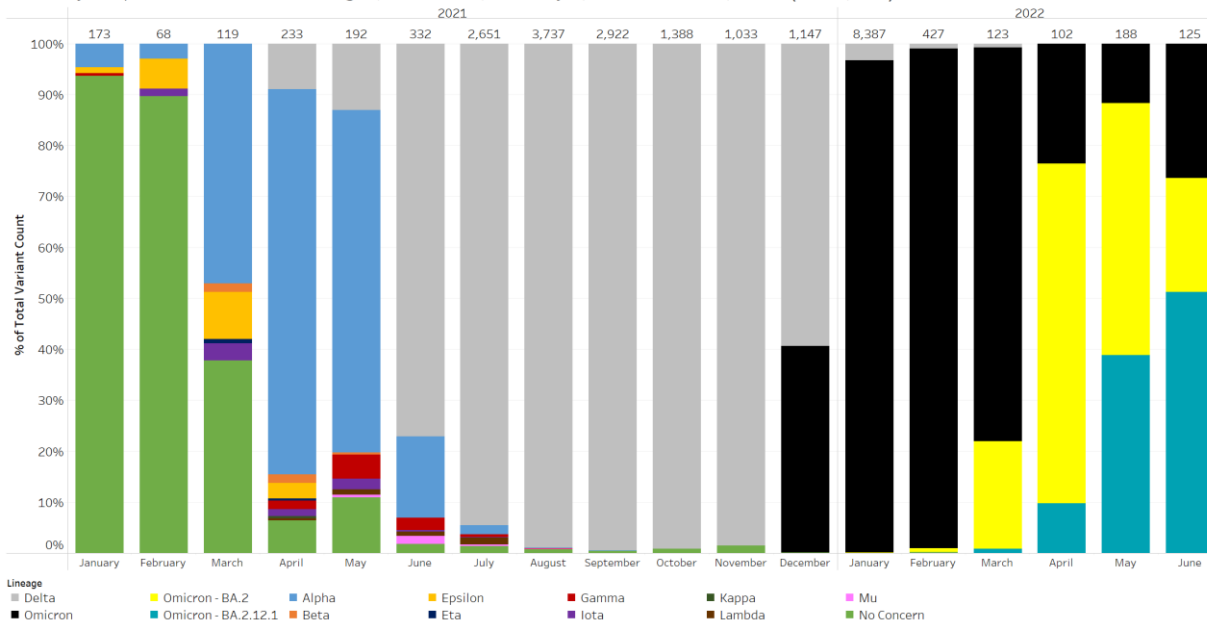
COVID-19 VARIANT STRAINS SEQUENCED*

Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2021 - June 27, 2022 (N=23,347)



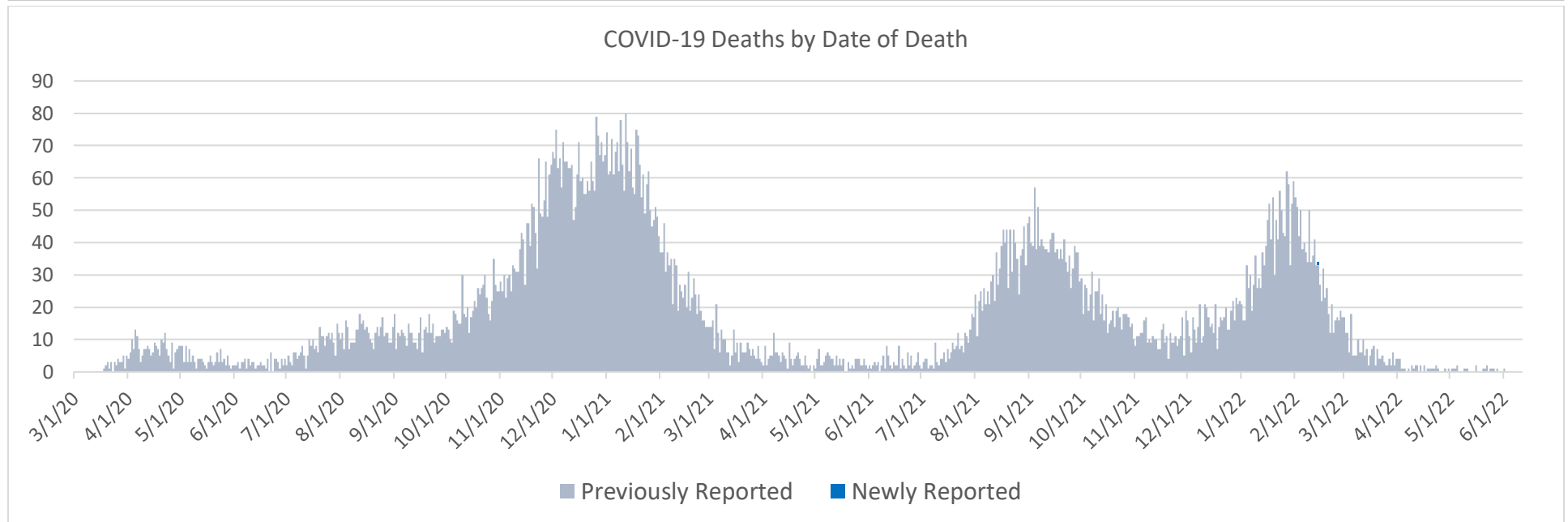
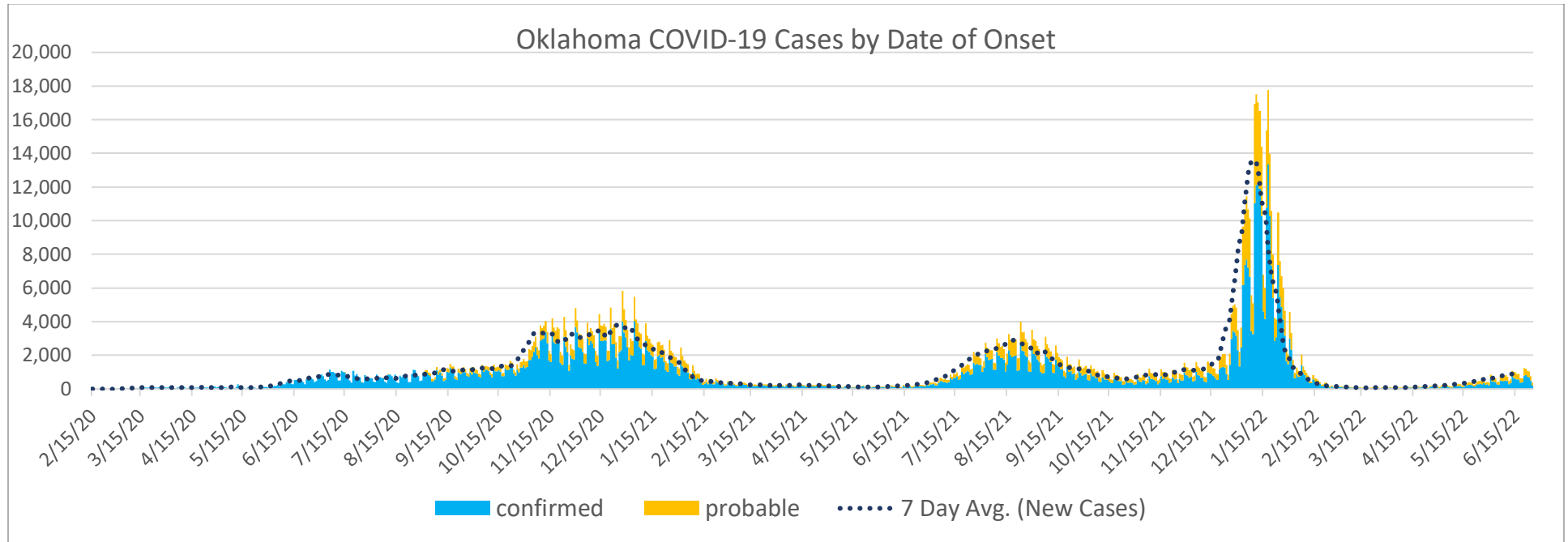

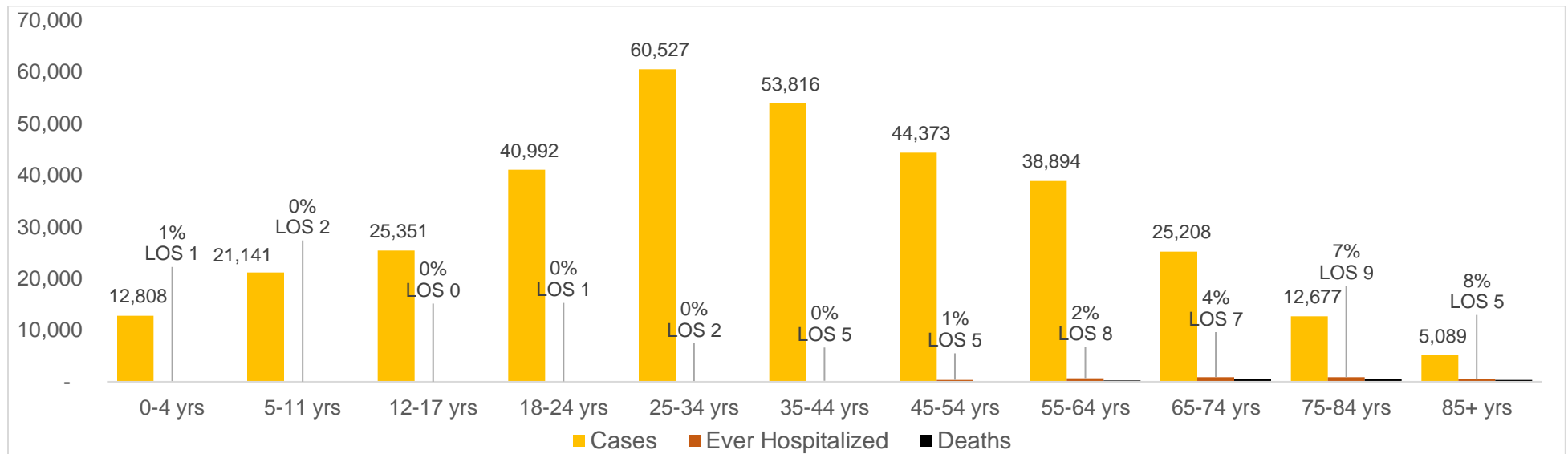

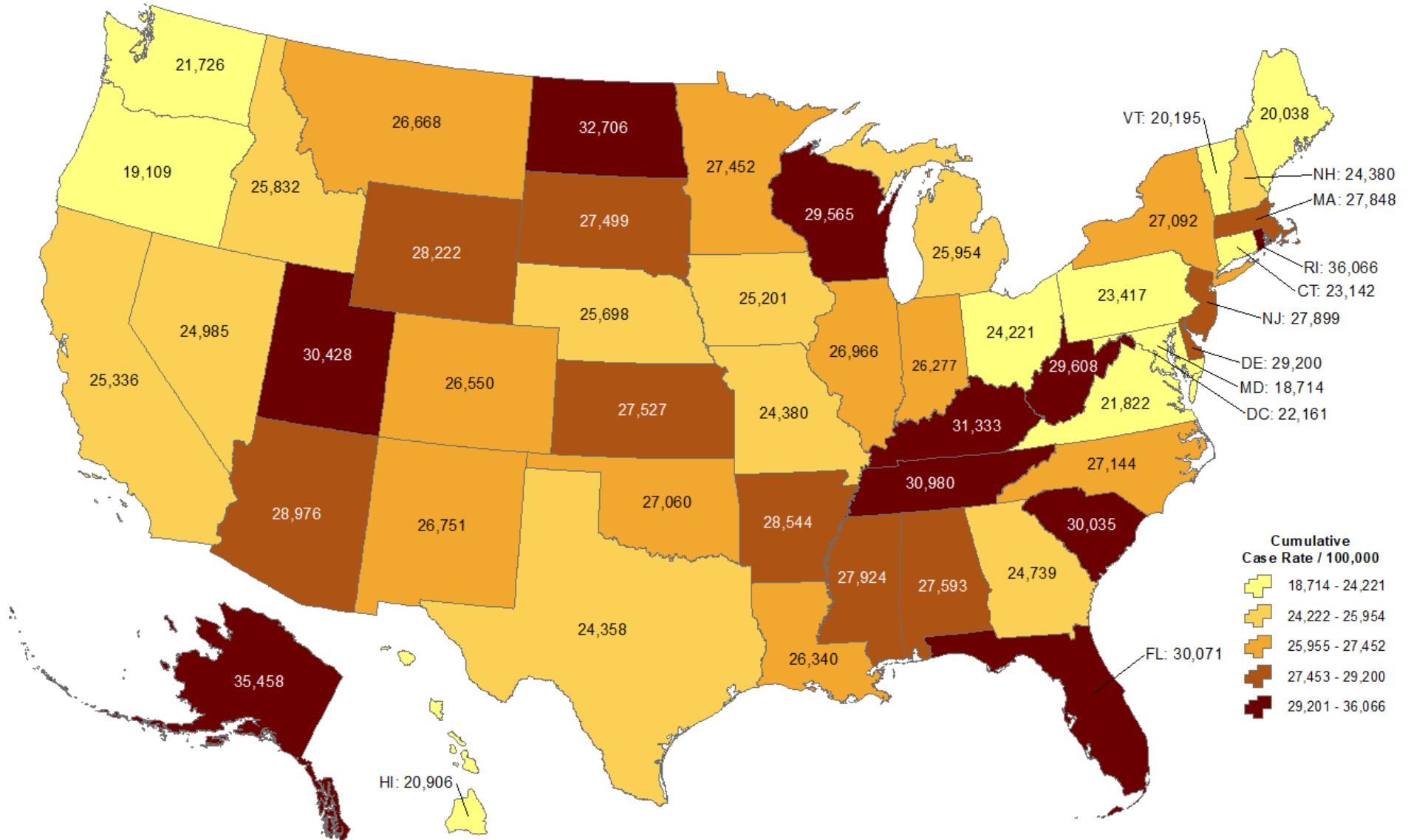

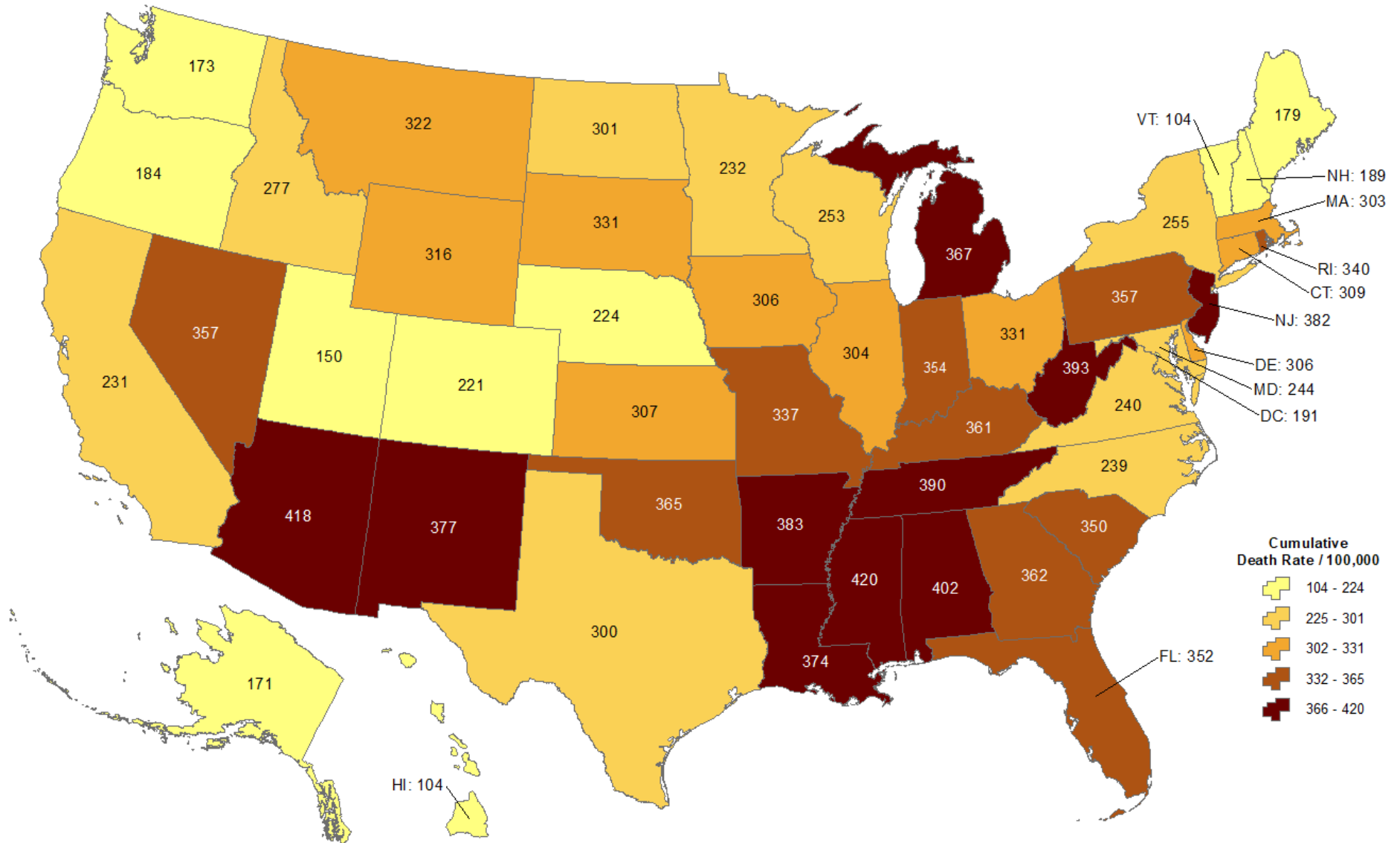

Cumulative death rate of reported COVID-19 cases

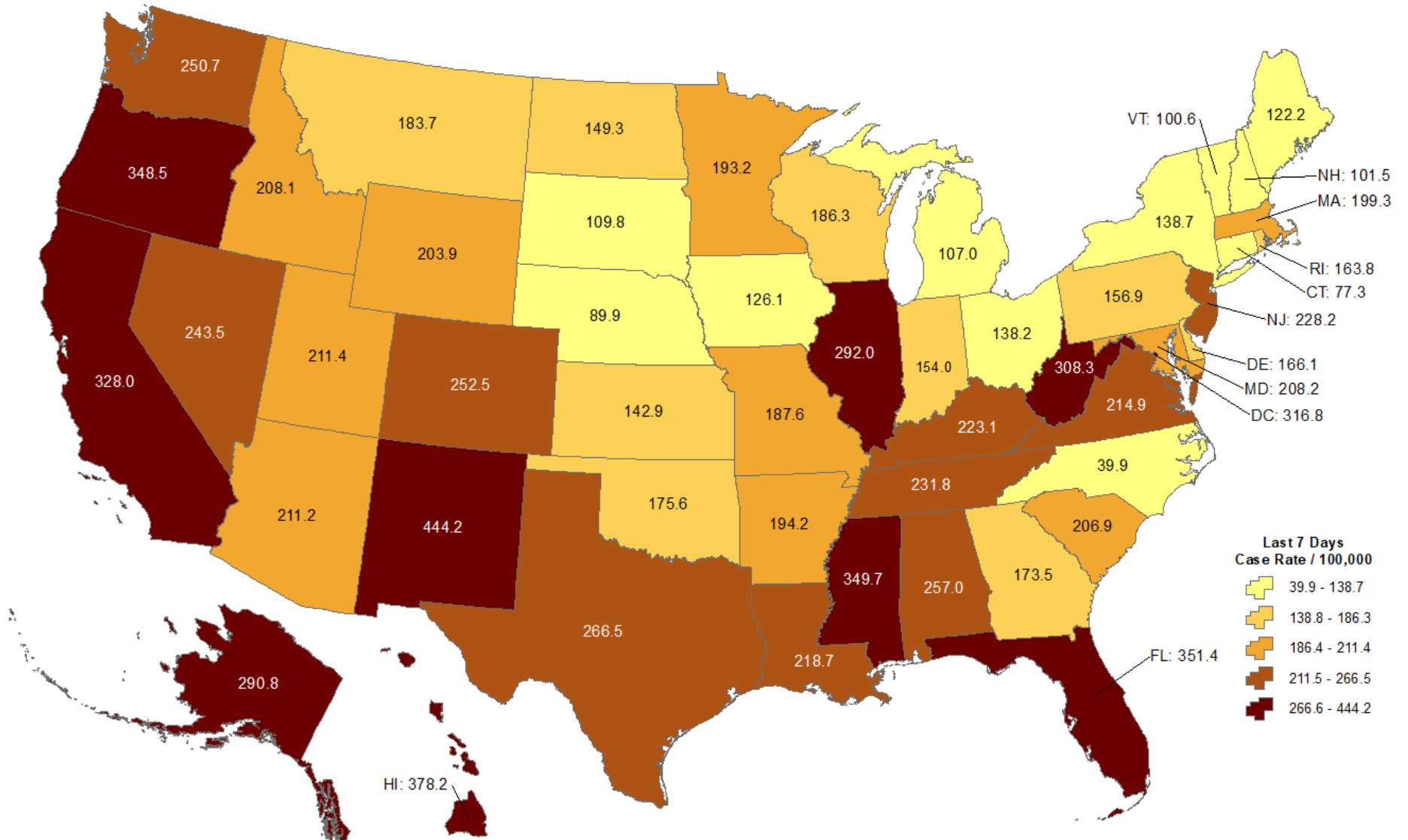

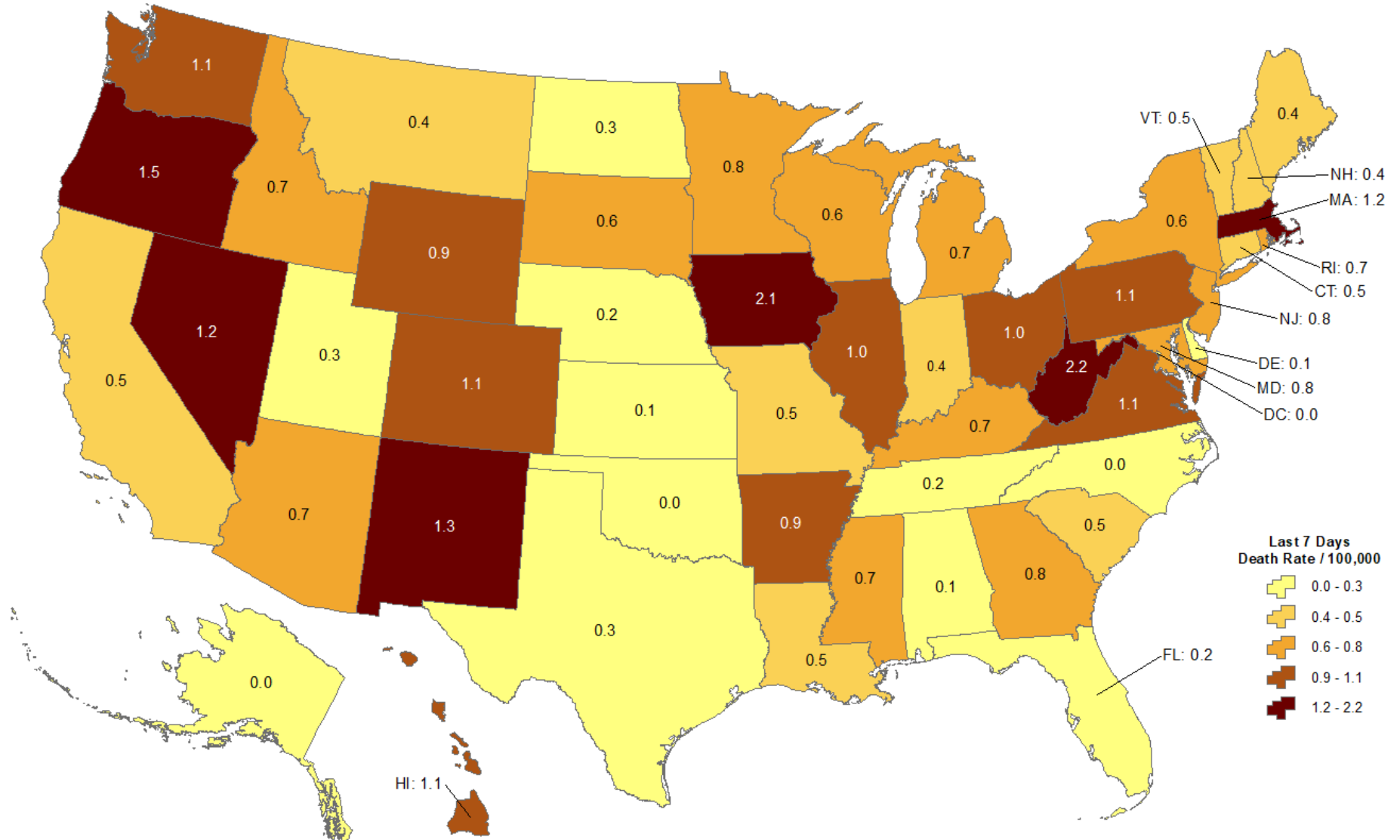

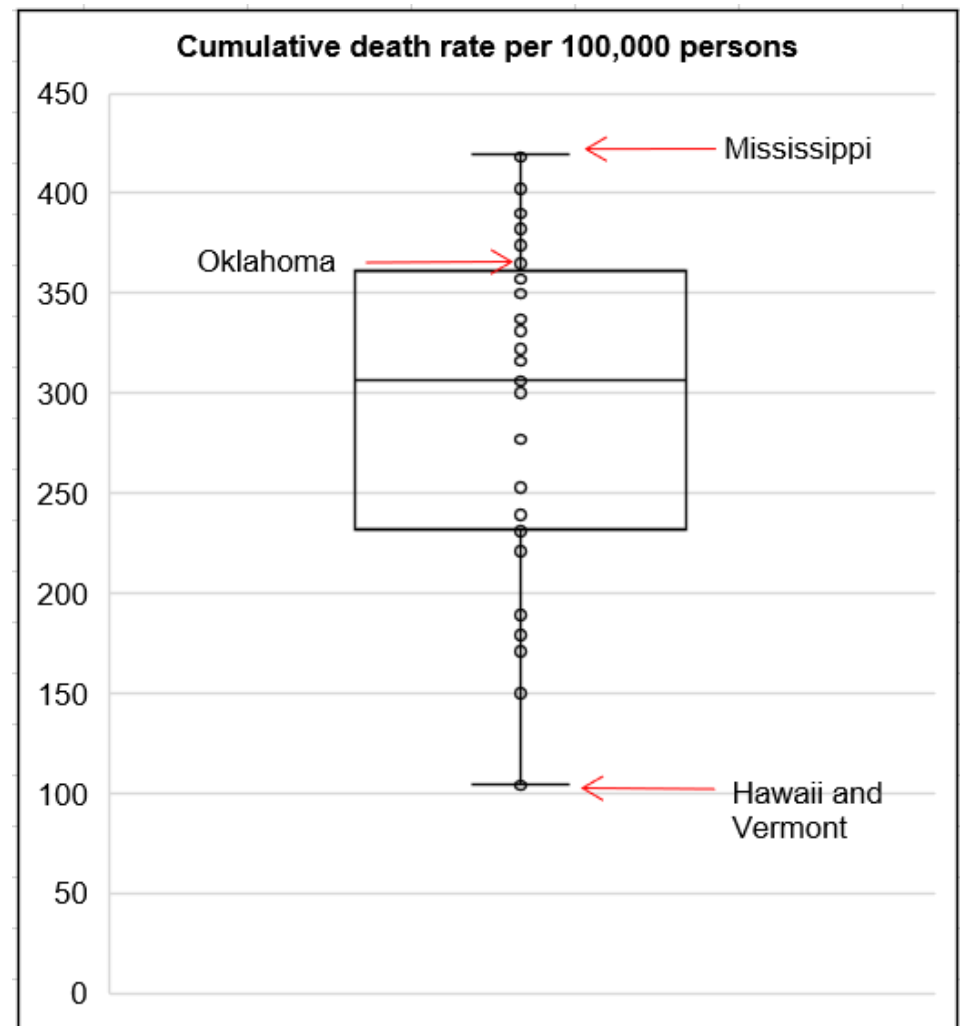
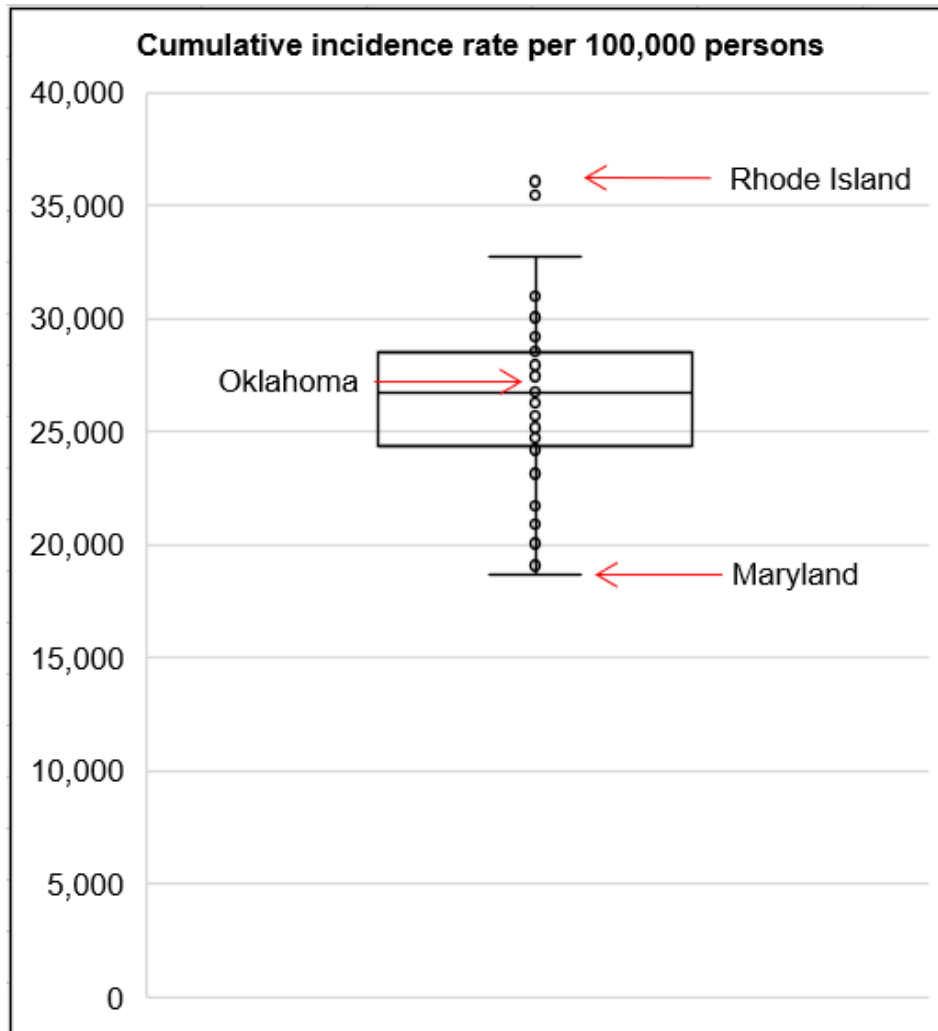

Weekly number of deaths (from all causes)

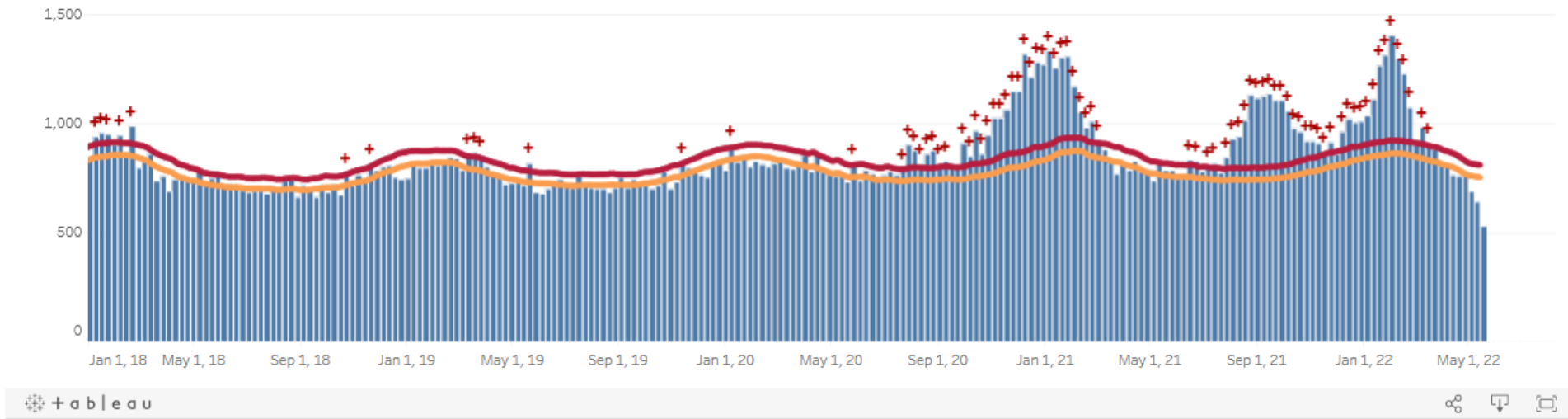

* On June 6, 2022, the National Vital Statistics System (NVSS) cause of death coding system began a system-wide upgrade, which required a temporary suspension of routine NVSS surveillance reporting. The upgrade required all 2022 death records to be reprocessed into the system. As routine NVSS surveillance reporting resumes, users may temporarily observe lower death counts for prior weeks in 2022 as the backlog is reprocessed and reloaded into the system. Data shown on this page may not be updated until the system upgrades are complete, anticipated around July 6, 2022.
