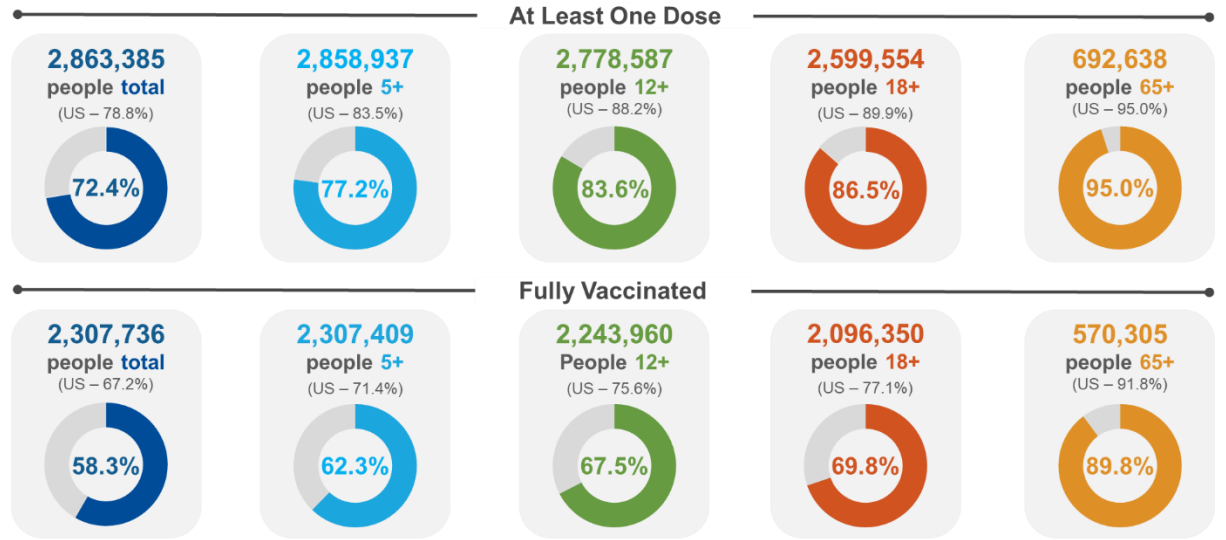

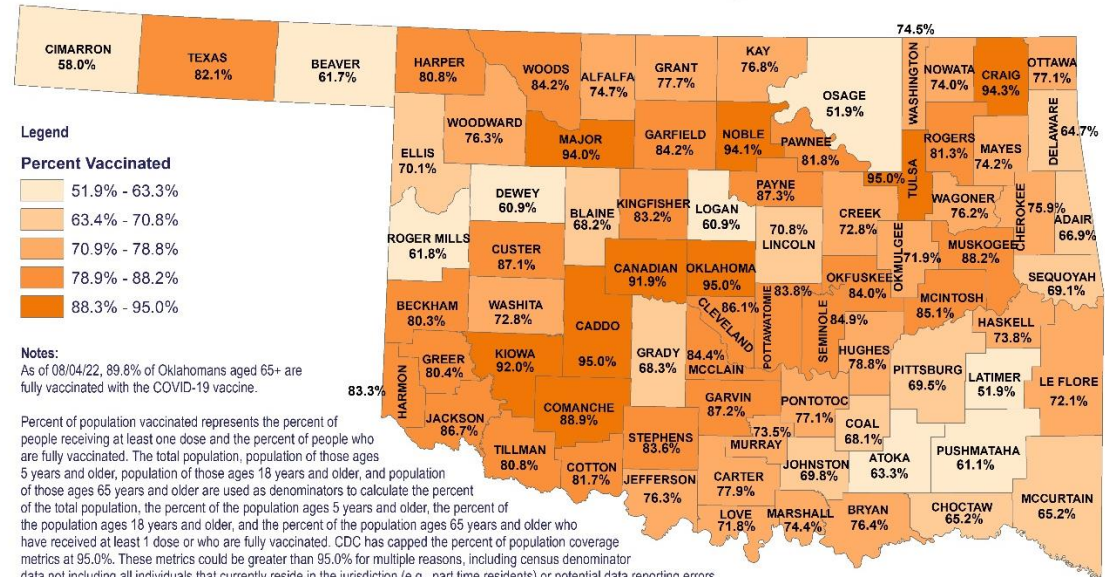

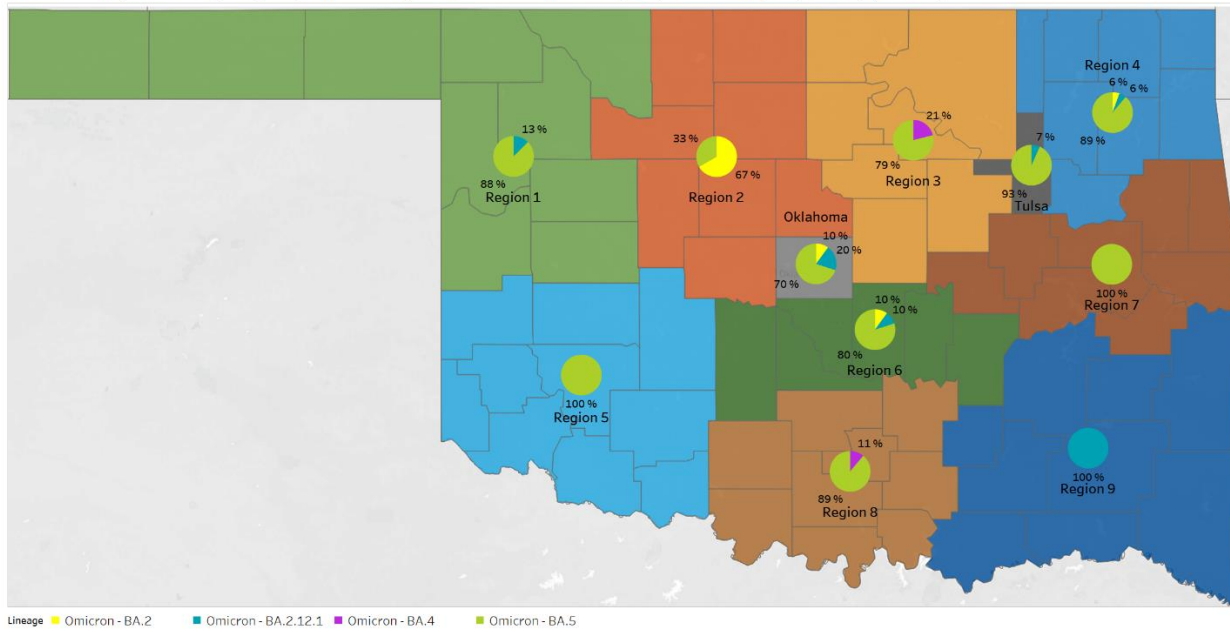

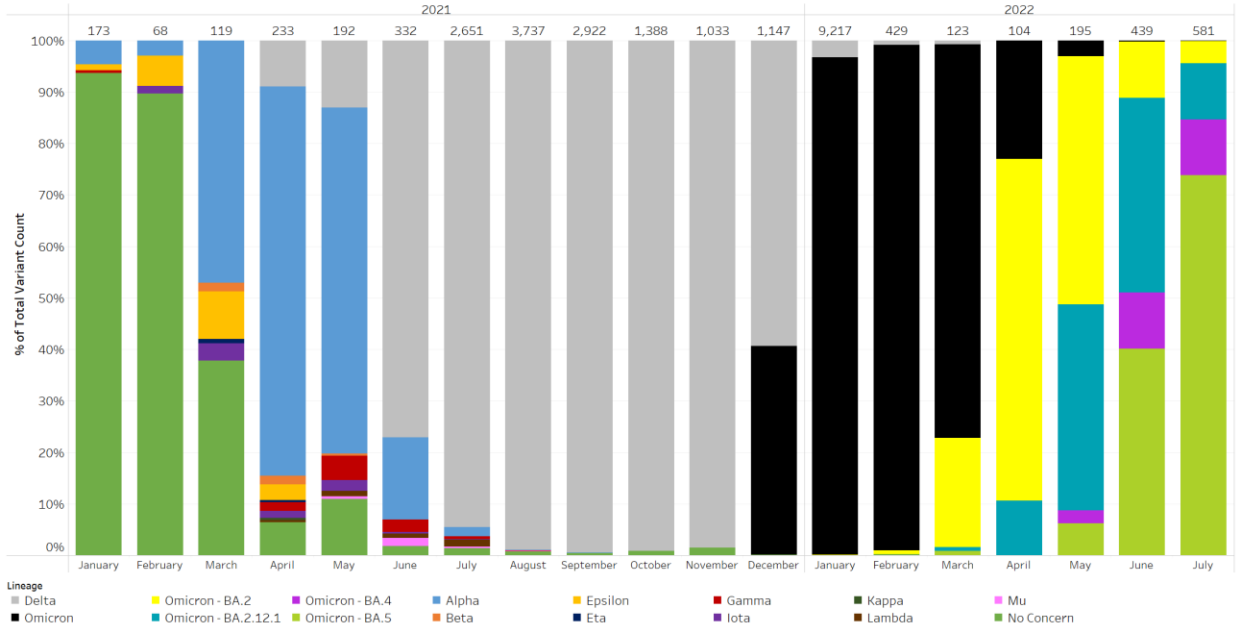
COVID-19 VARIANT STRAINS SEQUENCED*

Variant Proportions by Region, Dates of Specimen Collection: July 18, 2022 - July 27, 2022, (N=115):



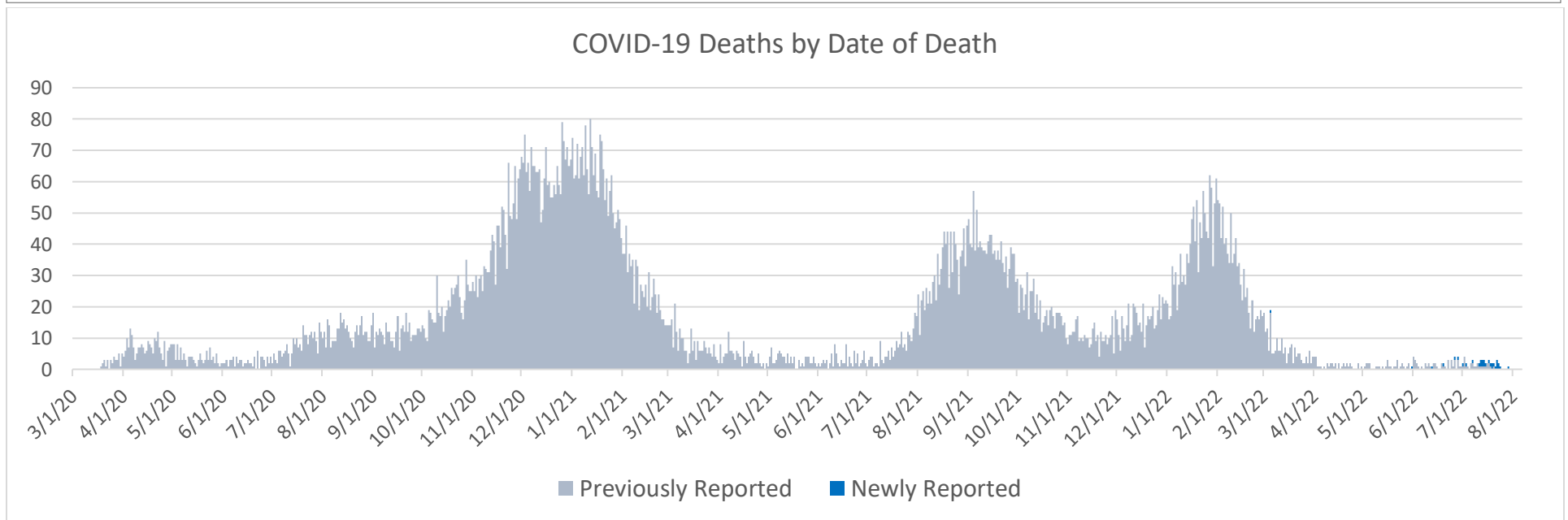
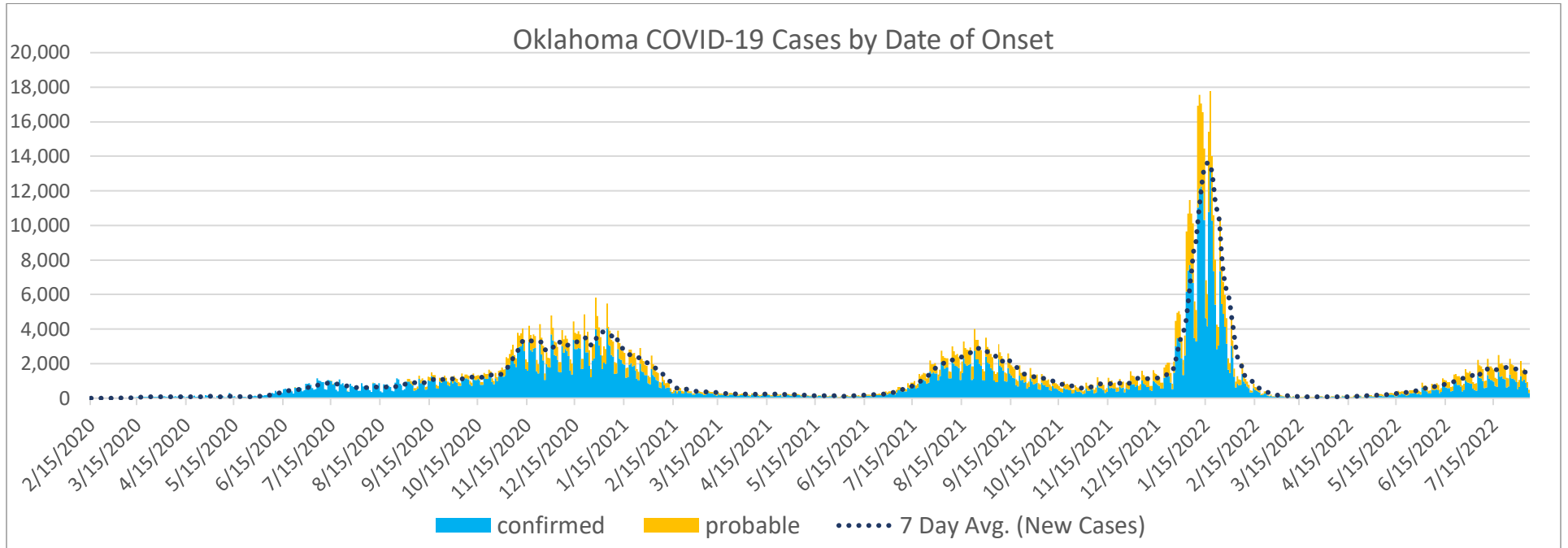

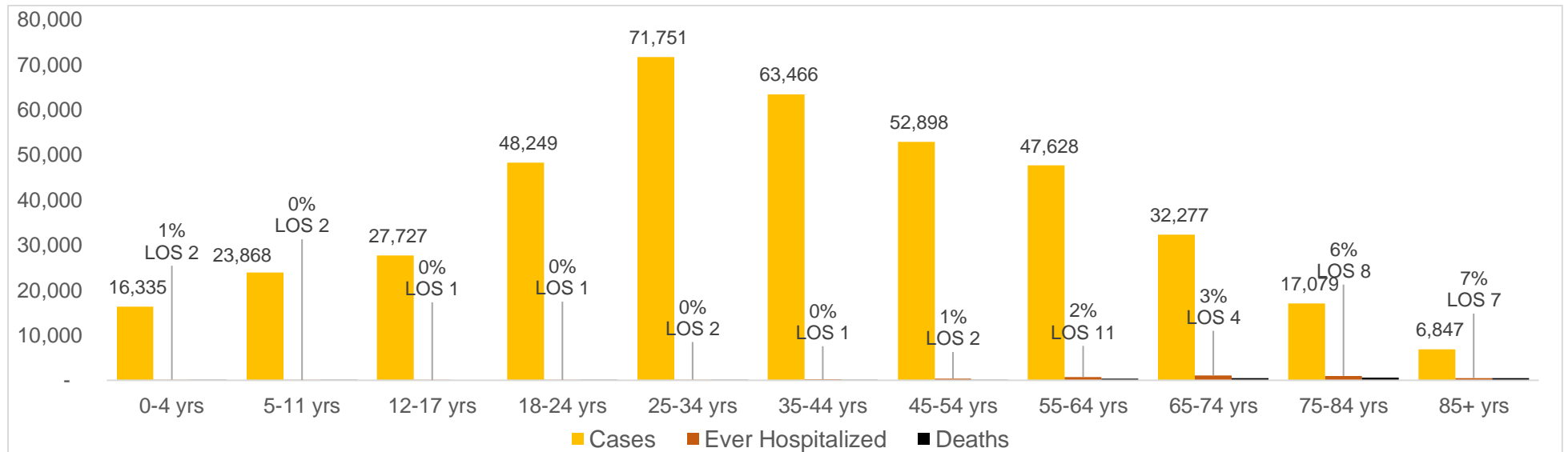

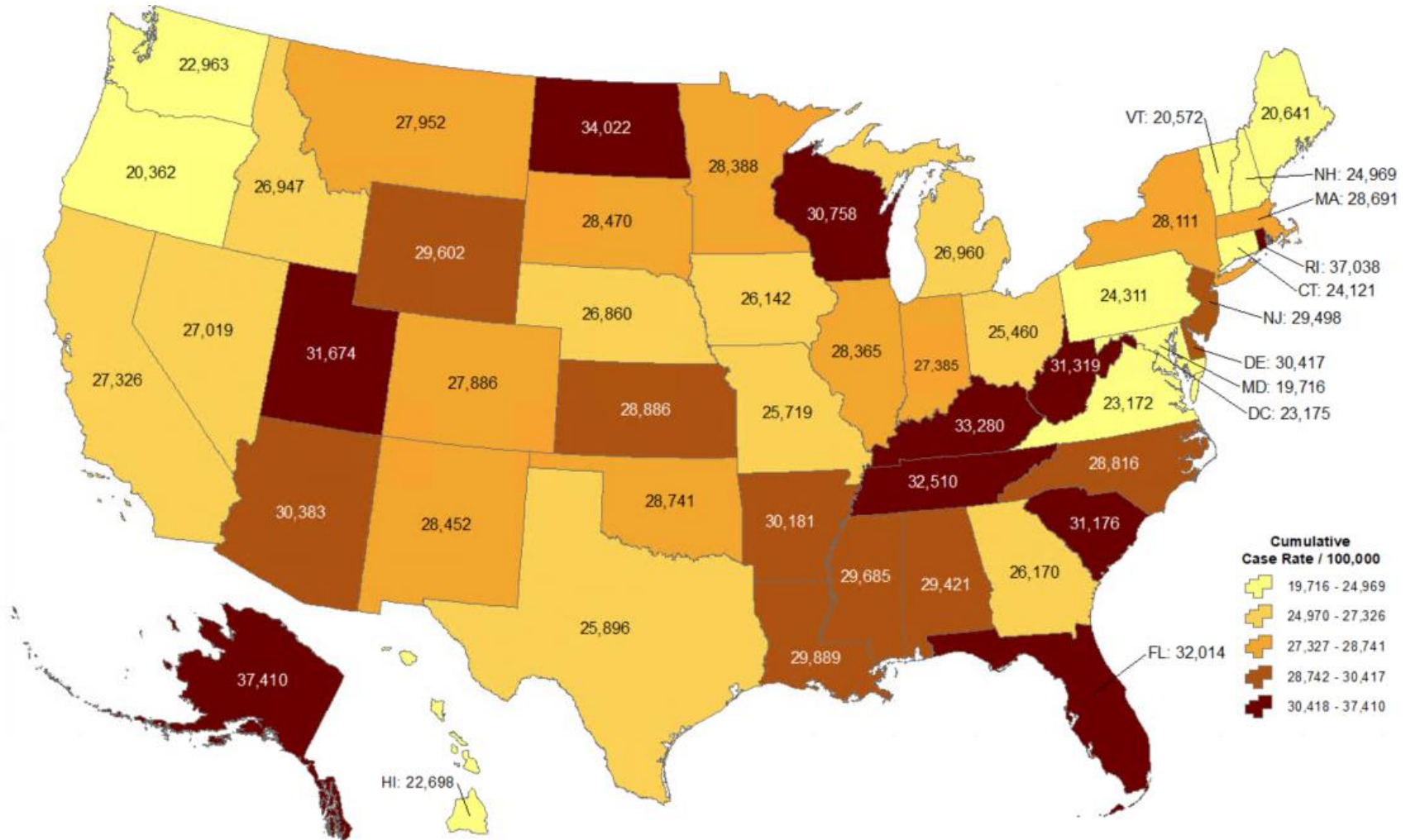

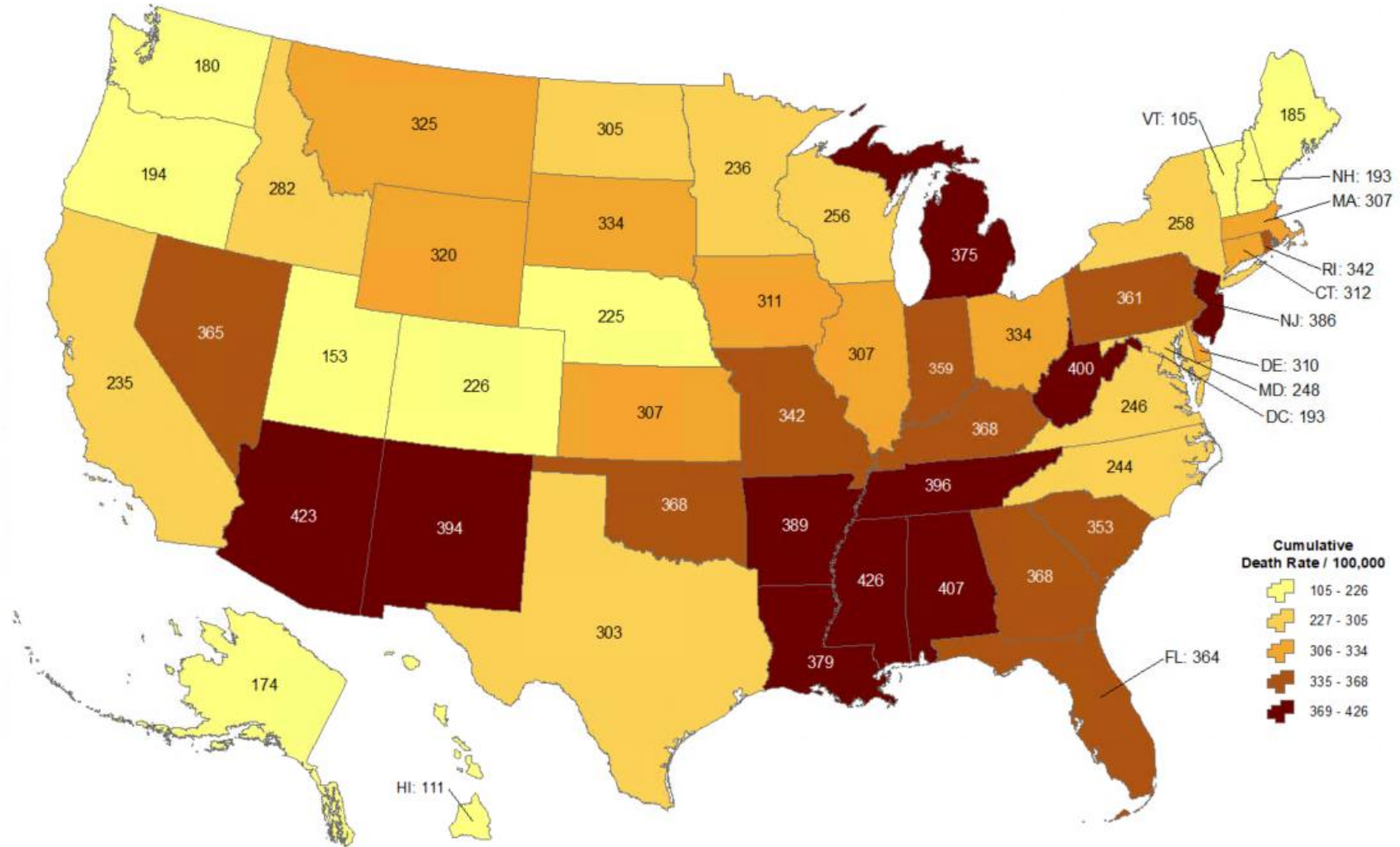

Cumulative death rate of reported COVID-19 cases

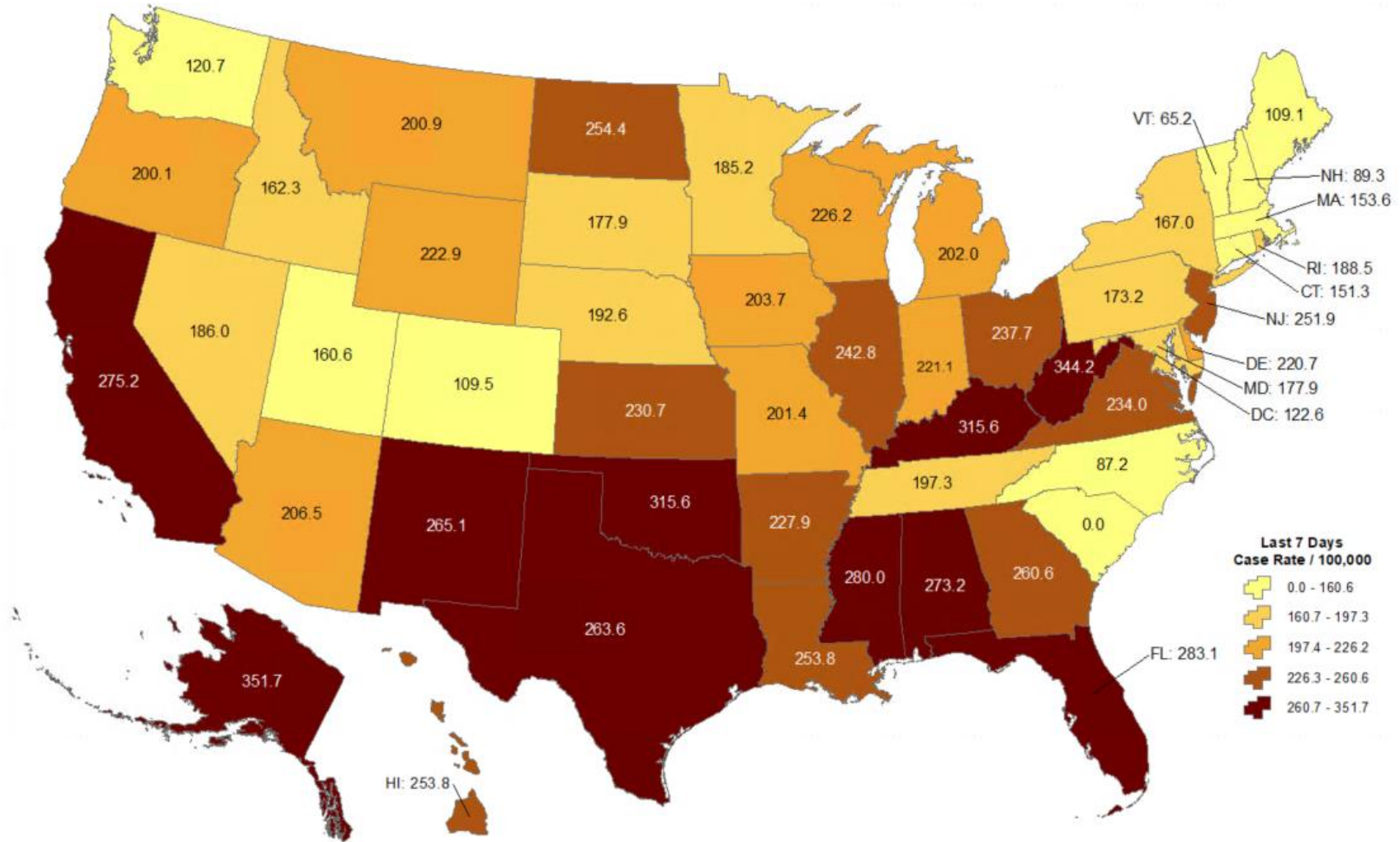

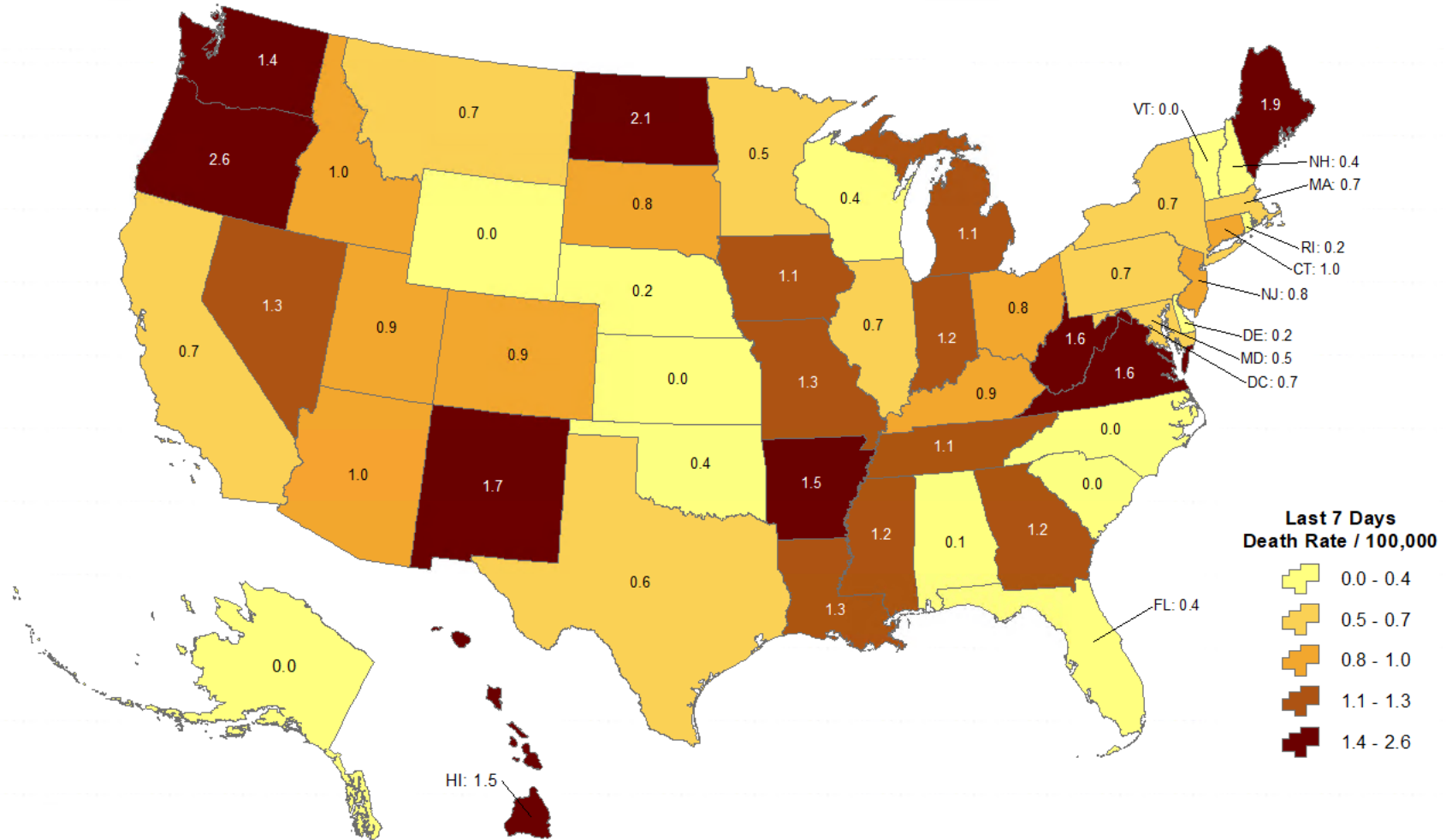

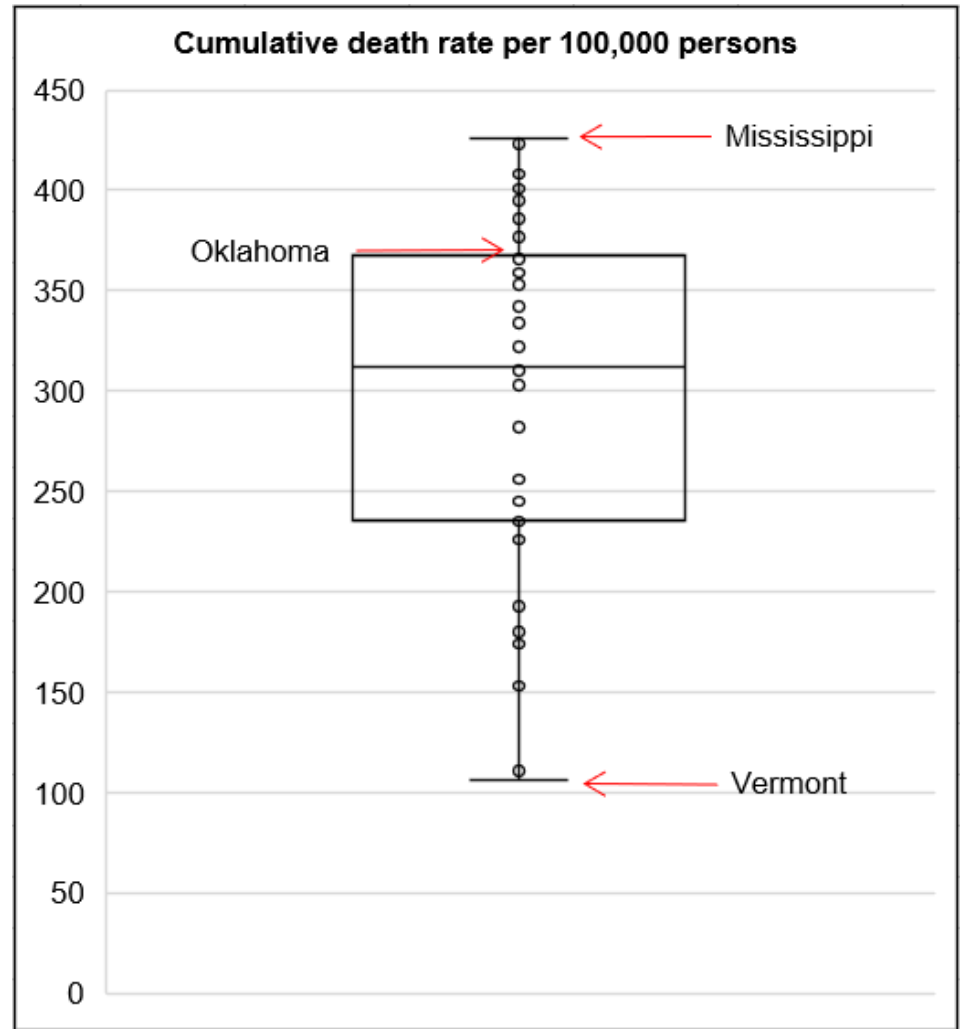
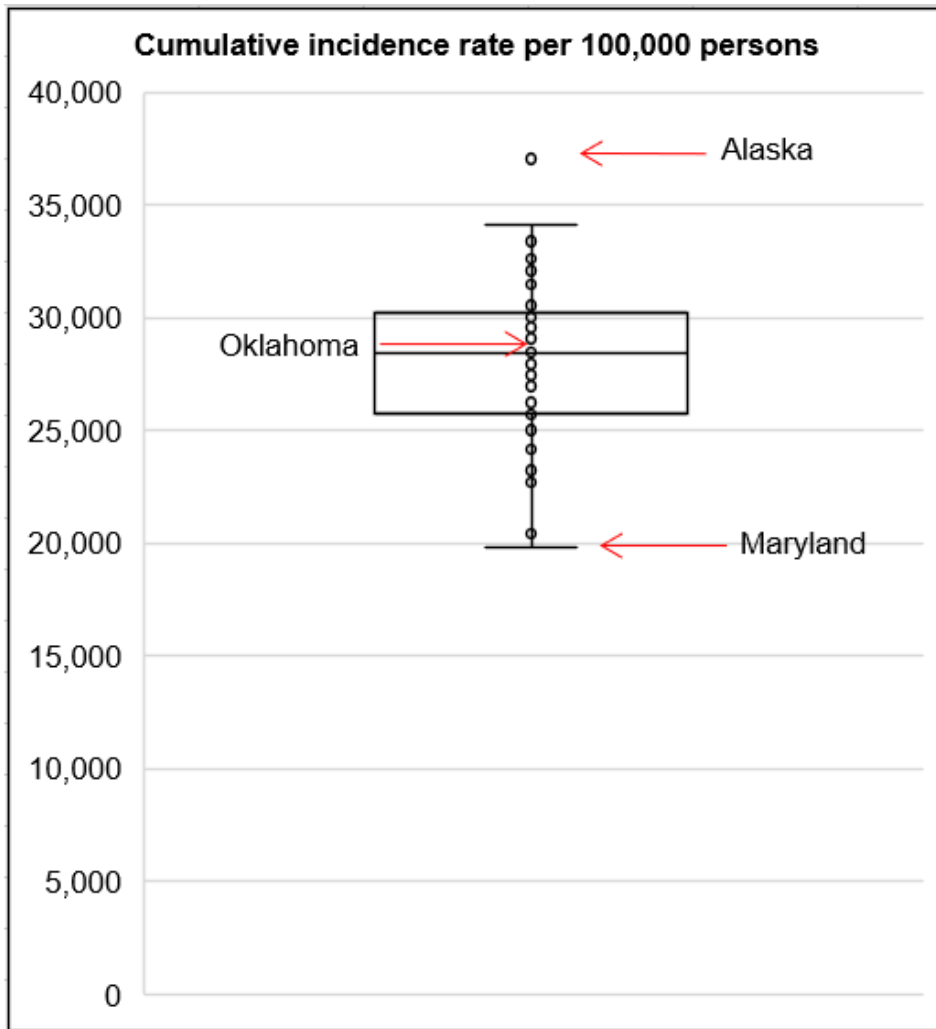

Cumulative incidence and cumulative death rate of reported COVID-19 cases



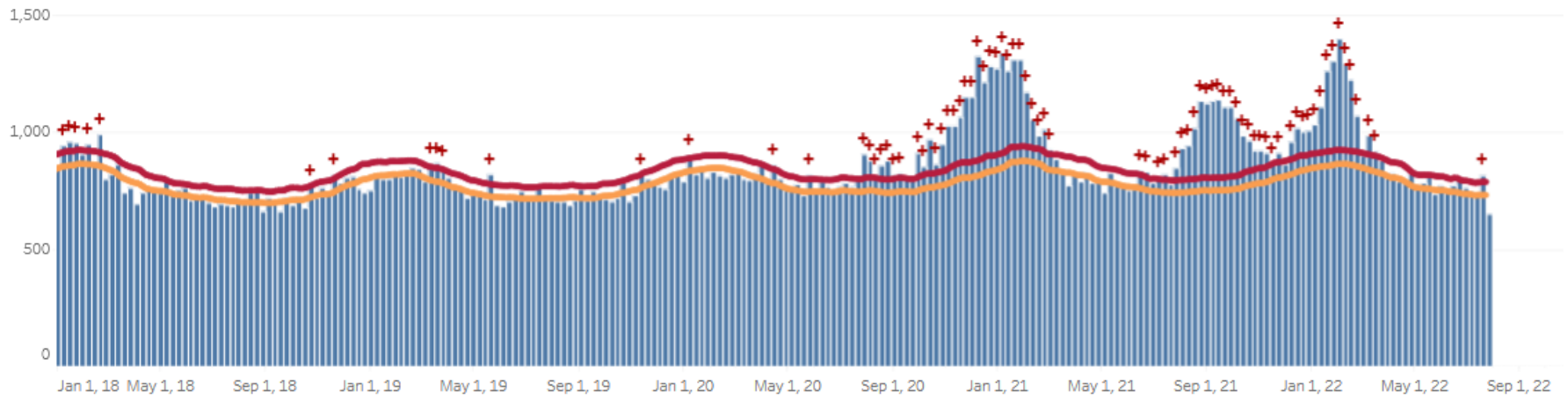
