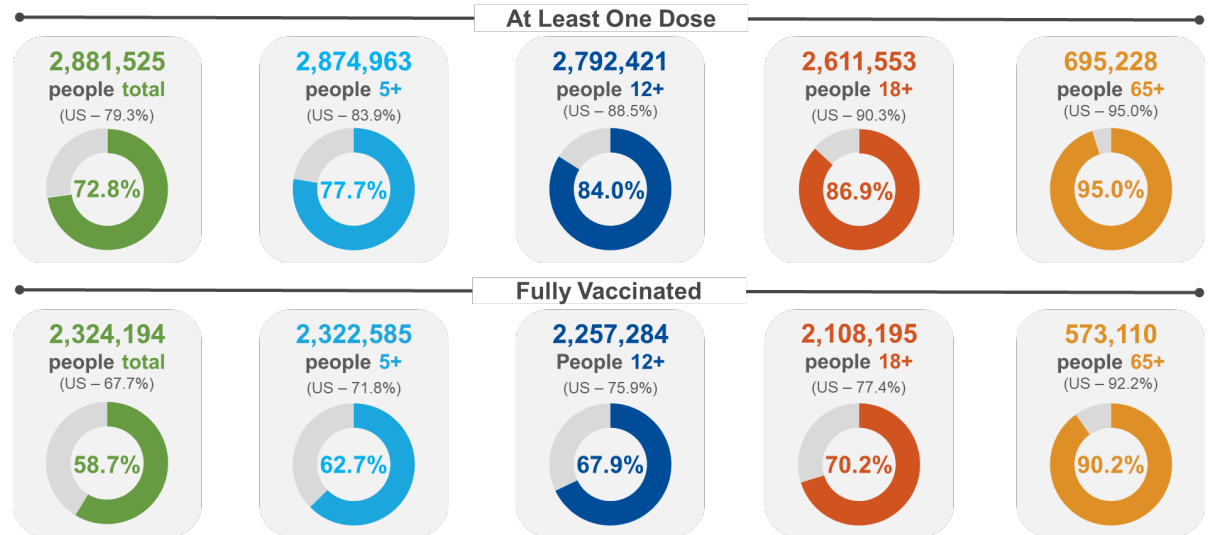

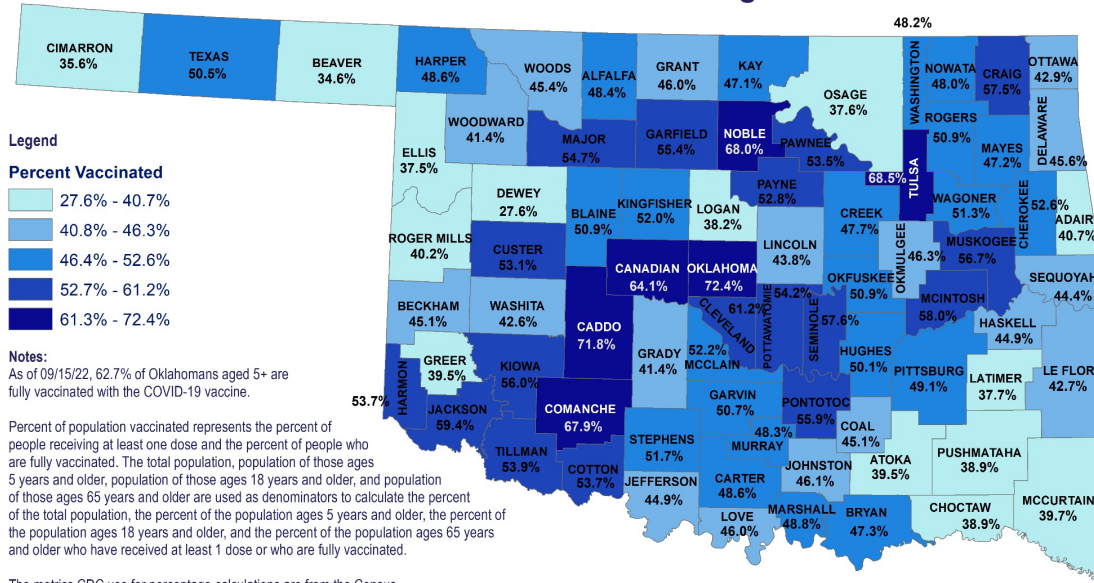

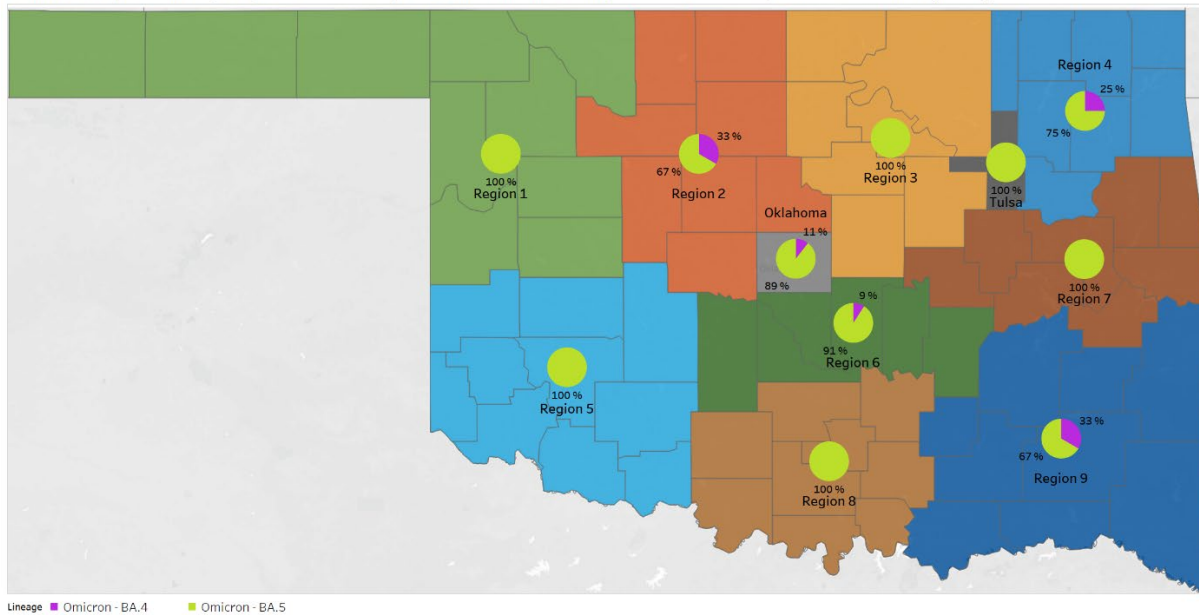

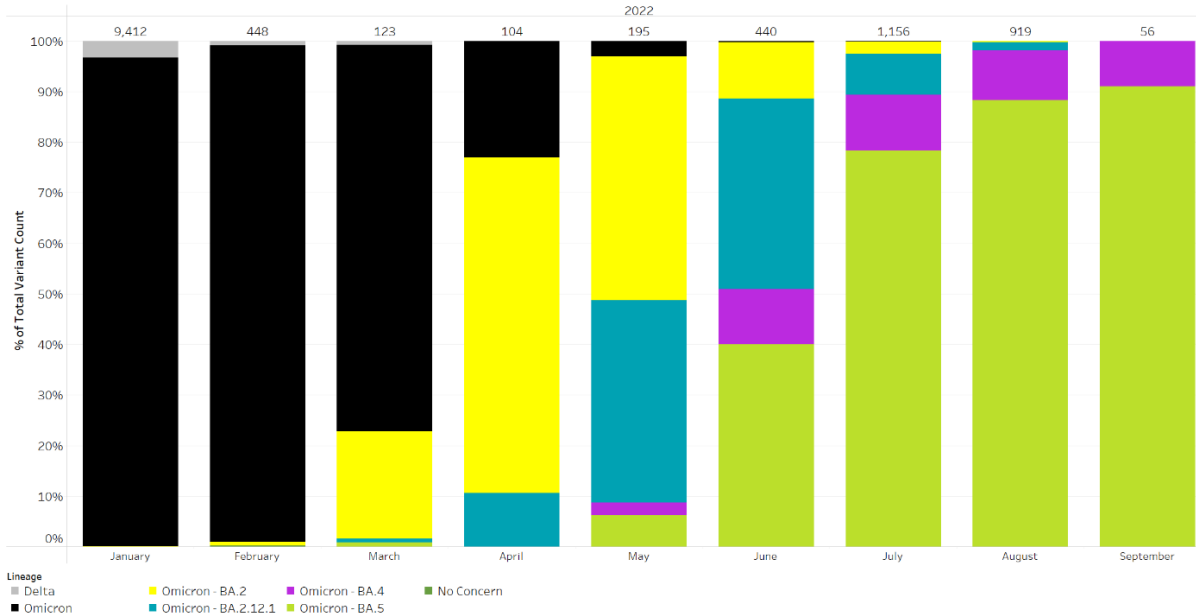
COVID-19 VARIANT STRAINS SEQUENCED*

Variant Proportions by Region, Dates of Specimen Collection: August 31, 2022 - September 9, 2022, (N=70):



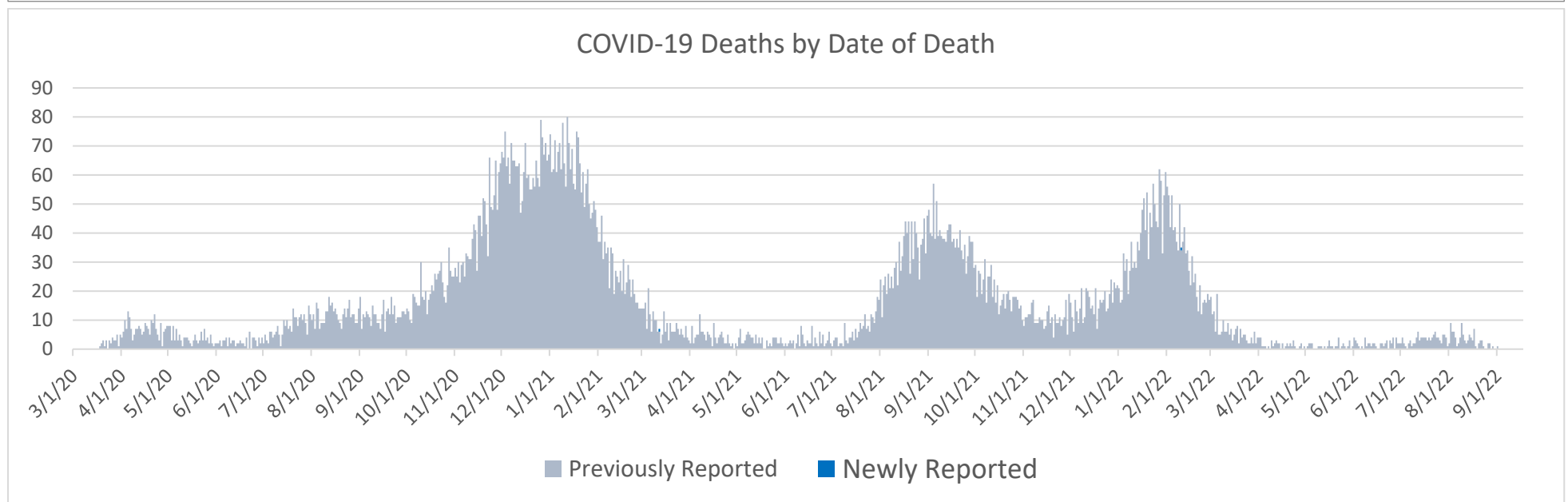
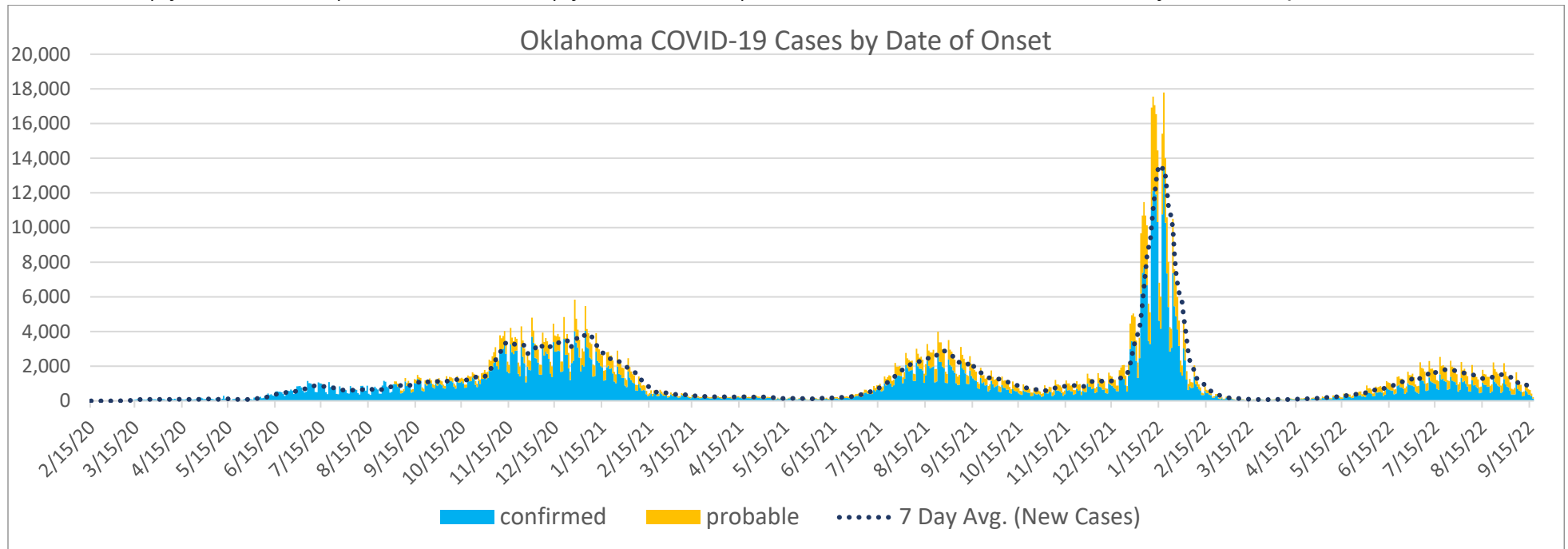

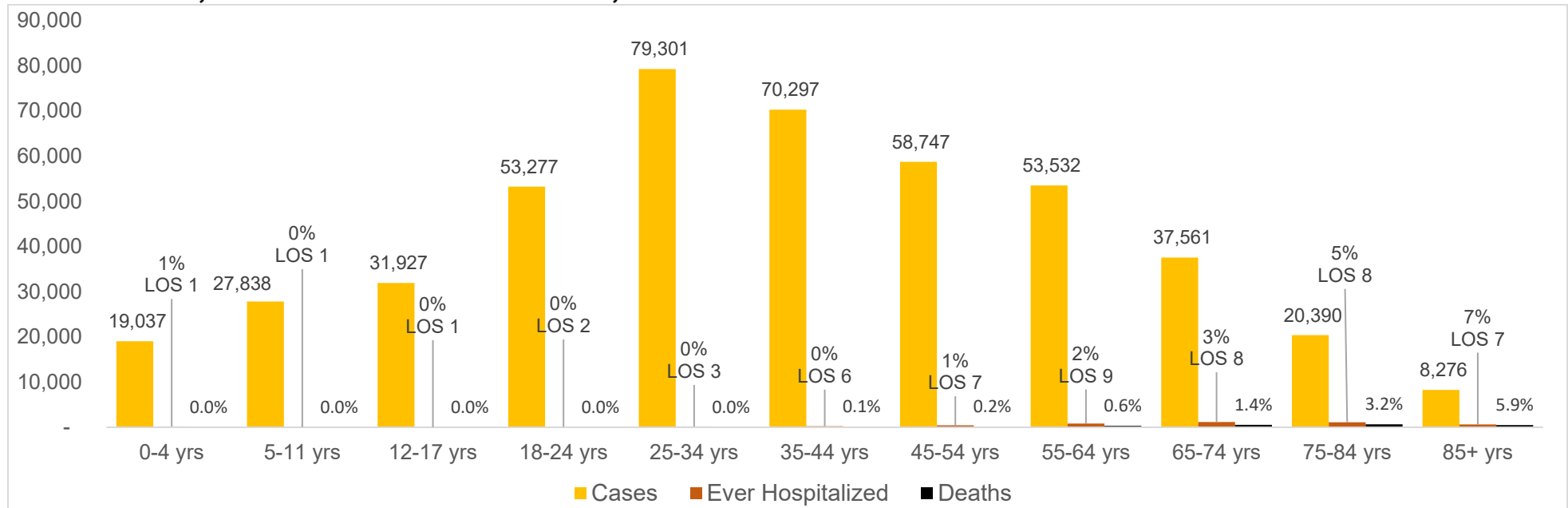

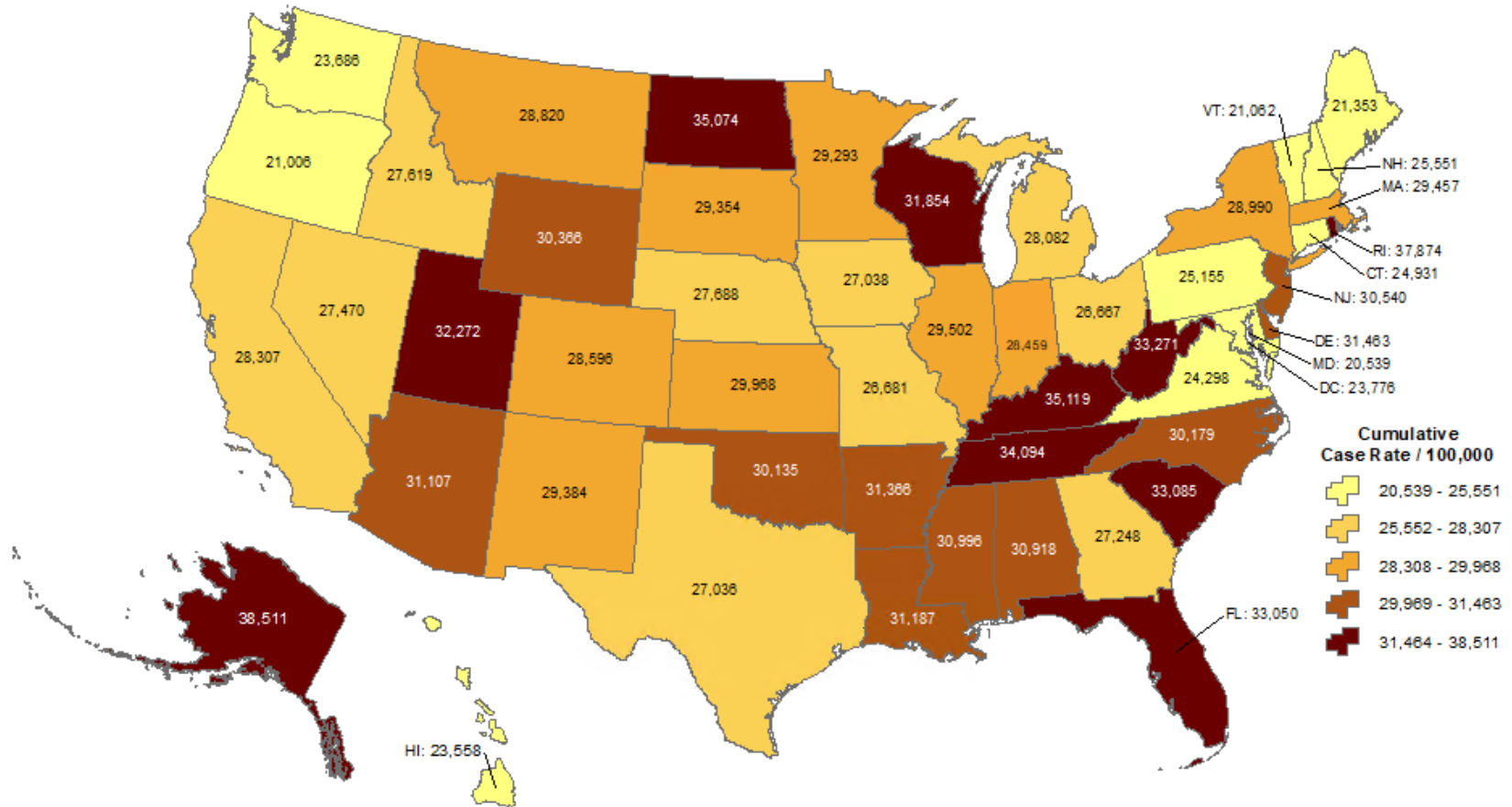
2022 CASES, PERCENT HOSPITALIZED, AVERAGE LENGTH OF STAY AND DEATHS BY AGE GROUP

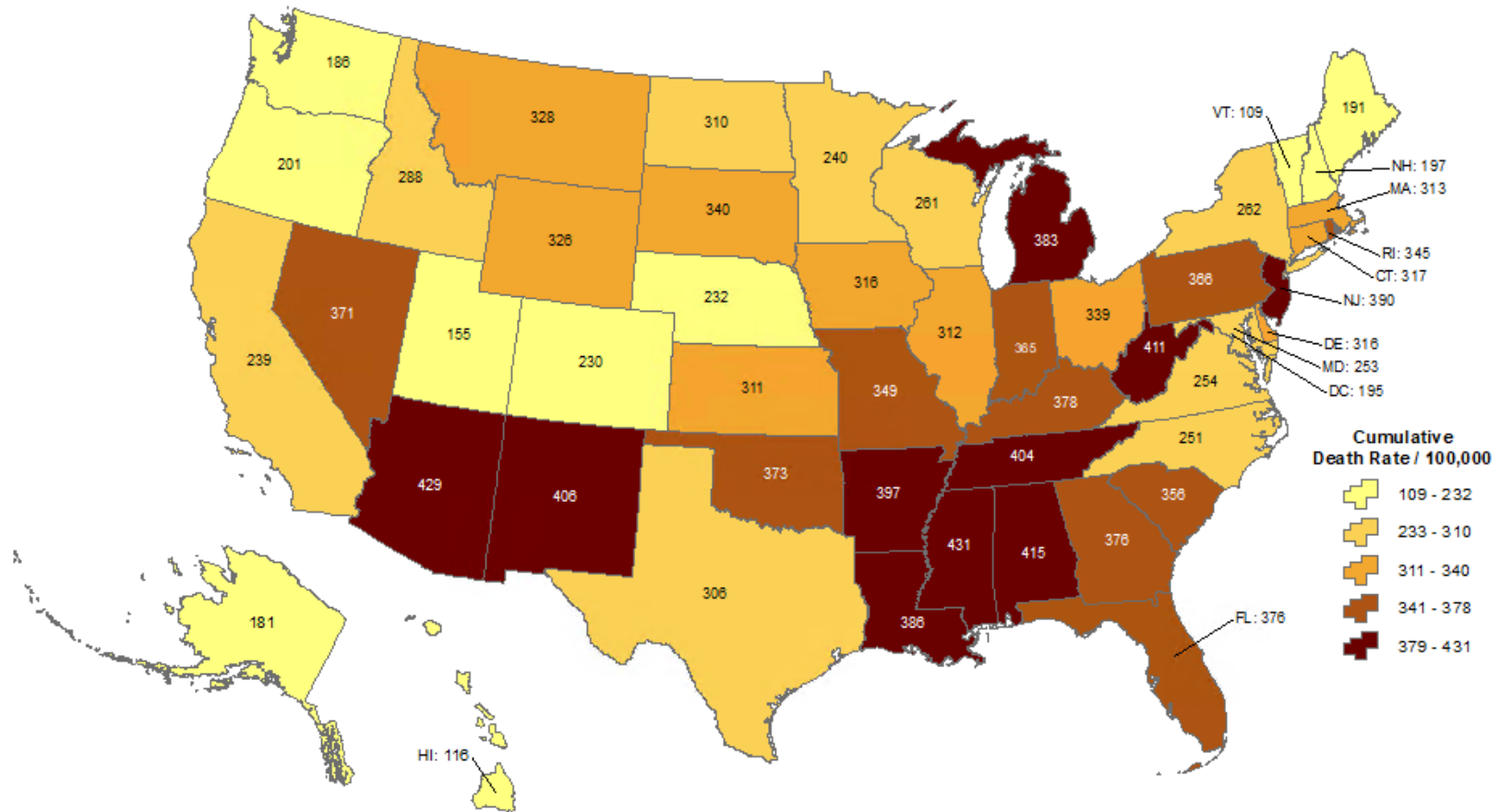

Cumulative death rate of reported COVID-19 cases

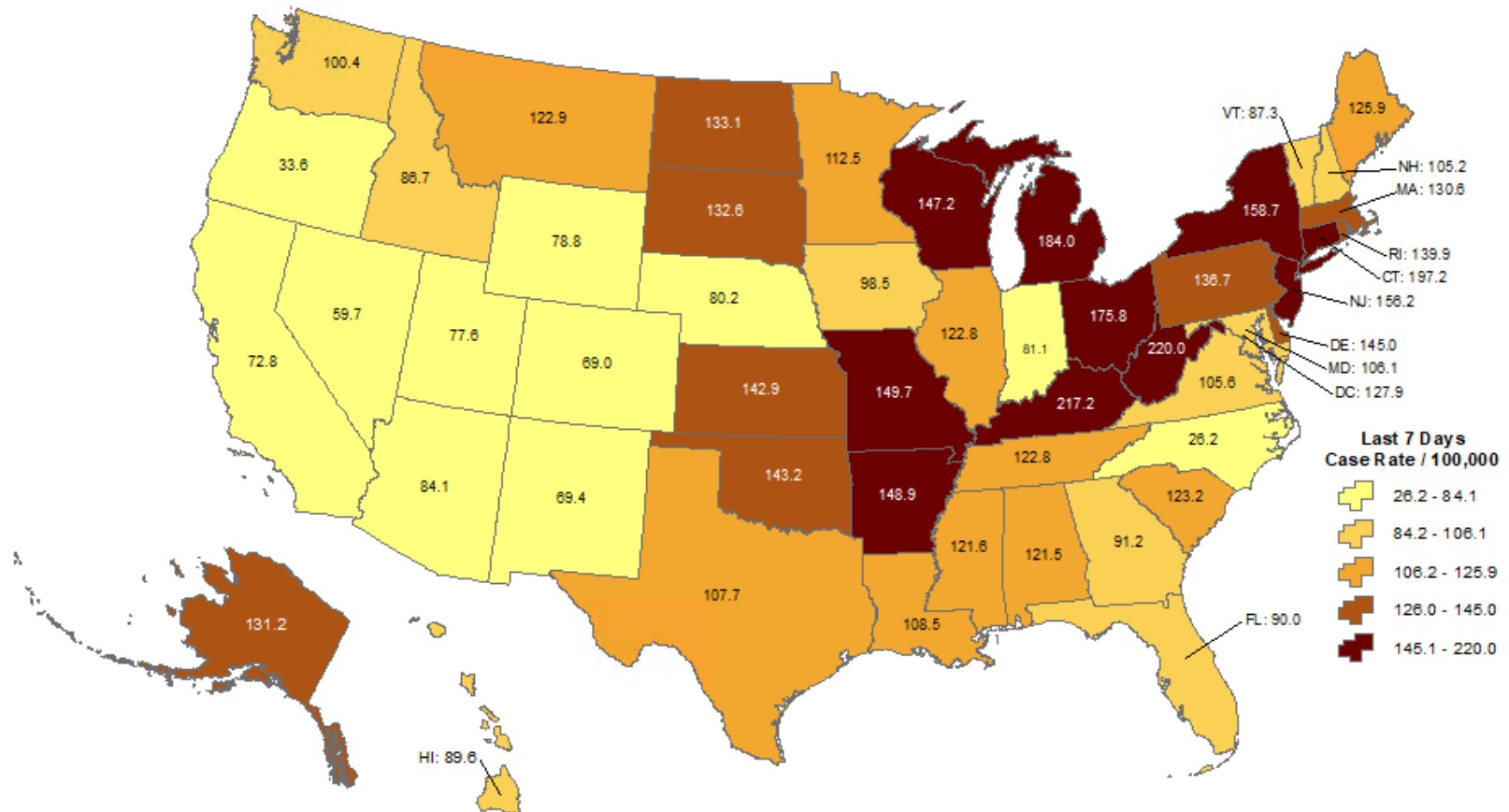

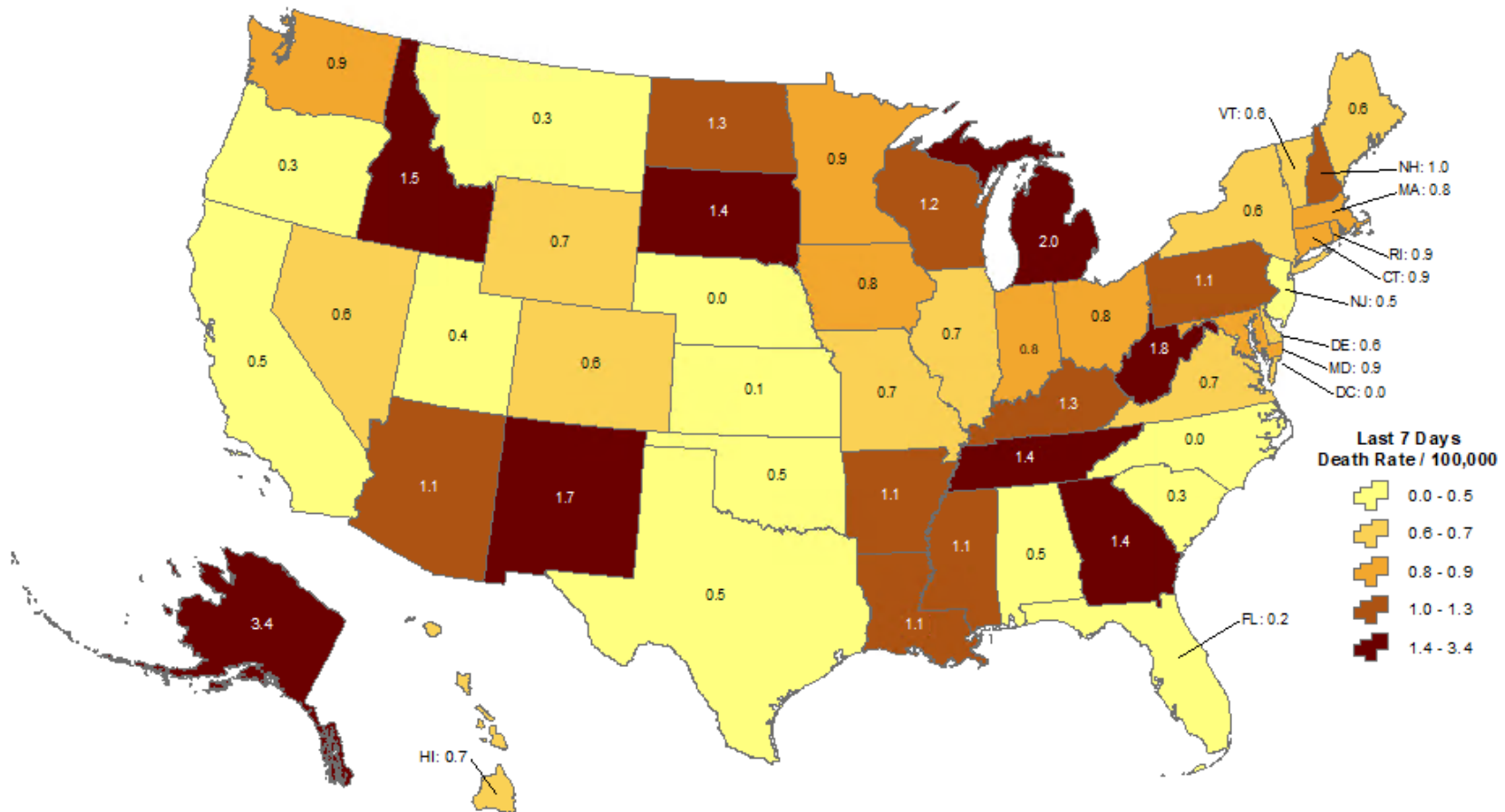

Cumulative death rate of reported COVID-19 cases in last 7 days

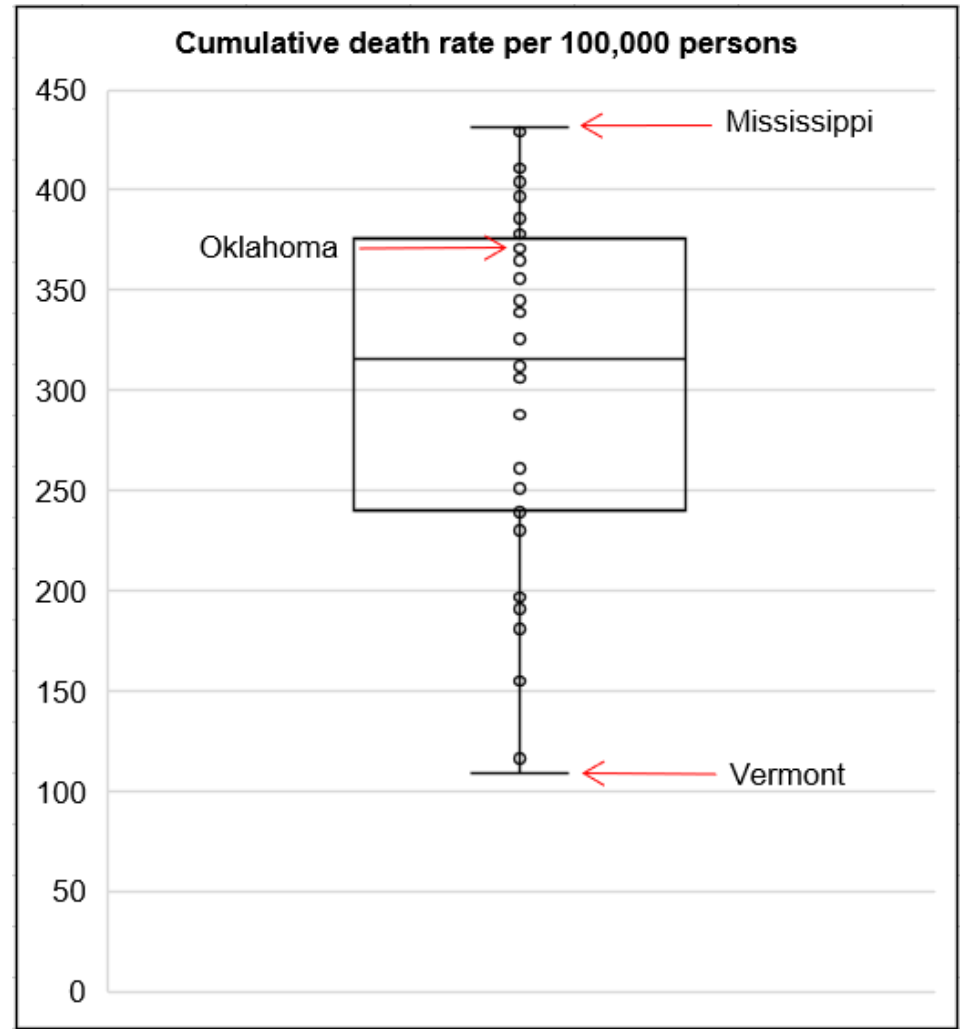
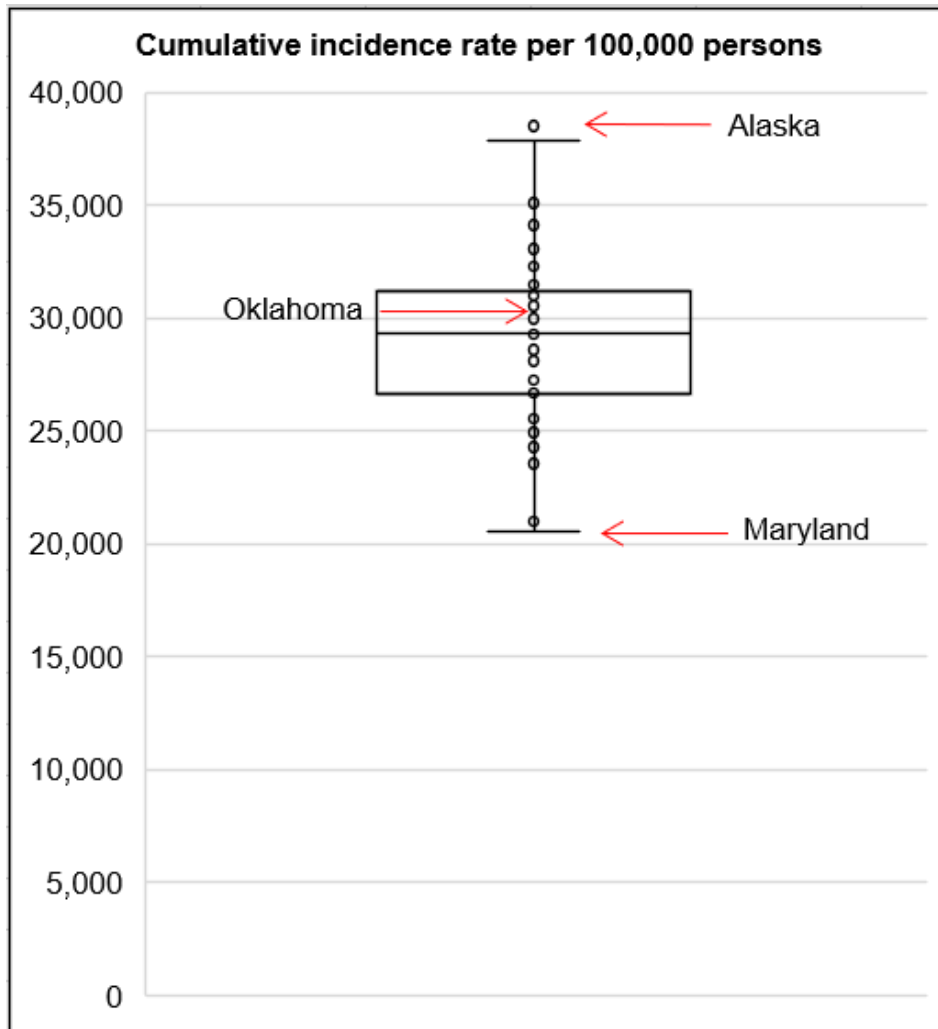

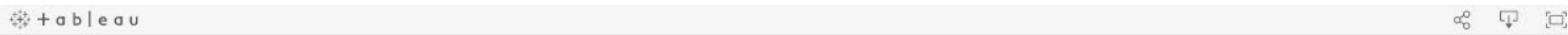
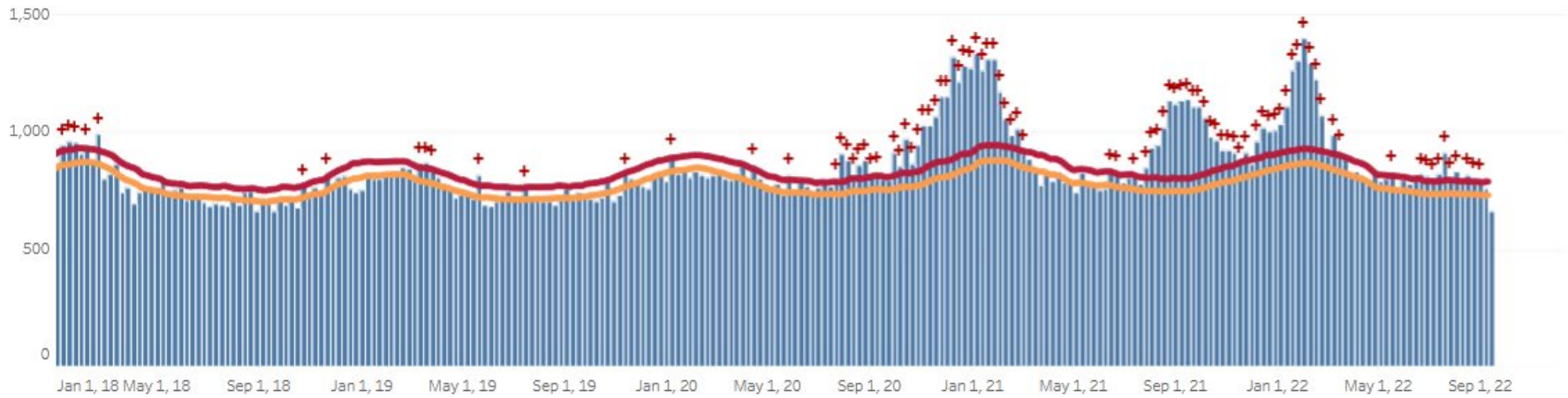
