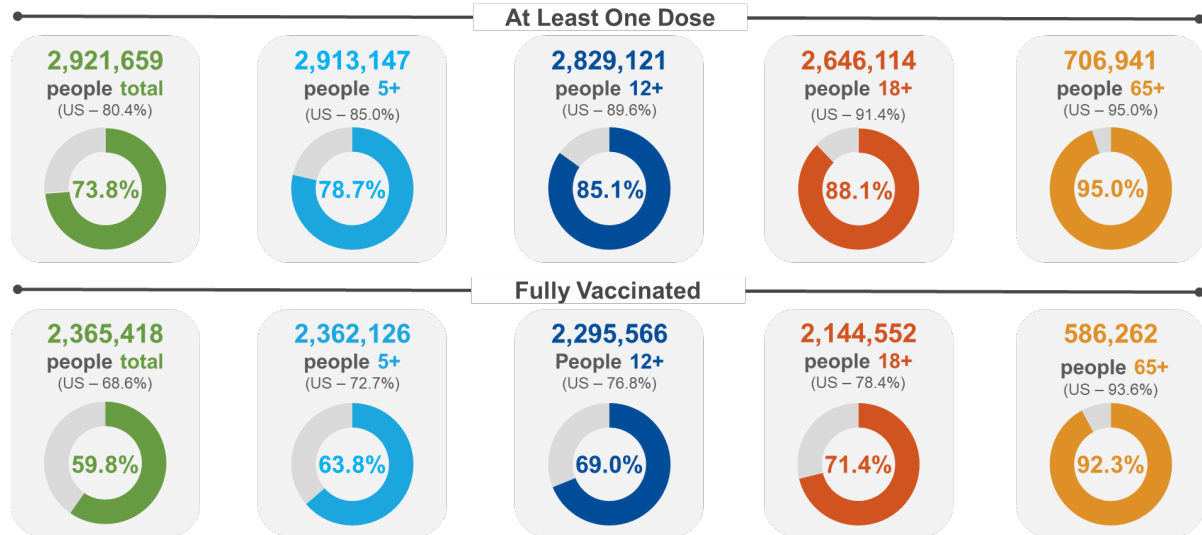

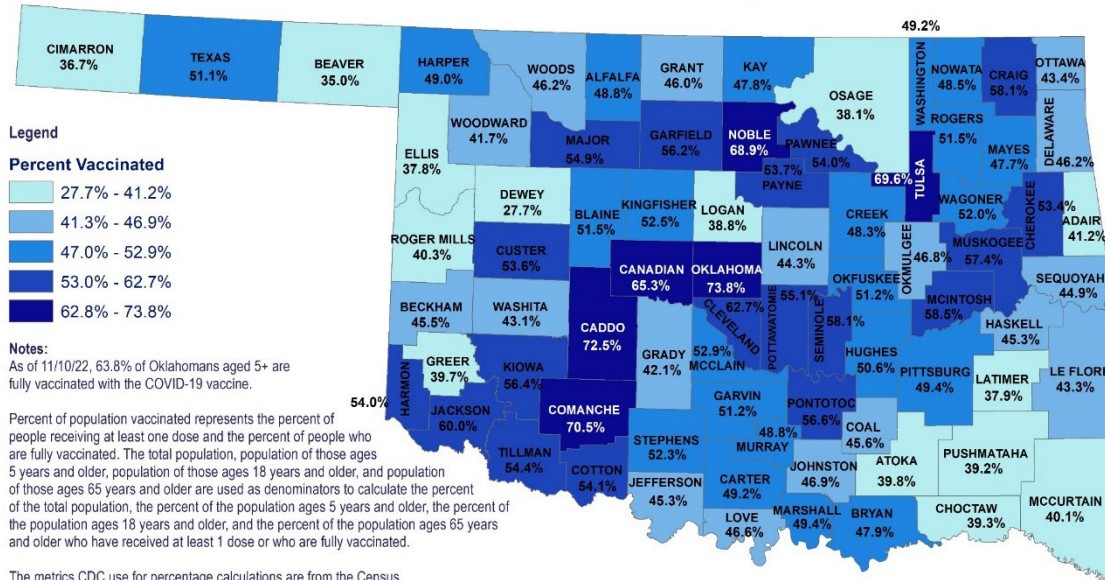

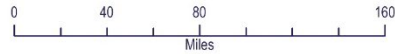

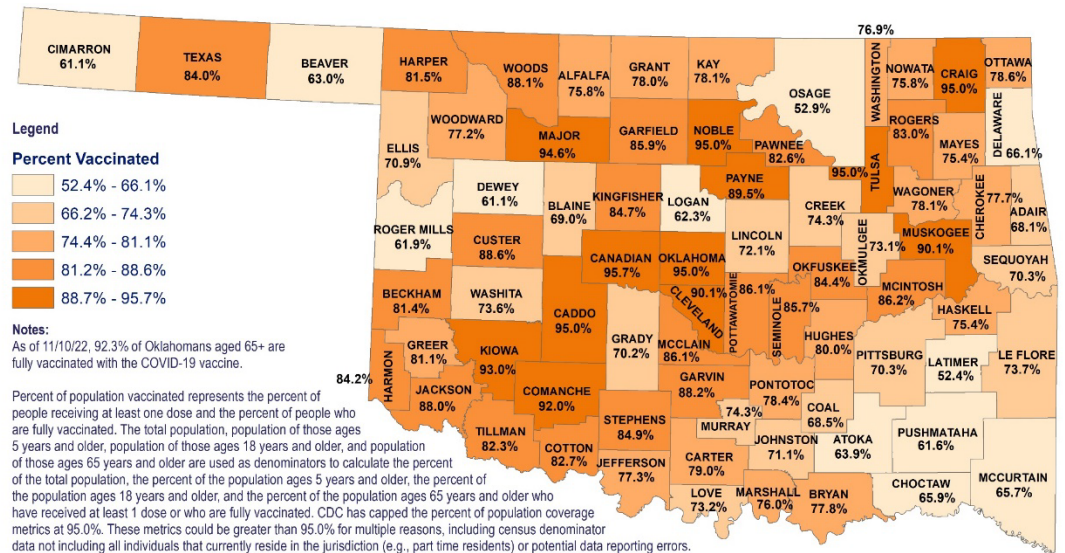

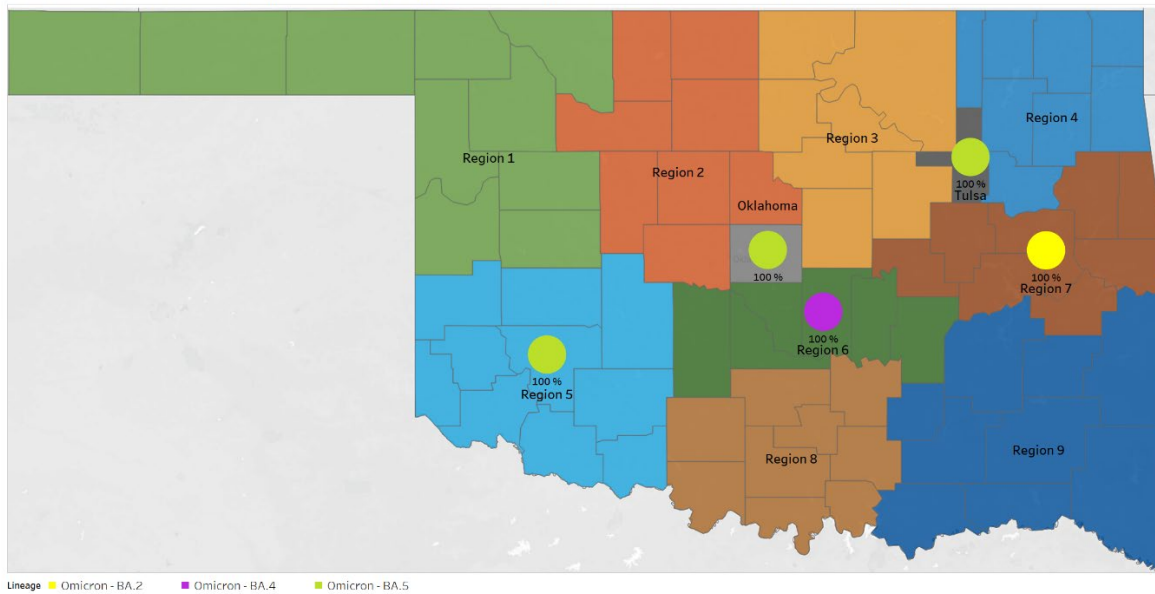

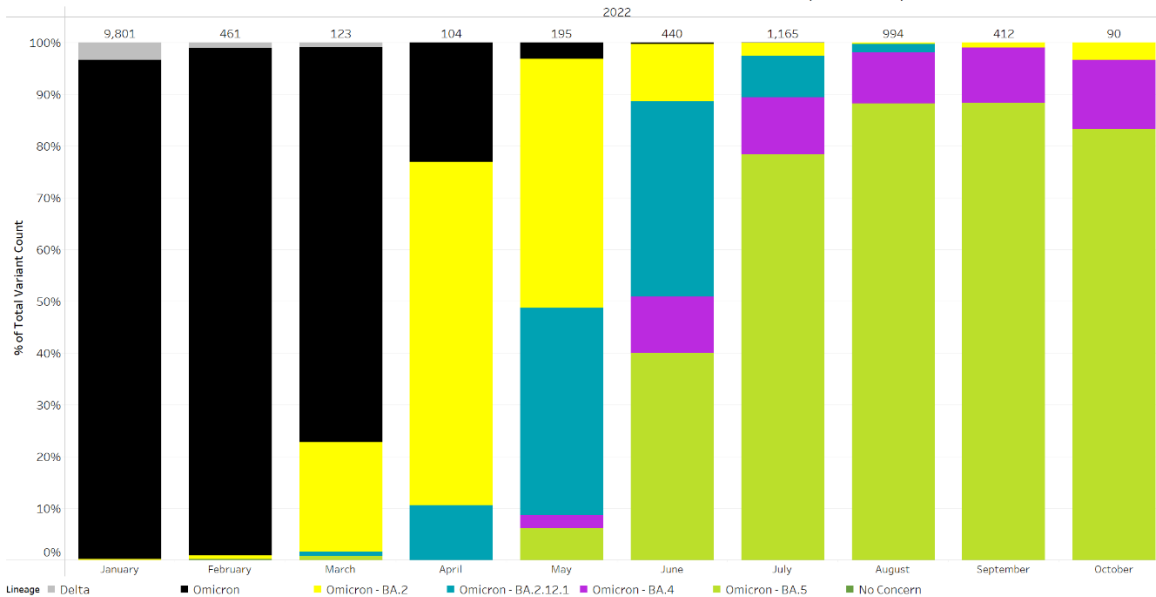
COVID-19 VARIANT STRAINS SEQUENCED*

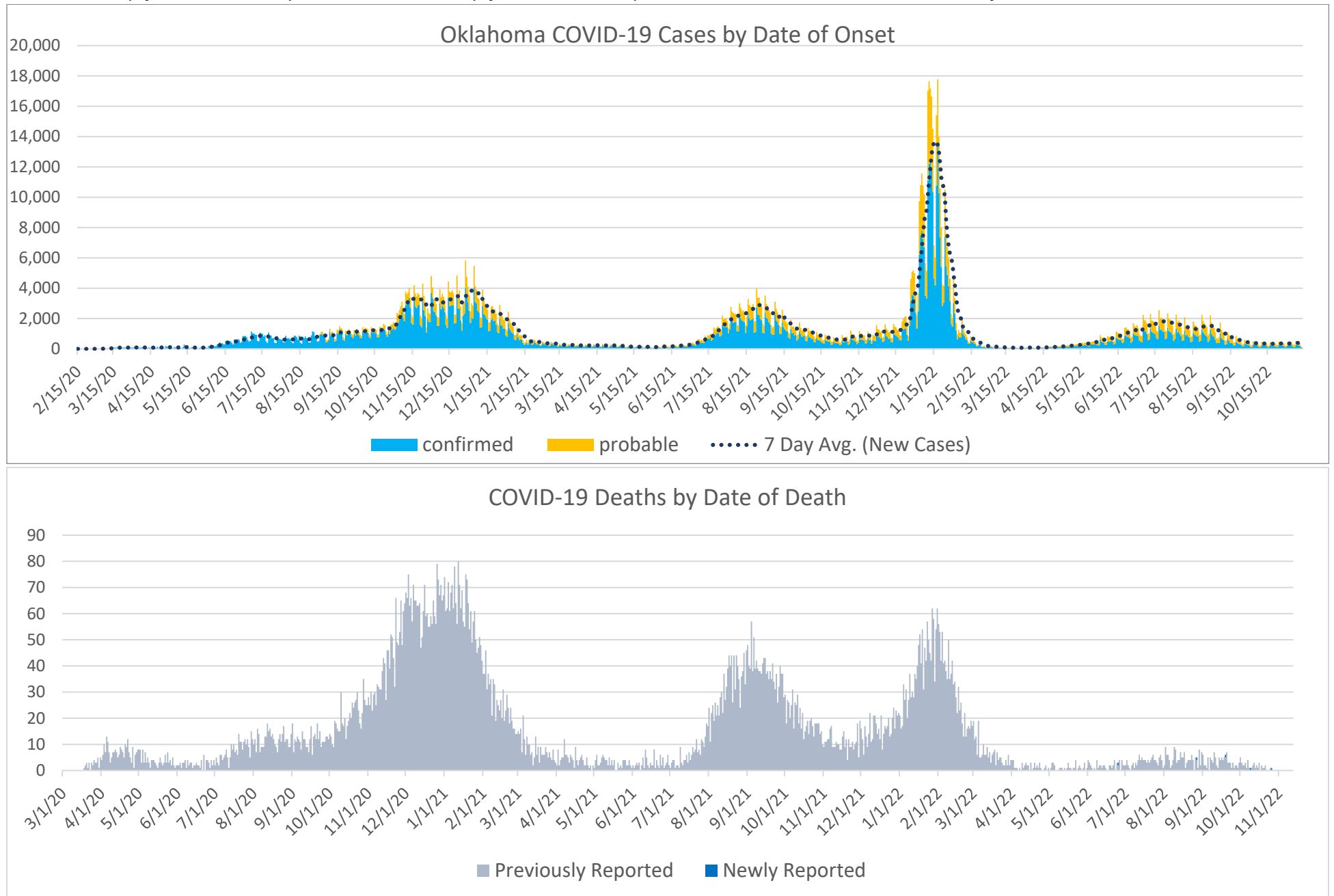
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - November 15, 2022 (N=13,785)

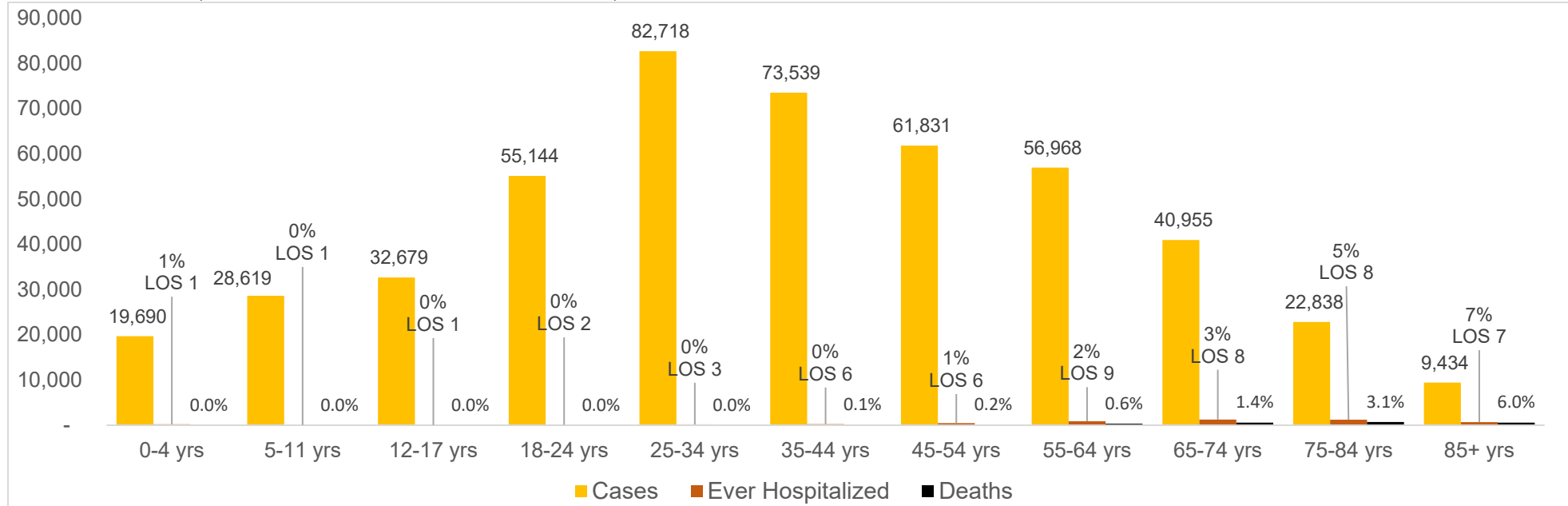

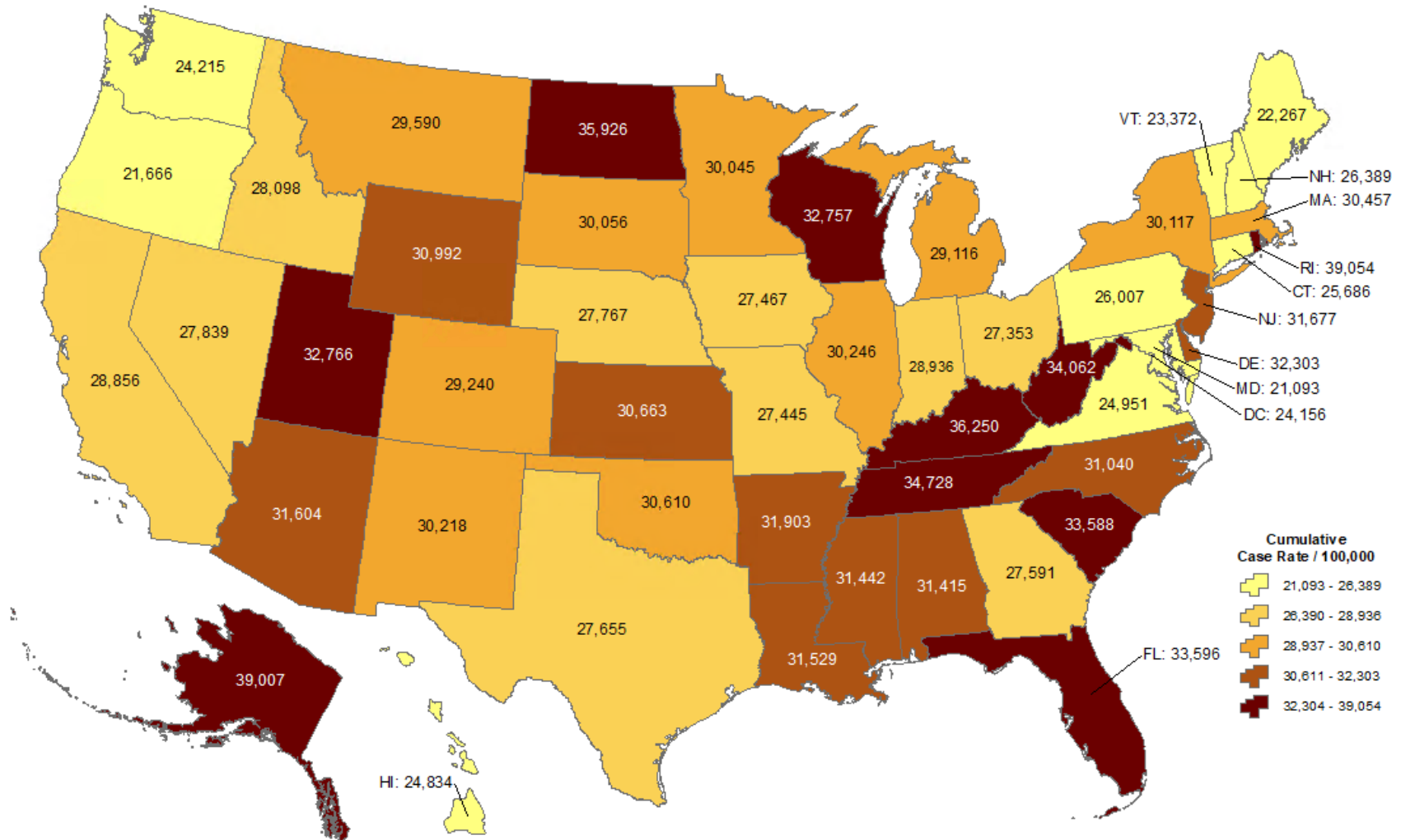
2022 CASES, PERCENT HOSPITALIZED, AVERAGE LENGTH OF STAY AND DEATHS BY AGE GROUP

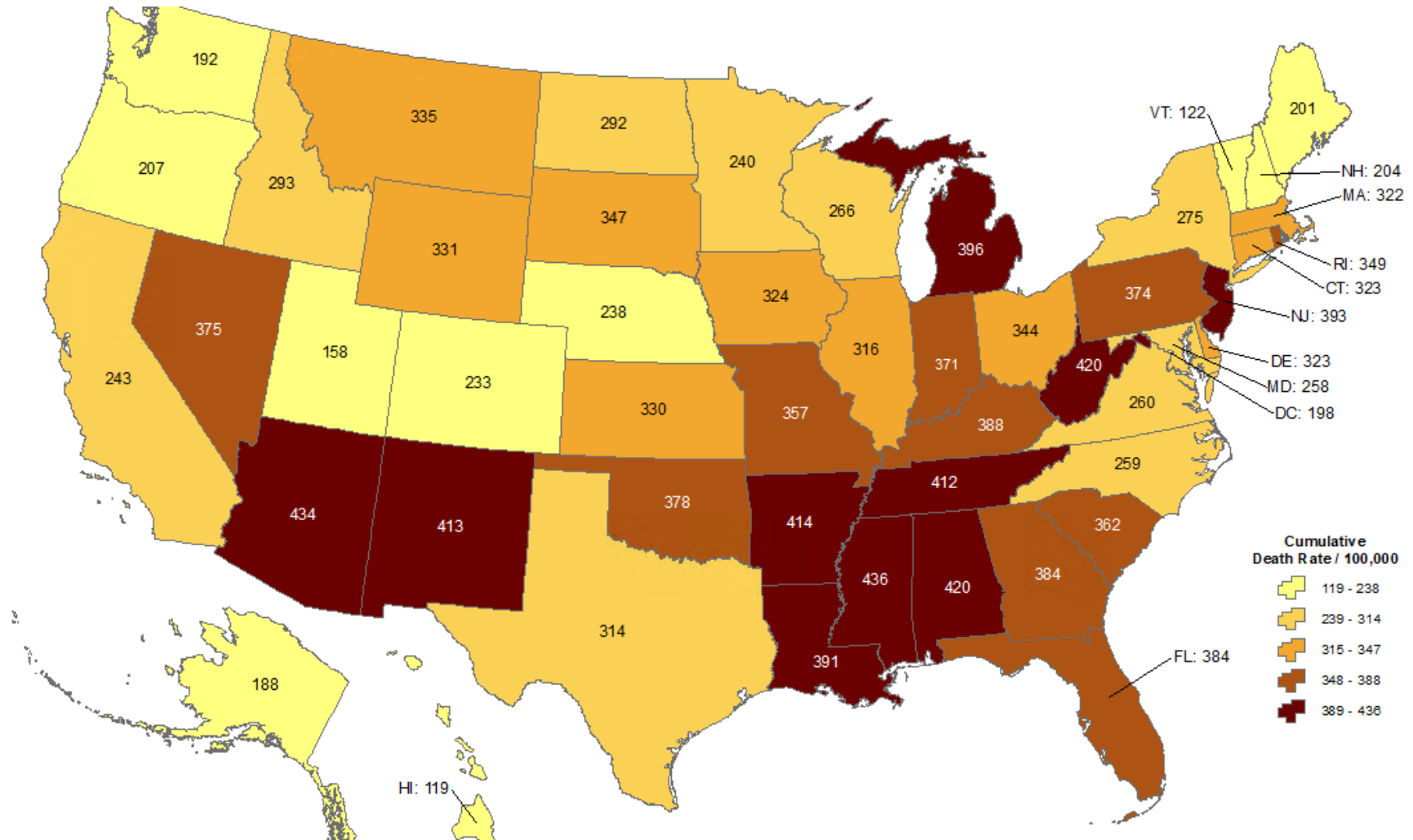

Cumulative death rate of reported COVID-19 cases

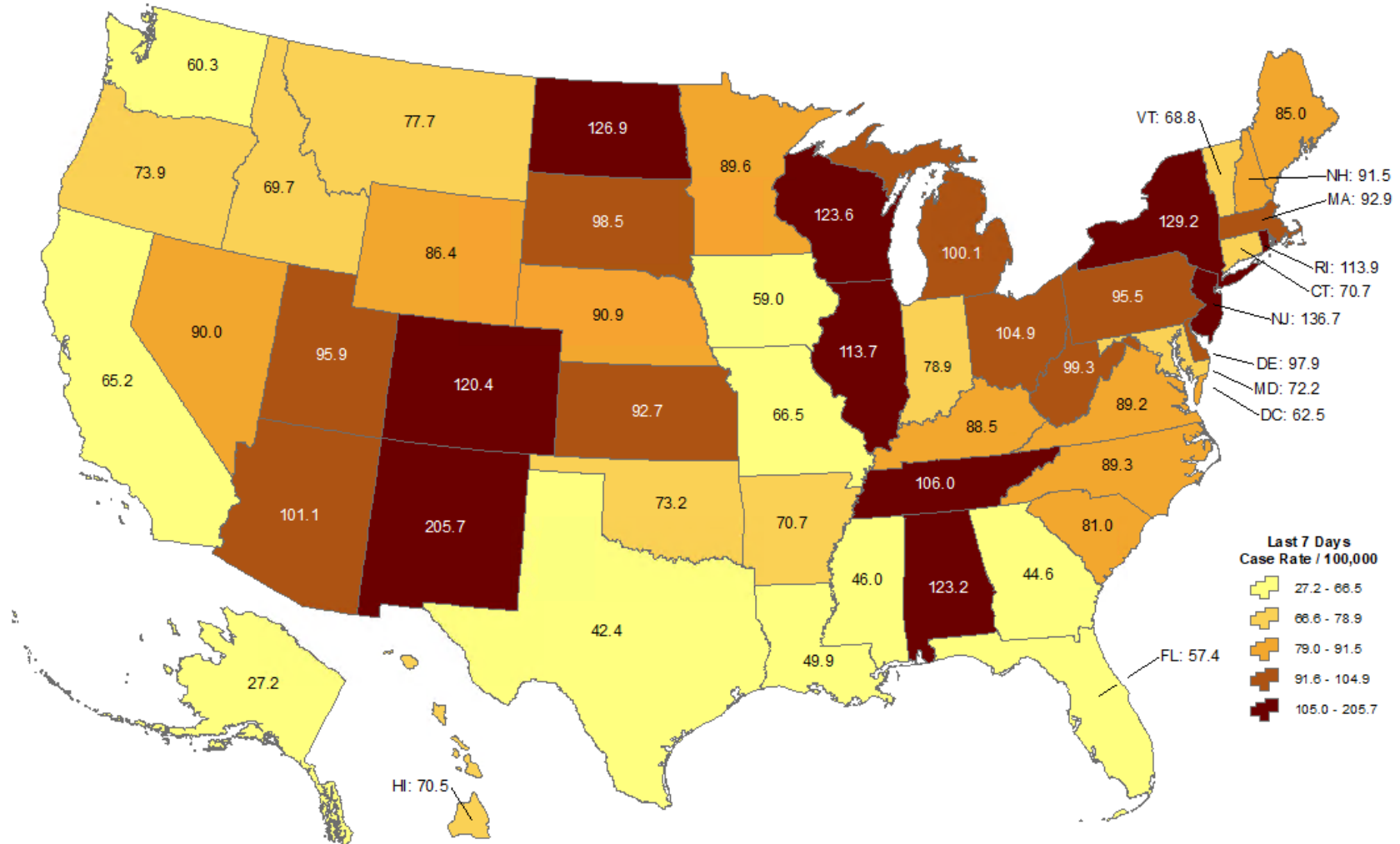

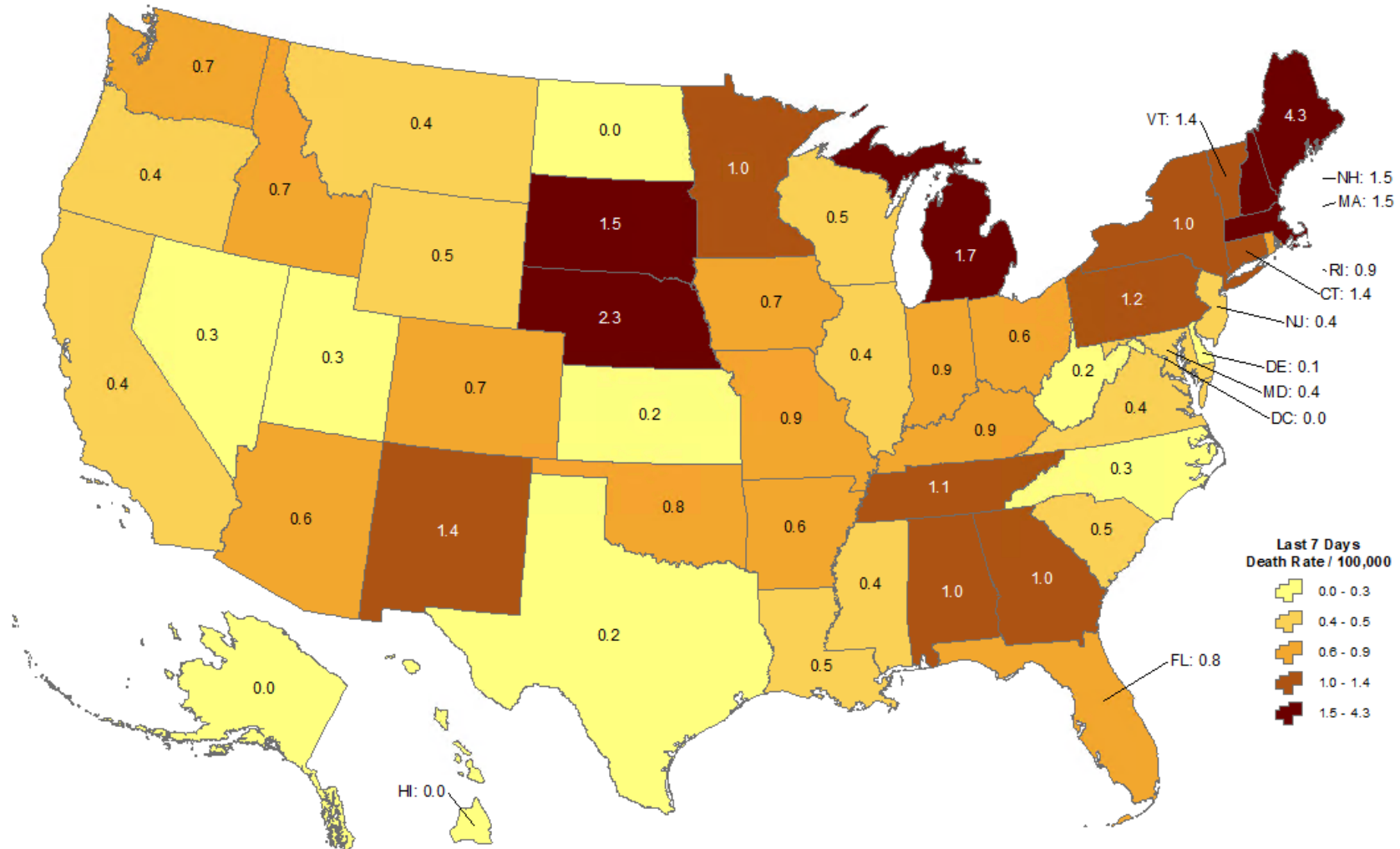

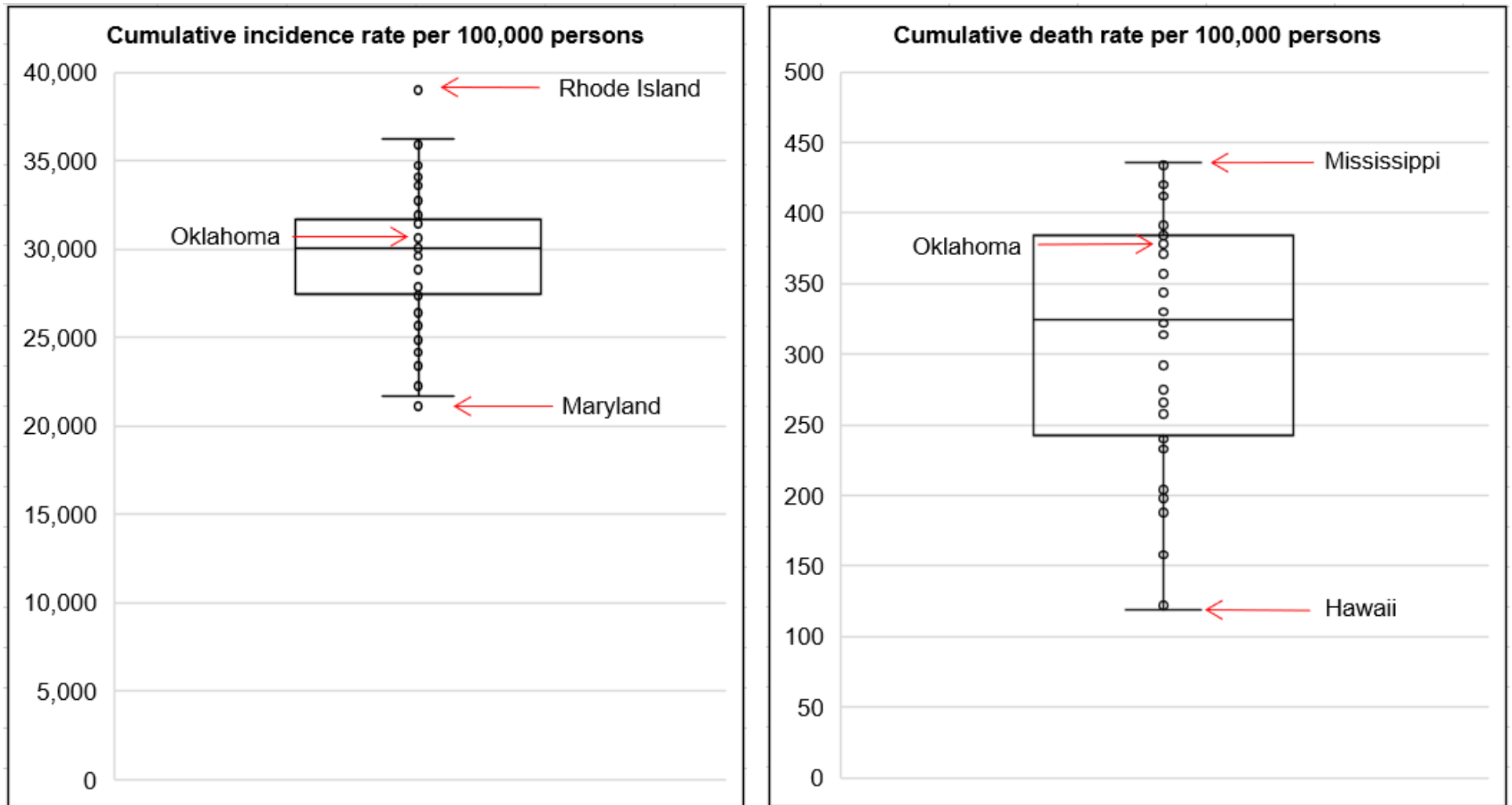

Weekly number of deaths (from all causes)

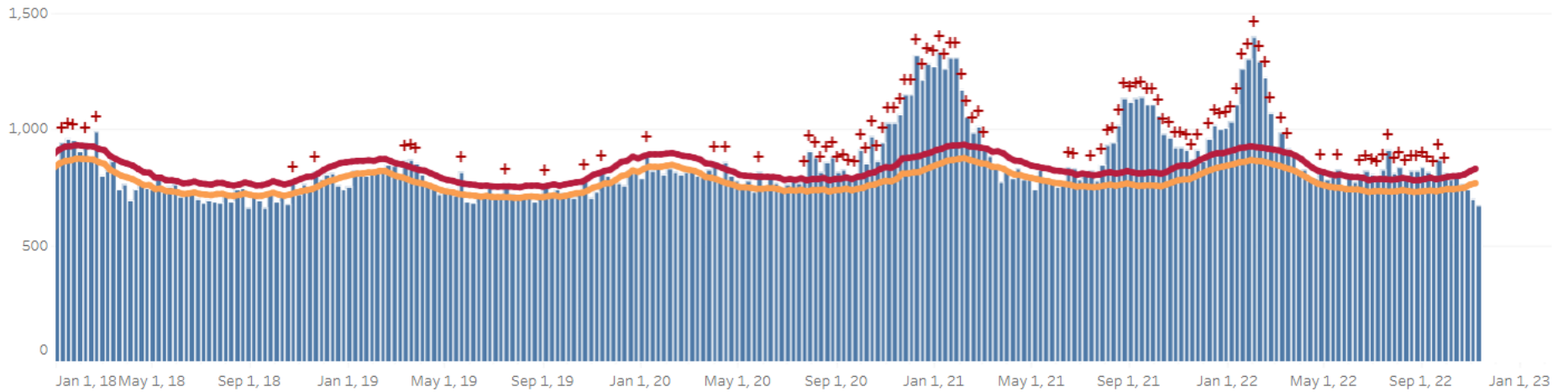
