








Variant Proportions by Region, Dates of Specimen Collection: January 16, 2023 - January 25, 2023, (N=53):



Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - February 14, 2023 (N=17,029)




2022-2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP



Cumulative death rate of reported COVID-19 cases








Weekly number of deaths (from all causes)


