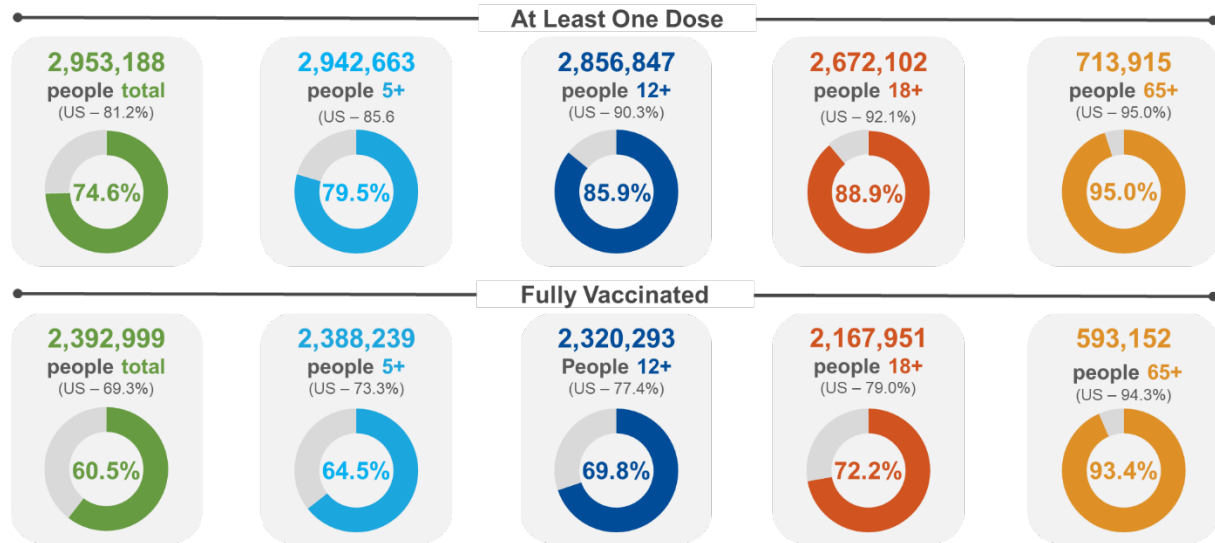

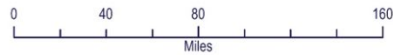

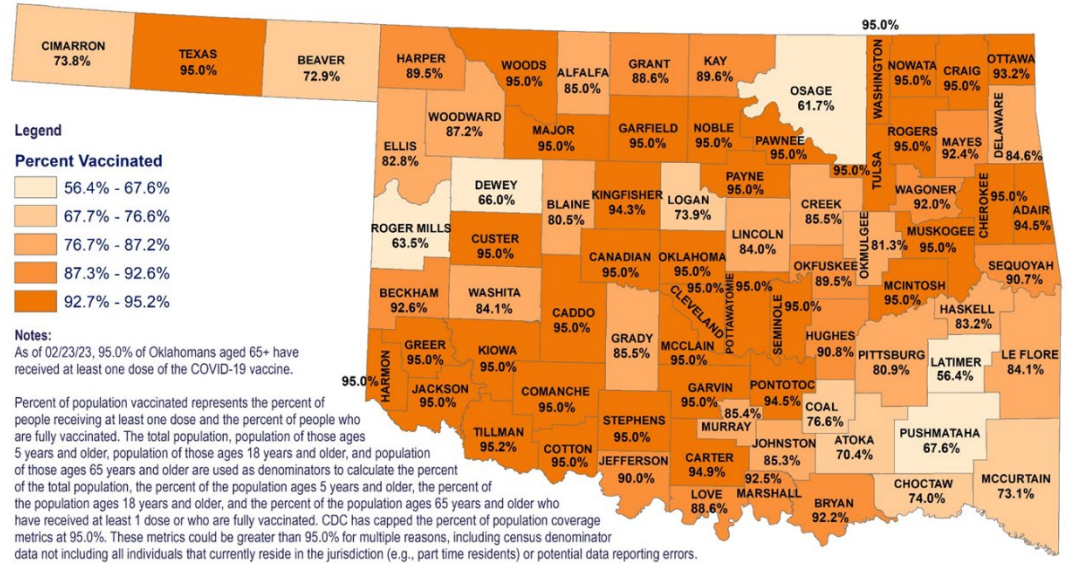

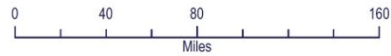

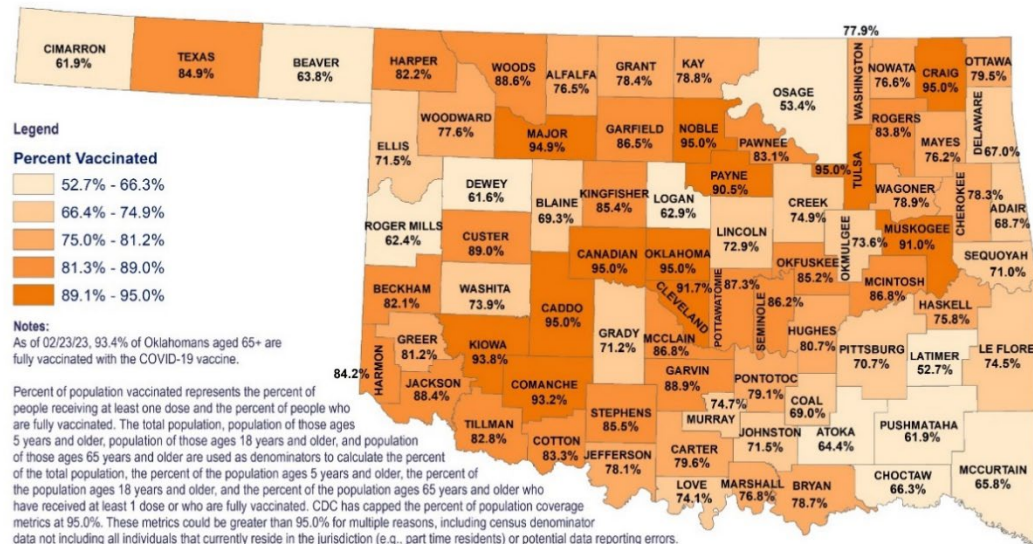

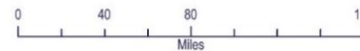

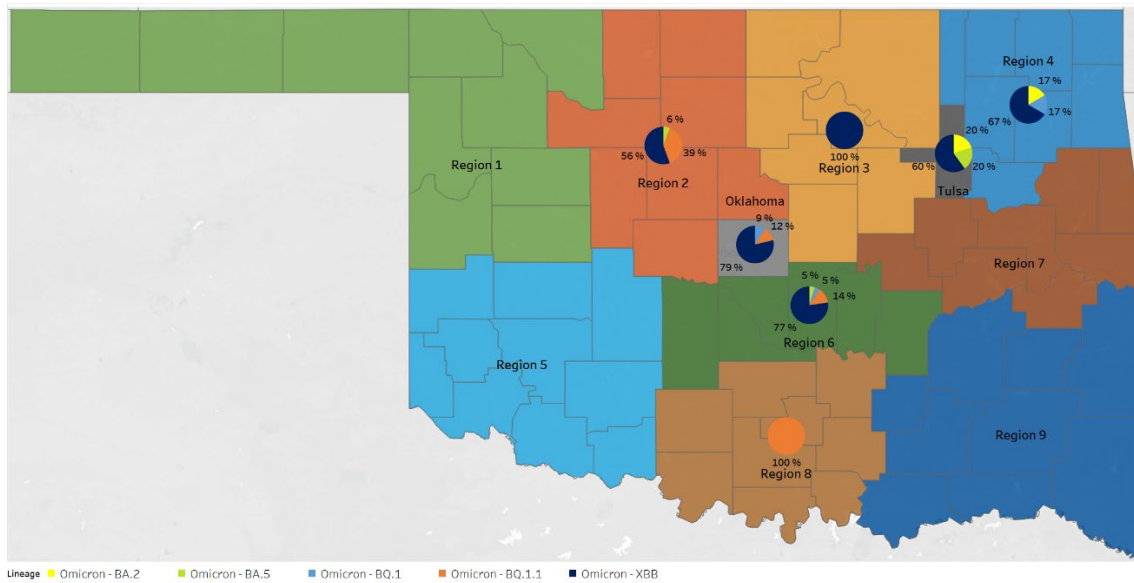

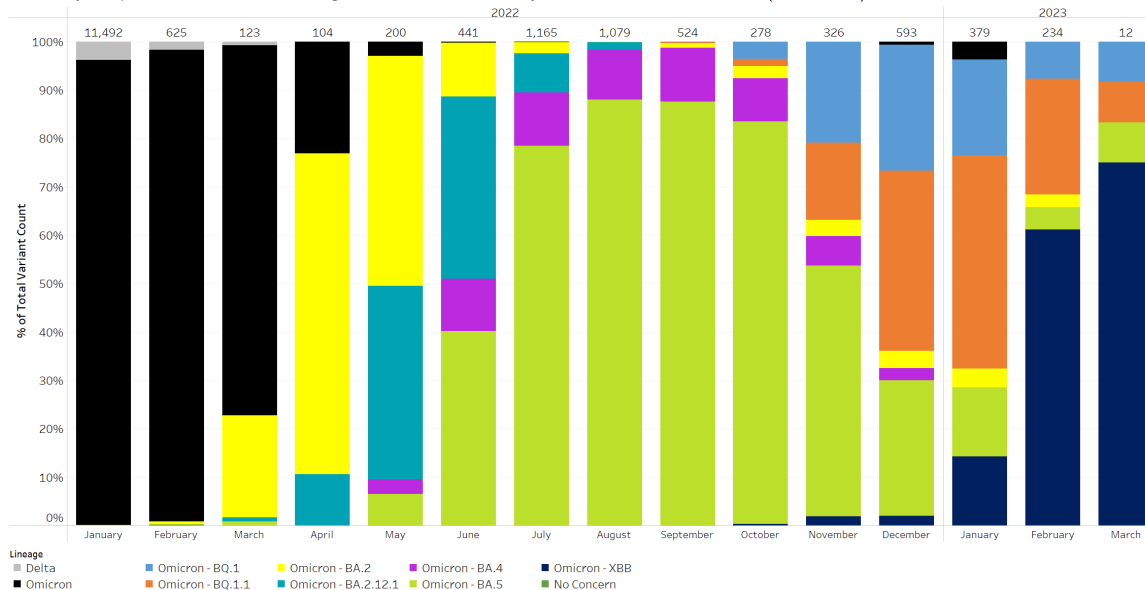
Variant Proportions by Region, Dates of Specimen Collection: February 20, 2023 - March 1, 2023, (N=91):

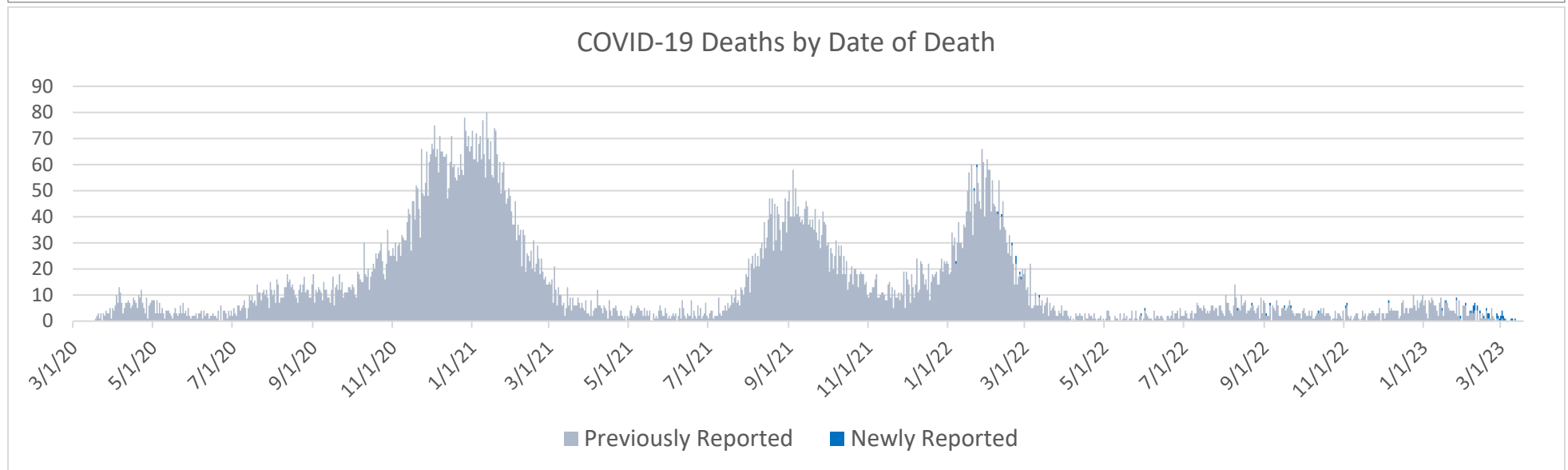
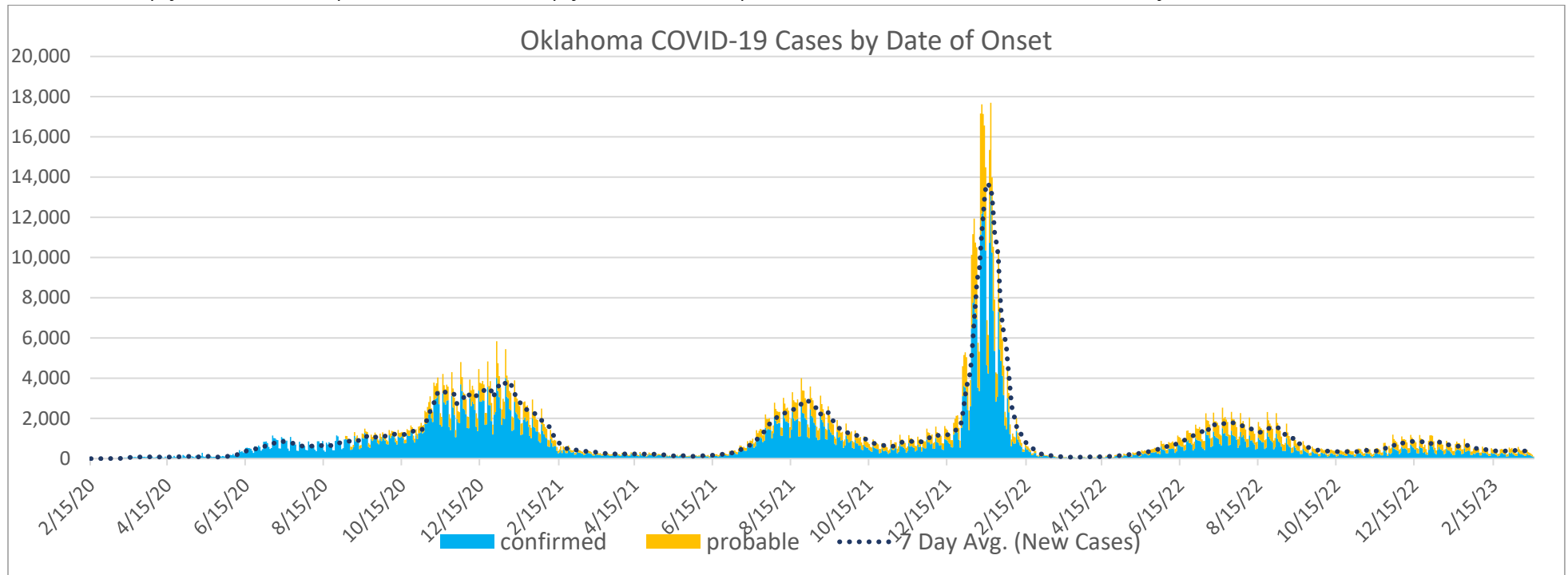
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - March 20, 2023 (N=17,575)

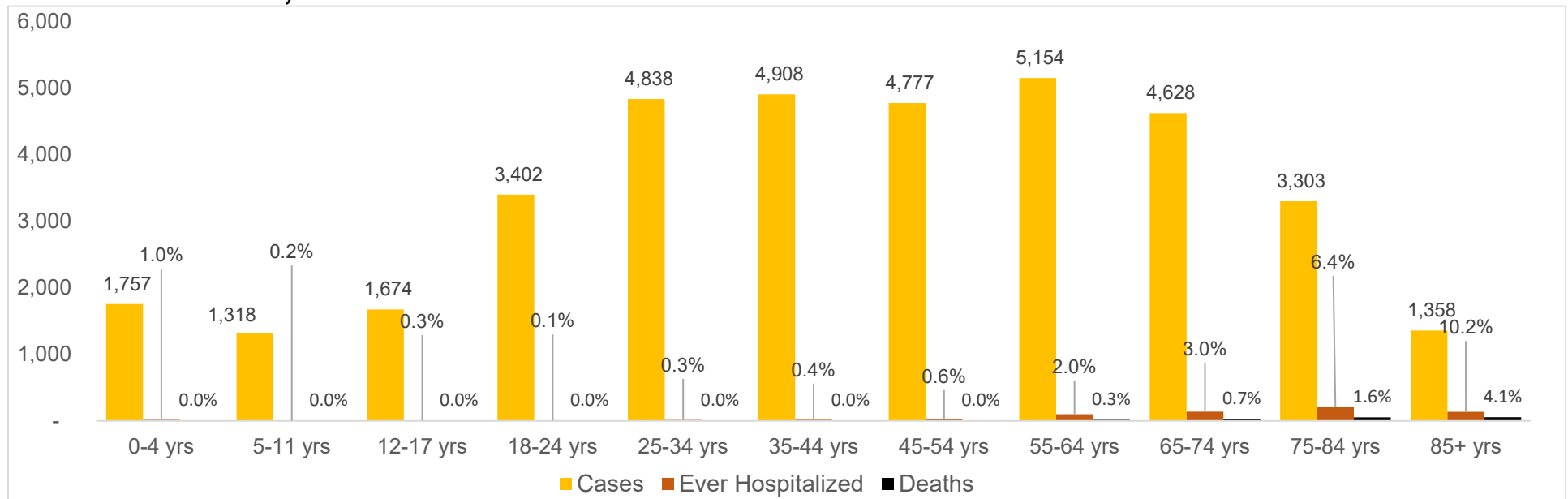

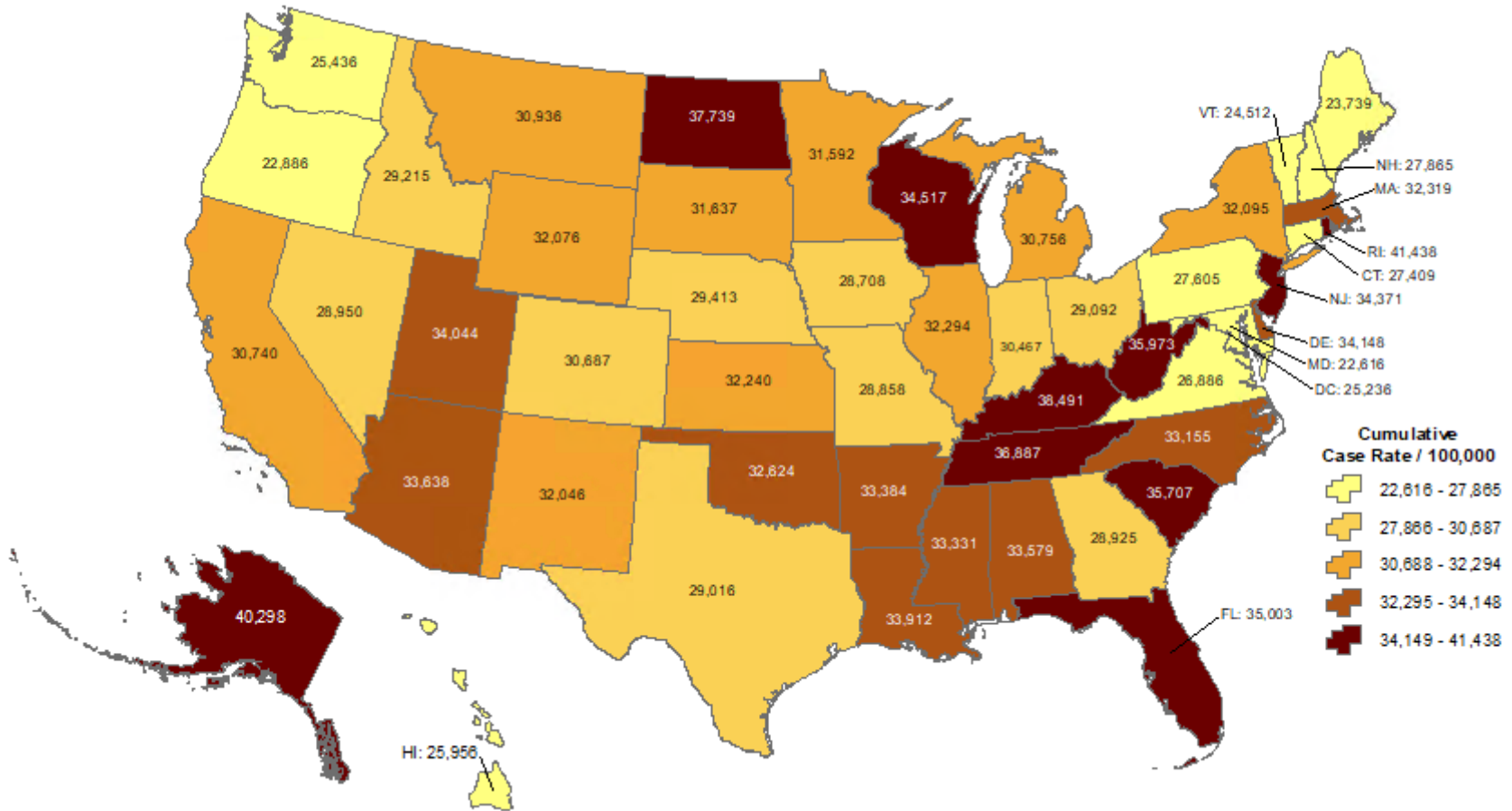
## 2022-2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

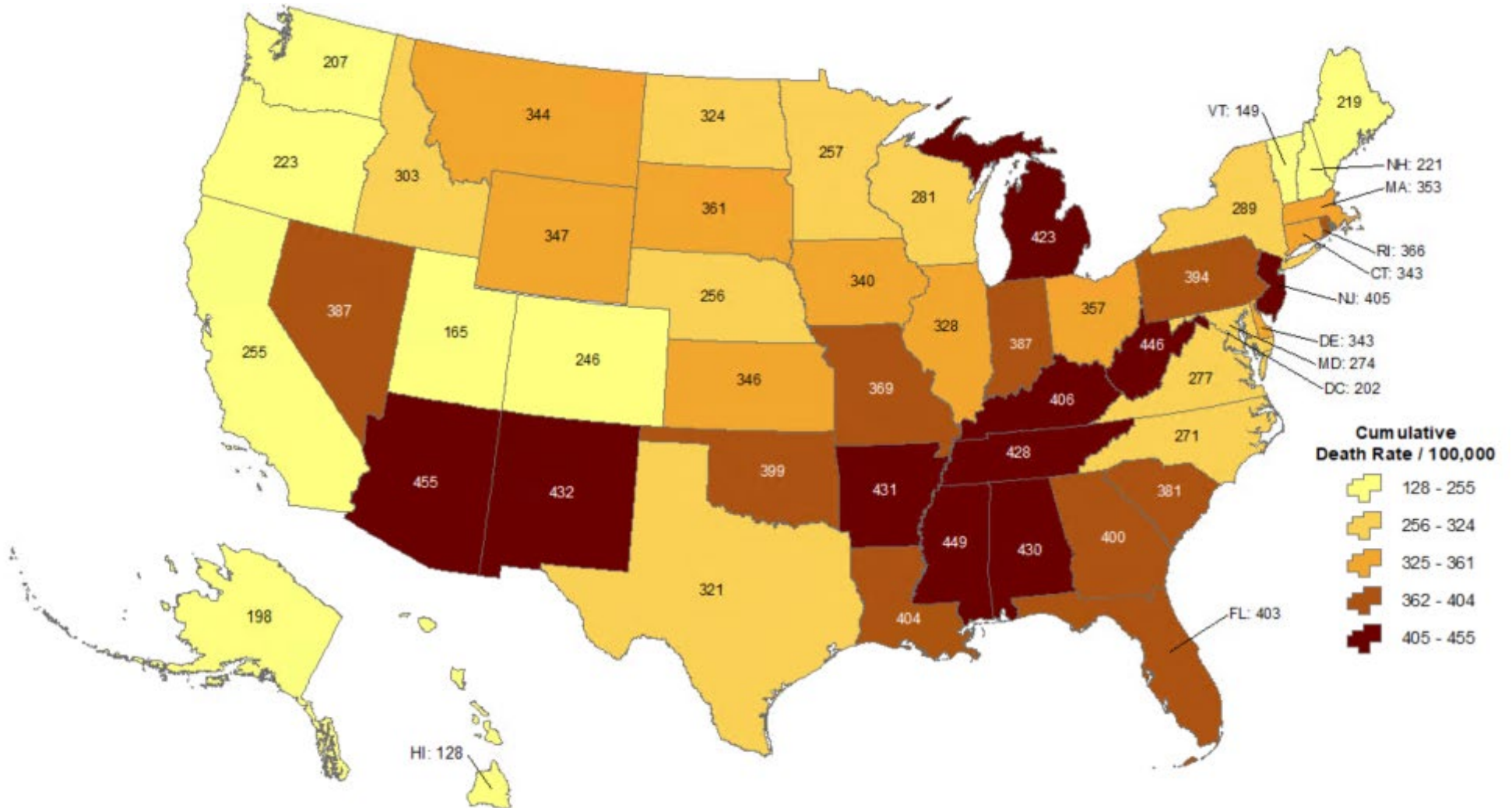

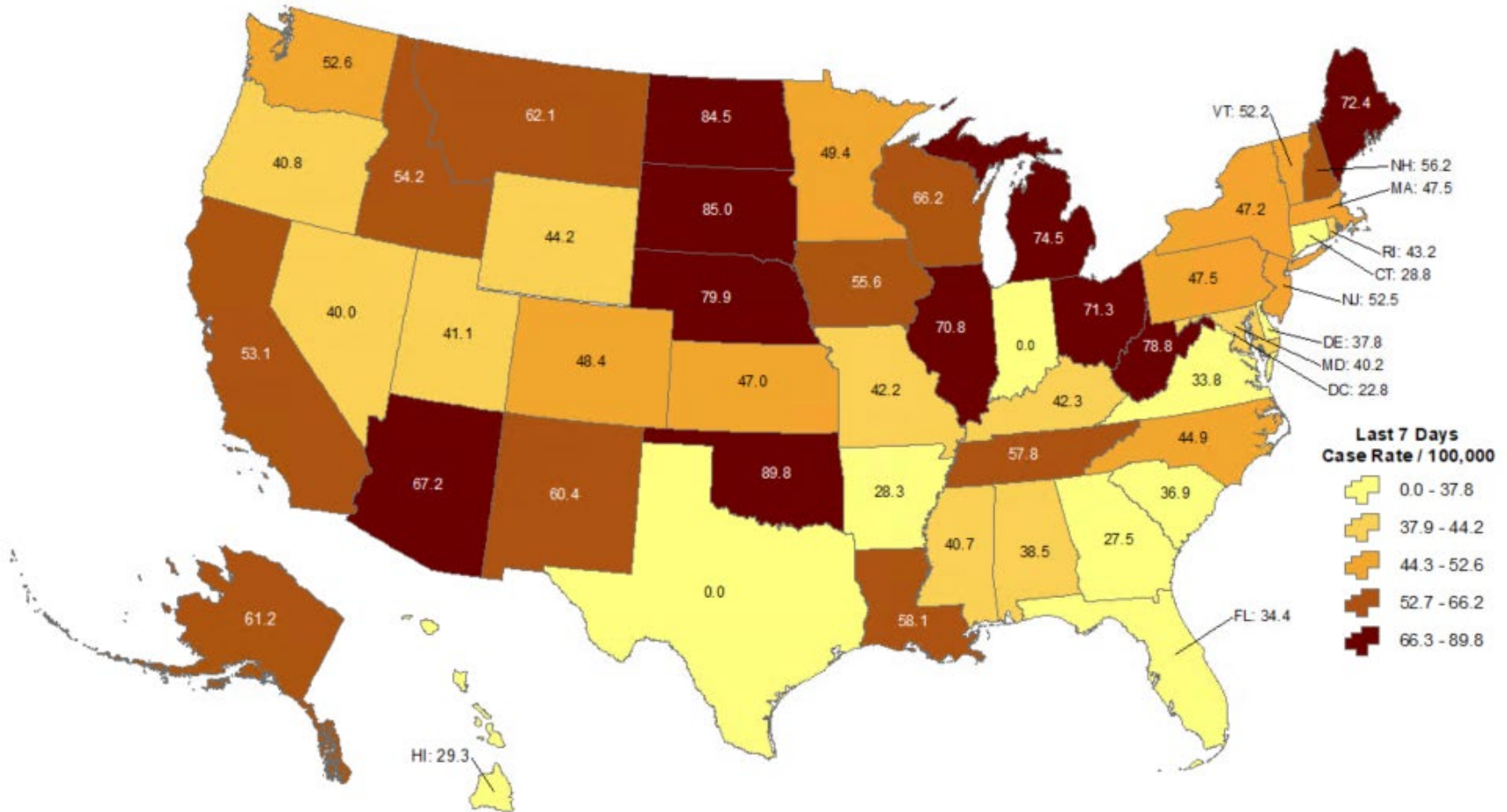

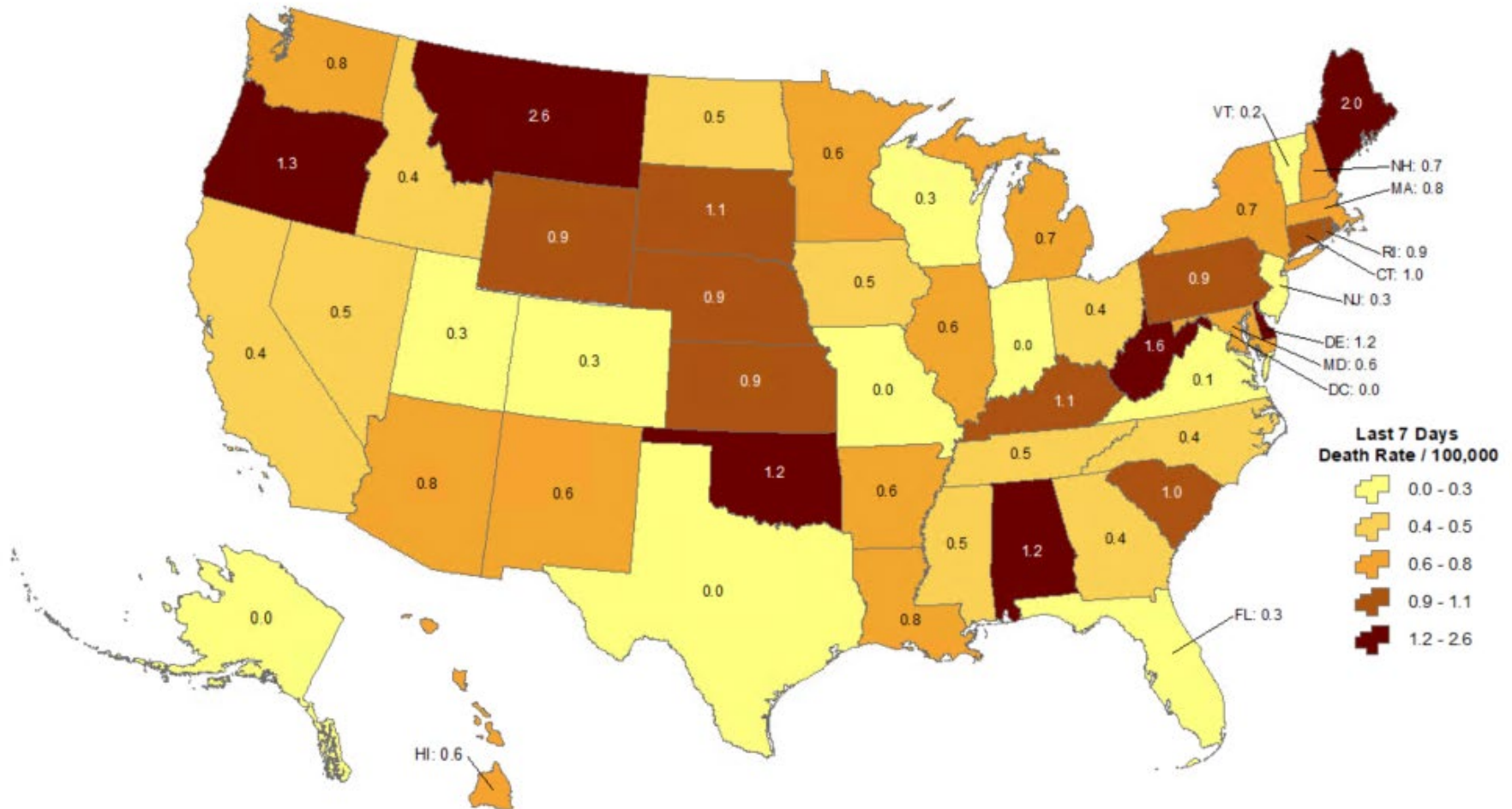

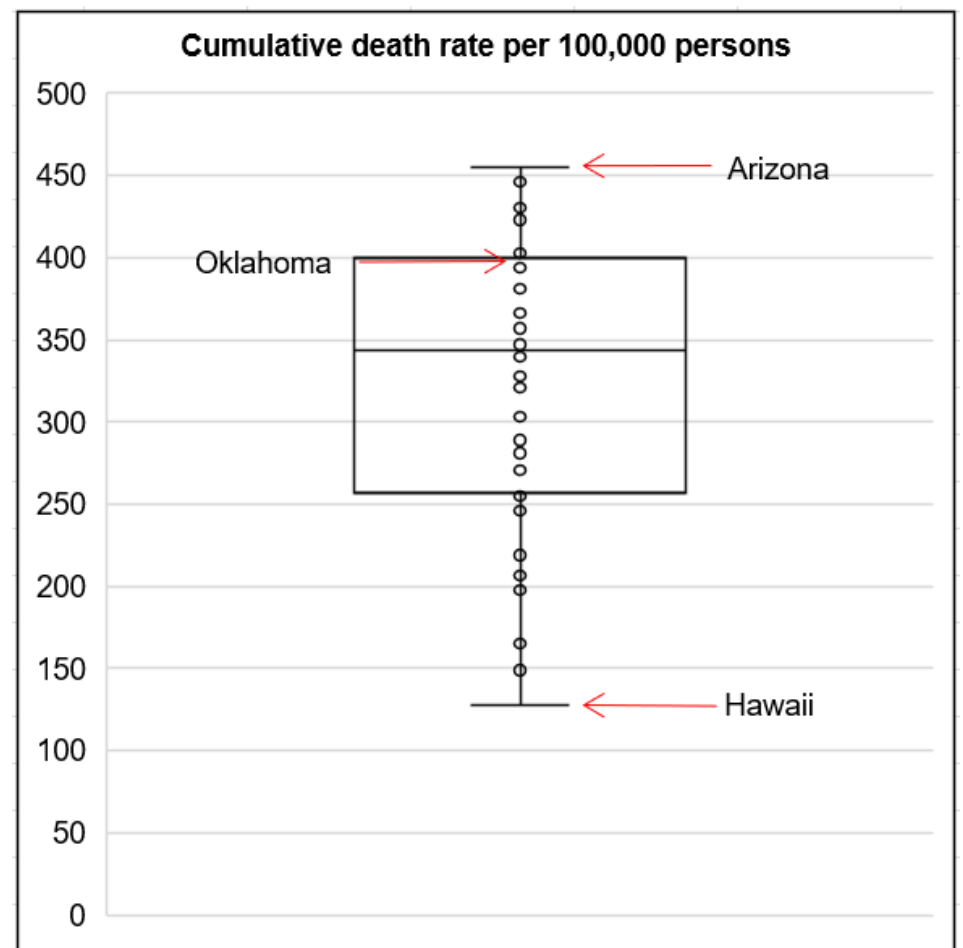
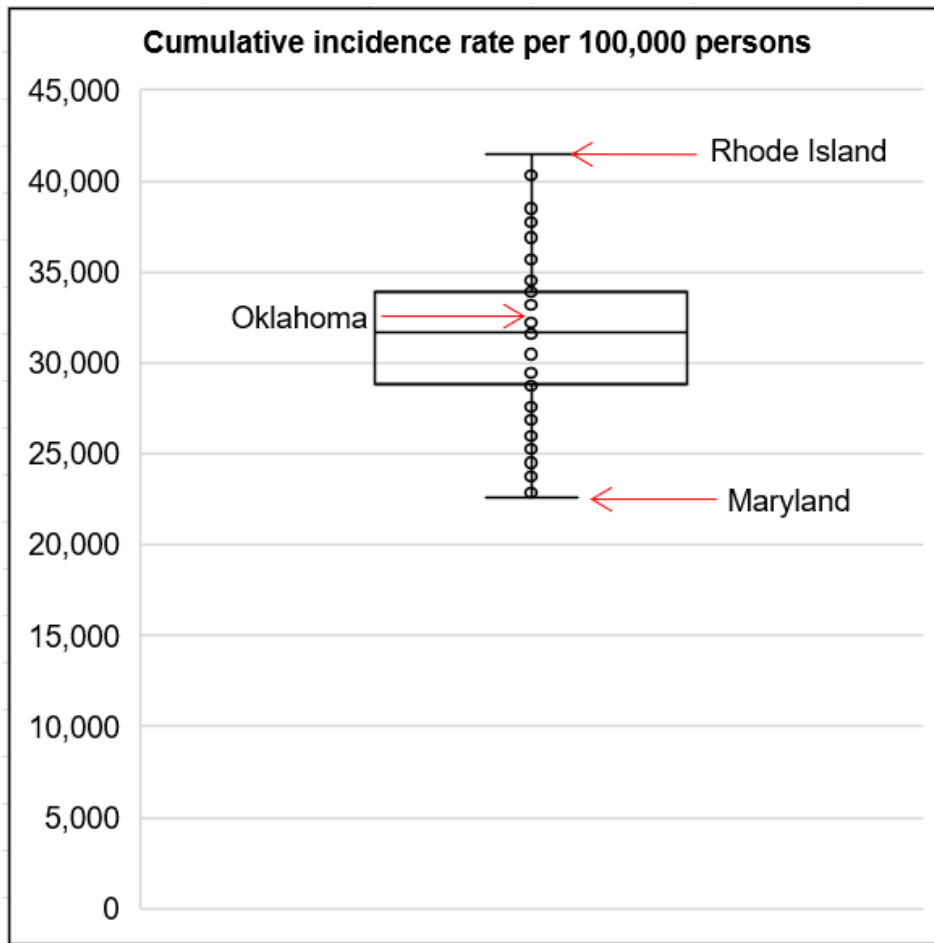

Weekly number of deaths (from all causes)

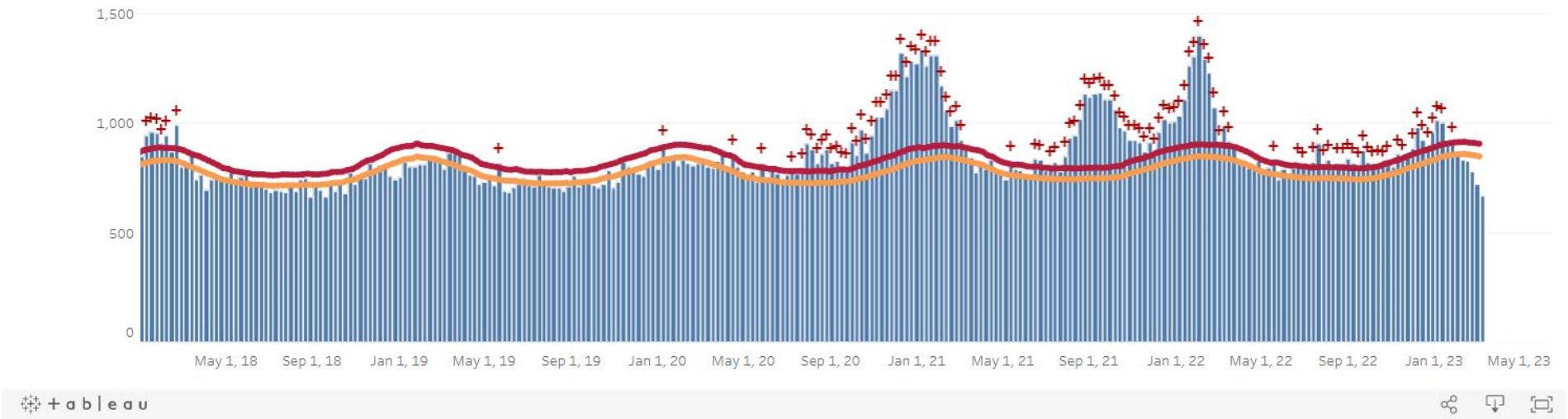
