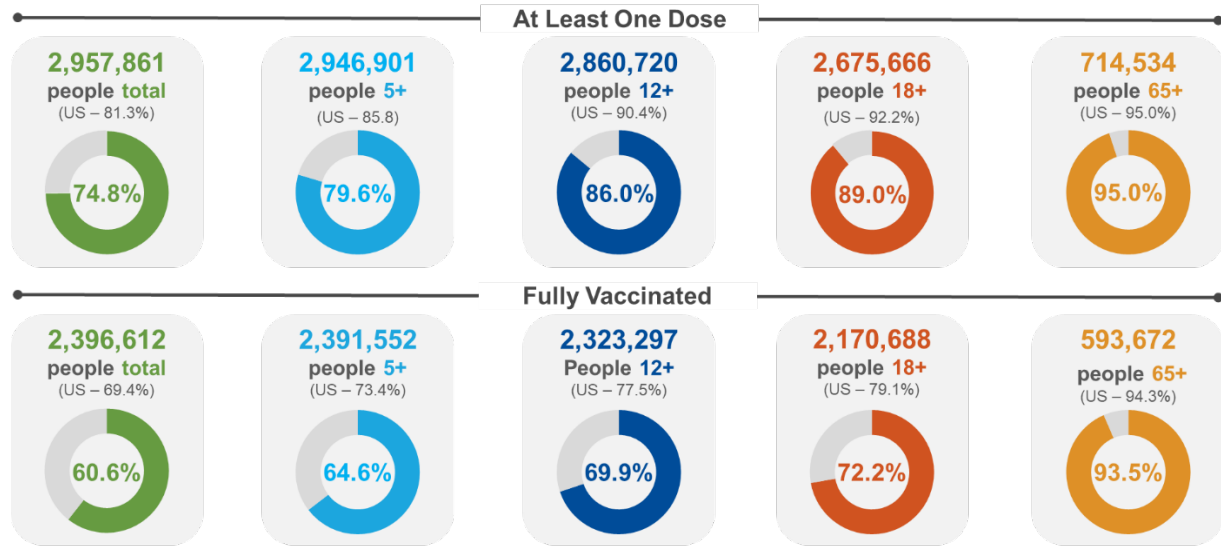

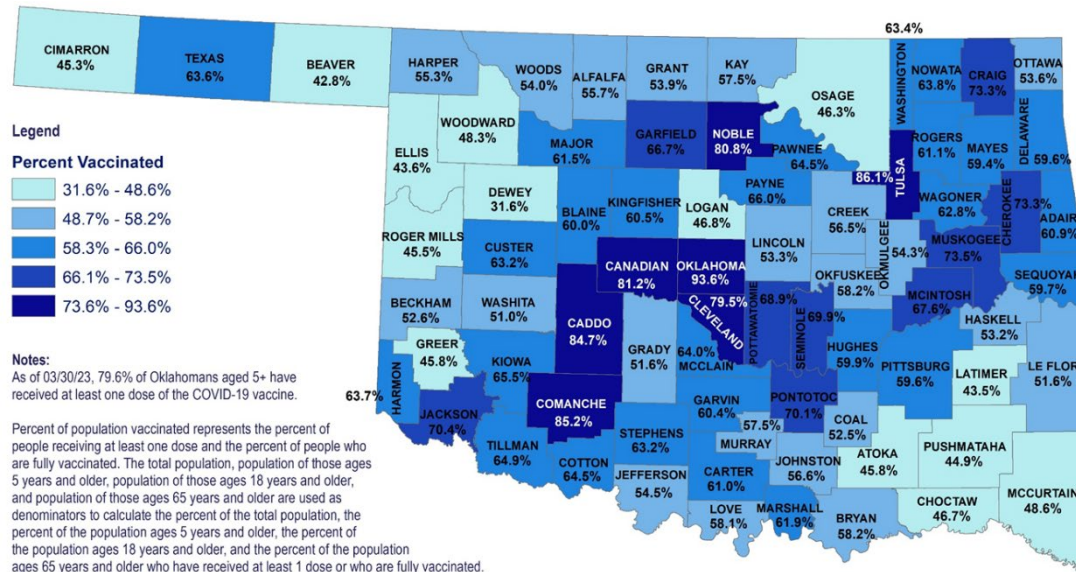

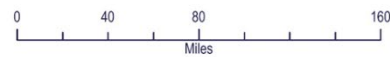

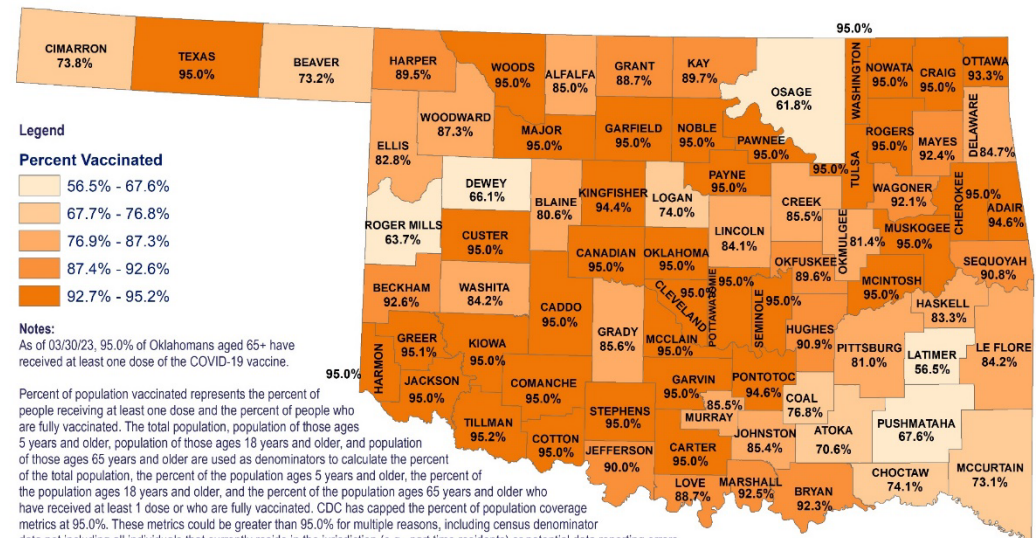

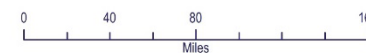

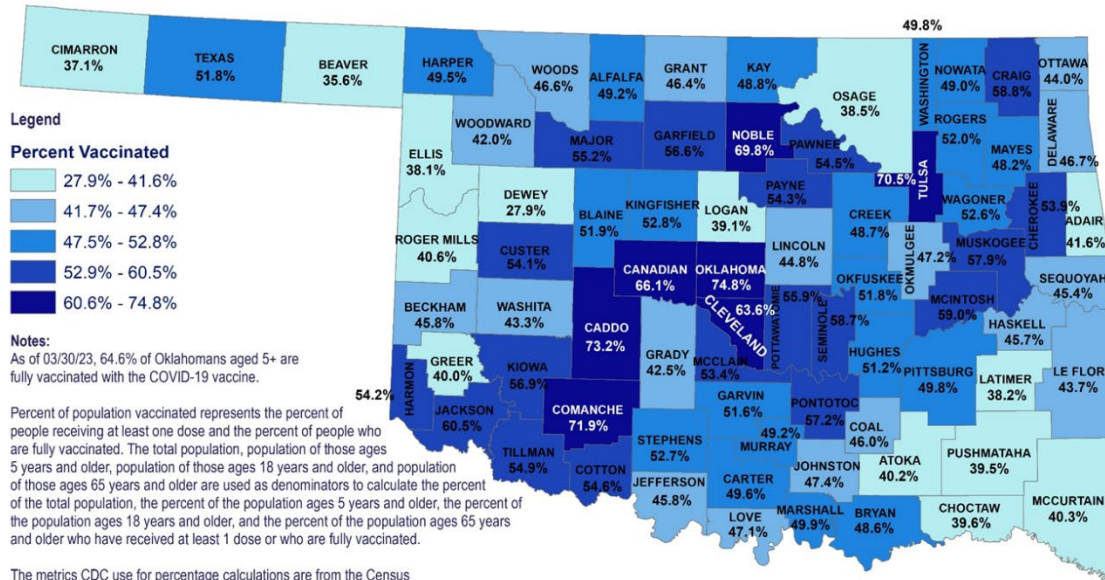

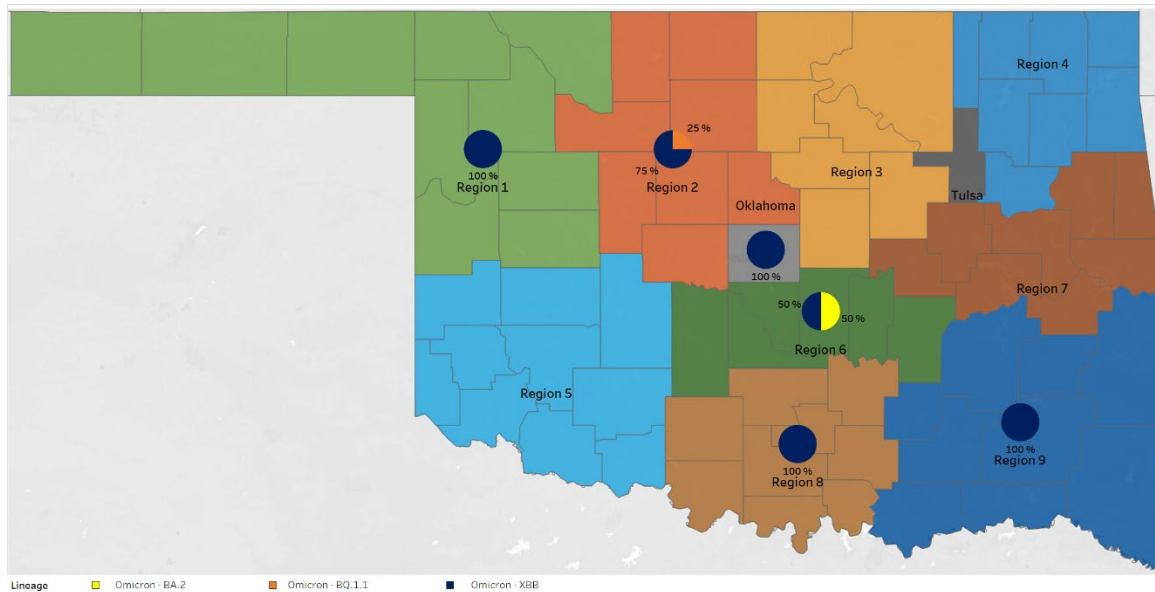

COVID-19 VARIANT STRAINS SEQUENCED*

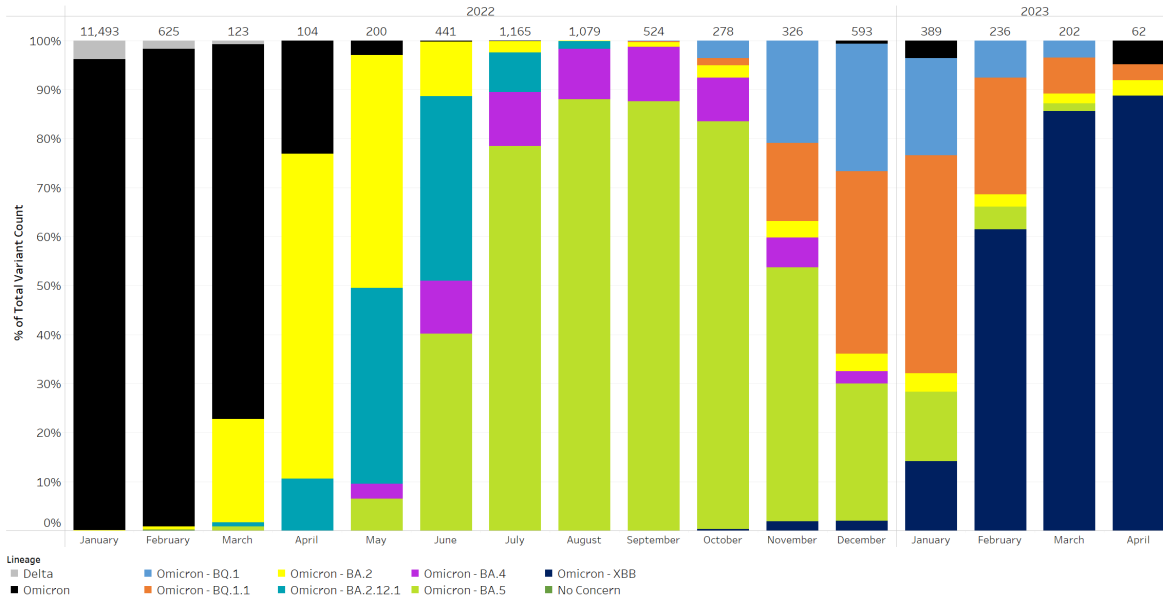
Variant Proportions by Region, Dates of Specimen Collection: April 12, 2023 - April 21, 2023, (N=20):

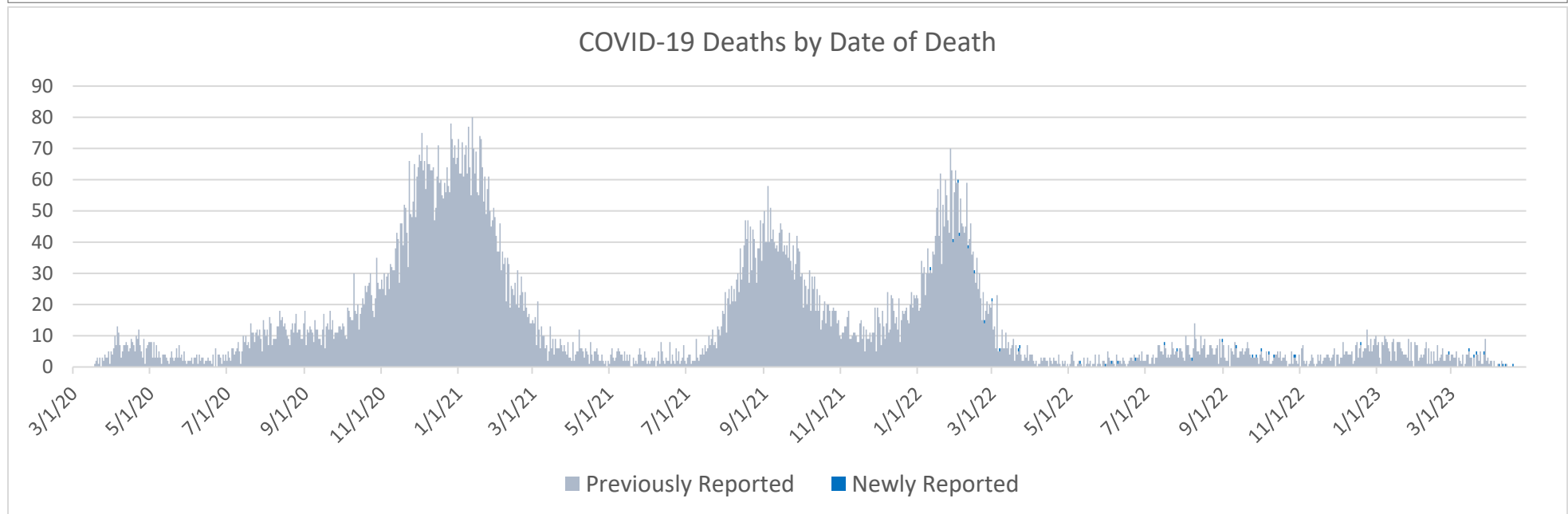
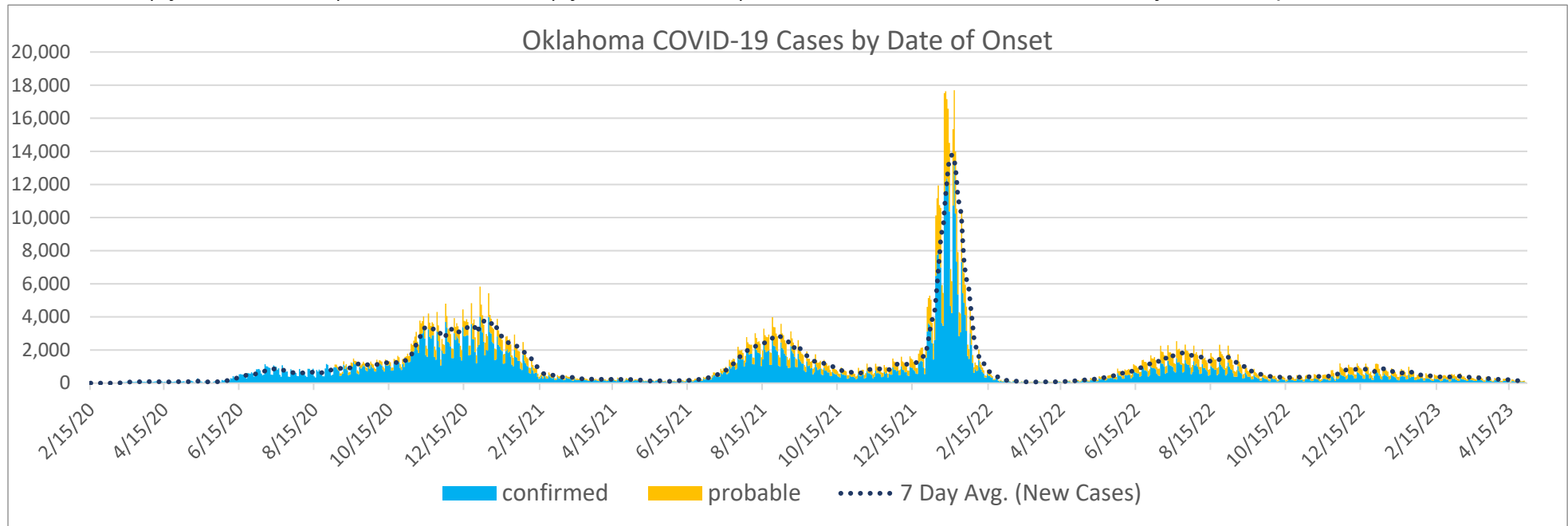
Monthly Proportion of Variant Lineages, Oklahoma, January 1, 2022 - May 2, 2023 (N=17,840)

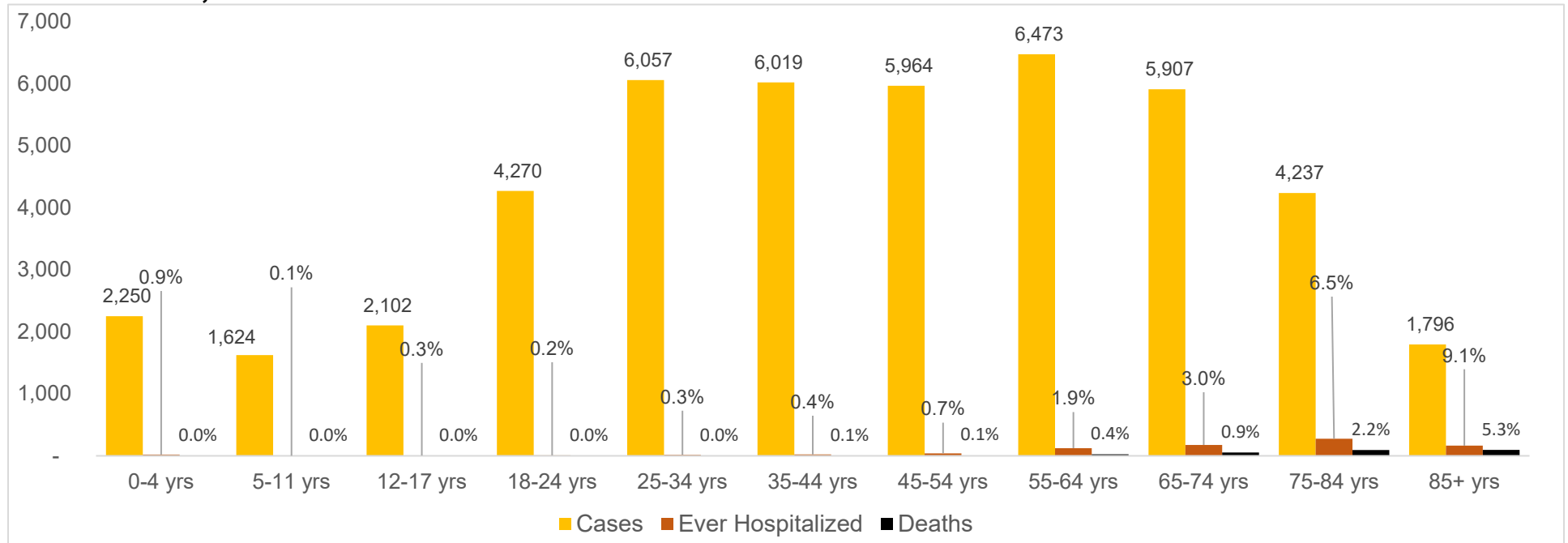

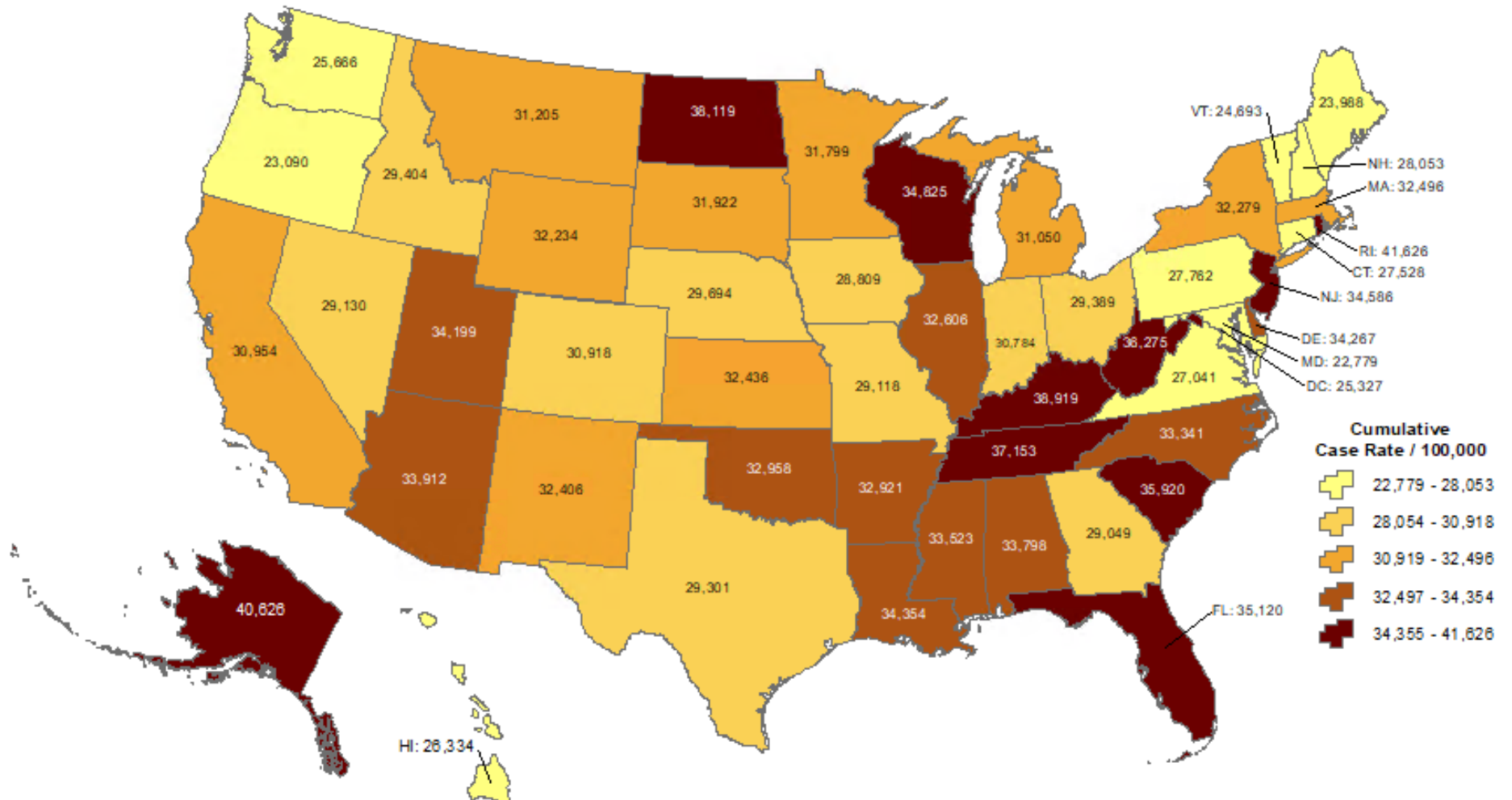
2023 CASES, PERCENT HOSPITALIZED AND DEATHS BY AGE GROUP

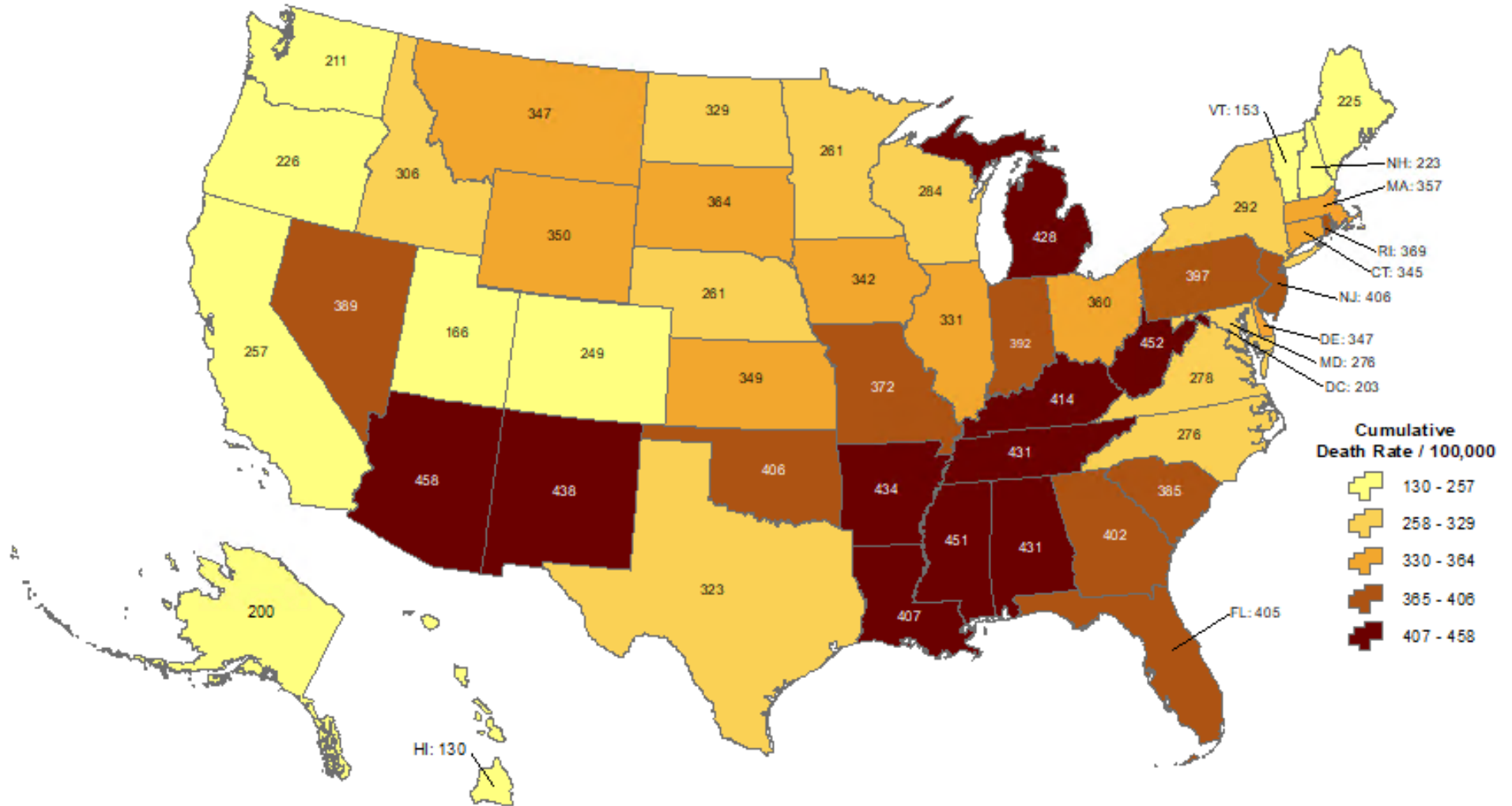

Cumulative death rate of reported COVID-19 cases

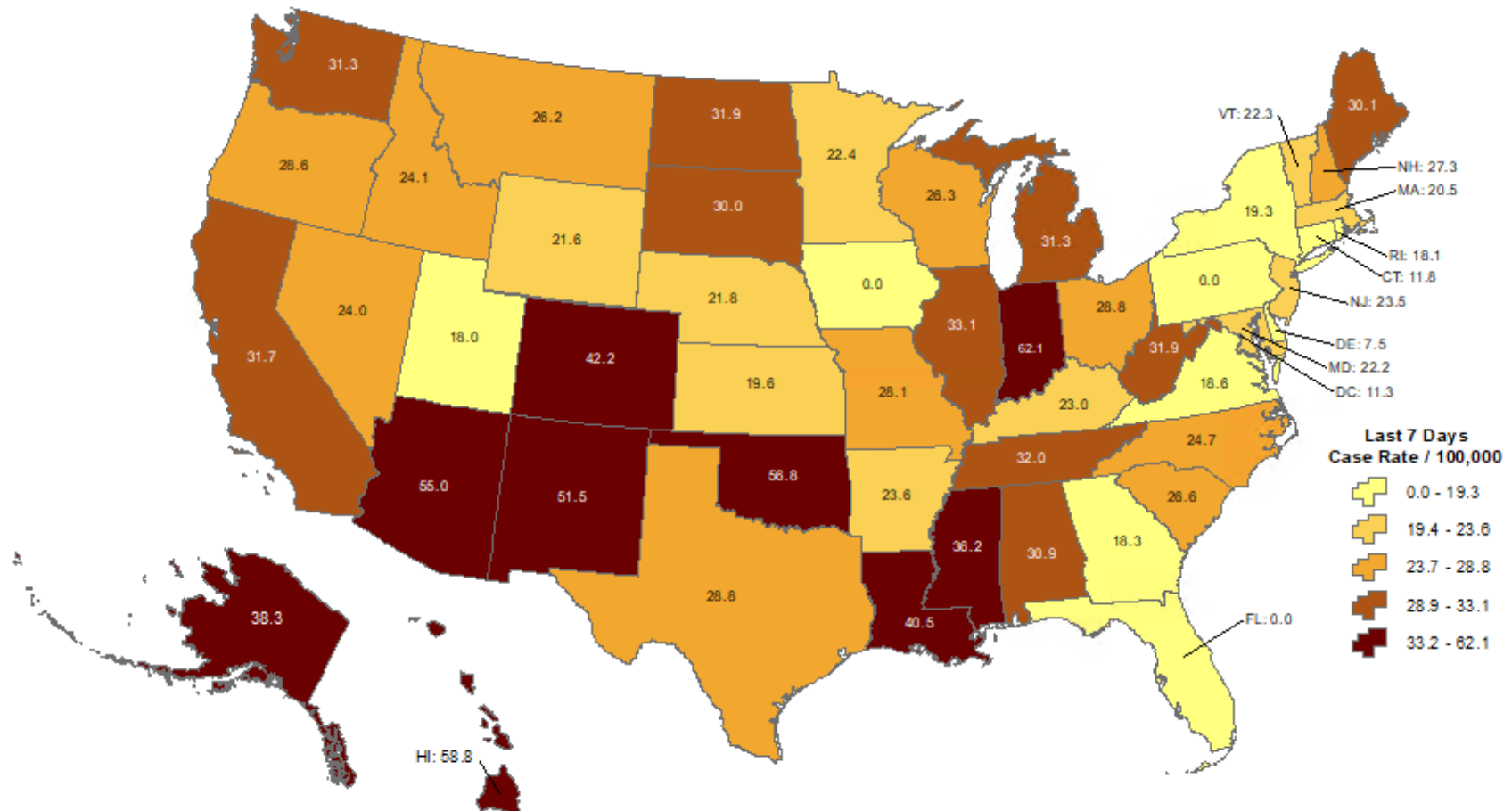

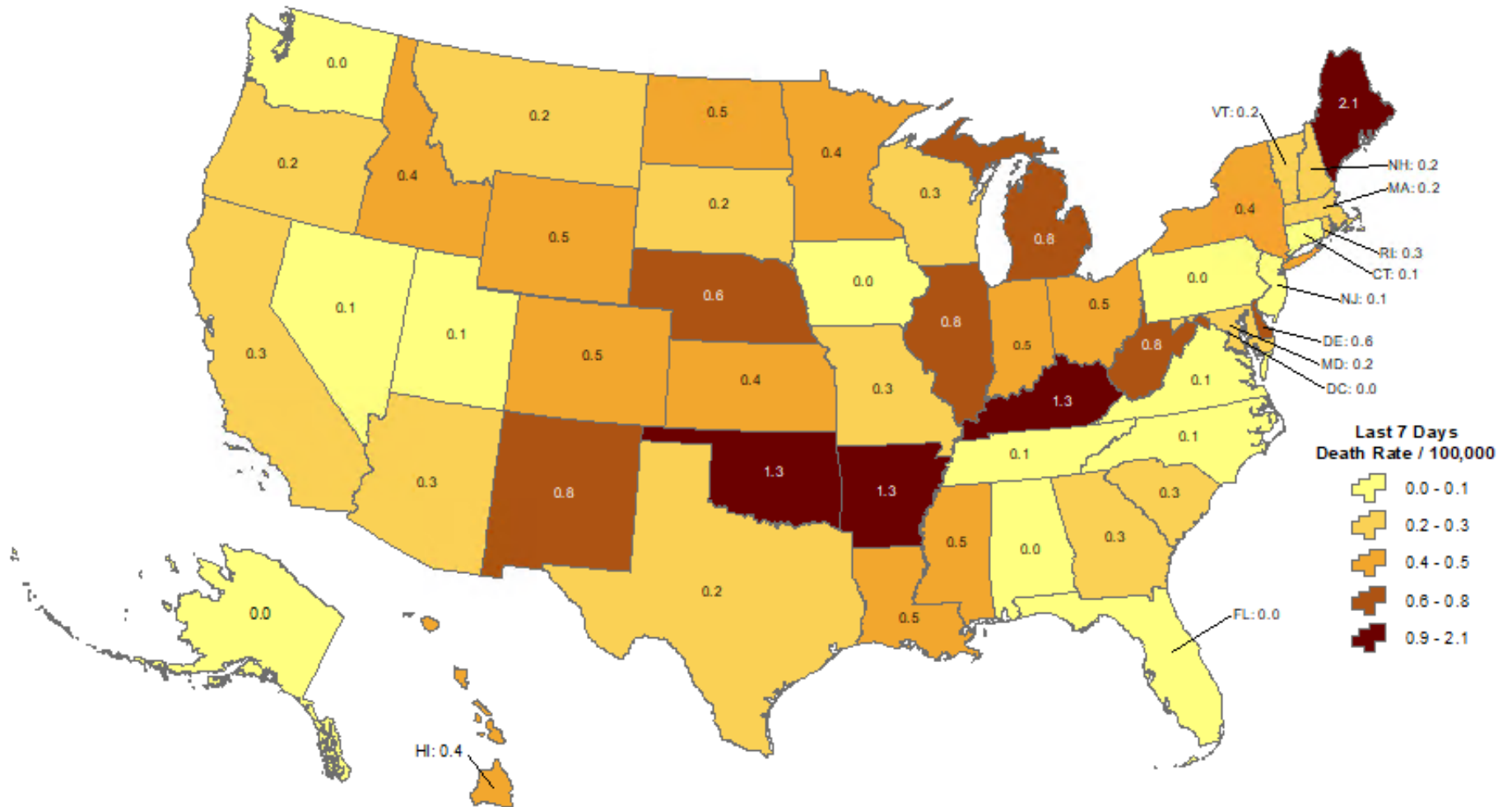

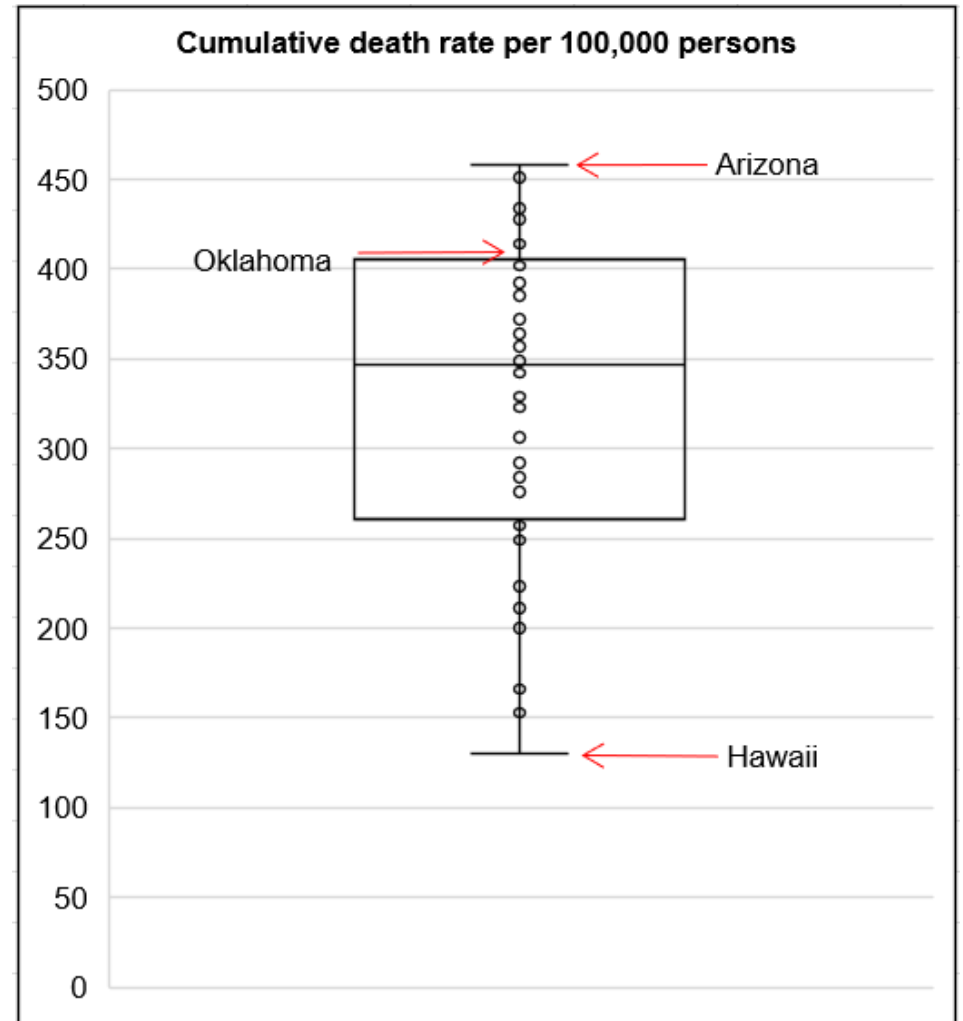
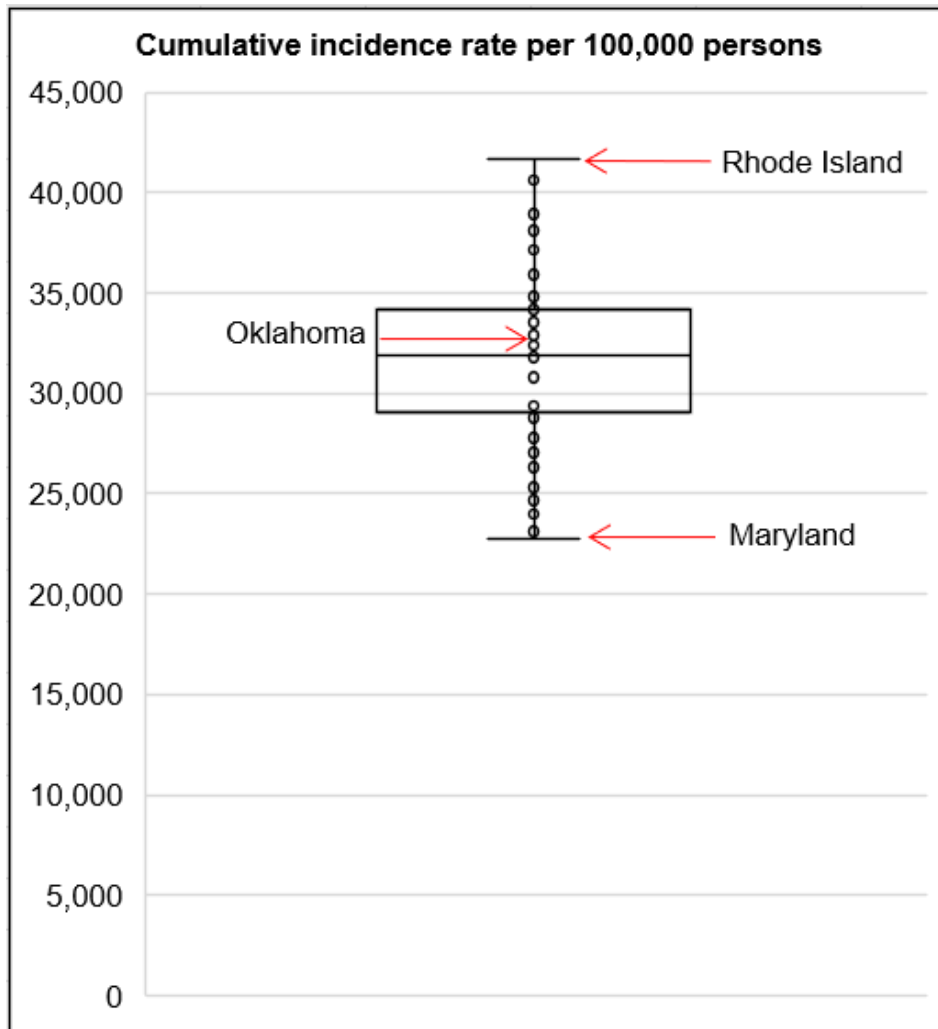

Cumulative incidence and cumulative death rate of reported COVID-19 cases



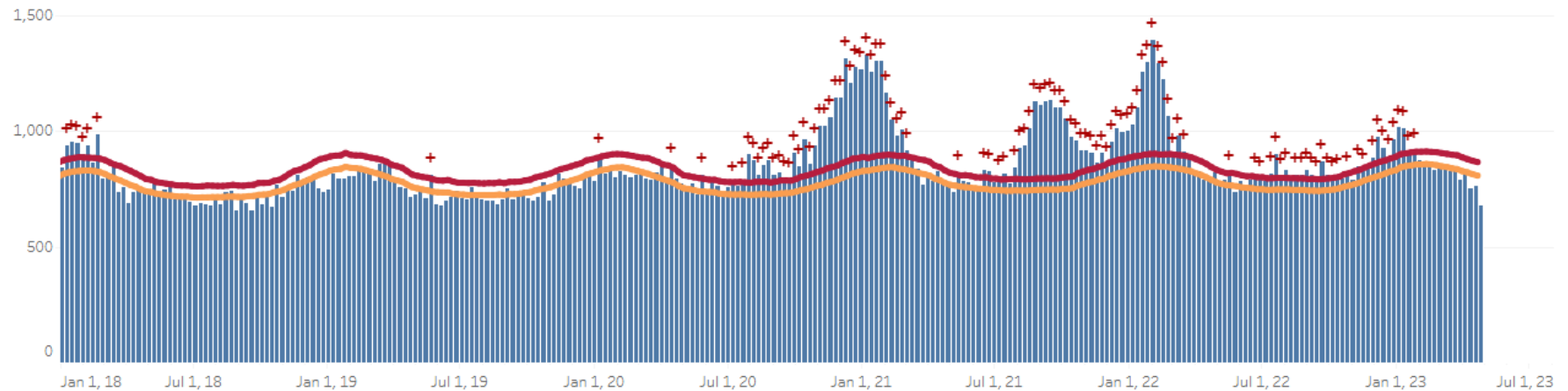
