

The economic crisis of American journalism threatens more than just the business models of newspapers – it undermines the ability of a free press to call the powerful to account. ProPublica is a new kind of institution: a non-profit newsroom, staffed with top talent but unencumbered by legacy costs, and having the sole mission of producing journalism with what we call “moral force.” It could not have been created at a more critical moment.

In just two years, ProPublica has had major impact in a variety of areas, including California’s then-scandalously lax system for licensing nurses, threats to our water from drilling for natural gas, and accountability in America’s biggest-ever stimulus program. Major milestones include:

- Recruiting the largest investigative news staff in the nation -- 32 full-time reporters and editors;
- Publishing more than 225 long-form stories with 50 leading publishing partners;
- Winning a Pulitzer Prize for Investigative Reporting, a George Polk Award for environmental reporting, the National Magazine Award for Reporting, the Selden Ring Award for “investigative reporting that has brought results,” and the Online News Association “general excellence” award for a news Web site of its size;
- Extending our reporting reach by creating and distributing databases that inspired and informed nearly 100 independent stories by local news organizations;
- Building a distributed reporting network of more than 5000 citizen volunteers.

ProPublica’s Reach and Impact

Since June 2008, we have worked with 50 different publishing partners, in print (New York Times, Washington Post, Los Angeles Times, USA Today, Newsweek, BusinessWeek), on television (60 Minutes and the CBS Evening News, 20/20, CNN), on radio (WNYC, KQED, This American Life, Marketplace), and online (Politico, Slate, Salon, Huffington Post, Daily Beast). In our first two years we published roughly 200 long-form stories through partners. More important than the wide proliferation of our stories is how ProPublica’s work has had far reaching effect.

The following examples illustrate how ProPublica’s investigations are exposing wrongdoing and, in turn, resulting in significant change. In each case we rely entirely on journalism, without lobbying or without allying ourselves with partisan groups. Instead, we strive to make our reporting accurate, fair, persuasive and compelling from the outset, to bring that reporting to the audiences best positioned to effect change, and to follow up where appropriate with new information and new audiences.

California's failure to monitor nurses – Reporters Charles Ornstein and Tracy Weber documented how the state's Nursing Board took as long as six years to remove licenses from nurses found to have beaten patients, stolen their pain medications, or been incapacitated by drugs or alcohol when patients needed crucial care. Nurses convicted of these offenses were often fired by one hospital, but, still having their licenses, easily found work at another. In July 2009, the day after the Los Angeles Times published a major Ornstein-Weber story exposing this scandal, California Gov. Arnold Schwarzenegger replaced a majority of the board, the executive officer and the chief of oversight soon resigned, and tougher standards for background checks and license renewals are on the way. Our 2009 coverage was a finalist for the Pulitzer Prize for Public Service and the Selden Ring Award from the University of Southern California's Annenberg School.

Threats to water from gas drilling – Reporters Abraham Lustgarten and Joaquin Sapien have published more than 75 articles on how enhanced techniques for capturing vast quantities of natural gas from deep underground can risk polluting our water supplies. As a result, New York's governor ordered a regulatory review, Congress is considering legislation to remove a legal provision barring the Environmental Protection Agency from regulating this water use, Manhattan's borough president has called for a drilling moratorium in the state, and the industry has begun disclosing what chemicals are in their drilling fluids. Publishing partners have included BusinessWeek, Politico, Salon, WNYC radio, and the leading newspapers in Albany, Pittsburgh, Denver and San Diego. Our 2009 coverage won the George Polk Award for environmental reporting and the Society of Professional Journalists Sigma Delta Chi Award for online investigative reporting; our 2008 coverage was a finalist for the Goldsmith Award from Harvard's Kennedy School of Government.

Secret plans to ration life-saving care in health emergencies – Reporter Sheri Fink's cover story, an astonishing narrative covering 19 pages of the New York Times Magazine, showed how a New Orleans hospital misused "do not resuscitate" orders in setting triage standards in the aftermath of Katrina. Her article demonstrated that several patients were given deadly doses of morphine. The work helped prompt an Institute of Medicine report rejecting that triage standard, won the Pulitzer Prize for Investigative Reporting and the National Magazine Award for Reporting, and was named a finalist for the Michael Kelly Award. Fink's subsequent reporting in the Times, South Florida Sun-Sentinel, and Orlando Sentinel spurred greater openness as governments from New York to Florida sought sensible guidelines for managing pandemics.

Good and bad in the federal stimulus program – ProPublica's definitive coverage of the largest spending program in the nation's history has been relied upon by officials ranging from the Joint Economic Committee of Congress to the President's Council of Economic Advisers, and from the House Speaker to the designers of the government's own Recovery.gov Web site. Our exposure of dubious spending on small airports was backed up by the Department of Transportation's Inspector General. Reporter Michael Grabbell and ProPublica colleagues have

collaborated with partners including WNYC radio, the CBS Evening News, USA Today, the Huffington Post, MSNBC.com, Salon, MinnPost and Patchwork Nation.

Broken promises to injured workers – The U.S. government promised legions of contract workers supporting American troops in Iraq and Afghanistan that they would get health care if they were injured and ample aid for their families if they were killed. Reporter T. Christian Miller demonstrated that, in many cases, those promises were not carried out by AIG and other insurers. Congressional hearings followed, the Department of Defense has proposed changes to the Defense Base Act, and the Department of Labor has stepped up enforcement and set new goals to speed delivery of benefits. Partners have included the Los Angeles Times and ABC. Our 2009 coverage won the Selden Ring Award from USC's Annenberg School and the Overseas Press Club Online Journalism Award, and was a finalist for the Daniel Pearl Award from the International Consortium of Investigative Journalists.

Extending the Reach of our Work

The core of ProPublica's publishing effort is our growing Web site. In addition to archiving all of our work on the site, we update it several times a day with short follow-up pieces to our own major investigations, links to and comments on important investigative reporting from other news organizations, and up-to-the-minute reports on topics like transparency in the federal stimulus and bailout programs.

The most important single way that ProPublica expands its impact is through the distribution of its most powerful work through major media partners. But also important is our Web site itself. Its audience includes thousands of journalists, so we augment our stories with Web tools and databases that make it easier for traditional and online journalists to adapt our work to their readers, listeners or viewers.

For example, ProPublica reporters spent many hours gathering, updating, and sometimes correcting, information on stimulus spending from numerous government agencies. In August 2009, the data were assembled in our Recovery Tracker database, which enables anyone to review federal stimulus spending down to the county level. Quickly, local reporters around the country dug into the database and produced 100 original stories on the impact of the spending in their communities.

Another example is the ProPublica Reporting Network, under the leadership of director of online enterprise Amanda Michel. To date, more than 5000 volunteers collaborate directly with ProPublica's investigative journalists, helping to follow-up and gather information on our investigations. In one initiative, members of the network help us regularly track the status of more than 500 stimulus-funded construction projects around the country.

We constantly seek to produce the sorts of innovative journalism made possible by new technologies. We maintain an active presence in social media, including Twitter and Facebook. We developed ChangeTracker, which facilitates monitoring of web sites such as whitehouse.gov. ChangeTracker received a Special Distinction Award in 2009 from the Knight-Batten Awards for Innovations in Journalism. And two of ProPublica's editors, Scott Klein and Eric Umansky, are leaders in developing Document Cloud, a Web site in development which is aimed at making original source documents easy to find, share, read and collaborate on. ProPublica was recently named one of the ten most innovative companies in media by Fast Company magazine, and received the first Edward R. Murrow Award for Media Entrepreneurship.
