— Judge Saylor grants it, still no bond / still no oath  
December 10, 2019 neither bond

Mulligan gets

- Wells Fargo records of \$25M in payment to Mayrant company Fraud Transfer Act
- files lawsuit against WC (even though no bond post)
- Jan. 2020 Sayfar got 3 bonds posted and ratified what was done illegally

- March 6, 2020 - Superior Court \$3.75M in evaluation being based on Class A interest

- stayed & due April 21, 2020; prosecutor agreed / end up back in District Court

- June 28

- Miller Milligan acting improperly to force sale

  - Super majority - did not interfere


