I am forwarding this per instructions from the AG. I cannot sign this because the complainant has not been forthcoming and above board with our Agency. He and his attorney have failed to provide me with relevant documents they have told me they possess, even though I have made numerous requests to the complainant's attorney for specific documents, i.e. the documents the attorney received from the U.S. Magistrate Judge in February, along with any copies of the search warrants served on the complainant's attorneys in August 2019 or thereafter. I feel that the complainant is seeking to manipulate me and this Agency into conducting an investigation without providing us all the relevant facts.
