Just confirming our call here. We are available for mediation or a meeting of the parties if a mediator cannot be timely agreed, any day between June 30-July 9. Further, as discussed we believe it is important that a mediation or meeting take place next week, which will give the parties an additional week before the two week period discussed at the hearing, for any follow on negotiations or documentation if a settlement is reached.

We also wanted to follow up and see if you have received a copy of Mitte's Form 990 filing for the years 2018 or 2019, in which the Foundation is required to report to the IRS the current value of its investments, including the two at issues in these proceedings. That is a critical piece of information necessary and our understanding is that they have inexplicably failed to file the same.
