TO APPROVE EXTENDING BUSINESS LICENSING DEADLINE FOR VENDORS WHO DEAL WITH SENECA GAMING CORPORATION OR IT SUBSIDIARIES

MOTION: by Richard Nephew, seconded by Nikki Seneca, that Tribal Council approves the following resolution:

**WHEREAS**, the Nation's President previously issued an Executive Order, giving those vendors who do business with the Seneca Gaming Corporation (or its subsidiaries), until September 1, 2012 to apply to the Nation's Business Permitting Office for a general business license under the Business Code;

**WHEREAS**, the Seneca Gaming Corporation has indicated that several vendors require additional time to comply with the provisions of the Executive Order;

**WHEREAS**, the Nation's Council desires to extend the deadline for compliance with the executive order, and provide for a streamlined process for businesses who have otherwise obtained a vendor license from the Seneca Gaming Authority, under the Compact, the Class II Gaming Ordinance or the Class III Gaming Ordinance.

**NOW, THEREFORE, BE IT RESOLVED**, that the deadline for vendors who do business with the Seneca Gaming Corporation (or its subsidiaries) to submit any required application for a general Nation business license under the Business Code is hereby extended to August 31, 2013; and be it further

**RESOLVED**, that, for those businesses who otherwise hold a vendor license issued by the Seneca Gaming Authority, compliance with the requirement to obtain a general business license under the Nation's Business Code may be alternatively fulfilled by filing a copy of the vendor's current and valid Seneca Gaming Authority-issued license with the Nation's Business Permitting Office, and paying the requisite general business license fee.
