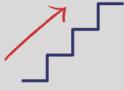


DESTRUCTION OF RECORDS (DOR)

? "Why would I request my records to be destroyed?"

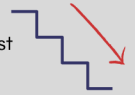
Requesting your records to be destroyed can be beneficial for background checks, state licensing, military enlistment, nursing or medical careers, and real estate. It also means you may be eligible to restore your rights to firearms as an adult. *Destruction of Records is not available in Adult Court.*

Diversion DOR



If you **successfully complete** your Diversion Program, your record will automatically be destroyed 90 days after your 18th birthday.

If you **do not successfully complete** your Diversion Program, you will need to call Durango Probation Reception* or Southeast Probation Reception* to speak with a Diversion Supervisor.



Be sure to talk about this with your Juvenile Probation Officer if you have further questions

Juvenile Court Cases DOR

Eligibility Requirements To Destroy Records At Age 18:

- No felony convictions or pending criminal charges
- No felony adjudications of §13-501 (A) or (B)
- No misdemeanor or felony DUI adjudications
- Successfully completed probation or successfully discharged from ADJC
- Not currently required to register as a sex offender pursuant to §13-3821
- All restitution has been paid in full
- All other monetary obligations have been paid in full or modified by the court

Eligibility Requirements To Destroy Records At Age 25:

- No felony convictions or pending criminal charges
- Not currently required to register as a sex offender pursuant to §13-3821
- All restitution has been paid in full
- All other monetary obligations have been paid in full or modified by the court

SET ASIDE JUVENILE ADJUDICATION

? "Why would I request my records to be set aside?"

"Set Aside" is a way to ensure that your record won't affect schooling, employment, or housing. Lastly, you will also need to work with the AZ Department of Transportation for any licensing requests.

Set Aside

Eligibility Requirements For Non-Violent & Non-Dangerous Offenses:

- At least 18 years old
- Fulfilled conditions of probation or successfully discharged from ADJC
- Not adjudicated of a dangerous offense defined in §13-105
- Not adjudicated of an offense for which there was a finding of sexual motivation pursuant to §13-118
- Not adjudicated of a sexual offense
- Not adjudicated of a DUI
- All restitution has been paid in full
- All other monetary obligations have been paid in full or modified by the court

MARIJUANA RELATED OFFENSES

Marijuana Related Offenses

Eligible offenses include, but are not limited to possessing, consuming, or transporting two and a half (2 1/2) ounces or less of marijuana

RESTORE RIGHTS (FIREARMS)



Can I restore rights to own a firearm?

Individuals with felony juvenile adjudications may request the court to restore the right to possess firearms. §8-249

Restore Rights

Option 1

The court may restore the right at the end of a person's probation term.

Option 2

An individual may apply for restoration of gun rights two (2) years after the completion of probation if they were adjudicated of a non-"serious" or non-"dangerous" felony offense. "Serious" offense felonies are defined in §13-706. "Dangerous" offense felonies are defined in §13-704.

Option 3

An individual may apply for restoration of gun rights at age 30 if they were adjudicated of a "serious" felony offense, burglary in the 1st or 2nd degree, a "dangerous" felony offense or arson.
