**TREATY EVENT
MULTILATERAL TREATY FRAMEWORK:
AN INVITATION TO UNIVERSAL PARTICIPATION
FOCUS 2006: CROSSING BORDERS**

UNITED NATIONS HEADQUARTERS
13-15 SEPTEMBER 2006

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

It is recalled that a series of successful treaty events has been held annually at United Nations Headquarters commencing with the Millennium Summit in September 2000. In 2005, the Treaty Event held during the World Summit of the General Assembly was focused on the theme "Responding to Global Challenges" and attracted 265 treaty actions undertaken by 99 States and the European Community.

The General Assembly has decided to convene a High-Level Dialogue on international migration and development during its sixty-first session - focusing on the linkages between migration policy and human rights, development, trade, state sovereignty and security. Consistent with the Organization's objective of consolidating and advancing the international rule of law, and consistent with the High-Level Dialogue on international migration and related issues, the theme for the Focus 2006 Treaty Event will be "Crossing Borders".

The Treaty Event will take place in parallel with the High-Level Dialogue at Headquarters in September 2006. The list of treaties being highlighted during Focus 2006 is attached. As is customary, it will be possible to undertake treaty actions with regard to any treaty deposited with the Secretary-General during the Treaty Event.

Delegations intending to sign or deposit instruments during the Treaty Event relating to multilateral treaties deposited with the Secretary-General may wish to inform their Governments accordingly for the purpose of completing the requisite domestic procedures.

The publication *Multilateral Treaty Framework: An Invitation to Universal Participation - Focus 2006: Crossing Borders* is currently being compiled and will be circulated to all Permanent Missions in New York as soon as possible. This publication will contain summaries of key provisions, relevant final clauses and the status of the treaties being highlighted at Focus 2006.
