The Closing Date for this ITB <u>has not</u> changed. Bids will be received until August 15, @ 3:00 PM Alaska time.

Questions:

- 1. A The bid states FOB Seattle, would you accept FOB Anchorage? Yes, FOB Anchorage will be accepted. Total landed cost in Anchorage will be used to determine low bidder. If bidder submits FOB Seattle Dock ARRC will add internal freight costs for shipping to and from Anchorage for comparison and evaluation purposes.
- 2. Are they SRW or DRW rear axle? All units should be single rear wheel axle configuration.
- 3. Do you have an OEM requirement for the trucks? *No, all manufacturers will be allowed or accepted.*
- 4. Will RAFNA rail gear be accepted in place of HARSCI? Yes, RAFNA gear will be accepted.
- 5. What are the delivery expectations 1st quarter of 2025 or sooner? The vehicles will be put in service as soon as they are available. We are expecting a 2024 delivery to fill the requirement. Please replace the Cost Schedule in its entirety with the one attached herein
- 6. Is the tailgate step a requirement, and if so will the Chevy version be acceptable? The tailgate step requirement will be removed, it is not necessary for these vehicles.

Please acknowledge receipt of this and all addendums in your firm's Supply Bid Form.
