Questions:

1. Is Railroad Protective Insurance required for this project?
A. No, RPI will not be required.
2. Does the contractor need to tie in the concrete barriers to the existing fence?
A. No, no work is required with the existing fence, except for the removal in the identified section.
3. What is required for any remaining / leftover fill material, where should it be placed?
A. Please see the map attached for the identified material dump location.
4. Is ARRC going to require an asphalt paver or roller?
A. No, ARRC does expect that the Asphalt Paver spec 401-3.07 is applicable for such small area.
Yes ARRC will require an Asphalt Roller in accordance with spec 401-3.08.
5. Will Acceptance Sampling and Testing per 401-4.02 be required for this small amount of work?
A. No, ARRC will not be requiring Acceptance Sampling and Testing per 401-4.02.
