SECTION VII: GUIDANCE

Department of Homeland Security (DHS) Directive 257-01, *Law Enforcement Officers Safety Act (LEOSA)*, establishes Department policy with respect to qualified individuals who are retiring, retired, separated, or separating from a law enforcement officer position, such as with U.S. Customs and Border Protection (CBP) or its predecessor agencies. Under DHS policy, this includes DHS law enforcement officers who convert to non-law enforcement positions within the same or another Component or agency.

CBP retired law enforcement officer credentials satisfy the photographic identification requirement of LEOSA when carried along with a current state compliant proof of annual firearms qualification. A CBP LEOSA-specific photographic identification card is **not required**; however, those who would prefer one may apply using this application.

NO REFUNDS

CBP will not reimburse for any expenses (e.g., FBI Identity History Summary check and notary fees) incurred as a result of applying for a CBP LEOSA Photographic Identification.

How do I submit my application?

Incomplete CBP LEOSA Photographic Identification application packages will not be processed.

Completed CBP LEOSA Photographic Identification application packages may be emailed to <u>CBP_LEOSA@cbp.dhs.gov</u> or mailed to: Office of Professional Responsibility, Security Management Division, c/o LEOSA, 90 K St., NE, Mailstop 1175, Washington, DC 20229. If emailing, ensure to password protect documents containing PII/SPII. NOTE: CBP LEOSA Photographic Identifications will only be mailed to residential addresses (**no P.O. Box**). The preferred method for submitting the CBP LEOSA application is via email; hard copy mailed in applications are subject to delayed processing.

In order for the Office of Professional Responsibility (OPR), Security Operations Directorate (SOD), Security Management Division (SMD) to process your CBP LEOSA Photographic Identification application, the following Personally Identifiable Information (PII) and Sensitive Personally Identifiable Information (SPII) will be required:

- 1. Applicant's Full Legal Name (PII)
- 2. Applicant's Personal Telephone Number (PII)
- 3. Applicant's Personal Email Address (PII)
- 4. Applicant's Residential Address (PII)
- 5. Applicant's Social Security Number (SPII)
- 6. Photocopy of Applicant's Driver's License or State Issued Photographic Identification ⁽¹⁾ (with photograph) (SPII)
- 7. FBI Identity History Summary Check ⁽³⁾ (SPII) (required for applicants who are no longer employed by CBP)
- 8. Photocopy of Applicant's SF-50 and SF-50 Termination (if applicable) ⁽⁴⁾ (SPII)

Replacement for Lost or Damaged CBP LEOSA Photographic Identification

Request for replacement CBP LEOSA Photographic Identification requires resubmission and review of a new LEOSA application package containing current applicant information and supporting materials.

SECTION VII: GUIDANCE (continued)

Required Documents

- 1. Signed, Initialed CBP LEOSA Photographic Identification Applications (CBP form 79) can be submitted within 90 days of the anticipated retirement or separation date from the LEO position.
- 2. A recent photo meeting the passport photograph requirements (Photo background must be white or cream)
- 3. Photocopy of Applicant's Driver's License or State Issued Photographic Identification
- Self-obtained FBI Identity History Summary Check (HSC) (only required for former CBP employee who Retired or Separated from CBP with 1+ Days break in Federal service with CBP AND former employees who Retired or Separated from a Predecessor Agency whose Functions were Merged into CBP) ⁽³⁾
- 5. Documentation for non-CBP LEO Service (if applicable) ⁽⁴⁾
- 6. For Military LEO Service by PAYNE
 - a. DD214 for Military LEO service or certificate of release of duty
- 7. Former employees who Retired or Separated from a Predecessor Agency whose Functions were Merged into CBP suffice for Federal Service
 - a. A minimum of 2 SF-50s evidencing an aggregate of 10 years or more of LEO service
- 8. Applicants with Federal or non-Federal law enforcement service (e.g., local law enforcement)
 - a. SF-50s, and/or
 - b. A letter on agency/departmental letterhead stating date, end date, and attesting that the applicant separated in good standing.

1) Photocopying a government issued Personal Identity Verification Card (PIV) is prohibited by law.

2) Mail original clear and focused passport photo or email a digital file (e.g., jpg) to OPR/SMD (CBP_LEOSA@cbp.dhs.gov).

3) FBI Identity History Summary Check must be obtained within 60 days prior to application submission and submitted together with all other required documentation. Applications submitted that have FBI Identity History Summary Checks with processing dates in excess of 60 days will be rejected. Comprehensive background checks are required for all eligible applicants. To find an FBI Channeler near you, please visit: https://www.fbi.gov/services/cjis/ identity-history-summary-checks.

4) Documentation for non-CBP LEO Service is ONLY required if you do not have 10+ years of LEO service with CBP and you would like your former LEO service from another agency to be taken into consideration. For applicants who retired or separated from a Predecessor agency whose functions were merged into CBP, you would only need to provide copies of your SF-50s evidencing your years of service in the law enforcement position. If you do not have your SF-50 copies, you can request them through the National Archives Program Division. Former Federal Civilian Employees (the person of record) may obtain copies of their most recent civilian and personnel medical records on file at the National Personnel Records Center (NPRC), including copies of their SF-50s.
