

Requirements for Partner Government Agency Information in ACE & **Methods for Export Data Submission**

8/1/2017

United States government agencies with a role in regulating international trade are working together to meet a White House Executive Order mandating the completion by 2016 of a Single Window for trade submissions of required import and export information. As part of this effort, CBP is transitioning core trade processing capabilities into the Automated Commercial Environment (ACE). In order to reach the 2016 deadline, CBP has established a transition schedule for the remainder of 2016. The following list identifies agency forms and/or data elements, specific to exports, required at time of export and specifies whether the forms and/or data may be submitted via the PGA Line or Document Image System (DIS). Please see each agency for specific regulations on paper or electronic requirements.

The trade community is advised to check the list below on a regular basis, as new PGA regulations may be promulgated which may require the use of PGA Line or DIS for the transmission of PGA data and/or forms.
