# Customs Compliance Verification Requests

#### **Overview**

This is a new provision in the new United States-Mexico-Canada Agreement (USMCA) that states that a Party may request another Party to conduct a verification to determine whether any customs office is occurring and mandates the Party to respond in writing. There was no such provision in the North American Free Trade Agreement (NAFTA).

A Party may request another Party to conduct a verification in that Party's territory to assist the requesting Party to determine whether a customs offence is occurring or has occurred by obtaining information, including documents, from an exporter or producer. 	<ul> <li>The requesting Party shall make the request in writing.</li> <li>The requested Party shall respond to the request promptly and in no case later than 30 days after the date it receives the request.</li> </ul>	
	<ul> <li>The response will include whether it will conduct the verification.</li> </ul>	
	<ul> <li>If the Party does not intend to conduct the verification, the response will indicate the basis for refusal.</li> </ul>	
	<ul> <li>If a Party will conduct the verification, the response will indicate the intended timing and other relevant details.</li> </ul>

Provision	USMCA	NAFTA
	2. If the requested Party conducts a verification under paragraph 1, it shall provide the requesting Party promptly upon completing the verification a report containing the relevant information including data and documents, obtained during its verification.	
	3. In the case of a site visit by the requested Party, the requesting Party may, through officials it designates and subject to the consent of a legally responsible person for the location visited, accompany the requested Party.	
	<ul> <li>Accompanying the requested Party does not create any legal authority for the designated officials of the requesting Party.</li> </ul>	
	<ul> <li>The designated officials of the requesting Party shall fulfill the conditions and procedures mutually agreed between the relevant Parties for the visit.</li> </ul>	
	<ul> <li>Nothing in this Agreement requires the requested Party to allow or facilitate the participation of the designated officials of the requesting Party.</li> </ul>
