This document reflects the status of CBP and PGA requirements for filing data in ACE based on published legal requirements. Note that ACE system edits may not reflect established PGA filing requirements authorized by law or regulation, but such requirements may be imposed at any time. In the event of any discrepancy between ACE system edits and a PGA's legal requirements, the PGA's legal requirements are binding.
