U.S. Single Window for Trade



INTERNATIONAL TRADE

- In FY 2014, CBP processed more than \$2.4 trillion in trade – an increase of more than four percent from 2013 – and more than 25.7 million cargo containers, up 4.5 percent from the previous year.

ACE / ITDS

- Executive Order establishes deadline of December 2016 for implementation
- ACE is the technology enabler through which Single Window processing will be achieved
- Key features to enable Single Window processing have been implemented

PARTNER GOVERNMENT AGENCIES

- 47 Partner Government Agencies
- Largely paper-based with multiple entry systems
- Nearly 200 forms required for imports and exports

Automated Agency interactions reduce paper, enable near-real time decision making by Government

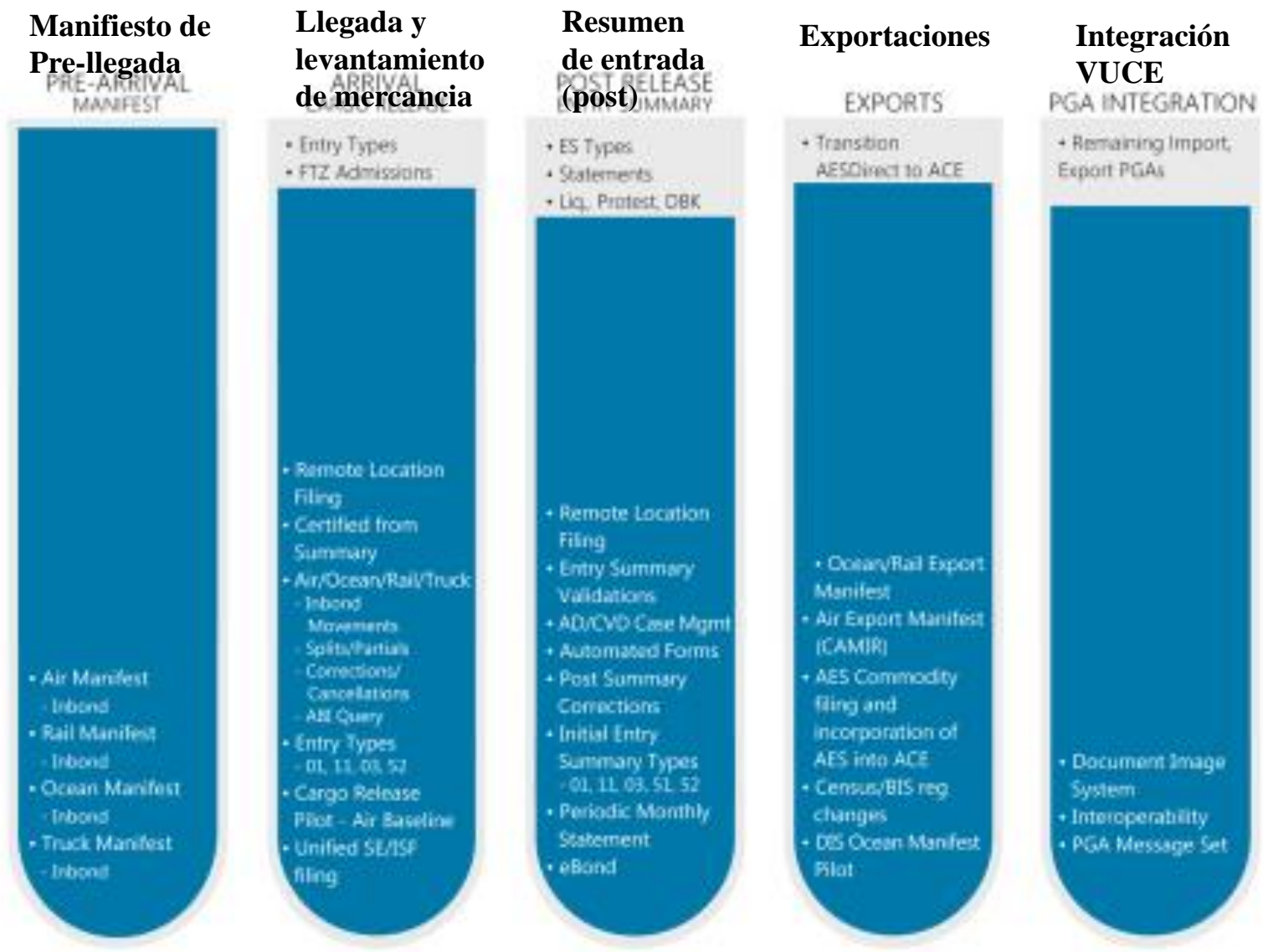

- Presentación del manifiesto electrónico para camión (incluye presentación en el portal ACE)
- Identificar **socios autorizados** que pueden usar bonos bajo custodia del transportista

Presentación de Entradas (liberación de mercancía)

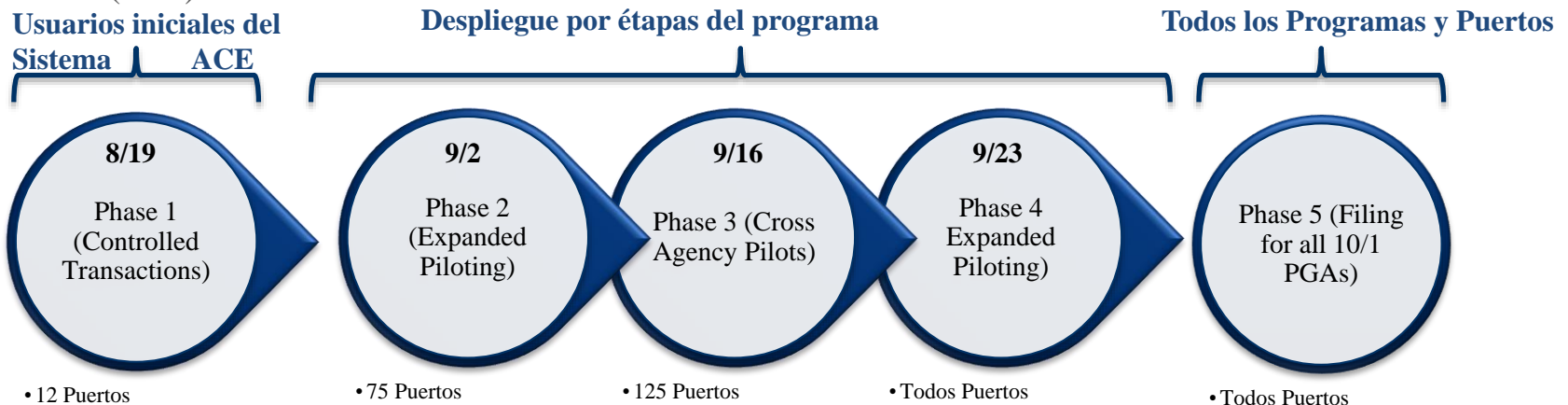

Cambios en el proceso de declaración del Lacey Act debido a la implementación del sistema ACE

La siguiente son nuevos cambios para el proceso de presentación de información:

- Declaración de Certificación (Certification statement) – al utilizar la letra “Y” en el grupo de datos del mensaje de PGA del Acta de Lacey, PG22, el importador certifica que la información en la declaración es correcta.
- Función de Disclaimer – Esto permite al declarante identificar los cargamentos que no necesitan declaración del Acta de Lacey o cargamentos cuya declaración se ha presentado por fuera del Sistema ACE.

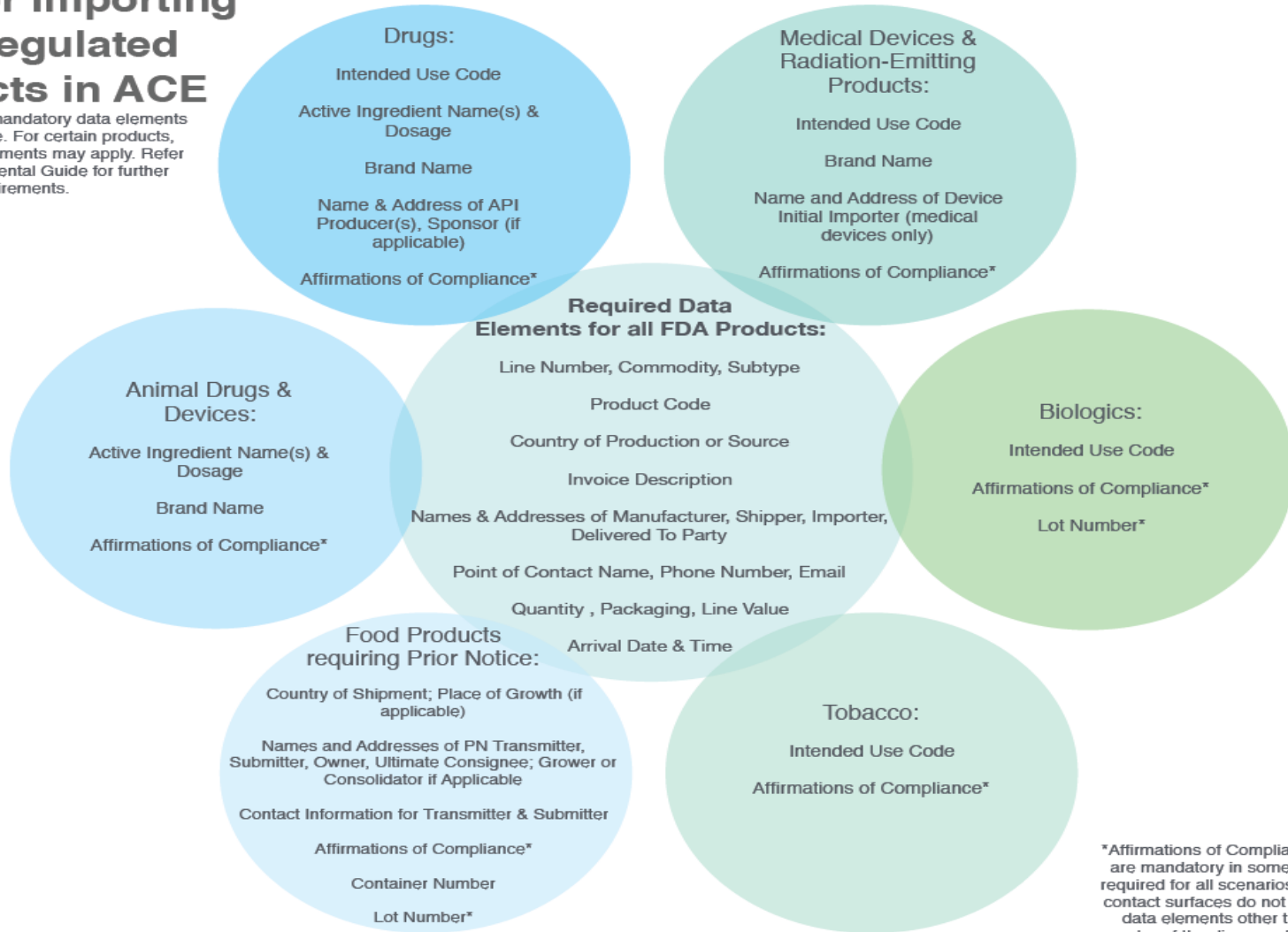

Tips for Importing FDA-Regulated Products in ACE

*Affirmations of Compliance and Lot Numbers are mandatory in some instances but are not required for all scenarios. National Highway Traffic Safety Administration

The National Highway Traffic Safety Administration regulates “motor vehicles” and “motor vehicle equipment” at the time of importation into the United States.

“Motor Vehicle” means a vehicle driven or drawn by mechanical power and manufactured primarily for use on public streets, roads, and highways, but does not include a vehicle operated only on a rail line. “Motor Vehicle Equipment” is defined as--

(A) any system, part, or component of a motor vehicle as originally manufactured;

(B) any similar part or component manufactured or sold for replacement or improvement of a system, part, or component, or as an accessory or addition to a motor vehicle; or

(C) any device or an article of apparel (except medicine or eyeglasses prescribed by a licensed practitioner) that is not a system, part, or component of a motor vehicle and is manufactured, sold, delivered, offered, or intended to be used only to safeguard motor vehicles and highway users against risk of accident, injury, or death.

When importing these commodities, the importer must file the NHTSA HS-7 Declaration form as part of the data elements submitted to U.S. Customs and Border Protection, which provide the lawful basis for the commodities’ importation.

NHTSA ACE Implementation

- With ACE, NHTSA-required entry data elements may now be made in all electronic format
 - No need for paper entries
- NHTSA ACE guidance is published
 - “PGA Message Set for Shipments Subject to NHTSA Regulations”
 - July 23, 2015 version
 - Available at: www.cbp.gov/trade/ace/catair
- CBP has announced that ACE must be used to import NHTSA-regulated commodities on February 28, 2016
 - Paper entries will remain possible

ACE and Automated Systems

CBP automated systems electronically support the facilitation of importing and exporting goods. By the end of 2016, the Automated Commercial Environment (ACE) will become the Single Window - the primary system through which the trade community will report imports and exports and the government will determine admissibility. Through ACE as the Single Window, manual processes will be streamlined and automated, paper will be eliminated, and the international trade community will be able to more easily and efficiently comply with U.S. laws and regulations.

CBP has established the following mandatory use dates for transitioning to ACE:
