This data is updated in the Spring after the IPEDS reports have been submitted

(usually around April 10) and the COE Annual Report has been accepted (usually around the end of March). The college placements were audited in Fall 2019 by COE for a substantive change, Spring 2022 as part of a COE reaffirmation, and confirmed in Summer 2022 with an onsite visit with 0 findings and a full 6-year reaffirmation of the entire college. COE placement rates are related to employment in the field of study or entering the armed services. We publish the COE placement rate.
