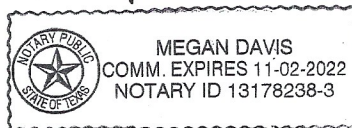


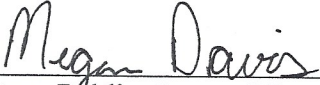

2020-2021 Budget for Collingsworth County

A motion was made by Commissioner Kirby Campbell and 2nd by Commissioner Jim Ellis to set the tax rate for Collingsworth County at .690845

“THE TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAT LAST YEARS TAX RATE.”

Compared to last year’s tax rate, this rate will be raised by 3% and will reduce the taxes for maintenance and operation on a \$100,000 home by approximately \$27.14.
