Revocation of Trainee Independent
Adjuster License Order under the
Provisions of AS 21.27.840

ACCUSATION & ORDER OF REVOCATION

1. On or about October 20th, 2022, the Alaska Department of Commerce, Community and Economic Development, Division of Insurance (Division) issued a Trainee Independent Adjuster License to transact the business of insurance to **TRINITY MARIE FALE (FALE)**, domiciled in the State of Alaska.
2. On October 20th, 2022, the Division sent correspondence to **FALE** informing her of the Trainee Adjuster Exam Requirements of Alaska Statute (AS) 21.27.840(c)(1). Based on the initial date of licensure, **FALE** should have taken the Adjuster exam on February 20th, 2023, and obtained a score of 60% or greater or Tuesday, June 20th, 2023, and

obtained a score of 70% or greater. In the same correspondence **FALE** was advised that if exam results are not provided to the Division in the time frame required her license will be revoked. There is no record of **FALE** taking the adjuster exam on the preceding dates or at any other time.

- 3. Alaska Statutes (AS) 21.27.410 (a)(8) dictates, "the conduct of affairs under a license if the licensee exhibits conduct considered by the director to reflect incompetence or untrustworthiness, or to be a source of potential injury and loss to the public;"
- 4. AS 21.27.840 (C)(1) further dictates, "the director shall revoke a trainee independent adjuster license unless the individual has not later than four months after the effective date of the trainee adjuster license, complied with the independent adjuster licensing requirements of AS 21.27.060 concerning the insurance laws and regulations of this state."

IT IS HEREBY ORDERED, under the provisions of AS 21.27.840, that **TRINITY MARIE FALE's** Trainee Adjuster license 3002216757 is **REVOKED** for failure to complete the four-month exam requirements.
