IT IS HEREBY ORDERED, pursuant to the provisions of AS 21.09.140 (a) (2), that Certificate of Authority No. F-974 issued to **R&Q REINSURANCE COMPANY** to transact the business of insurance in the State of Alaska shall be revoked. Pursuant to AS 21.09.160 (b), this revocation shall automatically revoke the authority of all its agents to act as agents of **R&Q REINSURANCE COMPANY** in Alaska.

IT IS FURTHER ORDERED that Certificate of Authority No. F-974 held by **R&Q REINSURANCE COMPANY** shall be returned to the Alaska Division of Insurance by September 30, 2023.
