16	9. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an

20	10. AS 21.27.025(b) states that "(b) In addition to any other penalty provided
21	by law, a failure to notify the director as required by this section is cause
22	for denial, nonrenewal, suspension, or revocation of a license."

24	IT IS HEREBY ORDERED, under the provisions of AS 21.27.440, that CONNER J.
